

# Investment to Recruit and Train California Workers for Community Revitalization Work

The U.S. Environmental Protection Agency (EPA) announced the selection of two California entities to receive a total of \$944,000 for environmental job training programs as part of President Biden’s Investing in America agenda. The grants through EPA’s Brownfields Jobs Training Program will help recruit, train, and place workers for community revitalization and cleanup projects.

1. Kern County Builders Exchange has been selected to receive \$500,000 for their job training program. The Kern County Builders Exchange is a non-profit located in California’s Central Valley that, through its larger network, supports workers and community members in Kern, Ventura, Santa Barbara, San Luis Obispo, Fresno, Tulare, and Kings Counties. The Builders Exchange plans to train 300 students under this Brownfields Job Training grant. They plan to specifically target underemployed community members and provide the skills and training needed to remediate idle oil and gas wells and other petroleum-related sites throughout the region. This approach has the dual benefit of providing trainees with the skills they need for a career in environmental remediation and supporting Central Valley’s continued energy transition.

2. The City of Pittsburg has been selected to receive \$444,000 for their Future Build Program. The program will continue its work to address public health and environmental justice in neigh-

borhoods impacted by environmental harms. Pittsburg’s program serves community members who are unemployed or underemployed and focuses on providing support to students who are low-income. In addition to training students in various environmental health and safety topics, all students graduating from the program complete a project installing solar panel systems on the homes of low-income community members.

“President Biden’s Investing in America agenda is having a real-world impact on the ground here in California, creating good-paying jobs and revitalizing communities,” said EPA Pacific Southwest Regional Administrator Martha Guzman. “Through these two Brownfields grants, EPA is investing in the next generation of environmental workers, helping them build the skills to clean up legacy pollution in communities across our state.”

“California is committed to expanding opportunity and driving sustainable economic growth all across our state” said Governor Gavin Newsom. “We thank the Biden-Harris Administration for furthering our efforts through these grants, which will help residents in Kern County and Pittsburg access valuable training and certifications for environmental jobs while helping to revitalize their communities.”

“I applaud the selection of Kern County Builders Exchange and the City of Pittsburg for the Brownfields Job Training Grant. This is an important investment that will boost the creation of hundreds of good-paying environmental jobs in

communities impacted by hazardous pollution,” said Senator Alex Padilla. “I’ll continue working to bring additional essential investments for the cleanup and redevelopment of these lands for the health and safety of our communities, and to ensure that we deliver on the transformational change needed to build a green economy in the 21st century.”

“Getting people in California greater access to good-paying jobs is a huge priority of mine, and I’m pleased to see this important funding go to the City of Pittsburg and the Kern County Builders Exchange,” said Senator Laphonza Butler.

“These grants will make a positive difference for hundreds of students in the East Bay and Central Valley by giving them the skills and training they need to thrive. They will get students ready for jobs that not only make our communities stronger, but also fit in line with our larger environmental goals. In the end, these are a win for our state, our economy, and our environment.”

“I am thrilled that the City of Pittsburg has been selected for the Brownfields Job Training Grant. This grant will enable the City and its partners to recruit and train residents of east Contra Costa

## Controller Issues Annual Fiscal Monitoring Report on Nonprofit Contracts

In FY23 (between June 2022 and July 2023), the City and County of San Francisco contracted with over 600 nonprofit providers to deliver \$1.7 billion of safety net services, ranging from family support services, homelessness and housing services, and senior services, to veteran’s ser-

vices and workforce development services. Our annual report and accompanying dataset detail the financial and operational health of 197 of these organizations. These 197 nonprofits either receive City funding above a certain threshold, contract with multiple departments, or were selected for fiscal monitoring based on a risk assessment.

In this most recent fiscal year, the City monitored more nonprofits than in years prior, and the majority of them were found to have sustainable fiscal operations in alignment with the City’s financial and administrative standards. Four contractors out of the 197 have been placed or kept on Elevated Concern status, meaning that these nonprofits need technical assistance to build proper fiscal and management practices, along with additional attention to address outstanding issues. These four organizations are:

- Bayview Hunters Point Foundation for Community Improvement
- HomeRise
- African American Art and Culture Complex
- PRC and Baker Places, Inc.

No nonprofits are currently on Red Flag status, which is one step above Elevated Concern and requires further corrective action.

“Nonprofit organizations under contract with the City deliver some of the most critical services supporting residents in great need. We trust these monitoring results highlight areas where some contractors are struggling and require technical assistance or other interventions,” said Controller Ben Rosenfield. “Our fiscal and compliance monitoring program is one component of a growing number of tools and strategies we’re using to ensure these services are monitored and, where needed, improved. Accountability and assistance are both important components of all of our initiatives.”

In April 2023, the Controller’s Office issued a report about nonprofit worker wages and demographics which helped inform FY23-24 budget allocations to increase wages in key sectors. To further our goals to improve government operations, the Controller’s Office developed guid-

# 15 Business Tips That You Need to Know

Many small business owners are happy to share their business tips with other entrepreneurs. Check out our 15 top business tips from small business owners, which can help you run and grow your business effectively.

### Business Tip 1: Build a Support Network

For Laura Kelly, being a business owner can be an isolating experience at times. “Especially if you’re a solo business owner, you can lose touch with other business owners,” says Kelly, who 15 years ago started The Handwork Studio, a Narberth, Pennsylvania-based company that runs needlework camps and classes for kids in 10 states along the East Coast.

The crucial solution for Kelly has been to stay networked in the larger business community. That means meeting with her personal business coach for an hour every four weeks. Kelly’s coach has provided business tips and helped Kelly her find solutions to problems and work through tough decisions with her business. She also networks on Facebook and LinkedIn from the comfort of her own home.

“[My coach] walked me through some visualization exercises,” Kelly recalls. “Just that sheer exercise of removing myself from the business and looking down on it really helped me see the problems that were bothering me. In an hour’s time, I walked away with clarity and a strategic plan to move forward.

And then there’s the mastermind group to which Kelly belongs. She and her fellow women service business owners get together on a conference line. “We discuss problems and solutions, and we talk each other off the ledge.”

As a busy business owner, it’s tough to find time to network, but getting better at networking and making new contacts—along with nurturing your existing ones—can pay dividends in the future.

### Business Tip 2: Be Very Specific With Your Goals

Another business tip that Kelly has learned over the years: Break big goals into smaller ones. “I have 10-year goals, I have three-year goals and one-year goals, and I have quarterly goals for my business,” she says. “When it comes to rev-

enues, I will break them into smaller numbers so they’re easier to obtain. If I know I need to make a couple hundred thousand in revenue in the first quarter, I say, ‘What does that mean in terms of camp sales? How many campers do I need to obtain?’ If I know I need 800 campers to reach the revenue goal, then it’s easier to figure out how to achieve it. These kinds of really specific goals can help drive your actions.”

Every employee at The Handwork Studio has a dashboard with their goals on it that shows their progress toward those goals. It helps keep everyone focused, Kelly adds: “I can tell you at any exact moment how much revenue we have, the traffic of our website, and how many Facebook likes we have.”

Building a performance-driven culture all starts with being very specific about goals—for yourself and for your employees.

### Business Tip 3: Delegate Whenever Possible

When the Marks Group, a technology consultancy, started in 1994, it was just Gene Marks and his dad. “He was doing sales and I was doing service,” Marks recalls. Then his dad died. “When he passed away, I took it over and realized I couldn’t do it all, and hired my first employees. I’ve learned that you can make a lot more money when you have other people doing it for you.”

As he hired more people, it dawned on Marks that he had been doing work that he was bad at doing. The revenue of the business soared after he brought on new employees, because he was hiring people who were better than he was at certain jobs. “I just sort of learned the hard way: Focus on what you do best, and delegate the rest.”

### Business Tip 4: Keep Your Overhead Low

Eight years ago, it occurred to Marks that he was sitting in an office costing nearly \$30,000 a year in rent, while his employees were out working with clients. So Marks got rid of the office in suburban Philadelphia and made his workforce virtual. Along the way, he replaced the landline with an internet-based phone that cost about \$10 a month, and he ditched computer servers for the cloud, too.

Lowering the overhead brought Marks some peace of mind through the Great Recession. “When things turn bad, you don’t have to panic, because you can take a cut in revenue,” Marks says. “Even in the brunt of the recession, we



never lost money. Cutting down overhead really gives you that peace of mind. If your overhead is low, you can make pricing decisions that you otherwise wouldn’t be able to make.”

### Business Tip 5: Find Your Best Niche—and Stick With It

Trying to do too much too soon? Feel like you need to be all things to all clients? A top business tip is that diversifying isn’t always the best strategy. Sometimes, it’s good to replicate the magic of something that already works well. That’s been the successful strategy for Ace Apparel, according to Marc Mathios, who along with his two brothers are the third generation to run the 78-year-old family business, based in the Bronx, N.Y.

“One of the industry silos that we’re really good in is parking garage operators,” Mathios says. “The reason that parking garage operators like to work with us is because we manufacture our own line of jackets that are suited for parking garage companies. We’ve duplicated that success with 30 different parking garage operators across North America.”

Finding your niche and continually innovating around that niche is a path to success.

### Business Tip 6: Stick to One Goal at a Time

People who chase two rabbits end up with none. It’s difficult to prioritize your work when you’re

a small business owner. You have 1 million things on your to-do list, and they are all top priority.

Multitasking is more of a myth than it is a productivity strategy. When you bounce between multiple tasks, you’re not multitasking. You’re task switching. Each time you move from one task to another, you lose productivity. This is because your brain needs to adjust to the changes in priorities and tasks.

Make it a point to focus on one task at a time. Allocate a certain amount of time to the task and keep yourself focused on that task—and that task only—while you’re working. Not as easy as it sounds? The next business tip can help.

### Business Tip 7: Use the Pomodoro Technique and 80/20 Rule

The Pomodoro Technique works like this:

1. You work for 25 minutes.
2. Then you take a three- to five-minute break.
3. You then go back to work for 25 minutes.
4. After four 25-minute work intervals, it’s time for you to take a 30-minute break

Working in this way helps prevent procrastination. Almost anybody can work on something for 25 minutes straight without breaking concentration. However, after 25 minutes, it’s normal for

people to need a break or they'll get distracted. If you schedule a time for your distraction, then the downtime will be less significant. Also, you'll be more dedicated to the task if you know you're only working on it for 25 minutes.

Here's another business tip to consider: The 80/20 rule, also known as the Pareto principle, states that 80% of results come from 20% of actions. And this isn't just for good results. It also can apply to bad results. For example, 80% of your customer complaints may come from 20% of your clients. That's a bad result. However, 20% of your clients may contribute 80% of your sales. That's a good result.

Look for the 80/20s of your business. Often, you'll find that a lot of your problems and successes are coming from just a few sources. This can help you become focused on what's working and what isn't so that you can take appropriate action.

**Business Tip 8: Encourage and Embrace Feedback**



into socially impactful and well-paying careers in the environmental remediation sector. Pittsburgh has already taken great strides to clean up legacy environmental contamination in the area, and this grant will enable the City to finish this important work," said Representative John Garramendi.

"Kern County and California's Central Valley's energy industry continues to transition," said Kern County Builders Exchange Executive Director Mikin Plummer. "The EPA's Brownfields Job Training funding provides opportunities for workers from the energy industry to develop the environmental expertise for brownfield remediation that comes with these changes. We look forward to both the individual impact for a worker's career, and the community transformation they'll support."

"The careers available to Future Build graduates of this EPA program are in-demand and important for moving the needle toward state-wide environmental and local workforce targets," said City of Pittsburg Council Member Juan Banales. "With a nearly 90% placement rate of graduates, we look forward to partnering with the EPA in enriching the lives of many more in our East County underserved communities."

Nationwide, these grants will provide funding to organizations that are working to create a skilled workforce in communities where assessment, cleanup, and preparation of so called brownfield sites for reuse activities are taking place. Individuals completing a job training program funded by EPA often overcome a variety of barriers to employment and many are from historically underserved neighborhoods or reside in the areas that are affected by environmental burdens.

Job training and workforce development are an important part of the Biden-Harris Administration's commitment to advance economic opportunities and address environmental justice issues in underserved communities. All of the FY24 Brownfields Job Training Program applications selected across the U.S. have proposed to work in areas that include disadvantaged communities as defined by the Climate & Economic Justice Screening Tool, delivering on President Biden's Justice40 Initiative which aims to deliver at least 40% of the benefits of certain government investments to underserved and overburdened communities.

Under the Brownfields Jobs Training Program, individuals typically graduate with a variety of certifications that improve their marketability and help ensure that employment opportunities are not just temporary contractual work,

ance and policy regarding multi-year contracting principles and is currently in the process of implementing a new ordinance to ensure inflation is accounted for in nonprofit contracts. This new initiative will enhance accountability of both departments and their nonprofit contractors and seeks to improve the way the City measures the impact and results of the vast array of services delivered to the public by the City's network of

nonprofits contractors. The Controller's Office anticipates releasing new policy and tools for this initiative later this fiscal year.

**Two New Mission Street Marketplaces Open to Support Permitted Street Vendors**

Mayor London N. Breed and Supervisor Hillary Ronen announced the unveiling of a plan to support permitted street vendors as the temporary moratorium on street vending begins along Mission Street, between 14th and Cesar Chavez Streets. The plan includes the opening of two temporary spaces where permitted street vendors will be able to sell goods and products. In addition, the City will provide complimentary wraparound services, including a resource fair, to support vendors.

This moratorium on Mission Street is the result of unprecedented safety concerns due to unauthorized vending and illegal activities which have been negatively impacting small business owners, permitted vendors, Mission residents, and visitors along one of the City's busiest transit corridors.

"We need to disrupt the dangerous conditions around unpermitted vending and create a safer neighborhood for residents, small businesses, and our permitted street vendors," said Mayor Breed. "We want to support people who are trying to make a living and following our permits and guidelines, and these new spaces and support will do just that. This is about helping the entire Mission community and making sure that merchants, residents, and City workers feel safe and that the neighborhood can thrive."

The City is partnering with community nonprofits including Clecha, Calle 24 Latino Cultural District, and the Latino Task Force Resource Hub on a plan that includes complimentary programs to support permitted vendors throughout the moratorium which will allow the selling of goods and products in the Mission.

The plan includes the opening of two temporary spaces for permitted vendors:

- **Tiangué Marketplace-** The formerly empty storefront will accommodate up to 50 vendors. The marketplace located at 2137 Mission Street will open daily from 10:00 am-6:00 pm starting on Monday, November 27th.
- **La Placita-** The outdoor parking lot operated by the San Francisco Municipal Transportation Agency (SFMTA) will be repurposed to accommodate up to nine permitted street vendors. Located on 24th Street, between Capp and Lilac Streets, the space will open Tuesday-Saturday from 10am-6pm. The space will officially open on Tuesday, November 28th.

Leading up to the moratorium, various City agencies worked collaboratively to devise comprehensive ways to mitigate concerns from the community and permitted vendors while protecting the health and wellbeing of Mission residents, small businesses, and workers. The interventions, planned with community input, included extensive outreach and education, supportive and technical services, street vending guidelines and permitting requirements. They also included public activations and events, increased policing, the addition of barriers and other traffic and pedestrian installations, and ambassadors to assist with daily cleaning programs.

Captain Vineyards is a winery in Moraga California that is dedicated to sustainability. Many rave about the winery's bold reds and beautiful views, but their green operations are also causing a commotion amongst viticulturalists, environmentalists, and wine-lovers alike.

Their consistent efforts to decrease waste have been acknowledged for eight years by the Central Contra Costa Sanitary District. And everything that is uprooted from the land is returned. This means 100% of organic materials – pruning clippings, grape skins, seeds, and stems – are recycled. In fact, Captain Vineyards is proud that they no longer require a green waste container because of this initiative.

Captain Vineyards began dry farming its 3,500 vines in 2007. All water used in the cleaning and wine-making process is recycled. Captain Vineyards Winery is clearly achieving its stated goal "to grow with our grapes and show that everyone's favorite beverage does not need to cause environmental damage or worsen a drought." Their water-saving actions have been acknowledged with the Water Smart Audit Award,

which they have received from the East Bay Municipal Utility District twice in the past eight years.
