

# Could the Pacific Ocean be California's savior?

From the earliest exploration by European explorers of what became California, its position on the western coast of the North American continent has been its most important attribute.

Its coastline allowed that exploration and the development of outposts while most of the continent was still a mysterious wilderness. It fostered the 1849 gold rush that hastened California statehood. Its beaches drew millions of visitors. It made California the arsenal and staging point for World War II's Pacific Theater and, finally, it became a focal point of global oceanic trade.

Could California's coastal waters now become its savior, ending ever-increasing shortages of water and electrical energy that threaten the state's economic and societal future?

Yes it could, but only if California's political and civic leaders overcome their tendency to muffle big public works — as symbolized by the bullet train's history of over-spending and under-performing, decades of foot-dragging on much-needed water storage projects, and crippling bottlenecks at the state's ports.

Finally, after decades of dithering, California's Byzantine bureaucracy is finally warming up to desalination of seawater as a vital piece of the state's water supply, although it still resists big



projects that could have real impact on shortages as it does in other water-short nations.

Meanwhile, California is just beginning to grasp the potential of offshore windmills to generate huge amounts of renewable electrical energy that would help close the state's current supply gap, fill enormous new demands, and meet the state's ambitious goals for ending its dependence on fossil fuels.

Last year, the federal government conducted auctions for windpower development rights on two oceanic sites, one 20 miles west of Morro Bay and the other off Humboldt County.

Advocates believe the sites could generate up to 8 gigawatts of electrical power, about one-sixth of the state's current peak power demand on hot summer days and about a third of the state's goal of 25 gigawatts of offshore windpower by 2045.

"Offshore wind is a critical component to achieving our world-leading clean energy goals and this sale is an historic step on California's march toward a future free of fossil fuels," Newsom said in a statement.

However, given the state's sorry record on big-impact projects, will it really happen? Will we, as state plans now suggest, really see offshore power begin to flow into the grid within 10 years?

I was honored to join several energy and environmental leaders in the public and private sectors to speak at the White House Electrification Summit. The summit, hosted by the White House Office of Science and Technology Policy, Climate Policy Office, and Office of Clean Energy Innovation and Implementation, convened

energy and environmental leaders from government, industry, academia, and stakeholder groups to showcase the unprecedented opportunities for inclusive electrification—the transition away from harmful fossil fuels to cleaner, more sustainable forms of energy.

It's clear that the impacts of climate change are not evenly distributed from neighborhood to neighborhood or from region to region. These frontline communities—often low-income

Equity is our best tactic of applied hope to reach the audacious goals and outcomes our communities need. As one of the only summit participants focused squarely on racial equity, I emphasized Greenlining's racial equity perspective that we must start with those that are most impacted in order to be successful in combating climate change and building more sustainable systems on the national and global scales.

Put another way: if we don't center frontline communities in our climate investments and action, we will never achieve our global climate and economic goals. It will simply not happen at the scale necessary to combat the enormous challenge before us.

## Opportunities

At this moment we are witnessing historic levels of federal investment and action to tackle climate change through the Bipartisan Infrastructure Law and Inflation Reduction Act. Paired with major investments from the private sector in cleaner energy systems and innovative climate finance solutions, we have a once-in-a-lifetime opportunity before us to redefine our future on this planet.

For the past three decades, Greenlining has confronted systems and structures to address the racial wealth gap and diversified our work to confront the evolving and compounding nature of climate change in formerly redlined neighborhoods.

We're taking our decades of experience working in communities and with regulators and legislators to scale our tested equity solutions with a national audience.

# Commerce Department's Minority Business Development Agency Announces Nearly \$100 Million to Expand Opportunities for Underserved Entrepreneurs

The U.S. Department of Commerce launched the Capital Readiness Program grant competition, which dedicates \$93.5 million to help minority and other underserved entrepreneurs grow and scale their businesses. This program, administered by the Minority Business Development Agency, marks the largest program of its kind in the history of the Commerce Department.

The Capital Readiness Program will provide funding to incubators and accelerators across the country, with expertise to assist and train minority and other underserved entrepreneurs seeking resources, tools, and technical assistance to start or scale their businesses in high-growth industries such as healthcare, climate resilient technology, asset management, infrastructure, and more.

Businesses owned by women of color represent one of the fastest growing sectors in the economy. However, structural barriers persist, preventing many women from starting their own businesses and accessing capital, childcare solutions, and peer networks. The Capital Readiness Program will provide the curriculum, tools, and resources to minority entrepreneurs to access capital and funding, and connect them to subject matter experts, vendors and peer support to help start or scale their business.

"This new program reflects President Biden's and the Commerce Department's continued historic commitment to underserved business

owners and entrepreneurs," said U.S. Secretary of Commerce Gina Raimondo. "During the pandemic, women and minority-owned businesses and entrepreneurs were among the hardest hit, often lacking the resources they needed to keep their doors open. We can't let this happen again. That's why the Capital Readiness Program prioritizes and encourages resources and tools, such as childcare services, that will ensure more people can launch and scale businesses."

"In 2020, Black and Hispanic female founders accounted for less than half of a percent of total venture capital investments," said U.S. Deputy Secretary of Commerce Don Graves. "Jump-starting the next generation of entrepreneurs and ensuring diverse representation in these high-growth industries is essential, not only to spurring innovation, but also to building a more resilient economy that's reflective of all Americans."

MBDA's Capital Readiness Program is funded by the Department of Treasury's State Small Business Credit Initiative (SSBCI), reauthorized under the American Rescue Plan Act of 2021. SSBCI provides \$10 billion to states, the District of Columbia, territories, and Tribal governments to promote entrepreneurship, increase access to capital, and help businesses grow—especially in traditionally underserved communities. The Capital Readiness Program is intended to serve entrepreneurs and businesses that are applying, have applied, or plan to apply to SSBCI or other government programs that support small businesses.

"We know that entrepreneurs and small businesses in underserved communities have long lacked equal access to resources and capital to reach their full economic potential," said Deputy Secretary of the Treasury Wally Adeyemo. "Through the Capital Readiness Program, the Minority Business Development Agency—tasked with promoting growth and competitiveness of our nation's minority-owned businesses—will help enable entrepreneurs and business owners to obtain the information they need to access funding through small business support programs. When entrepreneurs and small business owners in all communities have a chance to compete and thrive, it increases our country's entire economic potential and growth."

MBDA is the only federal government agency dedicated solely to supporting minority-owned businesses, enterprises, and entrepreneurs and helping them overcome the barriers to economic success that many women and minority communities face. The agency is uniquely situated to provide technical assistance and help these businesses be successful in applying to SSBCI capital programs and other government programs that support small businesses.

"The Capital Readiness Program will open doors for entrepreneurs," said Donald Cravins, Jr., Under Secretary of the Minority Business Development Agency. "The greatest obstacle facing disadvantaged entrepreneurs, especially entrepreneurs of color, is access. MBDA can effectively launch the initiative to help entrepreneurs

start and develop their business, access capital through the Department of Treasury's SSBCI Capital Program, and access networks that understand and address the unique challenges minority entrepreneurs and other underserved entrepreneurs face."

Entities that are eligible to apply include non-profit organizations, private sector entities, institutions of higher education, and a consortium of two or more of any of the above-mentioned eligible applicants. To address one of the largest barriers to women in the workplace, the competition incentivizes applicants to provide childcare solutions, such as on-site day care, as a strategic priority. The competition also incentivizes proposals from organizations that are working to break down economic barriers for underserved communities and support traditionally underrepresented, high-growth industries while growing America's economy.

Starting in January, MBDA will host a series of informational pre-application webinars. The webinars will assist potential applicants in better understanding the Capital Readiness Program and the application requirements outlined in the Notice of Funding Opportunity (NOFO). The webinars are scheduled on January 10, 17, and 24th 2023 at 2:00 pm Eastern Time.

Don't count on it.

The floating platforms to support the immense windmills, anchored in more than 2,000 feet of water, face critical attention from environmental groups and a phalanx of federal and state regulatory hurdles. They also would require onshore support facilities in coastal communities where resistance to development is culturally ingrained, plus cables to bring the power to shore

and extensive expansions of transmission facilities to tie into the grid.

The time frame to make all of this happen, as the state assumes in its overall plan to shift California to renewable electric power, is very short. We're now 22 years into the 21st century and supposedly all of this would occur in just 23 more years — simultaneously with many other elements of decarbonization, such as shifting to battery- or hydrogen-powered cars and trucks

and eliminating natural gas in homes, business and industry.

It would take an immense cultural change in the state's governing apparatus to make it all happen by the designated deadline, a sense of urgency, a unity of purpose, and much more managerial competence than California has mustered in the last half-century.

The ocean could, indeed, be our savior. Theoretically, it could provide limitless amounts of clean water and clean power. But it won't happen unless we make it happen.

# Hiring Our Heroes: Military Vets Could be the Answer to Your Construction Staffing Challenges

As construction companies struggle with finding skilled labor, military veterans are a segment of the labor force that deserves attention. Vets currently make up about 7% of the construction workforce and each year approximately 200,000 vets transition out of the military. Those construction firms that have been successful in recruiting and retaining veterans say their hard and soft skills as well as attitudinal characteristics make them great new hires. In addition, several programs are in place that makes it advantageous and cost-effective to train and hire vets. Here we share the key benefits vets offer, how to recruit, and how to help vets transition from military to civilian employment.

### 5 Traits that Make Veterans a Great Hire

1. Assume high levels of trust— Veterans are highly trustworthy. “Vets know how to take orders and show up for work in the morning,” says Bob Nilsson, a retired veteran and former president of Turner International, which has a long history of hiring vets. Nilsson is currently president and founder of 100 Entrepreneurs Foundation, a resource for vets who are interested in entrepreneurship.
2. Know the importance of discipline and teamwork —“Because of their military training and experience, veterans tend to have a strong sense of discipline, focus, team-orientation, and leadership“ says Erica Gilliland, director of Craft Recruiting for McCarthy Building Companies. According to Gilliland approximately 10% of employees are veterans. “We know that we can teach technical skills, but it’s more complicated to teach those types of soft skills that are so important on our project teams.”
3. Adept at skill transfer – Military personnel are often trained in one area and moved to another. They have to quickly embrace change, train, learn and adapt. At the same time, they learn how to leverage their existing training, skills and knowledge in new roles.

4. Comfortable in discontinuous environments – “A military member could be sitting in an office one day, and the next day they could be deployed to a disaster area or war zone,” says Julie Davis, AEM Director of Workforce Development. This translates well to the construction industry where employees move from project to project as needed.” Gilliland concurs. “Many veterans are willing to travel to projects in different states around the country, and that is a big benefit.”
5. Advanced technical training – “The military is always on the leading edge of technology,” says Davis. “Military veterans have been conditioned to be very technology-minded, always thinking about how innovation could advance their mission.” McCarthy has veterans succeeding in areas such as logistics, safety, quality control and operations as well as in hands-on craft positions.

### How to Recruit Vets to Construction

The construction industry has a lot to offer vets. Being part of building roads, bridges and build-

ings can provide a great sense of satisfaction and purpose. In recent years McCarthy Building Companies has launched several programs to engage more veterans in the construction industry upon their re-entry into civilian life. “We are seeing good success in these initiatives, particularly in the areas of solar construction and craft workforce,” says Gilliland.

Gilliland believes it’s important to have an open-minded approach to recruiting. “Veterans bring a range of skills, and sometimes their resumes aren’t easy for civilians to read and understand,” she says. “We’ve found that by taking time to talk to an individual and better understand their full skillset, you are going to be more likely to find an opportunity for them that may not have been apparent from reading their resume.” Your search shouldn’t be limited to veterans who have experience operating or maintaining heavy equipment.

Several resources can help you get a better understanding of the military resume, including:

- A brief introduction to military workplace culture

- An explanation of Common terms
- Difference between the military branches
- Difference between officer and enlisted ranks
- Civilian to Military Occupation Translator

Nilsson stresses the importance of getting out and talking to veterans. “You have to let the veterans know you are interested in them,” says Nilsson. “One great way is social media.” In person events are also effective. During his years working with Turner, they would take wounded vets on tours of construction sites to expose them to some of the work opportunities in construction. “Take advantage of the vets you currently employ and use them in the recruiting process,” says Nilsson.

Don’t overlook the opportunity on your website. Turner Construction has a dedicated web page that lets military service members and vets know they are welcomed.

According to Gilliland, McCarthy is getting the word out by partnering with organizations that are already successful in this space and have the ability to reach vets. Among their partners are Adaptive Construction Solutions, Solar Ready Vets and Hiring Our Heroes.

### Where to post your construction jobs to attract vets

These websites focus specifically on jobs for vets:

- **GI Jobs**— is a commercial base job board that advertises heavily in the military community (Stars and Stripes newspaper, Military Times, etc.).

## San Francisco and Northern California Laborers Launch First State-Certified Citywide Public Maintenance Apprenticeship

Mayor London Breed joined city officials and labor leaders to celebrate the launch of the City’s Laborers Apprenticeship Program, the first state-certified initiative of its kind to provide skilled workers to multiple city agencies. Apprentices enrolled in the program will be available to perform a variety of essential services, including street cleaning for San Francisco Public Works and maintaining public spaces for the Recreation and Parks Department, while earning training credentials.

The City’s Laborers Apprenticeship Program is coordinated by the San Francisco Department of Human Resources’ “ApprenticeshipSF” program to recruit underserved job seekers in local disadvantaged communities for public sector employment. The program builds on the success of nearly 15 years of partnership between the Northern California Laborers and various city agencies, including Recreation and Parks, which today also graduated the latest class of gardener apprentices before the City and County of San Francisco combines all such training pathways into a single, innovative citywide pool of apprentices in early 2023.

“This partnership with the Northern California Laborers is the exact kind of solution we need to create opportunities for people to not only get on the job training for stable, well-paying careers, but to earn a paycheck while they are learning,” said Mayor London Breed. “As part of our economic recovery, we know we need to grow our workforce to deliver the basic city services our residents deserve. Through programs like this, CityBuild, and our Opportunities for All, we are trying to remove financial barriers to people getting the training they need to provide for themselves and their families, while setting the foundation for their long-term success.”

## Greenlining's vision for an abundant future by centering community needs

### Continued from page 1

- Advancing Mobility Equity: In 2018, The Greenlining Institute published the Mobility Equity Framework, a tool outlining how to center a bottom-up, community-led approach in transportation planning and decision-making with the goal of avoiding many of the harmful mistakes of the past. In the four years that the Mobility Equity Framework has been published, it has been utilized by a variety of state and local government, transit agencies, and advocates to uplift community needs and voices in the transportation planning and decision making process. Here are a few case studies of communities that have utilized the Framework to enact clean mobility options that actually meet community-needs.

- The Towards Equitable Electric Mobility (TEEM) Community of Practice: In 2020, Greenlining and Forth established the Towards Equitable Electric Mobility Community of Practice which builds bridges between environmental justice organizations and traditional environmental organizations across the country to advance equitable electric mobility. With the networks built and lessons learned from across the country, we are developing a national agenda and political momentum for equitable electric mobility.
- Funding equitable electric vehicle infrastructure: This sudden influx in funding for electric vehicle charging infrastructure underscores the larger burgeoning green economy and the opportunities for communities of color to build generational wealth.

The Administration's Justice40 initiative brings important momentum, but fails to define equity or provide operational strategies to reach Justice40 benchmarks. We offer guidance and examples on how states can target federal funding equitably and use the deployment of charging infrastructure as a community and economic development strategy.

- Unlocking private capital for community climate action: The burgeoning field of climate finance can unlock unmatched resources from the private sector—particularly the financial industry—to meet the capital needs of both industry and communities looking to plan for a difficult future. One way we are approaching this work is through our ongoing work in negotiating Community Benefits Agreements as part of

bank mergers and acquisitions. For recently proposed mergers of US Bank and Union Bank as well as Bank of the West and BMO Harris, for example, Greenlining made recommendations that were incorporated in the final CBAs related to disclosure and decarbonization, and emphasized that these new institutions should make robust commitments to invest in community resilience.

- Strengthening the Community Reinvestment Act: The Greenlining Institute is also working with regulators at the federal level to strengthen the Community Reinvestment Act—a civil rights era law that ended the discriminatory practice of redlining and obligated banks to reinvest in low-income communities.

San Francisco hire the workforce necessary to support the city's economic recovery coming out of the pandemic."

Today, the City and County of San Francisco and Northern California Laborers formalized the partnership by establishing a ten-member Joint Apprenticeship Committee to oversee the program, including labor and management representatives, as well as non-voting participation by the California Division of Apprenticeship Standards, San Francisco Office of Economic and Workforce Development (OEWD), and City College of San Francisco.

"We are thrilled that our collective work and partnership with the Northern California Laborers has led to the establishment of the new Joint Apprenticeship Committee," said Carol Isen, Human Resources Director. "Apprenticeships can create promising new pathways for workers to well-paying city jobs. On-the-job training with an experienced mentor leads to a nationally recognized apprentice credential and creates safer city worksites with a stable and reliable worker pipeline and higher employee retention rates."

The City's Laborers Apprenticeship Program aims to enroll over 100 apprentices over the next three years, with a goal of connecting other training programs such as the CityBuild pre-apprenticeship and other programs that provide as-needed workers to the public maintenance apprenticeship pipeline. Program completion qualifies graduates for full-time journey level positions in multiple City departments, as well as prevailing wage opportunities in the private sector construction industry.

The program expects to begin accepting applications in early 2023.

# Peaches Patties, A Jamaican kitchen

Since 2014, Peaches Patties has been serving fresh and authentic Jamaica cuisine in the Bay Area. It prides itself on baking fresh homemade Jamaican patties and other popular Jamaican dishes as well. According to the founder and Executive Chef Shani Jones, the inspiration behind Peaches Patties is her mother, a native of Kingston, Jamaica, whose nickname is “Peaches”, and is known for making the most delicious homemade Jamaican beef patties. The family matriarch moved to the U.S. and married Jones’ New Orleans-born father. In the Jones household, the cultural collaboration resulted in eclectic dinners: grilled meats with Jamaican flavors served on the same table as Creole stews and gumbos. This spurred Shani’s love of bold spices and culturally rooted recipes. That same passion gave rise to Peaches Patties.

Shani came to seek for SBDC assistance when her business sales plummeted to zero when COVID started. Knowing that she was not going to give up on this business, she was looking for an advisor who can guide her to pivot and go through this challenging time.

SBDC advisor Gwendolyn Wrights shared a lot of COVID relief resources with Shani. She then applied for the SBA Economic Injury Disaster Loan, Paycheck Protection Program, and CA

Relief Grant. Government funding is critical in sustaining her business during the pandemic.

Prior to COVID, Peach Patties was a catering company whose primary customers were tech companies. COVID caused all the tech company offices shut down and it barely had any business from the catering side. After discussing the possibility of pivoting to individual meals, SBDC advisor got Shani on board with Great Plate Delivered Program, a meal delivery service for seniors. Through the program, Shani was able to keep the business open and retain her employees.

In the fourth quarter of 2022, Shani worked with advisor Gwendolyn to secure a retail location at the SF landmark Ferry Building. The move allows Peaches Patties to grow out of a commissary kitchen and boost retail sales. Shani knows it has been her dream to own a retail location and she is happy to close the deal with the guidance and encouragement from advisor Gwendolyn.

Seabright Crafts focuses on reaching mainly small businesses in the Santa Cruz community to offer unique team-building experiences to employees, by doing something creative and stress-relieving. A full-time teacher at Cabrillo College, Stephanie Michelet came to the SBDC to achieve her dream of turning her passion project into a profitable business.

Stephanie Michelet discovered her love for teaching crafts after participating in a workshop in Boston, which served as a catalyst for her entrepreneurial ambitions. Although at first local stores in Santa Cruz were very receptive to her offer of teaching workshops, the pandemic forced her to pause her business. However, no sooner had things started to get back to normal than Stephanie was eager to relaunch her business.

Due to Stephanie’s lack of business experience, mentorship was crucial to focus on the bigger picture and to design a strategic approach, especially around cost analysis. In order to accomplish this, Stephanie started her journey by participating in our Clicks2Bricks program (C2B), aimed at assisting entrepreneurs in developing a modern e-commerce website and a successful business strategy. Throughout the sessions, our advisors touched on relevant topics, while also providing substantial hands-on help with build-

ing Seabright Crafts’ website. This process involved switching to Shopify, which proved more functional and easier to navigate, and focusing on making Stephanie’s website more visible.
