2023 Construction Trends: 23+ Experts Share Insight

This past year has been an interesting one for the construction folks, to say the least. In 2022, we kicked off strong with four consecutive months of increased construction spending. However, supply chain bottlenecks, inflation, and labor shortages all remained significant challenges for the construction industry. A 2022 study by the Associated General Contractors of America (AGC) and Autodesk found that 93% of construction firms have unfilled positions.

Challenges will certainly flow into the coming year, but there are many reasons to be optimistic. To gain even more insights into the exciting opportunities and transformations in the year ahead, we asked more than 20 construction industry thought leaders and insiders to share their trends and predictions for 2023. This year, we've broken down their insights into three main focus

- Industry Transformation: significant economic and global shifts
- Future of Work: the changing tides of construction's workforce

Advanced Innovation: the evolution of data and technology

1. 2023 Trends: Construction Industry **Transformation**

"The construction industry realizes that to drive more predictability, profitability, and safety into their processes, firms must continue to embrace digital technologies and innovation in 2023. Today, backlogs remain strong - but construction activity is a lagging indicator. With a potential recession looming, I expect construction companies to counterintuitively increase their innovation efforts to find new ways to deliver projects more cost-effectively. This innovation will be thoughtful and directed, specifically focused on solving nagging problems and challenges on the iobsite such as labor needs and material tracking. I also expect a surge of interest in using data to identify and predict issues earlier, and to provide key learnings and insights both at the project level and at the business level.

Furthermore, rising environmental and government pressure as well as requirements from responsible owners will drive the industry to make better, informed decisions regarding more sustainable materials and methods. Specifically, we'll see a rise in the use of embodied carbon calculators, which will help project teams determine the impact of emissions generated by materials used during construction. I also expect this pressure to drive a steep increase in DfMA and other offsite and modular methods. In addition to helping better manage the environmental impact of construction, modular construction methods will improve project productivity, deliver construction outputs more quickly, better manage scarce resources, and improve site safety.

What California can learn from wave of storms

California, particularly Northern California, was walloped by a major winter rain and snow storm last week and meteorologists expect that high levels of precipitation will continue for at least another week

Despite some damage and at least one death from local flooding and tree-toppling high winds, the storm and the predictions of more to come are welcome relief from what had appeared to be a

There are lessons to be learned from this watery wave, if Californians and the politicians they have elected pay attention, to wit:

-Despite great advances in technology and data collection, weather forecasting is still an imperfect science. Until the storm hit, meteorologists had expected that a phenomenon known as La Niña would continue to block Pacific fronts from reaching the state and thus continue the drought.

That said, there's no guarantee that the 2022-23 season will be a wet one. A year ago we had a similar spurt of precipitation, but it did not continue into the spring.

-Erratic precipitation makes it very difficult for reservoir managers to decide how much water to release and how much to retain for future use. For example, Folsom Lake near Sacramento was scarcely a third full when the storm hit, but the Bureau of Reclamation tripled releases to 24,000 cubic feet a second, worried about the reservoir's ability to absorb runoff in the American River's Sierra watershed.

-Folsom's increased releases are another indication that California lacks enough water storage to cope with precipitation cycles that are becoming less predictable due to climate change. If we had built the additional storage that water managers had long proposed - Auburn Dam upstream from Folsom, for example - it would have meant less guesswork when opportunities arose to capture water from heavy storms.

Preliminary construction had begun on Auburn Dam when, during the 1970s, it was abruptly halted. Other storage projects have been on the drawing board for decades, such as Sites Reservoir on the west side of the Sacramento Valley. Were Sites a reality today, it would be absorbing excess flow from the Sacramento River, banking water for when it would be needed in the future.

-The "atmospheric river" now watering California underscores the state's vulnerability to catastrophic flooding.

Last year, a massive study was released, suggesting that climate change creates an ever-increasing risk of megafloods that would cause untold death and destruction.

It is the latest update to studies that originated from the historic flooding that struck California during the winter of 1861-62, when California had been a state for scarcely a decade.

As the study noted: "This event, which was characterized by weeks-long sequences of winter storms, produced widespread catastrophic flooding across virtually all of California's lowlands - transforming the interior Sacramento and San Joaquin valleys into a temporary but vast inland sea nearly 300 miles in length and inundating much of the now densely populated coastal plain in present-day Los Angeles and Orange counties."

If such a prolonged deluge occurred again, researchers Xingying Huang and Daniel Swain, wrote, it "would likely produce widespread,

EQUITABLE ACCESS

Oakland awarded \$500,000 grant to support planning for affordable, high speed internet access

The Oakland City Council accepted a \$500,000 grant from the California Public Utilities Commission (CPUC) to support the City in developing plans for providing affordable, highspeed internet access to underserved areas of Oakland.

The Local Agency Technical Assistance grant award will enable Oakland to plan and design projects to deploy and leverage fiber optic and wireless infrastructure, as well support community engagement and digital literacy plans for the future.

"We are thrilled to receive this grant, which will support us in developing a comprehensive broadband strategy for the City of Oakland," said Tony Batalla, Oakland's Director of Information Technology. "Access to affordable residential broadband service will help further the City's goals for racial equity by addressing social issues associated with the 'Digital Divide,' which particularly impacts areas of East and West Oakland. We are grateful to the CPUC for this award."

The project will build upon the City's ongoing initiatives to improve equitable access to and adoption of highspeed broadband, including efforts to bring together the Oakland Unified School District, Oakland Housing Authority, and other key stakeholders to assess needs and address barriers to highspeed broadband access.

The City will use this funding to update the 2019 Fiber Optic Master Plan, identify City-owned infrastructure that can be made available to last-mile service providers, conduct a needs assessment to understand gaps in connectivity, with a focus on high-density apartment units, and plan and design broadband infrastructure projects for priority underserved areas.

Access to affordable internet access increases microeconomic development by empowering residents with expanded job opportunities, job training, networking, and many other benefits. Broadband networks and residential internet service also play an important role in the transition to cleaner economy by supporting technologies that reduce carbon emissions like smart thermostats, electric water heaters, and other appliances that connect to the home's internet service.

The City recently issued a Request for Information (RFI) as part of its new OakWiFi@Home initiative to better understand the landscape of potential partners, receiving dozens of responses ranging from community-based organizations to large Internet Service Providers. The results of this RFI will inform the City's next steps.

OakWiFi@Home builds on the work of #OaklandUndivided, an initiative to ensure 100% of Oakland public school students have a computer, internet access, and tech support, and the OakWIFI initiative, launched in 2020, to expand Oakland's public WIFI network.

An estimated 94,000 (21.7%) of Oakland residents lack internet access. A recent report by the Greenlining Institute found a startling correlation between East Bay neighborhoods lacking broadband access and neighborhoods that had been redlined beginning in the 1930s. According to Oakland Unified School District data, a concentration of school-age children in the east and central areas of Oakland as well as portions of west Oakland lack access to the internet.

The Future Workforce: Talent When You Need It, from Wherever People Want to Be

Since the pandemic started, the supply of people and the demand for skill sets have become more dynamic than ever – both in the U.S. and worldwide. And this has huge ramifications for HR leaders. For example, when you're developing a workforce plan, you can't just assume that there's going to be a 13% turnover anymore; 13% can become 50% almost overnight, in which case your plan flies out the window.

Going forward, workforce plans must be dynamic and adjustable based on a continuous monitoring of supply and demand. Such flexibility used to be extremely difficult to accommodate – back when the top determinants of supply were worker location and role. Location-bound talent meant that when an employee worked in California, your skills were in California. If you needed specialized IT skills in New York, you had to fly

your employee across the country and often they also needed a role change.

cause their diversity of experience and unique skill sets aren't necessarily needed in their full-

But as the pandemic shifted working models to work from home or hybrid models, knowledge workers not only became untethered from the office, but part of a free-range workforce that can work anytime and anywhere. They became location unbound – and prefer it, as evidenced by the large volume of people moving out of the city to the country, to Florida, or even debating a move to the British Isles, anywhere with a good broadband connection.

At the same time, we're seeing a new trend: unbound workers who are performing multiple – and increasingly diverse – roles as part of their current position. For example, they may work three days a week on one project or in one part of the business, and on the other two days support other initiatives with teams that are across the country or even overseas. These versatile workers are in demand for dynamic teams be-

cause their diversity of experience and unique skill sets aren't necessarily needed in their full-time role, but they are in high demand across the business on an ad-hoc or project basis. This trend could be beneficial to both the organization and employee, as variety can prevent monotony – which hurts the employee experience and leads to attrition – and even increase job satisfaction, engagement, and retention. Mostly this leads to significant increases in productivity and organization agility.

Given these trends, we're seeing the future of work as a flexible, global, incredibly agile gig economy that encompasses internal and external workers. This means hiring managers don't always need to create a new position and budget for every skill set they need; rather, the business makes it easy for them to meet their "demand" by finding, accessing, and onboarding the right people – wherever they are – with the right skills to meet their needs. Imagine having a talent management system that can cross-charge the

salaries or hourly rates of workers to multiple tasks, departments, and operational units across the globe. People can also sign up for flexible, part-time opportunities, get exposure to new areas of the business, develop new skills, and add value along the way.

There is, of course, a balance to be considered between the permanent and flexible elements of any employee's position. Too much flexibility and fluidity could diminish job security and expose employees to the negatives of a potential precarious work environment – a healthy balance is therefore vital.

Looking ahead, this kind of role and location flexibility will increasingly become necessary to access the skill sets needed to meet business and sustainable economic growth.

Terra And Self

Terra and Self is a sustainable beauty products company whose mission is to create environmentally ethical cosmetics that incentivize body positivity and inclusivity. The owner, Kenne Johnson, is a brilliant entrepreneur who turned her passion into a successful, profitable business.

From a young age, Kenne knew her calling was to start her own business that would allow her the freedom and satisfaction that come with being one's own boss. After pursuing an education in graphic design and entrepreneurship, the perfect opportunity presented itself when COVID forced us into confinement and Kenne had to make a pivotal decision about her life trajectory. Growing up, skin care was not a familiar topic to Kenne, until she got a job at a cosmetic company where she learned about its importance healthwise, as she also became more empowered given how confident she felt when taking good care of herself. This planted the seed for her entrepreneurial journey.

Kenne is not just focused on creating good quality cosmetic products that have a positive impact on her clients, but also on the environment, by promising safe, vegan and organic ingredients, as well as recyclable, biodegradable packaging. Contrary to most companies in the beauty industry, Terra and Self aims to uplift its costumers, by enhancing their natural features, without perpetuating unrealistic beauty standards.

Despite her business based academic background, Kenne felt at a loss of knowledge and resources to kick start her business, which led to anxiety and stress as a solo entrepreneur. Working along with advisor Jake Nelson, Kenne focused on creating more traffic by increasing wholesales and optimizing direct-to-consumer-sales, in an effort to go from local to regional and national sales, and in order ro get additional working capital to purchase materials, she started looking into getting a grant. After finding out about the Dream Fund Grant, aimed at promoting entrepreneurship and small business in California, Keith Holtaway helped Kenne with the financial aspect of the application, and the reviewing of the later-on submitted business plan.

Hoping to improve her online sales, Kenne also completed the Clicks2Bricks program offered by the SBDC, where she worked on developing her website to attract organic traffic and improve her brand's credibility. This task included defining profit margins and a shipping strategy, as well as working on SEO(Search Engine Optimization) to increase the business' rank in search results. To do so, she received guidance on how to navigate Google, and she learned to improve her choice of

Juggling a full time job while enduring the hardships that come with starting a business can be very taxing, which is why it became key to come up with a plan that would remove the necessity of a full-time job, so as to realize Terra and Self's growth potential. Hence, a suitable path for Kenne would be to maximize her time by batching more products, and to figure out the number of monthly customers needed to quit her job to allow for motivation to take her business to the next level.

Since the beginning of Kenne's journey with the SBDC, Terra and Self has experienced a \$2,800 increase in sales, as well as an increase in their part-time staff. After being approved for the Dream Fund Grant, Kenne is confident she will be able to advance her business by expanding, upgrading her production and hiring more staff to maximize productivity and prevent burnout. Her next goal includes opening a retail space in Downtown Santa Cruz that could serve both as a retail and production space, and offering workshops to share her knowledge of skin care.

two-decade-long effort to build this Subway: another step toward our vision of a transit-first City."

"The Central Subway is a transformative project for our City and a critical bridge to connect our neighborhoods and bring people together," said Mayor London Breed. "This project is also about our economic recovery. As our City is still recovering from the impacts brought by the COVID-19 global pandemic, our recovery efforts rely on an efficient and reliable transportation system. It's also about making life easier for residents. Not only will it help traffic congestion on our street, it will also provide a faster and more convenient way for us to get to where we need to go."

"The Central Subway is a success story, and this victory will be enjoyed for decades to come by San Franciscans and visitors alike," said Jeffrey Tumlin, SFMTA Director of Transportation, "We appreciate the community's patience as we worked tirelessly to bring to life their vision of metro service from the southeastern portion of the city to Chinatown. Our staff members have poured their hearts and souls into this project, including today's opening, and we thank them and look forward to applying what we have learned to future SFMTA initiatives."

Service runs Mondays through Fridays, 6 a.m. to midnight every 10 minutes and Saturdays and Sundays, 8 a.m. to midnight every 12 minutes

The T-Third will now continue north at 4th & King, transition into underground tunnels with a portal under the I-80 freeway, cross under the BART and Muni Metro tunnels beneath Market Street and then continue under Stockton Street to Washington

The T-Third's new route means that it will no longer turn onto King Street and run along the Embarcadero and the Market Street subway. The K Ingleside will also now travel between Balboa Park and Embarcadero Station. Customers accessing those stops on Embarcadero at Folsom, Brannan and 2nd & King may now transfer to the N Judah at Powell Street or 4th & King

This unique project features complex and awardwinning designs. The Chinatown station is 120 feet deep, almost equivalent to a twelve-story building underground. The International Tunneling Association awarded Chinatown Station "Project of the Year" for its sustainability aspects and community involvement; Union Square/Market Street won an award for innovative solutions for underground space utilization. Most of the funding for the Central Subway Project is provided by the U.S. Department of Transportation and comes to about \$1.953B.

This project has been successful in avoiding disruptions to existing BART and Muni service, and has not impacted travel through the Stockton Tunnel, despite its proximity.

"The Central Subway will help make San Francisco even more connected and vibrant," said Senator Scott Wiener. "Residents and tourists alike will have quicker and more reliable access to Chinatown - one of the densest neighborhoods in the city. We've worked hard to make this happen for two decades. This is a victory for all San Franciscans, and for the future of our city."

catastrophic flooding and subsequently lead to the displacement of millions of people, the longterm closure of critical transportation corridors and ultimately to nearly \$1 trillion in overall economic losses.'

Again, the American River's situation illustrates the threat. Officials say that Folsom Lake's capacity, nearly one million acre-feet, is too small to protect Sacramento from such a disaster. One rationale for Auburn Dam had been to provide another layer of flood protection.

Will politicians heed the lessons from the current period of prolonged precipitation or continue disengaged business as usual?
