

# Here Comes the Infrastructure Boom

The U.S. construction and engineering sector is about to enter a time of infrastructure boom as the Infrastructure Investment and Jobs Act (IIJA) provides a \$1 trillion plus revenue opportunity for U.S. construction and engineering contractors to take on infrastructure projects. Forecasts from Global Construction Perspectives predict infrastructure construction will take center stage as it outstrips residential construction for the first time in years as the primary revenue stream for contractors. But with such large public investments at stake, how can construction contractors and governments ensure tax funds are put to good use?

Infrastructure has long been a less lucrative sector for the construction and engineering industry, with underfunding of public projects plaguing the sector for years. Research from the American Society of Civil Engineers shows the infrastructure investment gap is now at \$2.59 trillion over a 10-year period. The state of the current infrastructure isn't just a government problem but impacts everyone, as a lack of adequate funding means countries such as, the U.S. and the U.K. are forced to get by with archaic systems that are no longer fit for purpose in a modern society. If



the current condition of infrastructure continues in this way, the average U.S. household could lose up to \$3,300 per year by the year 2039.

## A Booming Year For Infrastructure Construction

With the disruption of the pandemic largely behind us and economies starting to get back on track, the time is ripe for a refresh of outdated infrastructure systems and the impetus of the Infrastructure Investment and Jobs Act (IIJA) has put in motion new infrastructure works. Sustainability is another key driver in the push to modernize U.S. infrastructure. When compared to the newly constructed infrastructure seen in many modernizing countries, U.S. infrastructure

is inefficient and highly pollutant. In order to achieve key ESG targets, infrastructure systems must be modernized with a greener outlook in mind.

## Criteria for Successful Infrastructure Construction Project: Reliability

Herein lies a golden opportunity for construction and engineering contractors to prove their mettle in these critical infrastructure projects. But the competition won't be easy, and governments will be looking to contractors who can get them the most bang for their infrastructure investment bucks. In order to win highly profitable Public-Private Partnerships (PPPs) contrac-

tors will need to focus on project delivery and demonstrate they will not fall into the age-old trap of project delays and budget overruns. It is here, emerging digital technologies and innovative management solutions will be the deciding factor in the allotment of contracts.

## Methodical Project Planning With Modular Construction And BIM Technology

Large, complex projects, such as infrastructure, require detailed and methodical planning from start to finish. Modern Methods of Construction (MMC) can improve the planning and implementation process by utilizing modular, offsite, or pre-fab construction. The assembly of pre-manufactured modules decreases the complexity of on-site construction by manufacturing large portions of the build in a controlled environment and allows builds to be standardized through design. This in turn lowers the risk of delays and improves efficiency where unforeseen risk factors have been planned out of the construction process. A recent IFS study suggests that within 5 years, 50% of all construction projects will use modular manufacturing and/or 3D printing, with prefabricated modules accounting for up to 25% of the construction.

## California High-Speed Rail Recognized for Industry-Leading Student Outreach

The California High-Speed Rail Authority's (Authority) student outreach program "I Will Ride" has received the prestigious Rosa Parks Diversity Leadership Award from the Women's Transportation Seminar (WTS) Sacramento chapter. This annual award recognizes a transportation organization that has contributed significantly to promoting diversity, inclusion and multi-cultural awareness.

"California high-speed rail is about providing safe, efficient and sustainable transportation for the next generation," said Authority CEO Brian Kelly. "We are proud to lead the industry in providing opportunities for students and educators to take on these jobs in the future of transportation."

"I Will Ride" is a student-outreach program dedicated to connecting students to information and career opportunities on the nation's first high-speed rail system currently under construction. Led by the Authority's Student Engagement

and Outreach coordinator, the program employs a variety of methods to connect with students, including conducting virtual and in-person presentations to high school and college students around the state about the program, coordinating on high-speed rail construction site visits for students in the Central Valley, sponsoring student conferences and competitions, mentoring capstone projects and even sponsoring a train exhibit at Kids Discovery Station, a children's museum in Merced. In 2022, the Authority conducted a total of 64 student outreach events, reaching close to 3,000 students or professionals that work with students in some capacity.

"Collaborating with the Authority for 'I Will Ride' has allowed the Mineta Transportation Institute (MTI) to impact the lives of many K-12 students, igniting a passion and understanding of high-speed rail and an interest in transit and mobility careers," said MTI Director and WTS International Board Director Dr. Karen Philbrick. "From curriculum to Central Valley construction tours, our parallel vision for building the trans-

portation workforce pipeline of the future is being achieved."

# 2023-2024 California Budget Proposal Includes Hard Cuts to Protect Basic Needs Ahead of Economic Uncertainty

Governor Newsom's 2023-24 California Budget proposal previews a rocky road ahead due to lower-than-anticipated state revenues and ongoing economic uncertainty as the threat of a recession grows. California currently faces a \$22.5 billion deficit, in stark contrast to the state's historic \$100 billion surplus last year.

Economic downturns have the harshest impacts on low-income communities that are already struggling to make ends meet, which is why we're encouraged to see continued investments in areas like healthcare, education, and housing. However, proposed Budget cuts and funding delays in areas like infrastructure, clean transportation, affordable housing programs, and climate resilience will undoubtedly slow the state's progress toward making equity a reality for all Californians, and not just the wealthy few.

"Already underfunded equity programs that support communities of color and low-income communities should be protected all the time, but particularly during Budget deficit years. Economic cycles are unpredictable, which is why it is so essential to prioritize communities that face the most severe consequences of economic downturns. We urge legislators to start work immediately on progressive revenue proposals that create a consistent source of funding to advance climate equity, affordable housing development, and broadband deployment—programs that can

help close the racial wealth gap," said Alvaro Sanchez, Vice President of Policy at The Greenlining Institute.

"As leaders of the fourth largest economy in the world, California lawmakers have a responsibility to invest in statewide resilience so our communities don't fall further behind," Sanchez continued. "We appreciate the Governor's commitment to protect the state's most vulnerable by maintaining key investments in healthcare, homelessness, and education. This Budget proposal reflects our flawed economic system, in which the wealthiest few are able to accumulate immense amounts of wealth while millions slip into poverty and rely on a sparse government safety net to make ends meet."

#### Key investments outlined in the proposed Budget include:

- **Investment in the California Racial Equity Commission.** The Budget includes \$3.8 million in 2023-24, and \$3.1 million through 2028-29 in the General Fund to support the state's first Racial Equity Commission established by Executive Order last year.
- **Continued investment in the State Small Business Credit Initiative (SSBCI).** With over 320,000 small businesses already receiving grants for COVID-19 relief, the Budget includes \$6 million in 2022-23, and \$26 million ongoing investments for technical assistance, and \$8 million in one-time funding to support women-owned businesses. In light of

economic uncertainty, this ongoing investment remains critical as the state delivers more loans to support businesses still recovering from the economic impacts of the COVID-19 pandemic. We look forward to learning more details on how the state will ensure these investments reach communities of color and low-income communities that need them the most.

While the Budget sustains a multi-year commitment of \$44 billion in state funds for infrastructure investments, it also proposes a reduction of \$3.9 billion in critical spending that includes climate and transportation investments for the 2020-21 and 2023-24 fiscal years. Such funds are said to be restored if costs are deemed sufficient to cover previous commitments.

Potential cuts and delays outlined in the proposed Budget include:

- **Reductions to Affordable Housing Programs.** The Budget includes \$350 million in General Fund reductions related to housing programs that were included as part of the 2022 Budget Act. Despite these reductions, approximately \$2.85 billion remains intact based on the commitments made for the 2022-23 and 2023-24 fiscal years. The Greenlining Institute supports prioritizing housing investments, and opportunities that aid in meeting the state's 2.5 million production goal by 2030, one million of those units being affordable housing.

- **Delayed funding for Equitable Building Decarbonization.** \$370 million in funding for building decarbonization will be delayed for this, and future years. This includes an additional reduction of \$87 million planned for 2025-26 that directly supports projects aimed at reducing greenhouse gas emissions in homes and advancing energy equity.

- **Reverting funds for the California Arrearage Payment Program.** The Budget reverts \$400 million put in place to provide relief to struggling households suffering from large amounts of utility debt. We recommend that the Legislature preserves this funding and implements program design changes such as requirements for utilities to provide more tailored technical assistance and support to increase the reach of these funds.

#### Reductions and delays for climate initiatives.

- A reduction of \$65 million in 2022-23, and \$40 million in 2023-24 for the Transformative Climate Communities Program that empowers communities that are most impacted by pollution the ability to choose their own goals, and projects to reduce greenhouse gas emissions, and improve local air quality.
