15+ Top Construction Trends for 2022

The resilience required to tackle the challenges of 2021 has become a solid foundation for building in 2022. So how do we turn lessons learned into something that makes us smarter, more strategic builders?

With some economists calling 2022 the year of "consolidation and rebalancing," the road ahead may not be without speed bumps, but at least we'll have a better sense of how to navigate them.

We asked recognized leaders, technologists, and industry strategists from across the globe to share their top trends and predictions for future-proofing a construction business in 2022 and beyond. Here are some of the most revealing insights, organized by the topics that matter most right now. Names appear alphabetically below each category.

Global & Economic Construction Trends

Increased tech adoption in US due to "Infrastructure Deal"

"The Bipartisan Infrastructure Law is an historic opportunity to transform what infrastructure we build and how we build it. Digital design and construction tools can help the AEC indus-

try meet the goals of the legislation, including building and constructing more cost-effective, safer, resilient, and greener infrastructure that improves quality of life and economic opportunity for all communities.

Notably, the legislation included a new program to accelerate adoption of digital design and construction tools in transportation projects – making clear that this is a priority for infrastructure development. Initial funding to states is already flowing with much more to follow, including through a broad range of new and expanded grant programs. AEC firms should be ready to

position themselves as leaders in using technology to meet the legislation's goals when bidding for projects that will define the next generation of U.S. infrastructure."

Key US growth opportunities ahead despite significant challenges

"Looking forward, as the economy continues to recover, we'll start to see a much more balance restored in the construction sector. Single family and residential will be strong markets next year. Ware-housing will continue to show strength with the demand for ecommerce.

Especially in light of supply chain issues, building out of that logistics infrastructure will certainly take precedence.

I also think healthcare will be a strong market in 2022, particularly, as it relates to inpatient care. In the past decade, a lot of the healthcare market has been focused on urgent care types of construction. I think we're going to start to see a shift back to the more inpatient side, as well as multifamily, given the challenges facing the single family market with higher prices and shortages.

Finally, another offshoot of the pandemic is manufacturing. Again, with logistics issues, the shortages of goods have created an opportunity for producers to bring the manufacturing process back on shore. We are seeing more manufacturing projects start to pile up in our planning database

But of course, with every good side of the market, there will be downsides as well. I think when we look at construction sectors that particularly rely on folks congregating, those markets will remain weak. For instance, office and hotel construction. This would likely include casinos, convention centers, and possibly even transportation like airline and terminal construction. Those might continue to be weak markets, but

Our own leading indicators of construction activity and macroeconomic data are telling us this. But even as that significant hope takes hold, we do need to recognize that the construction sector faces very significant challenges in 2022.

I've been referring to these as the three Ps: people, prices, and productivity. One thing to keep in mind is that even though these challenges are significant and could certainly restrain activity next year, there are key opportunities to capitalize on some of these challenges and to still grow your business in this environment."

APAC construction industry transforming at a rapid pace

"Considering what we have faced as a global community over the past two years, providing any form of a prediction is certainly a challenging prospect. However, I believe the APAC construc-

tion industry will help the economy rebound in the region and transform the industry at a rapid pace in 2022.

First, we will see companies being increasingly data driven. We are aware that a staggering research statistic found that 96% of data generated in the engineering and construction phase of a project goes unused. So we would expect increased focus and scrutiny on unlocking the value of their data to drive better decision making both at the project level as well as the firm level.

Second, the ongoing labour shortages in APAC will drive the need for increased automation to augment human processes both in the office and on the jobsite.

Third, we expect to see companies explore alternative business models such vertical integration, DfMA and offsite construction amongst others as they look to uncover scale economies.

Finally, given that our industry generates the most amount of waste compared to any other industry, and on the back of the outcomes from COP26 in Glasgow last year we expect to see a renewed focus on sustainability. Throughout the region a number of construction firms have pledged their intention to become net zero emission companies. There will be a significant opportunity to partner these firms and assist the industry transition to a low carbon future."

Governor Newsom Announces New Awards to Create 2,300 Housing Units

Under California Housing Accelerator program, affordable housing projects get the funds they need to break ground, creating much-needed housing for those most in need

Governor Gavin Newsom today announced more than \$923 million in awards for affordable housing projects across California as part of the California Housing Accelerator, a \$1.75 billion investment to provide bridge funding to shovel-ready projects that were otherwise unable to begin construction because of a shortage of federal tax credits and bonds.

"We're building more housing for people at risk of homelessness to prevent folks from ending up on the streets, and we're doing it faster than ever before," said Governor Newsom. "We're getting shovels in the ground in a matter of months, creating thousands of new affordable homes for people at the economic margins who need these new units the most."

In total, 27 statewide projects have been approved to date, with nearly all of the projects expected to break ground this summer. When fully completed, the projects will create 2,300 housing units, 500 of which are for those experiencing homelessness. The Housing Accelerator prioritizes projects for those experiencing homelessness and for those below 30 percent of the Area Median Income. A full list of awardees can be found here

Governor Newsom's comprehensive strategy to address the homelessness and housing affordability crisis includes historic multi-year

investments and new laws and accountability measures. Last year's California Comeback Plan invested an unprecedented \$22 billion to tackle these systemic issues, with \$10.3 billion to build more affordable housing and \$12 billion allocated for homelessness and behavioral health services. The Governor's California Blueprint builds on these bold investments with a proposed \$2 billion to advance behavioral health housing and encampment rehousing strategies as well as \$2 billion to boost housing production and preserve affordable housing across the state. The Administration continues to implement reforms targeting existing roadblocks to affordable housing production while addressing the interrelated problems of climate change and housing affordability by promoting denser housing closer to people's daily destinations.

"The pandemic underscored the urgent need to expand housing, particularly for communities that are most economically vulnerable," said Business, Consumer Services and Housing Agency Secretary Lourdes Castro Ramírez. "The California Housing Accelerator fast tracks stalled housing projects, making these units more quickly available to low-income individuals and families across the state. This initiative is a critical part of the state's multi-program housing strategy and will enable us to construct quality affordable housing for thousands of households."

The California Department of Housing and Community Development (HCD) oversees the Housing Accelerator program with funding derived from the Coronavirus State Fiscal Recovery Fund, established by the federal American Rescue Plan Act of 2021. In September, state officials announced utilizing these resources to create the California Housing Accelerator in order to move housing developments that were stuck through the funding pipeline.

"When we launched the California Housing Accelerator, we had clear objectives – eliminate the backlog of projects standing in long lines for tax credits and bonds, bring affordable housing to communities in need, and reduce the amount of time and money involved in preparing to make these homes available," said Director of the California Department of Housing and Community Development Gustavo Velasquez. "And while more work remains, today's announcement is an important step toward achieving our affordable housing goals."

In addition to today's awards announcement, HCD is finalizing the project solicitation and guidelines for the next round of the California Housing Accelerator, which will be released in mid-February.

"The California Housing Accelerator will help reduce one of the biggest bottlenecks preventing California from building more affordable housing – providing much-needed funding for dozens of shovel-ready projects stalled in the state's oversubscribed housing financing system," said Executive Director of the California Housing Consortium Ray Pearl. "This new program is going to allow communities all over the state to move quickly, starting now, to build safe, affordable homes for their lowest-income households. It will mean more affordable housing for those who need it most, and affordable housing providers are committed to working with state leaders to support these vital investments for years to come."

The next round of the California Housing Accelerator will be a competitive process for previously HCD-awarded 4 percent tax credit projects and the program will include regional allocations to ensure a broad geographic distribution of Accelerator funds. Projects will be rated based on four primary policy objectives: efficient use of Accelerator funds; age of HCD award; targeting of special needs populations; and climate change mitigation based on proximity to transit. Additionally, applications received will be evaluated for threshold criteria, such as ensuring projects proceed to construction within 180 days of awarded funds. For the next phase of projects, an additional \$735 million is available.

In Celebration of Black History Month, SBA Administrator Guzman Announces New Funding to Expand Outreach Centers for Women Entrepreneurs through Minority Serving Institutions

Administrator Isabella Casillas Guzman, head of the U.S. Small Business Administration (SBA) and the voice for America's 32.5 million small businesses in President Biden's Cabinet, announced the availability of \$1.5 million for 10 new grant opportunities for established Minority Serving Institutions aspiring to host a Women's Business Center (WBC) to provide local outcome-oriented business services for women entrepreneurs.

As Black History Month gets underway, the announcement highlights the Agency's commitment to creating funding opportunities that increase equity for small business owners – a priority under Administrator Guzman. Through the SBA's Office of Women's Business Ownership's (OWBO), the WBCs will help entrepreneurs pivot, grow and navigate new opportunities created through President Biden's Bipartisan Infrastructure Law, such as competing in the burgeoning industries solving climate change and to grow clean-energy supply chains that will help expand global exporting.

"Our efforts to help establish more Women's Business Centers at Minority Serving Institu-

tions across America will not only deliver on the Biden-Harris administration's priority to invest in equity but also will help more women entrepreneurs—one of the most energetic, innovative and fastest-growing segments of our small business economy-drive America's strong recovery and Build a Better America," said Administrator Guzman. "Our Women's Business Centers provide vital support, connecting women entrepreneurs with many of the SBA's most valuable resources including access to capital, professional networks, skills training for business growth and resilience, and much more. My hope is that leaders of every qualifying institution will seize this opportunity to establish a Women's Business Center and start building bridges to opportunity for our nation's women business owners.'

The purpose of the new funding will be for up to 10 private, non-profit organizations to provide entrepreneurial development services to women, with an emphasis on socially and economically disadvantaged entrepreneurs in locations that are outside of the geographical areas of existing WBCs.

Eligible applicants include the following institutions of higher education or their affiliates:

Historically Black Colleges and Universities (HBCUs)(as defined in 20 USC §1061)

- Hispanic Service Institutions (HSIs)(as defined in 20 USC § 1101a)
- Tribal Colleges and University (TCUs) (as defined in 20 USC 1059c)
- Native Hawaiian Serving Institutions (NH-SIs)(as defined in 20 USC § 1059d(b))
- Alaska Native Serving Institutions (ANSIs) (as defined in 20 USC § 1059d(b)) of higher learning with existing minority entrepreneurship or related programs

"Under the leadership of Administrator Guzman, the Office of Women's Business Ownership continues to work to advance the priorities of the Biden-Harris Administration. Our office looks forward to supporting initiatives to ensure that multicultural women and the academic institutions that support them across the nation, have access to resources and support to advance entrepreneurial opportunities and preparation," said Natalie Madeira Cofield, Assistant Administrator, U.S. Small Business Administration. "This notable expansion builds on our historic expansion in 2021, where our center footprint grew to include 24 new centers, 60-percent of which were located in rural communities across the nation, including Puerto Rico."

Since March 2021 alone, twenty-four new centers have opened. Among the newest WBCs are three affiliated with Historically Black Colleges and Universities (HBCU) and two in Puerto Rico, as well several focused on reaching entrepreneurs from rural communities. Currently, OWBO funds and supports the largest WBC network in the history of the SBA, with 140 centers in 49 states and Puerto Rico.

The SBA's WBC network provides one-on-one counseling, training, networking, workshops, technical assistance, and mentoring to women entrepreneurs on numerous business development topics, including business startup, financial management, marketing, and procurement. How to Apply

Eligible applicants must be private, non-profit organizations with 501(c) tax-exempt status from the U.S. Treasury's Internal Revenue Service and must or be affiliated with a Minority Serving Institution.

The Infrastructure Bill: What It Means & How You Can Get Ready

It's being called a "once-in-a-generation" infrastructure bill — with a trillion-plus dollars allocated to overhaul the U.S. public works system and start new road, highway, airport and other transportation projects. What exactly is included in the Infrastructure Investment and Jobs Act (IIJA), what does it mean for the construction industry, and are you ready for what it may bring? Here's a quick look.

What's in the infrastructure bill?

Signed into law on November 15, 2021, the IIJA funds \$1.2 trillion in infrastructure projects. That includes roads and bridges (\$110 billion), electrical grid improvements (\$73 billion), passenger and freight rail (\$66 billion), broadband internet infrastructure (\$65 billion), water infrastructure (\$55 billion), airport maintenance and improvements (\$25 billion), and port and waterway improvements (\$17 billion), along with a host of other projects.

The IIJA also includes an element called One Federal Decision (OFD), designed to streamline the permitting process that can cause big delays on many infrastructure projects. OFD could shrink the permitting timeline from up to 10 years all the way down to two years.

What does the bill mean for construction contractors?

In a nutshell, the potential for enormous growth. About half of the \$1.2 trillion must be spent over the next five years, which means a lot of new projects need to be "shovel-ready" fast. Some economists are predicting the biggest boost to come in 2023, with steady growth in 2024, 2025 and 2026 as well.

Is the construction industry ready?

Though a big influx of work is welcome, it comes at a challenging time. Labor shortages continue to dog the industry. A U.S. Chamber of Commerce survey last summer found that 88% of contractors were having moderate or high difficulty finding skilled workers — and 35% had turned down work as a result. Supply chain issues also remain a problem, leading to rising prices and delays in obtaining materials. Contractors will have to be strategic to overcome these challenges while taking on a bigger workload.

What can you do to prepare?

Start reaching out to state departments of transportation and municipalities to gauge just how much work might be coming your way. That'll help you determine if (and when) you should plan to add equipment to your fleet or operators to your payroll.

Dawn Russell, Treats for Chickens

Treats for Chickens hatched in 2009 in West Petaluma, California.

Those who knew Dawn thought she had simply lost her mind. She gave notice to her employer at a federal government agency in San Francisco to make treats for backyard pet chickens. She traded in her heels and 9-5 schedule for mud boots and the greatest tasting eggs this side of the Mississippi.

Treats for Chickens quickly gained popularity and by 2010, online retailers were selling its products. In 2011, the business leased its first commercial space and within two months had its first West Coast distributor.

The learning curve

However, the journey was not without its challenges. Dawn had to learn how to manage licensing, logistics, machinery, financials, and sales/marketing plans, on top of setting up a distributor network.

To meet these challenges Dawn met with an advisor at the Napa Sonoma SBDC. Together, they addressed issues relating to sales and marketing efforts. They talked extensively about setting up a distributor network, improving the website and reviewing financials, and discussing manufac-

turing strategies. As a result of these meetings, the business expanded its distributor network, initiated reviews of financial results, made plans for improving manufacturing capabilities with the possibility of purchasing additional equipment, and engaged the services of a webmaster.

Flying high

Fast forward to today: Treats for Chickens continues to produce a collection of healthy and organic treats, supplements, and non-toxic pest control for pet chickens. Products ship daily from their Cotati, CA warehouse to over 20+ accounts across the US.

Treats for Chickens has experienced some outstanding financial results. Sales increased by 233.7 percent from 2011 to 2012. Dawn was able to put together startup financing through personal savings, amounting to \$43,000. Currently, she has two part-time employees. Cash flow has been positive, which has resulted in no additional loans to the company.

Treats for Chickens products are available in local farm and feed stores, local pet shops, hatcheries, and online through a variety of merchants and directly at the website.

Sofia Lopez, Santo Hermano Pedro Boutique

Back in Antigua, Guatemala, Sofia Lopez had a small business. She sold items like pocketbooks, belts, and wallets on the vibrant main square. She always wanted to run such a venture and was achieving success. That is, until violence compelled her to leave her homeland a decade ago.

Now residing in San Francisco's Bayview, Lopez initially cleaned houses to make ends meet. But a nagging feeling left her wanting to run her own business once more.

That became a reality once Sofia came to MEDA a few years back. She initially took MEDA's Business Development seven-session workshop. She learned how to run a small business in the States. But this was a country with different rules than those in Central America.

Sofia also bettered her computer skills in the Digital Opportunity Center in Plaza Adelante.

Setting up shop

Once Sofia had graduated from the business workshop, she received free one-on-one coaching. The goal was to rent a retail spot. Finding a reasonably priced commercial space was a challenge already. The Mission Street location she found turned out to be on an inside corridor despite the \$1,200 a month rent. This meant a lack of foot traffic; some days not a single customer came into the store.



Being on a square in Antigua had translated to success for Sofia. So the new idea was to get a permit from the City and the police department. This way, Sofia could set up business each day in the heavily trafficked southwest corner of the Mission's 24th Street BART station. After a few months' process, payment of an annual fee, and the assistance of MEDA's Business Development department, it finally happened. Santo Hermano Pedro Boutique found its new home on the plaza under a colorful tent to provide aegis from the noonday sun. Business immediately picked up.

She had just one problem left.

Every month or so, Sofia needs to make the six-hour drive to Los Angeles to meet with her wholesalers. That requires a large vehicle.

So Sofia went to a traditional bank in the Mission. But all they offered her was a credit card at a super-high interest rate at one bank and a personal loan at astronomical interest at another financial institution.

Sofia was at a loss of what to do.

Meeting Adelante

That's when she serendipitously ran into MEDA Community Loan Fund Manager Diana Matei-Golopenta. Diana explained how the nonprofit's new Adelante Fund could help.
