

Abandoning high-speed rail will be more costly for California than the project itself

Sixty years ago, construction workers in the San Joaquin Valley began two major infrastructure projects that did much to build modern California: the State Water Project and Interstate 5. Backed by strong support in Sacramento, including adequate funding, the freeway connected drivers to Los Angeles in 1972, and the aqueduct began delivering water to Southern California in 1973.

Today another major infrastructure project rises in the San Joaquin Valley. The high-speed rail project is as essential to 21st-century California as the aqueducts and interstates were to the 20th century, enabling fast travel powered by clean energy to some of the state's most populated places. Countries around the world have built or expanded their high-speed rail systems in recent years, carrying large numbers of passengers and reducing the need for carbon-intensive travel by airplanes or cars.

Unfortunately, California's high-speed rail project has struggled. Unlike the aqueduct or the interstate, high-speed rail has never enjoyed more than tepid support in the state Capitol, even as it maintains majority support among California voters. The lack of legislative support means the

project has never been fully funded. It has been trapped in a morass of land use regulations and lawsuits from project opponents that delayed construction and helped drive up costs.

Delays and rising costs have given an opening for critics to try and defund it, even if it means leaving unfinished infrastructure in the San Joaquin Valley. Some critics claim that the problem was a route serving cities like Fresno and Palmdale rather than a more direct path between San Francisco and L.A.

Even if one overlooked the millions of potential riders in those cities, any alternative route chosen would still lack sufficient funding and would still have been subject to environmental lawsuits.

Still, it would be a mistake to abandon this crucial project now, leaving concrete guideways in the sky empty of tracks, trains and travelers. No other form of transportation works as efficiently at connecting people across the distances of the Golden State as high-speed rail. Airplanes may make the trip from gate to gate in an hour. But when you add in travel times to and from the airport, a trip from downtown LA to downtown SF takes roughly the same amount of time on a bullet train as on a plane – yet the plane spews far more carbon.

Oakland enters into historic deal to revamp Coliseum site

The City of Oakland has entered into an exclusive negotiating agreement (ENA) with the African American Sports and Entertainment Group (AASEG) for its 50% stake in the Oakland-Alameda County Coliseum Complex, which could lead to a reported \$5bn revitalisation of the site.

AASEG is an African American founded, Oakland-based group focused on creating economic opportunity in East Oakland and using the Coli-

seum Complex, which includes the RingCentral Coliseum and Oakland Arena, as a vehicle for economic equity and social justice.

AASEG's proposal includes bringing a WNBA women's basketball team to Oakland, along with other sports and entertainment projects, a hotel and new housing. The group has received strong support from the Oakland community, Oakland City Council, and Oakland-Alameda County Coliseum Authority (OACCA), the operating body of the Complex, with the proposal being presented at a press conference yesterday (Thursday).

The Complex sits on a 200-acre site, making the proposed deal the largest transfer of public land to African Americans in Oakland's 171-year history. Ray Bobbitt, AASEG founder, said in a statement: "Awarding the development agreement of this vital site to an Oakland-based African American led business entity will go far in addressing glaring racial disparities within the City of Oakland's contracting practices. This project will foster economic parity, entrepreneurial and local small business opportunities."

Councilmember Rebecca Kaplan, author of the Oakland City Council and OACCA resolutions allowing for the ENA with AASEG, added: "I am thrilled that we have the opportunity to bring jobs, housing at all income levels, sports, entertainment and more to this vital Oakland site, in a way that strengthens equity and vibrancy for the community at this transit-accessible location."

News of the pact between Oakland and the AASEG comes with Major League Baseball (MLB) franchise the Oakland Athletics holding the remaining 50% stake in the Complex. The team has played at the Coliseum since 1968, but

intends to leave its current home when its lease expires in 2024.

A's representatives were not present at yesterday's presentation, with the team still deep in negotiations with the City on its high-profile new ballpark project at Howard Terminal. "This party is going to try and work with the A's to come together, in terms of what we can do to develop this land," said Oakland City Councilmember Noel Gallo, according to local broadcaster ABC7.

Kaplan added: "Certainly, the A's are welcome to be a part of this, I want to make it clear, they're not being kicked out. We welcome them to be a part of revitalisation of the site."

MLB commissioner Rob Manfred in December increased the pressure on the Oakland Athletics and City of Oakland to seal an agreement for a new ballpark, stating 2023 would be a "crucial year" in determining the franchise's future while confirming it wouldn't be hit with a relocation fee should it choose to move to Las Vegas.

BLACK HISTORY MONTH

Black History Month: Black history is American history

To honor Black History Month 2023, we asked students and faculty within the UC Berkeley School of Public Health community what the month means to them and what everyone should know about the Black experience in healthcare. What we heard: representation, reverence, resistance, and fearlessness. Below, their thoughts in their own words.

Bria Brown

Bria Brown (she/her/hers) is a first-year MPH candidate in the Health Policy and Management program. For her, Black History Month is a time to be reminded that despite built-in systematic oppression, the legacy of her ancestors inspires her to continue to break through barriers.

What does Black History Month mean to you?

Black History Month gives me the opportunity to reflect on the past and present as well as undisputedly show gratitude, rejoice, and honor my ancestors as well as the fruits of their labors. Black history is American history; without Black history, there would be no history. A lot of times we are taught a false narrative of history or “selective” history in the school system, however Black History Month is a time where we can and should become aware of Black achievements, contributions, untold stories, culture, and the plight of our people. Through constant and deliberate attacks by way of institutional design, with the intention to break our communities down, we still stand! The legacy of my ancestors inspires me to continue to break through barriers and when faced with adversity tackle it fearlessly.

How do you feel the history of the Black experience in healthcare and public health can be better disseminated?

First and foremost, it is crucial to acknowledge and understand the historical trauma that Black people have experienced in the healthcare system. The Tuskegee Experiment and the story of Henrietta Lacks are prime examples of distrust, racial bias, and injustice that Black people frequently experience in oppressive systems. History frequently repeats itself, and today’s problems are analogous to those from the past. This problem will continue to persist if the past experiences aren’t recognized, acknowledged, and confronted. In order to seek change, you must

first have knowledge of the past and then actively take steps in order to dismantle a fragmented system. Also, having more representation in healthcare will allow for the Black voice to be heard and seen.

How do you think UC Berkeley and Berkeley Public health can amplify the voices of our Black community members?

UC Berkeley can amplify the voices of our Black community members by increasing the number of Black faculty and staff personnel in positions of leadership. This alone will enhance the visibility of our voices. Secondly, when having guest speakers, it would be nice to hear from a Black member about their experience in the different workforce fields. Additionally, providing more spaces where Black voices are heard and are able to congregate and discuss different matters and events is a great step in the right direction. Lastly, having more financial support in terms of fellowships and scholarships would provide a lot of opportunity for Black individuals to be able to enroll in UC Berkeley and graduate.

Olufunke Bamidele Fasawe (Funke)

Second year DrPH student Funke Fasawe (she/her/hers) thinks that one way that public health can move toward equity is to weave health into all core breadth classes here at Berkeley Public Health.

What does Black History Month mean to you?

Black history month represents a period of deep reflection of how far we have come as a people towards achieving racial equity and dismantling the structural barriers that exist and have held many people back from attaining their human rights and potential. It is a stark reminder of the struggles and bloodshed of tireless activists and advocates to advance the cause of Black people in the U.S. and all over the world, and how much more work we still must do. It brings a sense of responsibility to continue to amplify the core message of transforming our societies to be equitable, non-judgmental, and inclusive of all people everywhere irrespective of race, gender, or other social constructs that we have created to segregate. It reinforces the desire in me as a person to contribute in my own way meaningfully and practically towards this cause in my social and professional engagements.

How do you feel the history of the Black experience in healthcare and public health can be better disseminated?

I think we need to teach more about structural barriers to healthcare access and how these barriers play out in reality. I believe that teaching public health professionals and frontline health-

care workers about structural competency is critical and should be embedded in all aspects of healthcare and public health. We need more history and health ethics being taught. Finally, we have to be deliberate about creating forums for engagements across the board in the public health community to intentionally call out and address injustices, disparities and inequities in the delivery of healthcare as these affect Black people and others.

How do you think UC Berkeley and Berkeley Public health can amplify the voices of our Black community members?

1. Increase Black representation among students and faculty. It would be helpful to recruit more Black faculty members and admit more Black students. Seeing more Black faculty leaders will create strong models for aspiring public health graduates and social change makers of Black origin that will push the narrative of empowering Black people and creating a shared and equal space for people of all colors to thrive in the UC Berkeley community and beyond.
2. Expand the number of classes that shed more light on the structural barriers that drive disparities in healthcare access and how this affects the Black communities and other underrepresented communities. Similarly, I think health ethics should be considered as a breadth course for all degree programs here at Berkeley Public Health or at the minimum interwoven as a core theme in the breadth courses.
3. Increase funding and fellowship opportunities for research aimed at deconstructing these structural barriers. This critical funding support will support the development of innovative frameworks to increase diversity and representation of Black people and their experiences in the way healthcare and public health is designed, programmed, delivered, and measured.

Manfred provided an update on the A's situation from MLB's perspective at the League's winter meetings. In June, the A's and city authorities hailed another key vote to progress the franchise's \$12bn waterfront ballpark project and potentially ward off the threat of the team relocating to Las Vegas.

The San Francisco Bay Conservation and Development Commission (BCDC) voted 23-2 to remove port designation from the 56-acre Howard Terminal site at which the A's are seeking to build a new stadium and associated mixed-use development. A vote against would have likely killed off the project.

Abandoning high-speed rail will be more costly for California than the project itself

Driving is simply not competitive. Without traffic, it takes 5-6 hours to drive from L.A. to SF. With traffic, it can take a lot longer. I remember a New Year's Day drive from L.A. to Berkeley that took 10 hours in the early 2000s. Even if Californians switch en masse to electric vehicles, it will still take most of the day to drive from the Bay Area to Southern

California. And that's without the comforts of a train – the ability to stand up, walk around, get food, use the bathroom and work remotely.

Global experience has proven that if you build it, they will ride. High-speed rail systems connecting cities of 500 miles' distance or less typically grab a majority of the market share on that route away from airlines. That includes Amtrak's Acela train connecting Washington, D.C. and New York City.

The evidence is clear that California should finish the job and complete the high-speed rail service between SF and L.A. Yes, the cost has increased but the project remains more affordable than expanding airports or freeways. Its carbon emissions reductions will be essential to achieving the state's climate goals.

Neither the State Water Project nor the interstates were cheap. But they proved their value

many times over during the last five decades. California's high-speed rail project will prove its value many times over during the rest of this century – if political leaders in Sacramento commit to its completion.

San Mateo County Board Invests in Training Opportunities, Mentoring for Entrepreneurs and Job Seekers

The San Mateo County Board of Supervisors voted unanimously today to invest nearly \$1.5 million to help entrepreneurs launch businesses and make them grow.

The funds will also help job seekers gain the skills they need to compete for in-demand careers. Programs that include how to gain access to capital will launch through the North Fair Oaks Economic Advancement Center.

"This will be an important step to bring families and individuals closer to economic independence, giving them the right tools and training for advancement" said Supervisor Warren Slocum, who represents that 4th District that includes North Fair Oaks, parts of Menlo Park

including Belle Haven, East Palo Alto and Redwood City. "We know there is much talent and treasure within our vulnerable communities, and with the right services, they too can become enterprising small businesses here, or gain employment at some of our local businesses. It is also about equity – and giving others opportunities."

The investment builds upon work underway for several years to build entrepreneurship for residents in the North Fair Oaks area and to help job seekers gain valuable skills.

Over the last several years, the Board has taken extensive steps to assist households and small businesses that have been impacted by the negative economic consequences of the COVID 19 pandemic. This work will continue.

Two service provider organizations were selected and approved grants to begin the work of the North Fair Oaks Economic Advancement Center.

Renaissance Entrepreneurship Center was selected to provide services for local small businesses and entrepreneurs. Their work will be funded from a \$500,000 grant from Chan Zuckerberg Initiative and funds from the federal American Rescue Plan Act. JobTrain was also selected to provide employment services, including job training, to individuals, households and small businesses in North Fair Oaks.

Classes, tutorials and materials will be available in English and Spanish with a focus on:

- Programs for women.
- Skill building and industry-specific workshops (finance, marketing, operations).

- Technology training.
- Website development.
- Legal workshops on small-business topics (leases, intellectual property, contracts).

The program will also provide specific assistance for entrepreneurs seeking grants for Latinx-owned businesses and information on access to California Microbusiness COVID-19 Relief Grants.

Until a site for the North Fair Oaks Economic Advancement Center is located and leased, the Renaissance Entrepreneurship Center and JobTrain will begin their work at Casa Circulo in North Fair Oaks.

Utilities commission explores ways to mitigate high natural gas prices

Gas prices have spiked in California.

That may sound like old news after months of high prices at the pump, but this time another kind of gas is running up the tab: natural gas, which fuels stoves and heats water and homes.

Average bills for PG&E residential customers in Northern California shot up to an estimated \$195 in January, compared to \$151 the year before; SoCalGas customers got hit with \$300 on average, compared to \$123 last year, according to data shared by Jean Spencer, supervisor of the energy division of California's public utility commission, at a recent hearing. Meanwhile, across the country, wholesale natural gas prices have fallen an average of 50% since October, according to reporting in Bloomberg.

What gives? California's Public Utilities Commission held a hearing Tuesday attended by different state energy agencies and industry representatives to look into the question and discussed strategies to mitigate high prices. While the commission can't directly set prices, attendees raised different long-term options that might keep the cost of gas down for consumers.

The meeting followed a decision by the commission last week to speed up a climate credit for consumers that should reduce gas bills. That move will translate to roughly \$50 off customers' bills — but, said commission president Alice Busching Reynolds, it "was a short-term Band-Aid and this is a longer-term problem."

At least one California gas company expects bills to go down in February.

Why are prices so high?

California pipes in 90% of the natural gas it uses from elsewhere, making the state vulnerable to issues outside its borders.

Several factors conspired to send natural gas prices soaring in the West, according to the U.S. Energy Information Agency: below-normal temperatures; high gas use; lower imports of natural gas from Canada; gas pipeline constraints, including maintenance issues in West Texas; and lower gas storage levels in the Pacific region.

On Monday, Gov. Gavin Newsom made clear he isn't satisfied we have the whole story, writing in a letter to federal regulators that "those known factors cannot explain the extent and longevity of the price spike." He asked federal energy regulators to investigate "whether market manipulation, anticompetitive behavior, or other anomalous activities are driving these ongoing elevated prices in the western gas markets."

What, if anything, can be done?

The price of natural gas is set by regional and national markets. But the utilities commission and industry representatives raised short- and longer-term changes that could insulate California customers from wildly fluctuating bills.

In addition to accelerating the climate credit, the Public Advocate's Office at the utilities commission has proposed spreading the increased cost over three to six months, to make each individual bill more affordable and mitigate the risk of disconnections.

Industry representatives raised gas storage capacity and regulations as topics the commission should consider.

Storing gas can help protect California customers from shocking bills because, if a utility has ample gas in storage when prices are spiking, "you can run down your (current supply) for a while and not have to buy quite so much at the super expensive time," said Severin Borenstein, an energy economist at UC Berkeley, in an interview.

Roger Schwewe, senior vice president at Southern California Gas Co., suggested reevaluating how much gas is stored at Aliso Canyon, the largest natural gas storage facility in the state. A major leak occurred at Aliso Canyon in 2015, causing Southern California Gas to temporarily relocate thousands of households. In the aftermath, the utilities commission capped how much gas could be stored at the facility.

Mark Potca, a program manager at the utilities commission's Public Advocates Office, also emphasized the importance of storage capacity at Aliso Canyon, mentioning a proposal to increase the cap, which would provide more storage capacity. How Aliso Canyon gets used is something "that the commission will need to consider closely moving forward," Potca said.

Lucy Redmond, director of gas reservoir engineering and facilities at PG&E, raised the impact of regulations from California Geologic Energy Management Division, which went into effect in 2018.
