8 Common Construction Estimating Mistakes

Estimating is one of the most difficult jobs in construction. It is also one of the most important. Profits are typically won or lost based on how accurate your estimates are and how closely they match up to your final project costs.

So, how accurate are your estimates? A survey from QuickBooks and TSheets shows that nearly a third of construction companies make less profit than expected based on their estimates. That's not too surprising given that 40% of respondents aren't that confident in their estimates.

Chances are that one bad estimate on a project that loses money won't put you out of business. String together a couple of unprofitable projects and you might find yourself closing the doors for good. A quarter of all respondents indicated that it would only take two or three bad estimates to ruin their business.

Getting accurate estimates is no easy task and a good estimator is worth their weight in gold. There are a lot of variables that must be accounted for to deliver accurate estimates on every project. Everything from nailing down accurate labor and material costs and understanding workers' productivity, to getting precise takeoff measurements and factor-

ing in items like risk contingencies and overhead must be nearly perfect.

One or two mistakes could throw your estimates completely off and will result in a bad bid, one that you will either lose because it's too high or win because it's so low that you won't make a profit. Here's a look at some of the most common construction estimating mistakes and how to prevent them.

Not Conducting a Site Visit

Most bidding opportunities provide prospective bidders with a chance to attend a pre-bid meeting and visit the jobsite. Often, these are mandatory in order to submit a bid and with good reason. No two jobsite are identical and unknown site conditions can cause unexpected, and costly, issues when construction gets underway.

When conducting a site visit you'll want to take measurements, inspect the topography, and take some soil bore samples if that hasn't already been done. You also want to look at road access and traffic to the site, determine how much space there is for staging, equipment and materials delivery and storage, and what environmental protections will be needed during construction.

These sessions will include roundtable discussions, one-on-one matchmaking, information driven breakout sessions, and regional contractual opportunities. Senator Limón Introduces Pay Transparency For Pay Equity Act

Senator Monique Limón (D-Santa Barbara) introduced SB 1162 to help close the wage gap by requiring the disclosure of salary ranges on all job postings, and to make employer internal promotional opportunities available to current employees. SB 1162 also requires companies to publically report pay data broken down by race, ethnicity, and sex for both direct employees and employees hired through a third-party staffing agency.

According to a recent analysis of pay data required under SB 973, California women in 2020 lost \$46 billion due to the gender pay gap and people of color in the state lost \$61 billion due to the race pay gap1.

"Pay transparency is key to achieving pay equity. SB 1162 will help identify the gender and race-based pay disparities by requiring pay transparency at every stage of the employment process, from hiring, to promotion, and ongoing employment," said Senator Limón. "We must increase pay transparency in order to close the gender and racial wage gap, which prevents women, particularly women of color, from achieving economic security."

In 2019, SB 973 became law to require employers with more than 100 employees to submit pay data reports to the Department of Fair Employ-

ment and Housing. However, the bill did not require the information to be publicly available and did not include a growing workforce: temporary, contract, and contingent workers hired through third-party staffing agencies. SB 1162 closes this gap by requiring pay data to be publicly available and to include all workers.

Increasing pay transparency is a critical component to closing the wage gap, including at the hiring stage. Research shows that when job applicants are clearly informed about the context for negotiations, including the salary range, women are more willing to negotiate, more successful in negotiating, and the gender wage gap narrows 2.

"One of the biggest hurdles to combatting pay inequities is that they are often hidden from sight. By requiring greater transparency around employer pay data, this bill will help empower workers to seek fair pay," said Mariko Yoshihara, Policy Director & Legislative Counsel at the California Employment Lawyers Association. "Additionally, by requiring employers to make their existing pay day reports publicly available, it will help reveal the structural inequities within companies and within different industries that have allowed the race and gender wage gap to persist."

"During our research for the Contract Worker Disparity Project, we found that contract workers (who are disproportionately Black, Indigenous, Latinx, Asian, women, and nonbinary) are more likely to be paid less and have less access to benefits and protections, despite performing similar work to direct employees," Catherine Bracy, CEO and Co-Founder of TechEquity Collaborative.

"We need clear, tangible policy that will close the gap between contract and directly-employed workers and tackle the racial and gender wealth disparities inherent to this work. The Pay Transparency for Pay Equity Act will make pay equity a reality for contract workers in California, setting a standard for contracting practices across the country."

"Transparency is key if we want to close the gender and race wage gaps, which still persist in nearly every industry and occupation in this country. Providing salary ranges on job postings empowers women and other workers with information they need to make the best decisions for their families and negotiate for the income they deserve," said Jessica Ramey Stender, Policy Director & Deputy Legal Director at Equal Rights Advocates. "California has led the nation on equal pay protections and this bill is the next logical step to continue that progress and keep

forging a path for other states to follow."

"It's hard when you've poured your heart into doing amazing things for a company, only to find out that the men around you have been paid significantly more to do the same or less work. And it wasn't that the company decided to let us know there was this pay inequality, it was because one of my male peers told me his salary; which then led me to start asking questions about everyone's salaries. It was devastating to find out that so many women were making less than the men. I'll never forget being told "this is why we don't talk about salaries" when I brought everything up to my leadership team. It was not talking about pay that led to these inequalities. We need to be armed with knowledge of the inequalities we face so that we can advocate for ourselves and get fair treatment. The culture of silence with respect to wages only serves to maintain the status quo of inequity. That needs to end." - Jessica Seifert (employed by Riot Games from 2014 - 2019. CalOSBA Announces Grants to Expand Small Business Assistance in California

The California Office of the Small Business Advocate (CalOSBA) today announced grant awards to technical assistance and grantmaking partners of the California Dream Fund Program. The California Dream Fund Program is a one-time \$35 Million grant program that will provide microgrants to seed entrepreneurship and small business creation in California.

To qualify for the Dream Fund program, small startup businesses must complete a rigorous training and consulting program with one of seventeen technical assistance centers selected from CalOSBA's Technical Assistance Expansion Program (TAEP) network. Businesses that complete the program and qualify for the grant will be eligible to receive a microgrant of up to \$10,000. Lendistry has been selected to administer the grantmaking process.

"Access to capital is critical for small business success and when matched with Technical Assistance, it can make the difference between success and failure for small businesses, and entrepreneurs, especially those who are under resourced to start. California's stellar TA network is uniquely qualified and well positioned to provide services to diverse groups and communities across the state," said Tara Lynn Gray, Director of CalOSBA.

The Dream Fund builds on CalOSBA's existing technical assistance network, which is centered by the TAEP and Capital Infusion (CIP) programs. Since launching in 2018, technical assistance centers funded by TAEP and CIP have served over 500,000 small businesses with free consulting and no to low cost training in over 30 languages.



Mayor London Breed and Board President Shamann Walton Announce Next Steps for Dream Keeper Initiative

Mayor Breed and Board of Supervisors President Walton today joined Dr. Cornel West for conversation ahead of one-year anniversary of the process of redirecting funding to San Francisco's diverse Black communities

Mayor London N. Breed joined Board President and District 10 Supervisor Shamann Walton and Dr. Cornel West today to discuss the current progress and future of the Dream Keeper Initiative (DKI), which was announced one year ago. The Initiative, an intergenerational effort that aims to improve outcomes for San Francisco's diverse Black communities by strengthening economic empowerment through opportunity, addresses systematic racial disparities through City-funded programs, ensuring new investments are accessible to families most in need.

Since the launch of the Initiative, DKI has allocated \$59.8 million, representing more than 140 awards to more than 70 San Francisco-based organizations that provide direct services and

programs to the city's diverse Black communities. In addition to this funding, the Initiative has been and will continue working over the coming years to implement significant reforms to City policies and processes, including the hiring, retention, and promotion of City employees of color, the distribution of grants through a new Request for Proposal (RFP) selection process that directly engages community-based organizations and non-profits, and bringing City departments together to streamline these processes and maximize impact.

"The Dream Keeper Initiative was launched to address the racial injustices and inequities that exist not just in San Francisco, but across our country. If we are going to make any real changes and be a city that leads, we need action, not just more talk, and I am proud that our Departments have worked to make that happen," said Mayor Breed. "But the future of this initiative depends

8 Common Construction Estimating Mistakes

Be sure to have any subcontractors whose work may be impacted by the site condition make a visit as well. This allows them to assess the site for themselves and factor in any additional costs that existing site conditions might present into their estimates and bids.

Inaccurate Takeoffs

Your takeoffs lay the groundwork for your estimates. If they're incomplete or incorrect it can really screw up your estimates. Accurate takeoffs help you determine the exact quantities needed for all your materials and supplies. They are also required to determine your labor and equipment needs. If you miss items during takeoff or don't get accurate measurements, you'll either overestimate the project and not win the bid or you'll underestimate and risk winning a project that won't be profitable.

Takeoff software is a great option to ensure that you get accurate measurements for your estimates. It's also a huge time saver over doing takeoffs manually. These tools are only as good as the user, so it's important that estimators get the proper training and are comfortable using the software.

Labor Costs

Labor costs are probably the hardest item to nail down accurately when it comes to your estimate. In that survey from QuickBooks and TSheets, construction business owners say "labor costs are the hardest to estimate and are ranked as the most expensive project cost." There are several variables in play when it comes to estimating labor costs including the number of available

workers for the project, their experience level, rate of pay, and productivity.

A good, experienced worker may make a higher salary but are more productive and can get more done in less time than a worker with less experience who makes a lower salary. Focus on determining how many man-hours it takes to perform a task to use as a guide when estimating labor costs

Don't forget to determine whether prevailing wages are required on the project, which may or may not be different from what you typically pay each worker. Always keep records of job costs, especially labor costs, as you can use this historical data for more accurate estimates on future projects.

Materials & Supplies Costs

Building materials and supplies are another big cost for construction projects and rank high in being hard to accurately estimate. Prices for materials can fluctuate dramatically from the time you start an estimate to the time that construction commences. Demand for materials is high and uncertainty over tariffs and their impact on prices are making it even harder to get estimates right

Establishing relationships with your building product manufacturers and suppliers has its advantages. Not only can they help you lock in accurate prices while you put together your estimates, but they can also steer you to alternative materials that might be a better fit for your project.

Locking in prices for your materials is crucial but don't forget to make sure that you provide quantities to your suppliers. This allows them to ensure they can fulfill your order and deliver on time. Costly delays caused by workers not having the materials they need is embarrassing and will hurt your bottom line.

Failing to Assess Risks & Creating Contingencies

Every construction project comes with risks. Completing a risk assessment should be part of your estimating process. For one, it helps in your bid/no-bid decision-making. A good estimator can identify a project that is too risky and pass on submitting a bid. It also helps to determine how much to estimate for contingencies.

Failing to assess risks and build in contingencies to your estimate will be detrimental when things go wrong. The bigger the risk, the more time you should spend on determining ways to mitigate them and how that could impact your costs. You likely won't be able to recoup the losses that occur should an unforeseen issue crop up once construction is underway.

Making Uneducated Guesses

Don't gamble on your bids by making uninformed or uneducated guesses in your estimating. Tracking job costs on every project is a great way to ensure your estimates, and ultimately your bids, are as accurate as possible.

Job costs for labor, materials, and equipment should be based on the most current data available. Make sure to factor in overhead costs and soft costs such as those for permitting and inspections that can often be forgotten or neglected. You also want to make sure that you have the workforce and equipment available for the proj-

ect. Having to unexpectedly subcontract additional work or rent extra equipment can quickly eat up your profits or wipe them out completely.

Not Reviewing Your Work

Everyone makes mistakes. Estimators are no exception. Small estimating errors or omissions might not make much of an impact but big ones like omitting scope items, inaccurate measurement, or using the wrong units of measure can spell trouble. Take the time to carefully review your work or have another person on your estimating team review your estimates. Double-check your measurements are accurate, and your math is correct for all your costs.

Give yourself adequate time to put your estimates and bid together. Rushing through your work just to meet a bid deadline will only result in mistakes that will cost you in the end, so take the time to get it right the first time. Profitability on a project is almost always determined by your estimates. If you underestimate your bid, there's usually no amount of cost-cutting measures that will be able to make up for the shortfall.

Not Reviewing Subcontractor Estimates

If you're a general contractor, chances are you are going to have to subcontract out some of the work to trade contractors. Be sure to review their bid estimates and proposals thoroughly. Make sure they understand exactly what aspects of the projects you are wanting them to bid on and complete. This will avoid duplication of work in their estimates that are being covered by you or another subcontractor.

High-Speed Rail Funded Grade Separation Opens to Traffic

The California High-Speed Rail Authority (Authority) announced today it has completed another structure on the nation's first high-speed rail system. The South Avenue Grade Separation in Fresno County is now open to traffic, adding to the continued progress along the 65-mile segment known as Construction Package (CP) 2-3 in Fresno, Kings and Tulare counties.

The South Avenue Grade Separation, located between Cedar and Maple Avenues, allows traffic to travel over the existing BNSF Railway and future high-speed rail lines. It is one of 36 grade separations being built in CP 2-3 to improve safety along the high-speed rail alignment, and the Authority anticipates it will complete several additional structures throughout this summer and fall.

Grade separations provide major safety improvements, especially in rural areas that include Fresno County, by realigning roadways over or under a railway to eliminate potential safety hazards at intersections. In addition to improving safety, grade separations reduce noise from train horns and decrease traffic congestion.

"The completion of the South Avenue Grade Separation is another example of significant progress for California's high-speed rail project and a testament to our efforts to deliver a safe and sustainable transportation project for the next generation," said Garth Fernandez, Central Valley Regional Director. "With more than a dozen completed structures across all 119 miles of construction, we continue to make daily progress in building high-speed rail."

The South Avenue Grade Separation will ensure enhanced east-to-west mobility and safety for the travelling public while reducing the harmful greenhouse gas emissions from idling cars that would typically wait at the railroad tracks.

The South Avenue Grade Separation spans nearly 390 feet and is 40 feet wide. To complete this structure, design-build contractor Dragados Flatiron Joint Venture (DFJV) manufactured 12 pre-cast girders to form the bridge deck. DFJV's pre-cast girder facility in Hanford is the largest job-specific pre-cast facility in California and is responsible for manufacturing more than 1,300 different types of girders, pile foundations and deck panels for various structures along the 65-mile segment.

Since the start of construction, the project has created more than 7,300 labor jobs. There are currently 35 active construction sites in the Central Valley with 119 miles under construction. Nearly 300 miles of the 500-mile Phase 1 System from San Francisco to Los Angeles/Anaheim have been environmentally cleared, which allows the Authority to position itself to advance construction in Northern and Southern California with additional federal funding opportunities and local partnerships.

on not only making sure that this funding is sustainable, but also that our policies and processes are reformed to prevent these disparities from impacting future generations of Black people in San Francisco. We still have a long road ahead, but having seen the incredible success over the past year, I am excited about the impact this initiative will have for decades to come."

"During an historical period where we have the first Black man to serve as the President of the Board of Supervisors here in San Francisco, and working with the first Black woman to serve as Mayor of San Francisco, the Dream Keeper Initiative was created at the right time to address the disparities and inequities that exist for the Black community in this city. It has been great seeing community partners and city leaders working together to provide Black folks in San Francisco with opportunities in several areas that will improve the lives of our people, and help us achieve positive outcomes

as we focus on decreasing the wealth gap and providing economic viability and stability," said President of the Board of Supervisors Shamann Walton. "It is an honor to discuss the Dream Keeper Initiative in our own backyard with Dr. Cornell West, as he is a catalyst for creating opportunities for Black leaders like Mayor Breed and me, and in return we can fight for righting the wrongs of the past. We have much work to do, but the Dream Keeper Initiative is providing hope and achieving successful outcomes."

In the first few months following the initial announcement in February 2021, the city worked with the community to identify key focus areas to direct \$60 million annually, both via direct funding to community organizations and by expanding capacity of City programs and initiatives that serve the Black and African American communities. These include:

- Economic Empowerment and Mobility
- Health, Healing and Wellness

- **Education and Enrichment**
- Arts and Culture
- Narrative Shift
- Community Innovations and Mini-grants
- Technical Assistance and Capacity Building

Additionally, the Initiative worked with community-based organizations and non-profits to launch innovative mini-grant programs to support individuals or smaller organizations to implement community-generated ideas and create the Brighter Futures program, which supports culturally relevant economic, academic, housing, and health services for Black people and their families across generations. DKI also worked with the Office of Contract Administration to pilot a new grant-making process that increases participation from the community.

The San Francisco Human Rights Commission is the core City department for DKI, with a new

team of seven staff specifically dedicated to the Initiative. Other City departments involved include the Office of Economic and Workforce Development, the Mayor's Office of Housing and Community Development, the Department of Public Health, the Department of Children, Youth and their Families, the Office of Early Care and Education, the Department of Human Resources, the San Francisco Fire Department, and the San Francisco Arts Commission.

"Over the last couple of years, there have been marches, protests, and demands to invest and support Black humanity and community," said Dr. Sheryl Davis, Executive Director of the San Francisco Human Rights Commission.

Saul Chavez, El Gran Taco Loco

"I felt like I had lost everything. When something like this happens, it's hard to stay positive." That's how Mexican immigrant Saul Chavez, co-owner of El Gran Taco Loco with his spouse Angelica Quezada, describes his emotions following the destruction of his commercial space in the Mission and 29th streets fire in June 2016. Chavez' popular Mexican food eatery was located on the first floor of the Graywood Hotel, which suffered severe damage in the conflagration.

Saul felt very sad over his loss. The space was a mess from water damage. His electrical items — large and small — were all destroyed. It was also a loss for the community. El Gran Taco Loco had served up to 350 customers a day, regulars enjoying a menu that ran the gamut from tacos and tortas to steak fries and carne asada.

Saul's depression increased when the owner of the commercial space decided to break the lease due to a clause that allowed either party to do so in situations where the property would not be functional for a specified period of time. That meant El Gran Taco Loco would

lose its home of 12 years, with the landlord taking the opportunity to remodel and later ask for the much-higher rents the neighborhood's Mission Street commercial corridor can now demand

Once the initial depression over his loss had passed, it was time for Saul to take action. He was determined to somehow reopen his business and once again provide for his family. When he heard of a space available in the Excelsior — a space twice the size of his former location and for about the same rent — Saul seized the opportunity. He knew that such commercial rentals go fast in San Francisco.

"You have to jump on it quickly or it's gone before you know it," explains Saul of the urgency. That urgency translated to Saul applying for and receiving the \$10K maximum available from the San Francisco Small-Business Recovery Fund. In July of that year, the City had granted MEDA the right to be the sole overseer of this fund. There was \$50K total disbursed to five small businesses involved in the June 18 fire in Bernal Heights.

Saul then tried to obtain an SBA loan. After filling out the needed paperwork, he was advised that such loans were more geared to

owners of commercial properties, not renters. Needing more capital for supplies and to remodel his new space, Saul toyed with the idea of borrowing money from family, but he decided against such a problematic plan and instead came back to MEDA for help.

"The case of El Gran Taco Loco exemplifies why MEDA started Fondo Adelante. Saul and Angelica had suffered a tragedy, and these hardworking entrepreneurs had been denied a loan. They deserved the opportunity to get back on their feet," states MEDA Business Lending Manager Diana Matei-Golopenta.

Fondo Adelante was launched in 2015 to provide access to capital for community-based businesses that may not be able to garner a loan at conventional financial institutions. Loans of \$5K to \$100K are available to small businesses throughout the nine-county Bay Area.

Saul was offered a \$70K Fondo Adelante loan—at lower interest rates than he could get from traditional financial institutions. Now with the money to get his business going once again, Saul was able to hire more employees and opened November 1, 2016, in his Excelsior location at Mission Street and Brazil Avenue. This showcases how Fondo Adelante is building commu-



nity capital.

"I am so grateful to MEDA's Fondo Adelante. I can now talk about the experience of the fire like it was a life lesson. I am positive about my family's future once again, "sums up Saul.

Keba Konte, Red Bay Coffee

Keba Konte has demonstrated his commitment to creating good jobs for people in Oakland, California. In fact, over the years he's created over fifty jobs through three enterprises. But, when he went to his bank to secure funding to open a new wholesale coffee roastery and cafe, he was

He raised almost \$90,000 for the venture on Kickstarter, which helped to eliminate the initial financial burden that comes with brick and mortar businesses. But, to get the roasting equipment he needed and to build out the space he'd secured, he needed to raise more. Undaunted, he turned to the CDFI industry to make his vision a reality.

Small business owners like Keba often find themselves falling into a "gap" in funding. They're successful, yet can't secure bank loan large enough to grow their business, and the amount of funding available from most microlenders is simply not enough.

Keba has worked with Oakland-based CDFI ICA Fund Good Jobs since 2011, and he turned to them for capital. The team at ICA Fund Good Jobs believed in Keba's vision and structured a capital stack to meet his needs, partnering with San Francisco-based CDFI Pacific Community Ventures, to get Keba the amount he needed.

Entrepreneurs like Keba create stronger jobs and stronger communities. "We hire folks who have high barriers to employment whether that's formerly incarcerated, people of color, or folks with disabilities. And that just comes to us naturally, but what comes to us naturally is different from most other coffee companies," Keba says.

Red Bay Coffee's business model comes at a crucial time in Oakland's history when working-class people — and people of color, in particular — are getting priced out of their neighborhoods. Keba hopes that building a successful business and paying livable wages, he can allow them to stay.

Neither CDFI had done a joint small business loan before, but they both saw tremendous opportunity in working together. Both Pacific Community Ventures and ICA Fund Good Jobs are hoping this is the first of many joint efforts together, allowing them to serve more business owners across the Bay Area, and to create many more good jobs working people.

Recently, SFGate wrote a piece on Oakland's upand-coming coffee scene, praising Red Bay's highquality coffee and their chill atmosphere which "draws patrons for cupping and educational events, plus an eclectic calendar filled with live performances, video release parties, a pop-up brunch series and more."

Sandra Ann Harris, ECOlunchbox

Sandra Ann Harris developed a back-to-basics lunchware product line hewn from traditional reusable materials, stainless steel, and cotton. ECOlunchbox is completely free of waste and saves families hundreds of dollars.

ECOlunchbox sells wholesale directly to national chain retailers, such as Whole Foods and The Container Store; through established natural product distributors such as Down to Earth Distributors, Frontier Natural Products, Lotus Light Distributors and Honest Green Distributors; and direct to independently-owned natural groceries, co-ops, boutiques. They also sell directly to end-users through their online store.

Struggling to meet demand

ECOlunchbox had a well-established multitiered distribution network but the demand for its green consumer products was stronger than the small company could support due to undercapitalization. ECOlunchbox was frequently going out of stock on all its products due to high demand and lack of resources to adequately buy stock. Additionally, the bootstrapped company was seriously understaffed. Founder and President Sandra Ann Harris needed to focus on putting the financials together to obtain equity. So she went to the Marin SBDC for help.

The SBDC helped Sandra address several areas of improvement:

- Planning: Sandra worked with Ashwin Gulatiduring to research and write an executive summary that demonstrated the strength of the lunchware category and explained the market forces driving ECOlunchbox's strong growth.
- Financial: They evaluated Sandra's options in detail, including bank loans, equity investment, and convertible notes. Ashwin helped her fine-tune business loan packages and investment pitches for presentation.
- Sales Focus: ECOlunchbox analyzed its existing multi-tiered distribution and added new channels to its sales development plan for 2012.
