

# Small Business Confidence, Economic Optimism Rising Under Biden-Harris Administration

Recent reports show a surge in confidence among small business owners and consumers as inflation falls, recession fears subside, and consumer spending rises. The growth in optimism coincides with an unprecedented Small Business Boom, which has seen more than 16.5 million new small business applications filed since President Biden took office – a record level. Thanks in part to this historic surge, economic optimism among small businesses has hit a 22-year high, with a majority of business owners saying they are “highly optimistic” about the national economy.

**Other key indicators include:**

- Roughly eight in 10 small business owners feel confident about their financial prospects, with more than half expecting profits to rise in the next six months. (PNC Financial Services Group)
- 85% of small businesses report being satisfied with the success of their businesses, and 86% said they achieved their 2023 business goals. (American Express)
- 50% of small businesses surveyed have plans to grow or expand their businesses in 2024. (American Express)



- Americans’ assessment of the economy is at its highest level in more than two years. (CBS)

The Biden-Harris Administration’s strong economic track record gives business owners and consumers alike much to feel positive about. The United States has had the strongest growth since the pandemic of the world’s major economies, with the longest low unemployment streak in over 50 years, strong GDP growth, and considerable wage growth.

# New Report Finds Growth of Women Business Owners Outpaces the Market

*The number of women-owned businesses increased at nearly double the rate of their male counterparts*

*Black women and Latina entrepreneurs emerged from the pandemic stronger than all women-owned employers*

Women-owned businesses continue to fuel the economy, representing 39.1% of all businesses – over 14 million – employing 12.2 million workers,

and generating \$2.7 trillion in revenue. According to the 2024 Wells Fargo Impact of Women-Owned Business Report, in partnership with Ventureer, CoreWoman, and Women Impacting Public Policy (WIPP), the number of women-owned businesses between 2019 and 2023 increased at nearly double the rate of those owned by men; and from 2022 to 2023, the rate of growth increased to 4.5 times.

Whether it was during COVID-19 lockdowns in 2020 or supply chain disruptions throughout the pandemic, women business owners are driving economic growth:

- During the onset of the pandemic in 2020, despite business closures, women launched more businesses than they closed, while the number of men-owned businesses declined. Women-owned businesses also grew their workforces and increased their revenue while men’s numbers shrank.
- From 2019 to 2023, women-owned businesses’ growth rate outpaced the rate of men’s 94.3% for number of firms, 252.8% for employment, and 82.0% for revenue.
- During the pandemic, women-owned businesses added 1.4 million jobs and \$579.6 billion in revenue to the economy.
- Nearly half a million women-owned businesses with revenues between \$250,000 and \$999,999 grew their aggregate revenues by about 30%, illustrating their ambition, grit, and readiness to cross the \$1 million revenue threshold.

“The impact that women-owned businesses make on the economy is undeniable. Even more

# Greenlining Our Golden State: Our California State Legislative Agenda

For decades, discriminatory practices like redlining systematically denied economic services, investments, and opportunities to communities of color, triggering cycles of disinvestment and neglect. Deliberate infrastructure policies compounded these inequities, targeting certain communities for highways and industrial facilities, disrupting business corridors and saddling residents with higher levels of pollution. These systemic injustices are deeply interconnected and continue to fuel the racial health, wealth, and opportunity gaps.

**Greenlining is the practice of deconstructing systemic discrimination and proactively driving investments and opportunities into formerly redlined communities. The goal of Greenlining is to build a just economy that will pave the way for an abundant future for all.**

### Greenlined Policies

A just economy is one that is cooperative, sustainable, fair, participatory, and healthy—and getting there requires us to focus on the intersections between economy, climate, and race.

This year, our 2024-25 Legislative Agenda is all about Greenlined Policies—policies that address interconnected systemic injustices with intersectional solutions. Our legislative priorities include sponsored legislation and budget asks that will:

- Drive investments into communities that continue to bear the impacts of historic disinvestment;
- Create transparency into how policy and investment decisions impact California's communities with an emphasis on understanding inequitable impacts in communities of color;
- Establish accountability for state agencies and lawmakers to embed equity into state initiatives; and,
- Build power and capacity in communities of color that have been marginalized by past inequitable policies and practices

### Turning Towards Transportation: Our co-sponsored Legislation

Our transportation system sits at the critical nexus between race, climate, and the economy, informing the health, wealth, and opportunities within our communities. From how transportation funding is allocated, to where heavily polluted highways versus clean mobility infrastructure like electric rails and EV charging stations are located, transportation policies have the potential to shape our communities for the better.

However, inequitable transportation policies have saddled communities of color with higher rates of pollution, limited and less reliable transportation options, and a lack of decision-making power when it comes to transportation decisions that impact them. Greenlined transportation policies aim to deconstruct the systems that resulted in our highly inequitable transportation landscape, while building towards a more just transportation future that equitably connects our communities with healthier air, reliable and clean transportation options, and community ownership over transportation decisions. This will not only improve the lives of communities of color, but support California's climate and economic goals more broadly.

- **AB 2086 (Schiavo)** creates badly needed transparency and accountability in California's transportation investments, paving the way for a more efficient and equitable transportation system.
- **AB 2535 (Bonta)**, The Invest in Clean Air Act, limits freeway expansion projects in formerly redlined communities of color that are most overburdened by pollution, and reinvests those funds into clean energy infrastructure and EV technology to benefit our most vulnerable communities.
- **AB 2401 (Ting)** modernizes the Clean Cars for All (CC4A) program, increasing zero-emission vehicle (ZEV) incentives for low-income, high-mileage drivers with older, high-polluting vehicles and ensuring program benefits prioritize communities of color and low-income communities that face the highest barriers to transitioning to ZEVs.



Greenlining our transportation policies requires a holistic approach to transportation planning that recognizes the intersectionality of economy, climate, and race. By centering equity and sustainability in decision-making processes, these policies aim to create more just and resilient communities while advancing broader climate and economic goals.

### Building Resilience: Our Budget Priorities

Economic downturns have the harshest impacts on communities of color and low-income communities that are already struggling to make ends meet. In the face of rising costs, climate crisis, and widening racial health, wealth, and opportunity gaps—now is the time to fortify resilience in underserved communities, not delay or cut back already underfunded equity programs.

We are urging the California Governor and Legislature to make the following investments to help our communities build resilience and meet the challenges we face today:

- **Restore \$200 Million to Transformative Climate Communities Program to Uphold Commitment Made in the Historic 2021 California Climate Commitment.** TCC is a nationally recognized program that turns community priorities into impactful neighborhood-scale climate projects in communities most impacted by poverty and pollution. Despite overwhelming support for the program from advocates and communities across California, the program was zeroed out in 2023, and in the Governor's January 2024 proposed budget, cutting over \$200M in critical funding for the program. We urge the Governor and

Legislature to restore investments for this proven climate justice model through the Greenhouse Gas Reduction Fund (GGRF), the original funding source of this historic program.

- **Restore \$9.8 million for Strategic Growth Council's (SGC) Regional Climate Collaboratives (RCC) Program.** The SGC was preparing to announce awardees for Round 2 of this critical capacity building program in early 2024. Communities had already spent considerable time, energy and resources preparing for and applying for the RCC grant, and it is highly unacceptable to cut the funding right as it was about to reach communities. The Governor must restore this funding back to the RCC program, which aims to build capacity in disinvested communities to leverage climate investment opportunities.
- **\$3 million for FY 2024-25 to the California Air Resources Board** for the implementation of SB 253 (Wiener, 2023), a globally recognized emissions disclosure standard.
- **Avoid further delays and cuts to the Zero-Emission Vehicle (ZEV) Package, while ensuring all FY 2023-24 funding is awarded.** Any additional delays or cuts will further set back the state in supporting low-income and disadvantaged communities benefit from ZEVs. The state must also avoid going after unencumbered funds from FY 2023-24 to fill budget gaps.

## New Report Finds Growth of Women Business Owners Outpaces the Market

impressive is that growth in women entrepreneurship – whether it was their workforce or revenue – grew during an extremely difficult time,” said Wells Fargo Women’s Segment Lead for Small Business, Val Jones. “From the trillions in revenue they contribute to the economy to the millions in jobs, women-owned businesses are coming out of the pandemic stronger than they went into the pandemic and many are thriving. It’s a testament to their resiliency and the breadth and depth of support they’ve received from government entities, banks, corporations, and philanthropic organizations that must be sustained.”

Also, during the COVID-19 pandemic and the transition to the post-pandemic period, Black/African American and Hispanic/Latino women-owned businesses increased at a much higher rate than all women-owned businesses. Between 2019 and 2023, Black/African American women-owned businesses saw average revenues increase 32.7% and Hispanic/Latino women-owned businesses 17.1% compared to all women-owned businesses’ 12.1% rise.

Further, women-owned businesses with 50 or more employees account for nearly half of women-owned businesses’ employment and revenues. Currently, women-owned businesses with 50 or more employees average \$31.8 million in revenue generating \$1.3 trillion in aggregate

revenue. If they achieved the average revenue of men-owned businesses with 50 or more employees, they would add \$1.2 trillion in revenue to the U.S. economy.

“The surge in growth rates of women-owned firms with more than 50 employees proves their strength and adaptability during and post the pandemic era,” said Wells Fargo Women’s Segment Lead for Commercial Banking, Judith Goldkrand. “To sustain the growth and close the gaps, it’s important that we continue to create opportunities that help these businesses flourish, including removing barriers to capital, providing technical assistance, and offering support with business certification.”

### Industry trends

More than a decade ago, women-owned businesses were concentrated in just three industries. Now, half of all women-owned businesses (50%) are concentrated in these four industries:

- **Other services** (hair and nail salons, pet care, laundries, and dry cleaners): In 2023, women owned 2,267,000 other services companies, accounting for 16.2% of all women-owned businesses.
- **Professional, scientific, and technical services** (legal, bookkeeping, and consulting businesses): In 2023, women owned 2,017,000 businesses in this category, ac-

counting for 14.4% of all women-owned businesses.

- **Administrative, support and waste management, and remediation services** (office administration, staffing agencies, and security and surveillance services): In 2023, women owned 1,671,000 businesses of this type, accounting for 11.9% of all women-owned businesses.
- **Healthcare and social assistance** (child day care and homecare providers, mental health practitioners, and physicians): In 2023, women owned 1,588,000 healthcare and social assistance companies, accounting for 11.3% of all women-owned businesses.

While these industries have the most women-owned businesses, between 2019 and 2023, the sectors that saw the most significant growth (50%) were in finance, insurance firms, real estate, transportation, and the warehouse industry.

### Women-owned businesses show growth across the country

The impact of women-owned businesses diverges significantly across the U.S., influenced by varying economic conditions and programs that support their advancement. The report details how their growth plays out across the country, ranking the top and bottom states and Metropol-

itan Statistical Areas (MSAs) between 2019 and 2023. The states with the highest economic clout for women-owned businesses had strong economies during the pandemic with supportive environments for women-owned businesses:

- New York
- North Carolina
- Georgia
- Florida
- California

The top five MSAs had strong economies with a mix of industries, a strong job market, and entrepreneurial cultures in which there was access to capital, government contracting opportunities, training, mentorship, and networking opportunities:

- Miami, Fort Lauderdale, West Palm Beach – Florida
- Dallas, Fort Worth, Arlington – Texas
- Boston, Cambridge, Newton – Massachusetts, New Hampshire
- Los Angeles, Long Beach, Anaheim – California
- Phoenix, Mesa, Scottsdale – Arizona

in polling small and midsize business owners.

- “A majority of respondents – 55% – said they are “highly optimistic” about the national economy this year. That’s up sharply from 34% last fall and 26% a year ago according to the Pittsburgh-based bank. Roughly eight in 10 owners also expressed confidence about their own businesses’ financial prospects. Over the next six months, just over half of the business owners who were surveyed think their profits will rise, while only 5% expect earnings to fall.”
- “As inflation slows, fewer small business owners also see a need to raise their own prices in the near term.”

### Associated Press: Small business owners are optimistic for growth in 2024

- “Eighty-five percent of all small businesses surveyed said they were satisfied with the success of their business, and 86% said they achieved their 2023 business goals. In August 2023, by contrast, 80% of all small businesses surveyed said their long-term financial confidence was being negatively impacted by the economy.”
- “Fifty percent of small businesses surveyed have plans to grow or expand their business in 2024.”
