

# Putting Jobs First: California High-Speed Rail Crosses 13,000 Construction Jobs Milestone

The California High-Speed Rail Authority (Authority) today celebrated the creation of more than 13,000 construction jobs helping build the nation's first high-speed rail system, with more than 70 percent of those jobs going to residents of California's Central Valley.

On average, nearly 1,400 individuals are dispatched each day to a high-speed rail construction site.

**In the Central Valley\***

- 4,222 jobs in Fresno County
- 2,538 in Kern County
- 1,282 in Tulare County
- 580 in Madera County
- 462 in Kings County
- 189 in Merced County

**Remaining California Counties:** 3,387

**Out-of-State:** 369

## California Leaders Reach Agreement to Address Budget Gap



Gavin Newsom, Governor of California

Governor Gavin Newsom, Senate President pro Tempore Mike McGuire, and Speaker of the Assembly Robert Rivas issued the following statements on agreeing to budget solutions worth \$12 to \$18 billion to address the shortfall:

**Governor Gavin Newsom:** "Thanks to leadership in the Assembly and Senate, California is stepping up with a balanced approach that will take a significant chunk out of the projected shortfall. Despite the uncertainty due to the federal tax deadline delay last year, historic reserves and fiscal responsibility will assure a balanced budget that meets California's needs."

**Senate President pro Tempore Mike McGuire (D-North Coast):** "The deficit is serious and it's grown by billions since January, which is why we must move with speed to shrink the shortfall immediately. The quicker we make tough decisions, the better prepared we'll be to continue our work on a comprehensive budget to protect our progress. It's been an all hands on deck approach with Governor Newsom and Speaker Rivas to move this Early Action Budget Package forward. The Senate stands ready to take votes to get this initial job done, and I'm grateful to Budget Chair Wiener and all Senators for their continued focus on this tough challenge."

**Assembly Speaker Robert Rivas (D-Salinas):** "The Assembly is committed to a deliberative, transparent budget process that protects hardworking Californians. I appreciate our partnership with Governor Newsom and Pro Tem McGuire to finalize this preliminary and initial budget package in early April, which is an important first step. But the Assembly's budget work continues, including more than two dozen budget and oversight hearings scheduled next month. There are tough choices on the horizon, which is why our process is so critical. I extend considerable gratitude to Budget Chair Jesse Gabriel and our subcommittee chairs — and the entire Caucus — for their dedication, collaboration and accountability."

## Women in Construction: The State of the Industry in 2024

Construction is a predominantly male-dominated industry, with women making up a small percentage of the workforce. A 2023 report from the Bureau of Labor Statistics (BLS) reveals that 10.8% of construction workers in the United States are women.

Women in construction only make up 1.25% of the total workforce, despite constituting 47% of all employed individuals. This discrepancy is influenced by various factors, including unconscious gender bias, inadequate training opportunities, and negative stereotypes surrounding women in construction.

Regardless of these roadblocks, women continue to pave their way in an industry dominated by men. The rate of women in construction in the United States has grown by 2% since 2010, when women made up only 8.9% of the labor force.

The BLS also estimates that the construction industry will grow by 4% between 2021 and 2031. That's about 168,500 new jobs each year over the decade. With this fast and steady growth, companies are actively recruiting women to leverage their skills within the industry.

**Why Are There So Few Women in Construction?**

While women can excel in any construction job, their presence in trade and executive roles within the industry is notably lacking. This is due to a

combination of factors, including high levels of harassment and outdated gender stereotypes. As of 2022, women in construction mostly held office and sales positions. Here's a further breakdown of where women work within the construction industry:

- Sales and office roles: 36.1%
- Management roles: 36.1%
- Construction and maintenance roles: 24.6%
- Transportation roles: 2%
- Service roles: 1.2%

Despite the barriers standing in their way, forward-thinking organizations and hardworking women in construction are paving the way for progress. This includes inspiring the next generation with powerful women role models and promoting more women into leadership roles.

Although women are still underrepresented, they are making significant progress as leaders in the industry. A substantial portion of women executives and construction managers entered those positions in the last five years, suggesting that companies have more recently promoted women to leadership roles. Here are a few women in construction who are paving the way for future generations.

# Infrastructure Passes: Five Big Wins for Our Economy

Thanks in part to the Chamber's leadership, the bill includes a climate title within its surface transportation provisions—a first for major federal legislation—which will help ensure our infrastructure is built to withstand the winds, rising waters, and natural disasters likely to be wrought by climate change in the coming decades. Overall, the bill includes roughly \$100 billion in total climate, energy, and sustainability investment, making it the largest federal climate legislation in U.S. history.

### 4. Equips All Communities for the Future

The package provides funding for communities across the U.S. to not only fix old infrastructure, but also to think anew about how to prepare for their future. This could include broadband build-outs, new airports, energy infrastructure, and much more. By enabling community development, the

Chamber helped advance our longstanding priority of ensuring that every community across the country is equipped to participate in today's modern economy and opportunities of tomorrow.

### 5. Improves Project Delivery to Encourage More Private Investment

The Chamber called for increases in the use of public-private partnerships to cut down on the cost of project delivery to the American taxpayer. By modernizing the permitting process, increased private funding for both construction and project life-cycle costs will enable the business community to do what it does best: fuel growth, job creation, and economic progress for all Americans.

ing Trades. In 2023, the Authority marked 10 years since the establishment of our Community Benefits Agreement, which has helped create thousands of good-paying union jobs – including more than 10,000 in the past five years – with most of the jobs going directly to individuals from disadvantaged communities.

This announcement comes on the heels of the creation of the California Jobs First Council, External Link focused on aligning economic resources to create more jobs, faster for Californians in every community, including the Central San Joaquin Valley.

The Authority has begun work to extend the 119 miles currently under construction to 171 miles of future electrified high-speed rail from Merced to Bakersfield. There are currently more than 25 active construction sites in the Central Valley, with the Authority having fully environmentally cleared 422 miles of the high-speed rail program from the Bay Area to Los Angeles County. Two weeks ahead of the April 8 eclipse, Governor Kathy Hochul today updated New Yorkers on the state's preparations to ensure everyone can have a safe and memorable viewing experience. In October 2022, Governor Hochul convened an Interagency Task Force comprised of nearly two dozen state agencies and authorities. The Task Force has been collaborating for the past 17 months on plans to ensure everyone can safely enjoy the eclipse. New York State is expecting hundreds of thousands of visitors, and Governor Hochul is reminding travelers of several tips to ensure the smoothest possible experience for everyone. Governor Hochul is advising travelers to get to their destination early and plan on staying late to avoid the most traffic, allow for extra travel time, and travel prepared with water and snacks. Additionally, drivers should never pull over on the side of the road to ensure first responders can get by in an emergency.

"The April 8 eclipse is a once in a generation experience, and there's no better place to view it than in our beautiful state," Governor Hochul said. "New York is ready to welcome millions of visitors, and my administration has been working hard to ensure everyone in the path of the eclipse can safely enjoy this rare event. I encourage anyone traveling for this experience to plan on arriving early to their destination and staying late to enjoy all of what our state has to offer."

Governor Hochul is reminding New Yorkers that during the afternoon of April 8, a total eclipse will encompass 29 counties in the western and northern parts of New York State. For other areas of the state that are outside the path of totality, there will still be 88 percent to over 99 percent coverage.
