# AGC of California Survey Reveals Industry Optimism for 2023

A recent survey of its members by the Associated General Contractors of California (AGC of California) found that contractors are generally feeling optimistic about the construction industry's outlook and their companies' financial and hiring prospects in 2023.

"Our members' feelings of optimism for their business run in tandem with an equally strong urge to grow the construction industry and hire more talent to join the industry," said Peter Tateishi, chief executive officer, AGC of California. "As AGC of California continues to focus on delivering value for our members and the industry through our advocacy efforts, we also heavily invest in building a future workforce to meet the needs of the California construction industry that is both innovative and inclusive."

Some key statistics from the third annual AGC of California 2023 Optimism Survey include:

- Over 58% of respondents said they expect business activity in California to be strong or moderate in 2023.
- Over 65% of respondents expect the construction industry in California to stay the same or grow in terms of expansion.

- About 49% of respondents felt optimistic about California's construction industry overall, outnumbering those respondents with a more pessimistic outlook (25.5%) by nearly two to one. One-quarter of respondents were "neutral" (neither optimistic nor pessimistic) in their outlook.
- A strong 70.4% of respondents said they were optimistic about their own companies' prospects and success in 2023.

To capitalize on the market opportunities ahead, many firms plan to continue to grow their workforce and increase their talent pool. In fact, nearly 56% of survey respondents expect to increase their hiring in 2023 over 2022 levels either slightly (33%), moderately (15.1%) or significantly (4.7%).

On the revenue front, nearly 58% of firms said they expect their revenue to increase either significantly (10.1%), moderately (25.7%) or slightly (22%) in 2023, while 22.9% expect it to remain the same and 19.3% expect 2023 revenue to decrease. Asked about net profit, some 54.1% of respondents anticipate it will increase over 2022, while 22.9% expect it to remain the same and 15.6% expect it to decrease slightly.

ConstructConnect's support of the construction industry is largely a service to the boots on the ground, managers, and contractors putting plans into action. Additionally, women in the United States made up 4.2% of trade workers and front-line supervisors in 2022, and in Canada, they make up 5% of trades and 13% of the entire construction industry.

Organizations like the National Association of Women in Construction are fierce advocates for women in construction with strong dedication to career growth and development. ### 2. Evaluate Your Eligibility

equipment or real estate that the lender can lower interest rates with this option and secure seize if you default on the loan. Lenders also typically require a personal guarantee, which means you legally agree to repay the loan with your personal assets if the business cannot.

Lenders also look at the amount of time you've spent in business. A traditional bank will typically require two years of operation, but an online lender may accept businesses that have been in business for as short as six months to one vear

Annual revenue is another consideration for lenders, so it's wise to find out their requirements for annual sales, typically \$100,000 to \$250,000, and then assess your business to see if you qualify.

### 3. Compare Lending Options

Thoroughly research and compare lenders to ensure you find the best business loan. Term loans, microloans, and lines of credit are just some of the loan products that online business loan lenders offer. Requirements for online lenders tend to be less strict than traditional banks, so approval is typically easier. Plus, online lenders may offer funding as fast as the same day you're approved.

Traditional banks offer a lot of the same loans as online lenders, but you may find it more difficult to qualify due to stricter requirements. In some cases, like with a low credit score, you may need a co-signer who will repay the loan if you fail to do so. However, you may land a loan that meets your needs. This may not be the most suitable option if you need quick funds, as banks tend to be slower in this aspect than online lenders.

Another option is microlenders that can offer microloans up to \$50,000, which is ideal for those who don't qualify for traditional business loans as the requirements tend to be more flexible. Some microlenders approve you based on social capital instead of your credit score, which involves financial contributions from outside of the business.

### 4. Prepare the Required Documentation

The usual required documents for a loan consist of a business plan, a minimum of 12 months of personal and business bank statements, personal and business tax returns for at least two years, and any details about current and past business loans

As well as this, you will usually need to provide copies of applicable business licenses and legal documents, articles of incorporation, profit and loss statements, financial statements, and a building lease. It's wise to check with your preferred lender before applying to ensure you have the required documentation prepared and up to date.

### 5. Submit a Formal Loan Application

Once you've researched multiple suitable lenders, submit a formal loan application online or in person, depending on the lender.

You will normally need to provide the lender with your name, business name, and Social Security number, as well as your desired loan amount and purpose, business tax ID, and annual revenue. If you're approved, your funds will be issued once you have signed a loan agreement. You can always contact customer service with any questions if you have any uncertainty

A spokesperson from Forbes Advisor commented: "Diving straight into a small business loan application without taking steps to prepare can be overwhelming and lead to difficulties acquiring the desired loan.

"Following these simple steps, such as thoroughly researching lenders and checking your credit profile, could be all that you need to ensure that you don't pay more for your loan than necessary as well as avoiding a lengthy process."

women in all areas of technology is crucial. We must change how construction is perceived to attract more women to the industry, starting with college-aged professionals. With steady contact within the school system, the next step is to ensure women are guided and given opportunities to consider the possibilities of a career in construction as engineers and architects.

Attracting more women to tech careers begins with stepping up the promotion of science, technology, engineering, and math or STEM programs. The gender disparity in tech continues to be wide despite growth year to year. Women make up 28% of the tech industry in the United States and 23% of the tech industry in Canada. What is the issue? Much like the representation of women in construction trades, stereotypes and microaggressions have made STEM careers for women feel like an unrealistic pursuit.

### Women Business Enterprises (WBE)

A willingness to work with women businesses to complete construction projects can have a heavy impact on your company's ability to land major iobs. There's no excuse not to pursue partnerships with WBEs, as women owners and operators of construction-related companies are more accessible than ever.

When planning your next construction project, take time to research and consider the various programs available for contractors, subcontractors, and construction suppliers that are women and minority-owned business enterprises.

### Conclusion



# AGC of California Survey Reveals Industry Optimism for 2023

"AGC of California members acknowledge apprehension of a potential recession, but interestingly, the majority of respondents expect their companies to continue to grow net profit and revenue in the coming year," said Tateishi. "Respondents also expect to increase hiring in 2023, and AGC of California is continuing to capitalize and expand on our many workforce development programs that prepare future workers for jobs in our vital industry."

Respondents' concerns for the construction industry in 2023 in California include the threat of a potential recession (70.4%), workforce shortages (68.4%), regulatory requirements (62.2%) and increased pay and benefits (52%), to name a few. Asked to choose the single issue they are most concerned about, 21.4% of respondents cited the threat of a potential recession, followed by workforce shortages (20.4%), regulatory requirements (17.4%), increased pay and benefits (11.2%), and unreliable infrastructure investment (8.2%), among others.

The 2023 Optimism Survey is an annual questionnaire AGC of California issues to evaluate association members' and the construction industry's optimism regarding their business outlook in the coming year. The survey, sent via email, newsletters and posted on social media, garnered 109 responses, 93.6% of whom are members. Survey participants were 56% contractor members, 20.2% associate members, 16.5% specialty contractor members, with 7.3% unsure, and they represented the vertical construction building division (56%), highway and transportation division (47.7%) and the utility and infrastructure division (31.2%) of AGC of California. By total dollar amount of work in 2022, 20.2% performed \$500 million and above, 22% performed \$100 million to \$500 million, 11.9% performed \$25 million to \$50 million, and over 28% performed \$25 million or less.

The U.S. Department of Labor announced the availability of \$15 million in grant funding to support programs that help youth – particularly those in rural areas, people of color and people with disabilities – to overcome obstacles to educational and workforce success with training and career guidance.

Administered by the department's Employment and Training Administration, Workforce Pathways For Youth grants will support connections between out-of-school time organizations and state and local workforce partners to deliver career-focused programs to equip teens and young adults with the skills they need to succeed in college or in the workforce.

These grants align with the Biden-Harris administration's commitment to creating opportunities and connecting people to good jobs. They are also part of the department's Youth Employment Works Strategy announced on March 9, 2023, to expand access to programs that prepare all young people for good careers.

The department will award \$15 million in eight grants in varied amounts of up to \$2 million each. Projects serving young people in marginalized communities will be given priority. Specifically, the grants will support organization that offer the following types of activities:

- Career exploration services.
- Work readiness.



# How to Win More Construction Bids in 2023

Are you looking to win more construction bids in 2023? Maybe you're planning to grow and scale your construction business in the new year, or perhaps you're just looking to be more efficient in your estimating and bidding process to improve your bid-hit ratio.

What does it take to win more construction bids? Here are a few tips on how to bid smarter by going after the right opportunities to win more work.

### Find Quality Construction Leads

You shouldn't bid on every opportunity that comes your way. You also can't sit around and expect project leads to come to you. Market your business to owners and general contractors you want to work with by showcasing your experience and expertise in your trade.

Reach out to your network to find out about upcoming opportunities. Take the time to get prequalified with general contractors or owners you want to work with, so you can receive more invitations to bid (ITBs). Make sure they know what trades you can perform and the types of projects you are interested in bidding on.

Take a proactive approach by utilizing as many tools as possible to ensure you are receiving quality leads. Word of mouth, bid boards, local contractors associations, and your subs and suppliers are all great sources for learning about upcoming bidding opportunities. Consider investing in a leads service with a searchable database, updated project details, and plans and specifications attached so you can focus on finding the right opportunities for your business.

### Select the Right Projects to Bid

Winning construction bids on projects your business can't adequately perform can be just as costly as not winning them. Remember, it is never too late to abandon a bid—even after you've started working on it.

Once you start crunching the numbers you might discover that your company won't make a reasonable profit if you were to win the contract. The best thing to do is dump it and move on to the next project.

For example, you may discover during your bid preparation that your company cannot adequately handle the scope and requirements of the project. At that point, you need to make the smart business decision to walk away from the bid.

Finding the right balance between bidding and winning enough jobs can be difficult. On the one hand, you don't want to bid and win so much work that you can't properly manage and complete the projects you've been awarded. You also don't want too little work that you aren't making any money and your workers aren't staying busy.

Selecting the right work to bid is vital to maintaining a profitable business, which is why it's vital to have an established bid/no-bid decision-



making process in place to win more construction bids.

### **Understand Your Bid-Hit Ratio**

Are you keeping track of your bid-hit ratio? If not, you need to start. Your bid-hit ratio is the number of projects you must bid to win one job. Understanding your bid-hit can help you how many projects you need to be bidding to keep your pipeline full and weed out the opportunities that don't have a high probability of winning.

To really make your bid-hit ratio work for you to maximize your bidding efforts you need to do an in-depth analysis. Sort the projects you've bid and group specific categories. Consider things like public versus private work, building type, scope of work, geographic location, contract size, and the general contractor or owner of the project.

By categorizing and analyzing your bid-hit ratio, you get better insight into which types of projects to go after. For example, let's say your overall bid-hit ratio is 7:1. After performing your analysis you discover that your bid-hit ratio for medium-sized private office projects is 4:1 and your ratio for large, public school projects is 10:1.

In this scenario you have a better bid-hit ratio on the private office projects, so you should focus more effort on those opportunities and less time bidding on school projects.

### **Review Profitability**

Now that you know the types of projects that you have the best opportunity of winning, it's time to look at profitability on those projects. Make sure you are recording accurate job costs for materials, labor, and equipment. Compare your actual costs to your estimates and ask the following questions:

- Were your estimates for labor and materials accurate?
- Did you include all the job costs in your estimate including like bonding, supplies, and equipment?
- Did you factor in your profit and overhead mark-up correctly?

Was your contingency budget adequate?

If your profit margins on projects aren't what you expected there are two possible reasons. Either your estimates are too low, or you are having productivity issues on the jobsite which is causing job costs to be higher. Regardless of which is the cause, you should work to resolve the issues to get your profit margins where they need to be.

By combining the data from your bid-hit ratios and your profit margin analysis you can hone in on the projects that you have the best chance of winning and make the most money on.

### Conduct a Bid/No-Bid Review

Now that you're getting quality leads and you know the types of projects to pursue, it's time to start bidding, right? Not so fast, before you start investing your time into putting together a bid proposal you need to conduct a thorough bid/nobid review of each opportunity.

The first thing to do is gather all the project documents, plans, and specifications and familiarize yourself with them. You want to make money, so crunch some quick numbers to determine whether you can make a reasonable profit on the project.

Next, determine whether you can perform the work if you win. Make sure you have the manpower and equipment available to start the job on time and complete it on schedule. Does your company have the experience and expertise to handle the size and the scope of the project? It's no good to anyone if you bid and win a job you can't complete.

Perform a risk assessment to determine if there are any red flags that might cause problems if you win the project like unknown site conditions, safety concerns, accelerated timelines, and incomplete or inaccurate bidding documents.

Other factors to consider in your review should include project location, duration, competition, and client. Decide which criteria are most important to your company when selecting projects to bid and apply them to all projects you are considering bidding on.

### **Identify and Manage Risks**

Identifying and managing risks is probably the most overlooked aspect of preparing a bid. Once you've identified the potential risks, you will need to analyze and evaluate each one individually so that they can be properly managed and mitigated.

Consider the probability of each identified risk and the impact it can have on the project. For example, a low-probability risk with a low impact might be easy to mitigate. But a high-probability risk with a high impact that you can't effectively manage could be detrimental to the project's profitability.

Identifying and evaluating possible risks associated with a project when preparing your bid will make you better prepared to handle a situation when something goes wrong.

By starting the process early, you can avoid bidding on projects that aren't profitable. It will also lead to more accurate bids with reasonable contingencies built in and result in your company winning more bids. Project management will run smoother, and you'll save time, money, and resources as work progresses.

### Seek Clarifications, Avoid Assumptions

As you're preparing your bid, you need to do your due diligence to ensure that you have all the pertinent information, that the information is accurate, and that you have a complete understanding of this information.

Fully review the plans and specifications to determine everything required to bid on the project and complete the work. This includes knowing everything from what bonds are required to whether there are participation goals for minority business enterprises (MBEs) or if material substitutions are allowed in the bid. If you are unsure of any aspect of the project when preparing your bid, you should seek clarification from the architect, owner, or owner's representative.

Be aware that there are typically cut-off dates in place for questions to be submitted. This allows for the project team to make any changes to the plans and specifications and for any addenda to be issued to the bidders and plan holders.

If you are unclear on any aspect of the project, the onus is on you to get clarification. Making assumptions is no way to submit a winning bid. If you can't get your questions answered to your satisfaction, you might want to reconsider whether bidding the project makes sense.

Most bidding opportunities provide prospective bidders with a chance to attend a pre-bid meeting and visit the jobsite. Often, these are mandatory in order to submit a bid and with good reason. No two jobsites are identical, and unknown site conditions can cause unexpected, and costly, issues when construction gets underway.

After a trip to Ethiopia to visit family, Dagne Tedla brought a leather messenger bag as a gift for his daughter Xiomara. After countless compliments and inquiries from friends and strangers about the bag, Dagne suggested the two should start a business. Initially, Xiomara resisted as she was focusing on her corporate career and busy personal life. Soon after, friends and co-workers asked when Dagne was heading back to Ethiopia and asked if they could place pre-orders!

After her initial hesitation and the growing demand for her leather messenger, Xiomara said 'yes' and hopped on board! She then designed several bag styles and Dagne helped their current artisan partner obtain his export license. Thus, UnoEth was born.

While continuing to work full-time, Xiomara dedicated herself to the development of highquality samples and designs for her business. Despite having already secured funding through multiple avenues, this venture did not come without significant sacrifice on her part. One of the biggest obstacles that she faced was obtaining the necessary capital for production and operations. From the onset of establishing the brand, obtaining funds proved to be an expensive endeavor. This was due to exorbitant interest rates and limited funding options. This hindered their initial growth projections and resulted in a slower pace than anticipated. When asked how her team managed while seeking capital, Xiomara stated, "as entrepreneurs, we're resourceful and determined, so we kept pushing through the rejections and the no's while keeping close tabs with our business community and finding alternative options for our brand growing."

As her search continued, she discovered Pacific Community Ventures through a networking resource. This connected her to a business mentorship program. Through this program, she found out about the Oakland Fund 0% interest loan. She successfully secured this in the summer of 2022. The additional capital from PCV assisted her with growing the UnoEth team, acquire additional inventory, and establish a more stable monthly budget. UnoEth products are currently available for purchase online, as well as in 65 retail stores.

Xiomara and Dagne witnessed the dramatic impact of UnoEth's partnership and investment with artisans and small businesses in Ethiopia. The duo made it their mission to keep duplicating their business model across the globe, one artisan at a time.

Since then, Xiomara and Dagne have partnered with additional leather artisans and cotton weavers in Ethiopia and jewelry makers in Tanzania.

# **Margins Wine**

Megan Bell didn't always know she wanted to start her own business, but after experiencing the poor labour conditions in wine production, she took it upon herself to change the culture and set new standards for the wine industry to create a safe place for women and marginalised communities.

Working multiple jobs at the same time, Megan knew she needed to grow her business to sustain herself and reach higher profit margins. To do so, Megan worked with advisor Larry Hebert in implementing a cost escalation strategy to ensure steady profit percentages to counteract the recent sharp price increase.

After further analysis, Megan realised it was crucial to determine what categories sold the best to avoid excess wines that could tie up dollars. Knowing how many items per key category she needed would allow her to improve her investment and generate revenue faster based on a quicker turnover. Larry Hebert suggested that Megan implemented an OTB(Open To Buy) template to manage inventory, ensure greater turnover of product, increased cash flow and higher profits. Megan also envisioned opening a taste room where she could connect and build strong ties with other women-owned wineries. In order to obtain a loan for the space's reconstruction, Larry provided guidance on the narrative and type of loan to pursue. As a result, Megan was able to get access to additional funding to afford construction expenses.

Additionally, Megan's journey with the SBDC included reviewing her forecasting model and projected cash flows and any profit and losses for 2022 and 2023. To do so, Larry made a spread-sheet for the balance forecasting and helped create a better picture of where the business stood and what strategies should be implemented to achieve increased cash and profits.

Megan is confident the mentorship from Larry has shifted the way she organises and thinks about her business and herself as an entrepreneur. Because only 4% of wineries in California are owned by women, mostly due to the lack of access to funding, having someone like Larry Hebert on her side was very helpful. After being consistently ignored, Megan was able to connect with the right people as Larry vouched for her.
