These investments in innovations pay off significantly; research shows that firms that are rated as “digitally savvy” outperform companies by as much as 48% on revenue and 15% on net margin. And this is true across many fields, including AEC.

Research also show that when asked to self-assess, 25% of businesses overrate their ability to use data effectively and a whopping 80% of construction businesses are classified as beginner or emerging levels of data capabilities.

## EPA Investing Over \$43 Million in New Funding to Protect and Restore San Francisco Bay and Its Watersheds

The U.S. Environmental Protection Agency (EPA) today announced \$43.5 million to fund projects that will help protect and restore San Francisco Bay and local watersheds and wetlands. EPA also announced today that the Agency will be launching a new program office later this year that will focus solely on advancing the Agency’s work in the San Francisco Bay watershed.

The \$43.5 million in funding announced today comprises \$38 million in congressionally-appropriated funds for EPA’s San Francisco Bay Water Quality Improvement Fund (SFBWQIF) that will be awarded as grants later this year, over \$5 million in SFBWQIF grants from the Bipartisan Infrastructure Law (BIL) that are in the process of being awarded and a \$500,000 wetlands program development grant to San Francisco Estuary Partnership.

“San Francisco Bay is one of the most iconic natural places in the country and EPA is committed to ensuring it is protected and restored so that its ecosystems and local communities can thrive for generations to come,” said EPA Pacific Southwest Regional Administrator Martha Guzman. “This new funding – along with our San Francisco Bay program office – will play a major role to improve water quality and restore wetlands across the Bay and its watersheds and build climate resilience in underserved communities.”

**Organizations receiving grants from the \$5 million in BIL funds:**

**California State University, East Bay (\$915,786)** – Funds will support building a native plant garden to promote and sustain Indigenous food sovereignty for the Miwok and Chochenyo Ohlone Tribes. The garden will include a tool shed for rainwater harvesting and a community gathering space for Tribal meetings and educational workshops. The grant will also support workdays to build the garden and restoration work for the Galindo Creek. This work is part of a larger effort to improve the creek and garden spaces to restore traditional land stewardship.

**California State University, Sacramento (\$742,240)** – Funds will be used to reduce trash inputs to San Francisco Bay through on-land, community-based trash monitoring, cleanup, and career training in underserved communities. This grant will also support a network of community volunteers, high school and college interns, university-based technical experts, and two nonprofits in Pinole, San Pablo, Richmond, unincorporated areas in North Richmond and Tara Hills, and Berkeley.

**Friends of Sausal Creek (\$200,673)** – Funds will be used to restore William D. Wood Park, a public park located in lower Sausal Creek in one of the few public green spaces within ur-

# Groundbreaking Effort Reconnects Communities Divided by Freeways

**WHAT YOU NEED TO KNOW:** The state is launching a groundbreaking new pilot program to transform and reconnect underserved communities historically divided by the construction of highways. The communities of Arcata, South San Francisco and southeast San Diego/National City have been selected for the pilot.

Governor Gavin Newsom announced a pilot program to reconnect three communities historically divided by transportation infrastructure in California. The Reconnecting Communities:

Highways to Boulevards grant program will increase access and traveling options in underserved and underinvested neighborhoods in Arcata, South San Francisco and southeast San Diego/National City.

*“California is once again leading the way to repair the shameful history of redlining and other exclusionary policies of the past. We are advancing equity in historically underserved and underinvested areas through a community-driven vision to reconnect neighborhoods and support more vibrant spaces for Californians.”*  
 Governor Gavin Newsom

“Transportation at its best is a uniter – connecting people and communities with convenient and safe access to jobs, family and services,” said California Transportation Secretary Toks Omishakin. “Transportation at its worst is a barrier – dividing communities, increasing harms and cutting off access to opportunity. We must strive to always unite and never divide, and today represents an important step in righting the wrongs of the past by putting people and communities first.”

The pilot program, initially proposed in the Climate Action Plan for Transportation Infrastructure, seeks to convert underused highways that divide underserved communities into multimodal corridors and vibrant public spaces. Caltrans will assist the selected communities in working from concept to project delivery on a community-driven vision to reconnect their neighborhoods. This includes helping pilot communities to obtain additional grant support for project completion, including the application for the federal Reconnecting Communities and Neighborhoods Grant Program.

# CalOSBA launches new \$25 million program to increase capital access for California's underinvested small businesses

The California Office of the Small Business Advocate (CalOSBA), part of the Governor's Office of Business and Economic Development, announced participants in their new Technical Assistance for Capital Readiness Program.

Funding for this \$25.3 million program comes from the U.S. Treasury's State Small Business Credit Initiative (SSBCI), which was created by the U.S. Congress in 2010 and reauthorized through the American Rescue Plan Act of 2021. The SSBCI is designed to spur investment in businesses with 1-9 employees, small manufacturing companies, and businesses operated by owners from underserved communities.

**This program will help underserved small business owners by:**

- Guiding them through the loan application process, spurring the the approval of an es-

timated 40,000 new business loans over the next five years

- Building legal, accounting, and financial management skills to access the capital needed to get started and scale
- Increasing awareness of state-backed capital support programs

Additionally, it will support the deployment of \$1.1 billion in federal funding separately approved for capital support programs from the California Infrastructure and Economic Development Bank (IBank) and the California Pollution Control Financing Authority. Lenders across the state are expected to leverage the \$1.1 billion in funding for existing capital support programs into \$18 billion in new loans for small businesses over the next five years.

*"California's 4.1 million small businesses are the backbone of our economy and provide nearly half of the state's private sector jobs. But too many of them struggle to access the capital*

*they need to grow. This is a historic opportunity to catalyze inclusive economic growth and build a stronger California,"* said Tara Lynn Gray, CalOSBA Director.

At an event held in San Francisco today for network partners, CalOSBA named CAMEO, California's statewide small business network and leading voice for businesses with one to five employees, as the Capital Readiness Network Manager for this program. In this role, CAMEO will lead a network of 29 resource partners that seeks to ensure underserved small business owners are equipped to access capital from lenders offering both state-backed and traditional loan offerings. This new network of technical assistance and lending partners will begin working with Main Street borrowers starting in April as part of the state's ongoing efforts to support the small businesses community.

"CAMEO is honored to be selected as the network manager for the Technical Assistance for Capital Readiness Program and to help ensure

that small businesses across the state have full and equal access to this incredible opportunity," said Carolina Martinez, CEO of CAMEO.

# Outsourcing Strategies for Small Construction Businesses

Construction companies of all sizes are facing a common challenge: the need to optimize their operations and drive sustainable growth in an increasingly competitive and less predictable market. One solution that has emerged is a greater reliance on outsourcing—hiring external professionals or third-party organizations to perform specific tasks, functions or roles.

While traditionally associated with large corporations, outsourcing can be equally beneficial for small to medium-sized firms, presenting opportunities to leverage specialized expertise, mitigate talent shortages and drive innovation.

### INPUT TO OUTCOME

There are several factors explaining the growing popularity of outsourcing. First, there simply

isn't enough talent available to fulfill the diverse needs of construction companies, from finance to human resources to marketing. High turnover rates further exacerbate this challenge, making it difficult for organizations to maintain continuity and momentum.

Outsourcing represents a strategic talent-management approach, enabling companies to better focus their internal resources on core competencies while leveraging external expertise for non-core functions. For example, finance departments can play a pivotal role in facilitating outsourcing initiatives, supporting functions such as human-capital management, marketing, procurement and information-technology governance and strategy. By reallocating resources in this manner, construction companies can optimize their cost structures, enhance operational efficiency and drive overall profitability.

A fundamental shift is also underway in how outsourcing is perceived and implemented within the construction industry. Traditionally, outsourcing arrangements were input-based, focusing primarily on cost reduction. However, the changing landscape demands a paradigm shift toward outcome-based outsourcing, with an emphasis on delivering tangible results rather than merely reducing expenses. This shift is driven by a recognition of the need to maximize value and efficiency while maintaining quality standards.

Whether it's outsourcing a position or a project, companies can no longer outsource a single, fragmented slice of a process and hope to see much improvement in results. Instead, according to an article from McKinsey & Company, for the highest impact, the provider usually needs to own—and transform—the entire end-to-end process, through optimization, digitization, automation and the elimination of manual processes and work.

Consider an example of a young controller tasked with leading a finance team. By incorporating outsourcing into the company's talent strategy, the controller can leverage external expertise while providing skills-development opportunities within the team. This dual approach not only enhances the team's capabilities but also fosters a culture of continuous learning and professional growth.

Labor productivity is another critical area where outsourcing can yield significant benefits for construction companies. Historically reliant on domestic talent pools, firms now recognize the importance of diversifying their labor sources to mitigate risks and enhance scalability. In today's globalized economy, the traditional model of sourcing labor solely from major urban centers is no longer sustainable.

CalOSBA already oversees the California Small Business Support Centers, which provide no-cost 1:1 consulting and training for small businesses. This new partner network through the Capital Readiness Program will complement those existing services but focus exclusively on capital access to help business owners navigate the loan process, prepare their loan applications, and determine what loan products, if any, will be the best fit.

More than two-thirds of small business-owners report that they will seek capital over the next 12 months, but many don't think they understand all the available options. Many diverse business-owners – including women, people of color, veteran and LGBTQ+ entrepreneurs and other business-owners in low-to-moderate-wealth, rural, or disaster-impacted communities — believe they have experienced declines on loan applications unrelated to the fundamentals of their businesses. Studies prove that diverse business-owners must work harder to gain the same lending and investment opportunities as non-diverse peers. This program is designed to help level that playing field.

CalOSBA's mission is to make sure state services to support small business growth are available to entrepreneurs in every zip code. The Office also oversees the build-out of 13 Accelerate California Inclusive Innovation Hubs to help diversify our innovation economy and the Outsmart Disaster preparedness training program to help small businesses become more resilient in an era of rapid climate change.

banized Oakland. This project aims to improve water quality and overall health of the watershed and will produce a feasibility study for daylighting portions of Sausal Creek in the park. The project will also develop a dedicated community of creekside environmental stewards, increase access to public urban green space, and build climate resiliency by addressing impacts of invasive plants and the channelized creek.

**Grassroots Ecology (\$770,823)** – Funds will be used to restore 37,000 square feet of urban riparian habitat along the Cordilleras and Redwood Creeks to benefit underserved communities in Redwood City and North Fair Oaks. Restoration work will include the removal of invasive trees and planting 1,400 native plants and trees. Project funds will also support workforce development with eight environmental internships and eight California Climate Action Corps fellows that will work with high-risk youth and low-income families. Creek restoration efforts will decrease fire risks, improve water quality, reduce erosion and increase habitat biodiversity in a community in need of increased access to green space.**Greenbelt Alliance (\$324,908)** – Funds will support the creation of a climate learning exchange and training program, a 14-month course that will prepare approximately 25 local residents from underserved communities in Suisun City and Fairfield with the tools, experiences, and resources they need to be climate champions in their own communities.**La Luz Center (\$967,914)** – Funds will be used for a three-year project that will create a partnership between a Latino-serving community-based nonprofit, a watershed environmental nonprofit, and a community college to train a local, underserved, predominantly Latino workforce. The program aims to connect graduates to jobs that will meet the need for watershed climate resilience work across the North Bay. This project will help create a more climate-resilient community in the underserved, unincorporated, densely populated Springs area of Sonoma Valley.**Nuestra Casa de East Palo Alto (\$125,560)** – Funds will be used to engage 400 residents from East Palo Alto, Belle Haven, North Fair Oaks, and Redwood City in 16 shoreline clean-up days. The clean-ups focus on four sites: Cooley Landing, Don Edwards San Francisco Bay National Wildlife Refuge, Ravenswood Open Space Preserve, and Baylands Nature Preserve. These events will serve as a platform to engage residents who live on the shoreline to be active participants in the restoration of San Francisco Bay.**The Watershed Project (\$1,000,748)** – Funds will support the creation of two community-based groups that will plan, design, and implement a new watershed action plan for the Wildcat Creek watershed in the underserved community of Richmond. Community meetings and workshops will be held to recruit and train a community advisory board and a “friends of Wildcat Creek” group. The two groups will continue to engage the community as the plan is implemented and forge relationships with other agency-led restoration actions happening in the larger watershed. This grant will also support workforce development in riparian restoration and green infrastructure.
