# High-Speed Rail Investments Continue to Lift California Economy

Investments in California's first-in-the-nation high-speed rail project are pumping billions of dollars into California's economy and contributing to positive economic benefits throughout the state, according to the California High-Speed Rail Authority's latest 2022 Economic Analysis Report.

"High-speed rail creates good-paying jobs and generates income for Californians while leading the way for the state's future transportation," said Authority CFO Brian Annis. "We look forward to our continued partnership with the federal government and our local partners as we build this transformative project for California."

Last month, the Authority celebrated a historic milestone, announcing the creation of more than 10,000 construction jobs since the start of high-speed rail construction. Most of these jobs have gone to Central Valley residents and men and women from disadvantaged communities.

"This project is not only reconnecting the Central Valley to the rest of the state, but it is improving the economic prosperity of our region," said Fresno Mayor Jerry Dyer. "Creating goodpaying jobs gives our residents the opportunity to send their kids to college, buy homes and continue to invest in their hometown. High-speed rail will transform the Valley and California and will be a model for the country."

These jobs are the result of the project's investment of more than \$9.8 billion since 2006 in its planning and construction. More than one of every two of these dollars have been invested in California's disadvantaged communities, driving economic activity in these areas.

The Authority estimates a total of 80,000 jobyears have resulted from the project so far, sparking \$6 billion in total direct labor income earned by workers on the project and \$16 billion in total economic activity. Job-years are defined as the equivalent number of one-year-long, fulltime jobs supported by the project. For example, if one full-time job is supported for two years, it represents two job-years.

The Authority estimates completing the initial Merced to Bakersfield operating segment would result in a total of 325,000 job-years of employment and total economic activity of \$65.1 billion.

As of December 2022, more than 760 certified small businesses throughout the state are also **Continued on page 6** 

# How to attract more young people to construction

The global construction industry finds itself in a rather odd situation. It is caught in a storm of conflicting trends pulling at the very threads that hold a construction firm together: the ability to find and keep skilled, dependable workers.

On paper, it ought to be easier than ever for contractors and OEMs to attract young workers to their companies. Construction machines today are technological marvels with features that would have dazzled operators a decade ago.

Powerful new semi-autonomous guidance systems with 3D graphics combined with interactive, in-cab display screens now put precision control and high production within reach of even the most inexperienced operators.

And these very same systems can supercharge the capabilities of experienced operators – allowing them to post daily production numbers that would have been unthinkable on older machines. The 'office' operators work in has also evolved tremendously. Most modern machine cabs feature ergonomically laid-out interiors, with 360-degree views, comfortable seats, heat, air and even stereos.

Hydraulic control systems reward an operator with a feather-light touch and modern coupler systems mean that operators rarely have to leave the cab to change attachments.

The work is out there, too. Construction markets worldwide today are generally robust with plenty of work available.

Markets have seen strong growth, thanks to government investments in new infrastructure as well as renewal and repair. To meet these demands, construction firms are happy to pay good wages for skilled, dependable operators.

#### Attracting younger workers to construction

Despite this, young workers with the ability and desire to learn are hard to come by. Even in normal times, this would be a worrisome problem.

But, by an odd quirk in demographic timing, this young worker shortage is hitting the global

construction industry at a time when older workers and highly skilled operators are beginning to retire in large numbers, leaving owners with a vacuum in knowledge and skills.

"Naturally, this is a bigger problem in some global markets than others," notes William Chimely, senior director, North America and global training and publications, Komatsu.

"In Asia, for example, operating a machine is seen culturally as a more revered, honored role in a company. So, it's difficult for a young person to get the training required to move into the cab of the machine.

"The bigger issue is that technical education for young people has fallen off all over the world. Trade schools and public schools used to provide elementary training for a career in trades.

# Latest Worker Organizing Task Force Report Shows **Continued Progress**

On Friday, March 10, in former Secretary Marty Walsh's last public event in office, the White House Task Force on Worker Organizing and Empowerment, chaired by Vice President Kamala Harris and vice chaired by Secretary Walsh, held a roundtable discussion with employers and unionized workers on the benefits of collective bargaining and positive labor-management relations. The companies and unions featured at the event included Ford and the United Auto Workers, Orsted and North America's Building Trades Unions. Microsoft and the Communications Workers of America, and Siemens and the International Brotherhood of Electrical Workers. In a follow-up to the event, the task force released an update on the status of the 70+ action items in the first task force report and more than 30 additional actions that have been taken by agencies across the government.

It was a fitting way for Secretary Walsh, a cardcarrying union member and the first union member to lead the Labor Department in more than half a century, to conclude his time as labor secretary. During his tenure, Secretary Walsh worked tirelessly to support the collective bar-

gaining process, help workers and employers reach agreements, and settle disputes. And through Secretary Walsh's and Vice President Harris' leadership of the task force, the 20 agencies and offices on it have found ways to reduce barriers to organizing and support workers and their organizing rights. As importantly, the task force has provided a vehicle for a governmentwide discussion of the value and importance of unions to workers (both union and non-union), employers and our economy.

Another exciting aspect of the task force is how it has brought agencies together to collaborate in new ways on supporting workers' rights. This has included actions by the independent labor agencies - the National Labor Relations Board. the Federal Mediation and Conciliation Service, the Federal Labor Relations Authority and the National Mediation Board - who, while not on the task force, have made important contributions to its work. For example, the NLRB and FMCS are pursuing an initiative to help the parties bargain a first contract when workers first organize - a persistent challenge workers face.

These agencies also have provided valuable content to the Labor Department's Worker Organizing Resource and Knowledge (WORK) Center, our one-stop shop for information on unions and the union advantage, and to worker.gov, a plain language website with information on key worker rights, including organizing rights and protections against retaliation. The Labor Department. the FMCS and the NLRB also collaborated with the Small Business Administration on the first resource guide for small businesses on unions. workers' right to organize and employer responsibilities in worker organizing campaigns.

Additionally, the departments of Labor and Commerce have collaborated on Good Jobs Principles, which include respect for workers' right to organize. The whole-of-government approach of the task force has encouraged interagency collaborations like these, with more to come in the future.

At the Labor Department, we have made significant progress on our task force action items. Here are a few highlights:

- We're getting information on unions and organizing into the hands of workers who need it to help close the enormous gap between the percentage of workers who want union representation (52%) and the percentage of workers who say they have the information they need to form a union (10%)
- We are working to highlight case studies of employers who take a constructive view

of worker organizing and elect not to run anti-union campaigns when their workers choose to organize - a positive trend that more employers are choosing to follow, according to a recent report.

The department's Office of Labor-Management Standards has reinstituted a Labor-Management Partnership Program to highlight and encourage this approach. As the task force event earlier this month demonstrated, when employers take a constructive approach to worker organizing and collective bargaining, their businesses benefit through greater productivity, less turnover and more satisfied workers.

The Biden-Harris administration has sent a clear message to its agencies to find ways to support workers and their right to organize, and, under the leadership of Acting Secretary Julie Su, the Department of Labor's commitment to this work will continue unabated.

helping build high-speed rail. To date the Authority has paid more than \$1.3 billion to certified Small Businesses, Disadvantaged Business Enterprises and Disabled Veteran Business Enterprises in California for their work.

The Authority has begun work to extend the 119 miles under construction to 171 miles of future electrified high-speed rail from Merced to Bakersfield. The project has more than 30 active construction sites in California's Central Valley, with the Authority having environmentally cleared 422 miles of the high-speed rail program from the Bay Area to the Los Angeles Basin.



# **10 Tips for Submitting Better Bids**

Putting together a winning bid proposal, or even a competitive one, takes knowledge and skill. It's a bit more complicated than just putting some numbers together and hoping for the best.

Good bid preparation requires a lot of time and effort and involves everything from reading and fully understanding the plans and specifications to accurately estimating costs for labor, materials and equipment.

Making even the smallest mistake can mean the difference between submitting a winning bid and missing out on a coveted and profitable project. We've put together our top 10 tips for submitting better bids.

#### Select the Right Projects to Bid

You don't have to bid on every job you come across. Winning jobs your company can't adequately perform can be just as costly as not winning them. Remember, it is never too late to abandon a bid you are working on. For example, let's say you have purchased plans, attended the pre-bid meeting, done your takeoffs and started taking subcontractor pricing.

Once you start crunching the numbers you realize that your company won't make a reasonable profit if you were to win the contract. The best thing to do is dump it and move on to the next project.

If at any time during your bid preparation you realize that your company cannot adequately handle the scope and requirements of the project, you need to make the smart business decision to walk away from the bid. Finding the right balance between bidding and winning enough jobs can be difficult.

On the one hand, you don't want to bid and win so much work that you can't properly manage and complete the projects you've been awarded. You also don't want too little work that you aren't making any money and your workers aren't staying busy. Selecting the right work to bid is vital to maintaining a profitable business.

#### Visit the Site and Attend Pre-Bid Meetings

Having a good understanding of the existing site conditions can eliminate problems down the line should you be awarded a project. Unique site conditions like limited accessibility or a location that would require additional costs on items like transportation, equipment, material storage and labor could exist. Failing to visit the site would leave you unaware that these conditions exist and that additional costs need to be factored into your bid which would cut into your profitability.

Many times a pre-bid meeting will be held at the construction site or a site visit will be held directly following a pre-bid meeting. Pre-bid meetings are held to in order for the project team to answer questions regarding plans and specifications, site conditions and specific project details.

Failing to attend a pre-bid meeting means you miss out on the best opportunity to get clarification on the requirements of the project. It could be the only chance you get to walk around the site and get a better understanding of exactly what you will be dealing with. If the pre-bid meeting is mandatory, failing to attend would result in not being able to even bid on the project. When preparing a bid proposal you want to have as much information as possible in order to submit a competitive bid and refusing to attend a pre-bid meeting or a site visit will put you at a severe disadvantage.

#### Seek Clarification

When preparing a bid you need to do your due diligence to ensure that you have all the pertinent information, that the information is accurate and that you have a complete understanding of this information. This means fully reviewing the plans and specifications to determine everything required to bid the project and complete the work.

This includes knowing everything from what bonds are required to whether or not there are participation goals for minority business enterprises (MBEs) or if material substitutions are allowed in the bid. If you are unsure of any aspect of the project when preparing your bid, you need to seek clarification the architect, owner or owner's representative.

Be aware that there are typically cut-off dates in place for questions to be submitted. This allows for any changes to the plans or specifications to be made and for any addenda to be issued to the bidders.

If you are unclear on any aspect of the project the onus is on you to get clarification. Making assumptions is no way to submit a winning bid. If you aren't able to get your questions answered to your satisfaction, you might want to reconsider bidding the project.

#### Perform Accurate Takeoffs and Measurements

Take the time to fully review the plans and specifications to determine accurate measurements and takeoffs. This will result in correct construction costs when calculating your bid. Takeoff software can ensure that correct measurements are obtained in order to submit an accurate bid.

Inaccurate measurements will cause you to miscalculate the amount of building materials and labor needed to complete the job which in turn will lead to either over- or underestimating your construction costs. Using the right units of measure is also important when calculating your bid. Using square feet when you should have used square yards or vice versa can drastically affect your estimated costs.

Make sure that you are taking measurements from the right place. Often the plans will instruct you not to scale the drawings or direct you to use the written or calculated dimensions provided in the specifications. This often occurs when electronic documents are used because enlarging or shrinking the size of a drawing to in order to print them can result in the scale being incorrect. If there is ever any doubt as to where to take your measurements from you should contact the architect for clarification.

#### Avoid Arithmetic Errors

Errors with your math can have a devastating impact on your bid. Arithmetic errors can result in your bid being under or over the actual cost of completing the job. Manual calculations can easily result in arithmetic errors. Always use a calculator or some type of construction bid software to ensure that your calculations are accurate.

in getting our country back on track, and ready for a new chapter of opportunity.

#### How We Did

I had the pleasure of talking with Forbes about our work at EDA and my reflections on our efforts to make the American Rescue Plan as impactful as possible for the economy. In that interview, I shared how the \$1 billion Build Back Better Regional Challenge was the marquee of EDA's American Rescue Plan suite of programs. The application process gave communities an opportunity to share their best ideas and strategies designed to help rebuild American communities, including some that have been grappling with decades of disinvestment.

Hundreds of worthy applicants submitted project proposals to develop or scale industry sectors, train the workforce of today, and build resilient economies. The applicants emphasized the importance of methodically addressing the unique needs of a region, and of the power of partnerships between the private and public sectors — so much so that we saw more than \$20 billion in private investment reach American communities because of this program.

I also noted our \$500 million ARP Good Jobs Challenge and how it plays a pivotal role in helping communities across the country to invest in innovative approaches to workforce development that will secure job opportunities for more than 50,000 Americans. We are excited that President Biden has included \$100 million in his Fiscal Year 2024 budget to continue this model.

#### Informing How We Invest In America

Our ARP programs were truly an investment in ourselves as a nation. Every state and territory received funding and support. We did not just invest in the "usual suspects" — we prioritized equity and geographic diversity to ensure often overlooked and underinvested communities could have a shot at rebuilding and supercharging their economies.

The same approach that helped us succeed implementing ARP is guiding us now as we "hit the road" to solicit feedback on two of our newest initiatives to create jobs and grow economies. The Regional Technology and Innovation Hub Program, known as "Tech Hubs," is an economic development initiative that will — equitably and inclusively — drive technology- and innovation-centric growth within a region to catalyze the creation of good jobs for American workers at all skill levels. For distressed communities across the country, the Recompete Pilot Program will provide grant funding to create and connect workers to good jobs and support longterm comprehensive economic development by helping to reduce the high, prime-age (25 to 54 years of age) employment gap.

By listening to the diverse array of needs and innovative solutions across America, EDA will deliver the precise support where and how it is needed most. Quantifying and sharing what we've learned from listening is another critical element to our success. We changed the paradigm for transparency during ARP by posting all the applications we received. This helped more stakeholders identify opportunities for resource sharing and partnerships, and helped stretch the taxpayers' dollar even further by combatting repetition.

When I think of some of the other projects ARP investments powered at the EDA — the Economic Adjustment Assistance program; the Indigenous Communities program; the Travel, Tourism & Outdoor Recreation program; Statewide Planning, Research & Networks — as well as all the initiatives we're spearheading now, the future of economic development in America has never felt brighter.

#### The Work Ahead

Through continued opportunities provided by our Public Works and Economic Adjustment Assistance Programs, Build to Scale Program, STEM Talent Challenge, coal and nuclear community support, and much more, EDA is working to make sure every community and every territory in the United States is prepared to grow the industries and jobs that power a strong, inclusive national economy.

We continue to thank all the organizations who applied or helped spread the word about funding opportunities during the ARP roll-out, and have toted its successes ever since. The pandemic and the historic approach the Biden Administration, EDA, and our partners across America took to recover and become more resilient should serve as a model for the future.

The plan to recue America's economy is succeeding, and now we must continue the President's mission to grow the economy from the bottom up and middle out to fortify it for generations to come. The work ahead is vast and challenging, but as the American Rescue Plan taught us: if we invest in ourselves and unite in support of one another, anything is possible!

Hand in hand with pricing, Jenni also received help with documenting her expenses and determining legal requirements, like the need for licenses and a fictitious business name.



To get additional funding, Jenni decided to apply for the Dream Fund Grant. After explaining the application process and expectations to Jenni, the SBDC provided assistance with the completion of the fund allocations and the income statement, as well as the review of formatting issues to make the application process simple and clear.

As a result of working with the SBDC and improving her business plan, not only was Jenni granted \$5,000, but she was able to establish her business as a solid brand with prices that accurately reflected her talent. She has high hopes for Jenni Ritchie Photography as she intends to use some of the funding to expand and consolidate a steady clientele in order to gain more traction.

## San Francisco to Require Inspections for Newer Tall Buildings after Recent Storms

San Francisco launched a new safety requirement for tall buildings in response to glass failures in a number of buildings during March's winter storms. The San Francisco Department of Building Inspection (DBI) will now require accelerated façade inspections for San Francisco buildings that are 15 stories or taller and built after 1998. Owners of these buildings will now be required to provide a licensed architect or engineer evaluation of the entire building façade to ensure the safety and stability of all façade elements, including windows.

Under the existing City program, these post-1998 buildings would not be required to undergo these inspections until 30 years after the building was built. Of the six buildings that experienced glass failures during the intense March wind and rain storms, three of them are less than 30 years old and, under the original program, were not required to submit a façade evaluation until 30 years after they were constructed. Through Mayor London Breed's emergency declaration issued on March 27, 2023, DBI has the authority to expand the façade inspection program to ensure the safety and stability of newer buildings. This new requirement is meant to identify cracks or other issues that could signal a potential glass failure or other unsafe, non-code compliant facade conditions. The new requirement will apply to 71 buildings.

"This is an important step we are taking to ensure the safety of all of our buildings to keep our residents safe," said Mayor Breed. "I want to thank the Department of Building Inspection for their work to not only respond immediately to these glass issues during the storms, but also for quickly taking on this critical program expansion."

"While we are endeavoring to understand what caused the recent window failures in half a dozen buildings downtown, this legislation will ensure all tall buildings are immediately inspected and made secure," said Board President Aaron Peskin. The reports will be due six months after receipt of a letter from DBI notifying the property owners of the new requirement. DBI will review the reports submitted by the building owners to ensure they are complete, comprehensive and that the evaluations were properly conducted. If necessary, DBI will issue Notices of Violation to the building owners for any unsafe façade conditions requiring additional work to bring the building back into code compliance.

The new requirement is an extension of the existing building Façade Inspection and Maintenance Program detailed in Chapter 5F of the San Francisco Building Code. The existing program requires building owners to submit a façade evaluation for certain five or more story buildings based on the original construction date of the building.

"This is a smart and straightforward evaluation that will give building owners additional insight so they can maintain their properties responsibly and help ensure the safety of our city," said DBI Director Patrick O'Riordan. "We will officially inform building owners of the new requirement later this month."

In March, the Department issued a public advisory to building owners to prepare for upcoming storms by closing and latching operable windows, removing or securing objects on roofs and balconies, checking for cracks or signs of distress around windows and securing any scaffolding or construction equipment.

The Department of Building Inspection (DBI) is the regulatory building safety agency responsible for overseeing the effective and efficient enforcement of building, electrical, plumbing, disability access and housing codes for the City and County of San Francisco's more than 200,000 commercial and residential buildings. # **10 Tips for Submitting Better Bids**

If you are using bid software or a calculator errors can typically be attributed to not inputting your numbers correctly. If you are using a spreadsheet like Excel to calculate costs, check that your formulas are correct.

Always double-check your math to make sure that all you numbers and calculations are correct. This is another one of those instances where having another set of eyes to look over your figures and calculation can help prevent costly mistakes.

#### **Evaluate Subcontractors & Subcontractor Pricing**

Getting subcontractor pricing can be complicated. You want competitive prices from your subcontractors but you also want some assurance that they can perform the work required. This is true whether it is a subcontractor you are using for the first time or one that you have worked with for years.

One solution is to set up a prequalification process for subcontractors who wish to work with you. This allows you to have a better understanding of the type of work they are capable of performing by evaluating their quality and performance on past projects.

At a minimum, you should get bids from at least three different companies for each trade you will need to subcontract out work for to ensure you are getting competitive prices. Carefully review and evaluate every subcontractor bid to make sure that the prices quoted are complete and accurate.

When requesting bids from subcontractors, clearly define the scope of work that the subcontractor is expected to perform. Failing to do this can result in unnecessary costs being added to your bid from an overlap of work being bid by both you and your subcontractor.

#### Identify and Manage Risks

Every construction project comes with its own unique set of risks. Identifying and managing risks

is probably the most overlooked aspect of preparing a bid. Once you've identified the potential risks, you need to analyze and evaluate each one individually so that they can be properly managed and mitigated.

Take into account the probability of each identified risk and the impact it can have on the project. A low probability risk with a low impact might be easy to mitigate, but a high probability risk with a high impact that you can't effectively manage could be detrimental to the profitability of the project. Identifying and evaluating possible risks associated with a project when preparing a bid will make you better prepared to handle a situation when something goes wrong.

#### Labor Costs

Accurately estimating labor costs can be one of the most difficult aspects to preparing your bid. To determine your labor costs you have to factor in hourly wage rates with the number of man-hours a specific task will take to complete. You also have to take into account the productivity and experience of your workers.

Employee turnover, absences and injuries can all affect your actual labor costs. More experienced workers may be able to complete tasks quickly which would reduce the number of man-hours needed, but you will have to pay a higher rate for their services. Workers with less experience will require more man-hours to complete a job but you can pay those workers a lower wage.

Wage rates can vary greatly from state to state and even from county to county. It is important to understand what, if any, wage rates apply to the project you are bidding in order to incorporate those rates into calculating your labor costs.

Wage rate determination is required on all federal government construction projects as mandated by the Davis-Bacon Act. Wage rates are determined by the location of the project and the type of construction being performed.

Many states also have prevailing wage laws for public construction projects. Always check the current prevailing wage rates where the construction is taking place so you can accurately determine your labor costs. When determining your labor costs remember to factor any projected overtime needs as the wage rates for overtime hours worked can be as much as double the prevailing wage rate.

#### Materials and Equipment Costs

Costs for building materials and supplies can change rapidly and can vary greatly in different parts of the country. If specialty materials are required that you aren't familiar with you shouldn't assume that the cost is comparable to similar items. Your best bet is to call around to local suppliers to get up-to-date costs for materials and delivery.

You also need to make sure that the building materials and supplies required in the specifications are clearly defined so your pricing is correct. If you are uncertain of the materials being requested in the specifications you should always get clarification from the architect, owner or owner's representative.

When putting a bid together you need to make sure that you have all the necessary equipment needed to perform the work. This may mean you have to rent or purchase additional equipment. Even if your company owns all the equipment needed you need to make sure that it isn't already allocated for use at another jobsite and that no major maintenance or repairs are scheduled that would take the equipment offline for an extended amount of time.

Make sure that the equipment is in good working order and operating at peak performance which might otherwise cause delays in your construction schedule. Equipment that isn't optimally performing can increase the time it takes to complete certain tasks. Unexpectedly having to rent additional equipment or face delays can negatively affect the bottom line on a project. Remember to factor in fuel costs to operate the machinery and to transport the equipment to the jobsite.

#### **Incomplete Bid Forms and Documents**

Failing to fully complete the bid form and submit all required documents is a surefire way to get what might otherwise be a winning bid rejected. Required documents and paperwork can be anything from bid bonds to acknowledging receipt of any addenda.

A good way to ensure that you have all the required paperwork for your bid is to use a checklist as you prepare your bid and then go back and doublecheck to make sure that everything is included. It never hurts to get another set of eyes to look over the bid proposal to make sure nothing has been forgotten before you submit your bid.

There are a few other requirements that go along with preparing your bid that can get your bid rejected if you don't comply with them or simply overlook them. The first is to get prequalified to bid a project when it is required. The second is to attend all mandatory pre-bid meeting and site visits. The third and most important of these is submitting your bid by the due date and time. All of these requirements will be clearly stated in the bid.

#### **Construction Bid Proposal: Not an Easy Task**

Preparing a construction bid proposal is no easy task. A competitive and winning bid proposal requires a lot of time and attention to detail. Making mistakes can lead to submitting a lot of overpriced, uncompetitive bids or worse a lot of underpriced bids that you win but make no profit on.

The key to winning more bids is being able to accurately estimate all costs required to complete the job while factoring in a reasonable profit for you company.
