State of the Construction Industry: One Year Into the Pandemic

It's been a little over a year since the World Health Organization declared COVID-19 a pandemic. In the days and weeks that followed, we started to get a feel of how it would impact our lives as states began issuing stay-at-home orders, mandating people shelter in place except for essential work and activities.

This forced many businesses to have to halt operations and many workers started to make the transition to working from home. For the most part, construction activity was deemed essential, although there were a handful of states and cities that categorized it as nonessential in the beginning.

And while construction projects in progress continued, with enhanced safety protocols on job-sites in place, projects in the design and bidding phases were heavily impacted as projects began being delayed or put on hold.

Questions and uncertainty over how long the pandemic would last and what the economic impact would be caused many owners to rethink starting new projects or moving forward on anything not already under construction.

So, where does the construction industry stand one year later? As the rollout of vaccinations continue and states start easing more and more pandemic-related restrictions and things start to reopen, it feels like we are slowly progressing toward whatever our new normal might look like.

Here's a brief look at what the overall impact COVID-19 had on the construction industry and where it stands today.

Construction Spending

Despite the pandemic, construction spending increased in 2020. Total construction spending last year was \$1.43 trillion, a 4.8% increase over total construction spending in 2019. The increase in construction spending last year was due mostly to the almost 12% increase in residential construction put-in-place which totaled \$813.9 billion in 2020. Nonresidential construction dropped 0.04% in 2020 with the drops in spending for lodging, office, commercial, manufacturing, educational construction projects.

Construction spending in 2021 has gotten off to a good start as well with the seasonally adjusted annual rate of construction spending totaling \$1.52 trillion in January.

- **Advocates**, leading strategy and policy efforts, raising the visibility of issues that impact communities of color, and building political will for transformative policies to end racial inequity.
- **Incubators**, working with communities to generate and test new policies and programs while training multi-ethnic leaders so they can be the strongest and most resilient advocates for change.

In order to more effectively push for systemic change, Greenlining is realigning its internal staff structure to more precisely achieve the new plan's priorities, while maintaining its

ongoing work on issues such as banking, housing, climate, health and access to technology, including crucial work with regulatory bodies such as the California Public Utilities Commission and Federal Reserve.

"Since our founding, Greenlining has brought literally hundreds of billions of dollars in investment into communities of color, but dollars – even when equitably distributed – aren't enough," said Greenlining Institute President and CEO Debra Gore-Mann. "While we work to meet the immediate needs of underserved communities, we're going to redouble our efforts to fundamentally transform the systems that created these inequities in the first place."

Small Business Pulse Survey Phase 4 Weekly Data Release

The U.S. Census Bureau today released new data from the fourth phase of the Small Business Pulse Survey (SBPS). Data collection began Feb. 15. Results will be released weekly Feb. 25 to April 22. The SBPS includes questions on topics such as location closings, changes in employment, disruptions in the supply chain, the

use of federal assistance initiatives such as the Paycheck Protection Program, vaccine requirements, planned capital expenditures, and expectations concerning future operations.

Data are available through the SBPS interactive tool [<https://portal.census.gov/pulse/data/>] and

downloadable files [<https://portal.census.gov/pulse/data/#downloads>].

The SBPS collects near real-time data on the effects of the coronavirus pandemic on small businesses. These data inform federal and state decision-making.

How to Prevent Burnout and Encourage Engagement in a Remote Construction Workforce

The construction workforce of today looks very different from even a couple of years ago. More construction professionals are remote than ever before due to social distancing requirements and health regulations. Even with a large portion of professionals now back on the jobsite, new processes and procedures have altered their work environment for the foreseeable future.

While many firms are entering a year or even longer of remote work, challenges to employee engagement remain. On the operations side, many firms have adapted their workflows and processes for their remote and hybrid workforces. Still, burnout is a real issue that has the potential to impact all employees.

Employee engagement is essential to business success, particularly in the areas of productivity and retention. How can firms keep employees engaged when there is so much uncertainty present? According to business management experts at Harvard Business Research, "If you want your teams to be engaged in their work, you have to make their work engaging." Let's explore top strategies for keeping your remote workforce connected in a disconnected world.

1: Give Employees the Freedom to Explore New Ideas

One of the biggest drivers of burnout besides workload? Monotony. For today's remote workforce, the lines between working and non-working hours and even the workweek and weekend are blurred. Repetitive, uniform tasks only increase boredom and raise the risk of burnout.

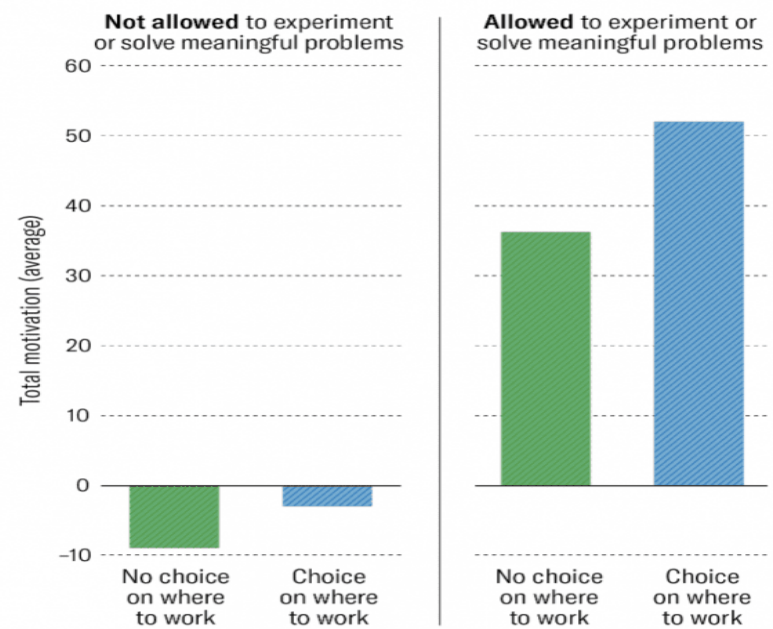
To make work engaging, you have to give people the opportunity to explore new ideas and valuable concepts. People want to feel like they're solving problems that matter. For the operations side, that might look like, "How can we maximize our resources?" On the customer side of things, you might ask, "What can we add or take away from our customer experience?" These 30,000-foot questions help to generate conversation so you can narrow things down to an identifiable problem and actionable steps.

Top construction firms around the world are already taking the lead to empower their employees to solve real and complex problems at their companies. For instance, the team at Buro Happold, a British engineering consulting and advising firm, sought to answer the question, "How can we help clients solve big problems with advanced technology?" 8 Options for Small Business Startup Loans

What is a Startup Business Loan?

A business startup loan is financing meant to help with the financial needs of a new business. Business startup loan proceeds can go towards things like working capital; the purchase of equipment, machinery, supplies, inventory, and furniture; and the purchase of construction equipment or real estate. New business owners can also consider business credit cards, certain SBA loans, and crowdfunding among other options.

One of the biggest challenges a new small business must face is obtaining the capital necessary to support their initial growth. New employer small businesses are the primary source of U.S. job growth, but are much more likely than larger firms to face financial challenges accessing borrowed capital, according to a 2020 Federal Reserve report. In order to proudly turn on your physical or metaphorical “open for business”

sign, you may need to have access to money in the form of a small business startup loan.

If you’ve already started your hunt for a loan, you’re well aware that there is a seemingly infinite amount of small business loan options out there, available from banks and online lenders. Each one will come with their own set of pros and cons, and perhaps you’ve discovered that most of the low-cost options are not available to new business owners without a couple years of business under their belts, strong credit and/or solid revenues.

While a bank loan may be your first choice, for the majority of startup businesses, a traditional loan will be out of reach. Banks have strict small business lending standards, and what they offer is often not available to brand new businesses. You may, however, be able to work with your bank to secure equipment financing or other types of business funding if you have a solid business plan in an industry the bank serves. If you are unsuccessful getting a bank loan for startup costs, there are other lending partners to consider:

How a Startup Business Loan Can Grow Your Small Business

You need to think outside the box when looking for financing for an early-stage business. Although the SBA does offer some financing to startups, you are more likely to find success from other sources. Equipment financing is a good example of this. There are some things where you will simply need cash, financing (or leasing) the equipment you need allows you to free up cash for those things you can’t finance. And, because the equipment is often considered the collateral for the loan, if you have a good personal credit score, it’s easier financing to qualify for than a traditional term loan.

With that in mind, here are some examples of startup financing.

Where Do I Get a Small Business Startup Loan?

1. Equipment Financing

Specifically designed to pay for the purchase of equipment and machinery, equipment loans are

similar in structure to conventional loans, with monthly repayment terms over a set period of time. However, the proceeds are used to purchase equipment or machinery. The lending standards on equipment financing can be less strict because your equipment will be used as collateral for the loan—in other words, if you default, the bank has the right to seize your equipment to cover the cost of their lost money. (Note that some SBA loans may be used to finance equipment. In particular, the SBA 504 loan is helpful for financing larger equipment and real estate purchases.)

Equipment leasing is another option that you should consider. Keep in mind that many different assets you use in your business may be leased, including computers, a pizza oven, or even the furniture in your restaurant.

2. Business Credit Cards

While many of us think of credit cards as a safe and convenient way to pay for purchases, they also offer access to an unsecured loan in the form

State of the Construction Industry: One Year Into the Pandemic

Continued from page 1

It'll be worth watching to see what impact soaring construction materials prices will have on construction spending moving forward. According to the Producer Price Index, final demand construction is only up 1.0% from a year ago despite some massive price hikes for materials like softwood lumber which is up 79.7% from a year ago.

Construction Starts

Construction starts, on the other hand, have not fared as well as construction put-in-place spending. ConstructConnect's nonresidential construction starts were \$386.6 billion in 2020, down 27% compared to 2019. For February 2021, nonresidential construction starts totaled \$18.5 billion, down 34.6% from January 2021's \$28.3 billion and down 38.5% from February 2020's \$30.1 billion.

ConstructConnect's construction starts compile the total estimated dollar value and square footage of all new project groundbreaking in any given month. They lead, by nine months to as much as two years, put-in-place statistics which record monthly spending on projects in progress as they proceed through completion.

Basically, starts records the total cost of projects the month it starts and put-in-place records what was spent each month. So, in 2020 total nonresidential put-in-place was \$813.9 billion versus starts that totaled \$386.6 billion.

Construction Employment

Despite the strong numbers in construction spending, construction employment took a massive blow shortly after the pandemic hit. The

construction industry lost over 1.1 million jobs in March and April 2020. Factors that impacted this include the construction activity being shut down in areas where it was deemed nonessential as well as new and upcoming projects getting delayed or put on hold.

To put that number of jobs lost in context, leading up to and during the Great Recession, the construction industry shed over 2.2 million jobs, but that was over the course of about three years compared to the 1.1 million jobs lost in just two months during the pandemic.

The good news is that construction employment has been steadily increasing since May 2020 and has added back 931,000 of those jobs through March 2021 despite a drop of 56,000 jobs in February 2021 based on preliminary numbers from the U.S. Bureau of Labor Statistics. The construction industry is still down 182,000 since the pandemic struck so it'll be something to watch to see how quickly those jobs can be added back as recovery from the pandemic continues.

Architectural Billings

Architectural billings have taken a big hit since the pandemic struck. The Architectural Billings Index score from the American Institute of Architects reflects the approximate nine to twelve-month lead time between architecture billings and construction spending. Any score above 50 indicates an increase in billings and any score below 50 indicates a decrease in billings.

In February 2020, the ABI was 53.4 and things were looking good to start off the year. Then the shutdowns and stay-at-home orders started rolling out and the ABI plummeted to 33.3 in March

and bottomed out at 29.5 in April 2020.

The ABI score did improve in the following months, but never got above 50, meaning there was no increase in billings in a year. Things might actually be starting to turn around because the ABI score for February 2021 was 53.3, nearly matching the last score before the pandemic was declared.

Coronavirus Outbreaks on Jobsites

With construction practically deemed essential everywhere during the majority of this pandemic, it's no surprise that we saw a number of outbreaks on construction sites across the country. Many of those reported were on larger jobsites where there could anywhere from a few hundred to a few thousand daily workers.

So, what constitutes an outbreak? The CDC has this recommend definition for declaring an outbreak:

- During (and because of) a case investigation and contact tracing, two or more contacts are identified as having active COVID-19, regardless of their assigned priority, or
- Two or more patients with COVID-19 are discovered to be linked, and the linkage is established outside of a case investigation and contact tracing (e.g., two patients who received a diagnosis of COVID-19 are found to work in the same office, and only one or neither of the them was listed as a contact to the other).

One of the biggest outbreaks of COVID-19 was in Montana on the construction site of the Montage Big Sky luxury resort where at least 116 workers tested positive through July 2020.

Suffolk, the general contractor on the project, implemented additional safety measures and guidelines back in March after six subcontractors tested positive while working on the \$400 million ski resort.

At the SoFi Stadium construction site in Los Angeles, the new home of the NFL's L.A. Rams & Chargers, there had been 49 confirmed cases (as of July 21, 2020) of COVID-19 dating back to March when an ironworker was the first to test positive for the coronavirus.

A nuclear power plant under construction in Waynesboro, Georgia became something of a hotbed for COVID-19 cases. At least 75 people at the site had tested positive for the coronavirus by mid-July 2020.

And those are just three examples of dozens of outbreaks reported last year at construction sites.

Construction Technology Adoption

Let's end it on a positive note today. According to JLL's State of Construction Tech 2020 report, the construction industry saw accelerated growth and adoption of construction technology in 2020. By their estimates, the rate tech adoption that would normally have taken three year was accomplished in just nine months of 2020.

This makes sense as contractors turn to technology to stay connected with stakeholders, staying productive and efficient with fewer workers, and improve jobsite safety during and, hopefully, after the pandemic.

Consulting, answered this question by launching the computational consulting department to assist clients involved in real estate development and infrastructure projects solve some challenges using computation and advanced analytics.

Emidio took an experimental and innovative approach to promoting the service internally by leading the firm's Hackademy 3.0. During the virtual program, Emidio shared updates from the department, engaged with teams across the firm, and demonstrated new ways to approach engineering through the application of computation.

At Mott MacDonald, a global consulting firm, Maria Mingallon leaned on social purpose to engage and include a larger community of people in design technologies. As the Technical Director of Automation and Computational Design, she focuses on how to deliver tangible outcomes through automation and computational design. When the pandemic began, Maria went into problem-solving mode, pivoting the format to a virtual coding club and using her expertise to mitigate the effects of COVID-19. By collaborating with the Coronavirus Makers Movement,

she helped frontline workers by 3D printing face shields and other protective equipment to fight COVID-19. As a result of her 3D printing activism and enthusiasm, several Mott MacDonald offices now include 3D printing as a great design and prototyping tool.

How do you build a communication strategy to ensure quality project delivery in the times of COVID-19? That's the question Weston Short, Vice President of Business and Engineering Services at Gaylor Electric, Inc., sought to answer this past year. He needed to be creative in how his engineering team engaged with on-site electricians, field supervision, and customers. Instead of resorting to merely video calls and emails, Weston experimented with the VR/AR capabilities of Revit. By collecting video footage and pushing content to Oculus headsets, Gaylor Electric's engineering team engaged in real-time collaboration with the jobsite and the fabrication department. Owners were even able to virtually walk through and inspect jobsites from the comfort of their own homes or offices. This innovative solution helped to solve the problem of multi-site collaboration while driving a better employee and customer experience.

2: Build Trust and Provide a Safe Space

Over the last two decades, society as a whole has faced increasing rates of mental health conditions and emotional distress. The pandemic has only exacerbated these feelings as most people have lost their traditional outlets for relieving stress and connecting socially. Emotional pressure is a concern for all employees but has been shown to be a key demotivating factor for remote employees.

Managers and colleagues can help support employees by establishing a trusting environment and safe space to keep morale up. Trust impacts every aspect of work, particularly the willingness of employees to go the extra mile. Research shows that employees are more likely to go above and beyond at firms with high levels of trust.

As one example, Donald P. Hill, Project Manager at Hensel Phelps demonstrated how to create an inclusive environment through his role as the subcommittee chair for the Diversity, Inclusion and Community Engagement (DICE) Committee at Hensel Phelps. Alongside the DICE committee, Don educated employees on the meaning

and importance of Juneteenth, the holiday that commemorates the enslaved African American people's emancipation in the United States. The event not only received overwhelmingly positive feedback but also increased the momentum for the team to engage in challenging conversations in a safe space.

3: Centralize Technology to Combat App Fatigue

Technology can help to simplify work but it can also introduce more complexities. Technology overload is a contributing factor to burnout. Employees jump from platform to platform and app to app over 1,100 times per day on average. Some remote powerhouse tools such as Zoom and Microsoft Teams are relatively easy to use, others have much steeper learning curves. This only frustrates and demotivates employees through cumbersome and time-consuming mechanisms.

of a line of credit. That means business credit cards can be a great alternative to start up business loans. They can also help you get off on the right foot separating business and personal finances and establishing business credit. To qualify you for a business credit card, issuers will generally look at your personal credit scores and combined income (personal and business). While they may not require collateral, they typically require a personal guarantee. Most business credit cards have the added bonus of great rewards programs and sign-up bonuses.

A good tip would be to choose a card with a 0% introductory rate offer. Doing so allows you to make purchases and carry a balance for 9, 12, or even 15 months without paying interest while you get your business going. In a recent Federal Reserve Small Business Credit survey, 53% of small businesses reported using credit cards to help fund their operations.

3. SBA 7(a) Loans

For the most part, the Small Business Administration (SBA) doesn't make loans—it guarantees them. Individual lenders are approved by the SBA to make loans under SBA programs.

There are several different types of SBA loans, and among the most popular is the 7(a) program which offers loans up to \$5 million. If you're wondering if you can get an SBA loan to start a business, keep in mind that in the 2020 fiscal year, 17% of the money lent to small businesses through the 7(a) loan program went to start up businesses.

Getting an SBA loan isn't a super fast or easy process, though the SBA Express loan program (which generally offers loans of up to \$350,000) aims to speed it up somewhat.

There are a number of qualifications required, including acceptable credit. There is no minimum personal credit score required, but for 7(a) loans of \$350,000 or less, the SBA requires a minimum FICO SBSS credit score of 155 to avoid a manual credit review. (This commercial credit score can take into account the personal credit of multiple owners along with the business credit of the business. The score ranges from 0-300.)

SBA 7(a) loans for startups are more likely to go to business owners with experience in their industry (a veterinarian opening her own practice, for example) or those purchasing an existing business, including a franchise. Because the terms are favorable it is a financing option worth exploring.

As mentioned earlier, SBA 504 loans may be helpful for businesses looking to acquire real estate or equipment, while SBA Export Loan programs may be available to businesses that will be participating in international trade. Learn more about SBA loans here.

4. SBA Microloans

SBA microloans are made by approved intermediaries, often community development financial institutions (CDFIs) and other non-profit organizations. While the total maximum loan amount is \$50,000, the average loan is closer to \$14,000. An SBA microloan is a term loan, with a maximum term of 72 months; the average is about 40 months. Funds may be used for working capital or the purchase of inventory or supplies, machinery or equipment, or fixtures and furniture.

5. Other Microlenders

The SBA is not the only microlending option. Microlenders are often non-profit organizations that offer small businesses the opportunity to secure financing in smaller amounts. When it comes to microlenders, be sure to check out these two options:

- **Accion:** Loans are available from \$300—\$250,000 through Accion's CDFI partners. It tends to be flexible on credit requirements and provides assistance to applicants.
- **Kiva:** Kiva operates on a largely community-based, trust-driven platform. Small business owners can crowdfund business loans from philanthropic-minded individuals up to \$15,000. These loans carry a 0% APR and are provided to struggling entrepreneurs who have proven their character, invited their own network of lenders, were unable to access other financial means, and have a business that has a perceived positive social impact.

6. Invoice Financing

If you get paid by your customers via invoices, invoice financing (which is different from invoice factoring) is a convenient, albeit usually expensive way to avoid cash flow issues caused by long invoice cycles. This is a speedy option—you can get your financing in as little as a day—that requires little paperwork.

7. Crowdfunding

Popular crowdfunding platforms like Kickstarter allow anyone with a vision, including entrepreneurs, to raise money for their project or venture.

There are three main types of crowdfunding that may be available to startups:

- **Rewards** (e.g. Kickstarter, Indiegogo)
- **Debt** (e.g. Kiva)
- **Equity** (e.g. Wefunder)

A business startup seeking capital through crowdfunding will require the business owner to share their business goals and objectives with a large group of people in hopes that multiple people (the crowd) will help fund their request. These campaigns take lots of marketing effort, but the end reward, should you raise your funds, is startup funding and validation of your business idea by many potential future customers for your business. It's worth noting that equity crowdfunding may be a more accessible funding option than angel funding or venture capital for businesses looking to raise up to \$5 million.

8. Personal and Friends/Family Funding

Yes, personal funding is a viable option; and one of the ways many small business owners access capital. But using personal funds or personal loans is a gamble, and you'll need to do a solid job of calculating all of your costs, so that you don't run out of money before the business can support itself. Even if you use personal funds to start, we advise you to start taking steps to establish business credit right away.
