### **Governor Newsom Announces New Help** for Small Businesses & **Workers Displaced by** COVID-19

Governor Gavin Newsom unveiled a series of new resources to aid small businesses and help California workers who have lost work due to COVID-19.

Beginning tomorrow, California small businesses impacted by the COVID-19 crisis can apply for a loan from the federal government for up to \$10 million. Importantly, the program is firstcome, first-serve and the Governor encourages all eligible California small businesses to contact their lender to learn more.

Today, the Governor also announced that the state is allocating \$50 million to the California Infrastructure and Economic Development Bank for loan guarantees to small businesses to help eliminate barriers to capital for individuals who do not qualify for federal funds, including low wealth and undocumented immigrant communities. The state is also allowing small businesses to defer payment of sales and use taxes of up to \$50,000, for up to 12 months.

Additionally, the Governor joined Bitwise Industries and the Kapor Center to launch OnwardCa. org, a new platform connecting displaced California workers with more than 70,000 job opportunities in critical industries.

Earlier this week, Governor Newsom signed an executive order to help small businesses, granting a 90-day extension for small businesses to pay sales taxes.

Governor Newsom also today announced \$17.8 million in new state initiatives to support California workers impacted by COVID-19. The al-

## **How COVID-19 Is Affecting Construction Bidding & Jobsite Activity**

It's been 27 days since the World Health Organization (WHO) proclaimed the coronavirus outbreak a pandemic. In the U.S., as of April 7, there have been approximately 360,000 cases and over 10,000 deaths due to the virus

The situation is really starting to worsen as we're seeing more states, counties, and cities choose to close nonessential businesses or issue some sort of "stay at home" or "shelter in place" orders. These include states like California, Connecticut, Delaware, Kentucky, Illinois, Louisiana, New Jersey, New York, Ohio, Pennsylvania.

For the most part, construction activity has been included as essential activity that can continue with business as usual during these orders. Workers should try and maintain a 6-foot separation from others as much as possible and follow the CDC's guidelines for protecting themselves from being exposed to the coronavirus.

### **Construction Bidding Activity**

Here at ConstructConnect, we are still seeing a healthy number of new bidding opportunities (public and private) coming in, both in the U.S. and Canada. For the U.S., new public opportunities during the week of March 16 were down -3.62% and new private project bids were down -8.62% compared to the same time last year.

We also looked at projects that were currently bidding within the next 60 days with a mandatory pre-bid meeting scheduled for March 18 -20, 2020. Of those:

- 63.1% of the meetings were as scheduled
- 14.1% of the meetings dates were extended
- 16.5% of the meetings were cancelled

### Bid dates were also verified on the projects mentioned above:

80% of the bid dates are currently scheduled to open as originally advertised

- 10.3% have been extended
- 9.7% have been cancelled

### **Jobsite Activity**

As more state, county, and city agencies issue orders to "shelter in place" or "stay at home" in order to slow the spread of the coronavirus and flatten the curve, we are starting to see some construction activity halted and jobsites being temporarily shut down.

The Associated General Contractors of America (AGC) recently released a survey of their members regarding active projects and those expected to start in the next 30 days. For those projects, 28% of respondents said that they had been directed by an owner, government agency, or official to halt or delay starting on those projects.

For projects with start dates more than 30 days from now, 11% stated they had been instructed to halt or delay any work on those projects for the time being.

Delays and disruptions are also occurring due to a shortage of materials and equipment (16%), craftworkers (11%), government workers to issue permits, perform inspections, and award contracts (18%). Another 8% responded they had disruptions due to an infected individual en-

## Visa Foundation Pledges \$210M For COVID-19-Stricken **Businesses**

The Visa Foundation announced that it is pledging \$210 million to fund two different programs that will support small and micro enterprises that have been financially disrupted due to the coronavirus pandemic.

Money from the Visa Foundation will offer capital to non-government organizations (NGOs) and investment partners that assist small and micro-businesses.

The first program is a \$10 million fund that will provide fast emergency assistance to charities on the frontlines fighting the pandemic — public health and food relief — in North America; Latin America and the Caribbean; Europe; Asia Pacific; and Central Europe, Middle East and Africa.

"As COVID-19 continues to unfold, communities are feeling the effects and need our immediate support," said Al Kelly, chief executive officer (CEO) and chairman of Visa. "As a global company that operates a very local business, we recognize this need. We're also committed to the long-term recovery and will continue to explore ways we can accelerate economic activity in line with our mission to help individuals, businesses and economies thrive.'

The second program pledges \$200 million over five years to assist small and micro businesses worldwide. The focus will be on cultivating the economic advancement of women.

Small and micro-enterprises are the nuclei of the global economy. Visa maintains. They account for over 90 percent of businesses around the world and also account for 50 to 60 percent of global employment.

Further, there is a \$300 billion annual credit deficit in funding small businesses that are womenowned. The disparity is expected to grow because of the financial reality of the pandemic.

"Now more than ever, we must accelerate our support for small businesses on the frontlines driving economic growth," said Kelly. "As many small and micro business owners are women, there will be a ripple effect supporting women's economic advancement, which we believe is one of the most important ways to achieve gender equality, reduce poverty and foster inclusive economic development."

The Visa Foundation will distribute the \$200 million in \$60 million grants to NGOs that assist entrepreneurs in the regions where Visa operates.

"Two hundred million dollars in new financial resources demonstrates our continuing commitment to support small and micro businesses, with a focus on women's economic advancement globally," said Graham Macmillan, president of the Visa Foundation. "When women thrive, communities thrive. We know this matters now more than ever as the global economy seeks to recover and rebuild."

In other Visa news, the company announced it would delay the rollout of a new fee structure due to the coronavirus pandemic.

## Gov. Cuomo Slashes Medicaid as **New York Struggles to Get Handle** on COVID-19 Cases

New York remains the epicenter of the crisis in the U.S., representing nearly half of the country's fatalities. Over the weekend, more than 1 200 New Yorkers died within a 48-hour window, bringing the state's official death toll to over 4,000. There are over 123,000 confirmed cases. New York City Mayor Bill de Blasio said the city has enough medical supplies to last until Tuesday or Wednesday, as he repeated a plea for any available healthcare workers to join the fight against the pandemic.

Mayor Bill de Blasio: "Please, we need your help. We need supplies. We need medical personnel to come forward to volunteer. We will compensate them, but we need them to come forward and give us their time and energy where it's needed most."

At his briefing, Mayor de Blasio also blamed the surge in New York cases on the lack of early testing and mobilization from the federal govAs New York races to keep up with the explosion of coronavirus cases, progressive critics say the state budget agreed to by Governor Cuomo and the New York Legislature last week will harm New Yorkers already suffering the most from the coronavirus crisis. The \$177 billion budget will slash the state's Medicaid program by \$2.5 billion a year, including a \$400 million cut in money for hospitals. The budget also rolls back

Meanwhile, a prisoner at Rikers Island in New York has died of complications from COVID-19. Hundreds of prisoners and prison workers at facilities across the city have tested positive as calls mount to release more detainees in order to stem the spread of the coronavirus

## Which NYC construction projects are 'essential' right now?

By Amy Plitt and Caroline Spivack,

In the past week, construction in New York City has largely ground to a halt after Gov. Andrew Cuomo deemed most work on buildings and other sites nonessential in an effort to stop the spread of the novel coronavirus

"We're closing down nonessential construction sites," Cuomo said at the time. "Some construction is essential to keep the place running, but nonessential construction is going to stop.'

But what is considered essential at this time? Cuomo's directive made exceptions for some crucial work, including on infrastructure, hospitals, homeless shelters, and affordable housing, along with emergency repairs. And now, the city's Department of Buildings has launched a map that shows where these projects are underway.

The map includes active construction sites that have been deemed "essential," with the option to select a particular type of project—hospitals, an affordable housing development, and so on and see where those are still operating in all five boroughs. It's informative to see where construction has been allowed to continue, and may be useful if you suspect nonessential construction work is happening near you. The DOB has asked New Yorkers to report any suspected violations to the agency through 311.

The pause on nonessential construction—which includes many office buildings, luxury condos, and work that was underway on major megaprojects-came after reports that construction had continued on sites where workers tested positive for COVID-19. Some sites, including LaGuardia Airport and the Moynihan Train Hall, temporarily stalled work due to sick workers.

As the number of confirmed COVID-19 cases ballooned statewide, lawmakers criticized the governor and the mayor for allowing work on high-end apartments and office space to endanger the health of workers, who could not practice safe social distancing on work sites, and their families. Those who violate the order may be subject to fines of as much as \$10,000.

PISO utilizes the latest available charging technology to provide an affordable, approachable and modern charging experience at hundreds of locations throughout New York State. PI-SO's client roster includes universities and colleges, municipalities, residential developments, retail centers, the hospitality industry, and will soon include locations along the New York State Thruway through a sizeable contract from the New York Power Authority.

While the details are still being determined, it is anticipated that TAC's new location will offer additional dedicated offices and rehearsal rooms to address the growing demand for these amenities. TAC's ever increasing membership base makes one thing clear: that the performing arts are enjoying a heyday in New York City, and The Artist Co-op is an important factor in this success.

# Senate COVID-19 Relief Bill Put Corporations First – Now, Let's Take Care of People

The COVID-19 pandemic has illuminated glaring structural and racial inequities in American society. What the Senate has put forth is not nearly good enough.

US House Speaker Nancy Pelosi speaks with reporters during her weekly press conference at the US Capitol March 26, 2020, in Washington, DC. – The US Senate unanimously passed the nation's largest-ever rescue package late March 25, 2020, a \$2 trillion lifeline to suffering Americans, critically depleted hospitals and an economy ravaged by a rapidly spreading coronavirus crisis. The measure now heads to the House of Representatives, where a Democratic leader said he expected it to pass by voice vote March 27 before it goes to President Donald Trump for his signature.

The Senate's approval of a COVID-19 relief and economic stimulus package—seemingly on track toward House approval as we write this—marked a significant first step. Cash payments and increased unemployment benefits will provide some help to many, but in truth this bill did more for corporations than people. Much more will be needed to support American families, particularly in the communities of color that have been especially hard hit by the pandemic and the economic crisis it has caused.

While the payments to families, expanded unemployment insurance and support for small businesses included in the bill will help to slow the bleeding, they represent just the beginning of what we must do. We need a plan for a just recovery that supports workers and families and recognizes the special challenges faced by communities of color, where families and small businesses have fewer resources to fall back on. In addition, we also need a long-term plan that addresses structural racism and inequality while moving us toward a more environmentally sound, healthier, more sustainable economy.

While it provides some needed short-term help, the current bill represents just the first, small step in a journey toward an economy that truly works for all

In the near term, another round of relief and economic stimulus will be needed, and soon. As they consider next steps, Congress and the president must consider the following:

• Implementation will be critical. The oversight committee that will oversee aid to companies must look like America—not like corporate America—with at least three of five members being nonwhite and at least three being women. The inspector general's and oversight committee's purview should

be expanded to include a review of the small business fund. This oversight should include a report within six months examining how long it has taken for funds to reach small businesses and to what extent those funds have reached businesses owned by people of color

- Families need consistent cash payments for the next 12 months. Economists are predicting "an economic tsunami" that will not end in a few weeks or even a few months. A one-time payment of \$1,200 just isn't enough
- Small businesses need an additional recovery package that matches the \$500 billion industry funding in the current bill. They also need a pause in debt payments and incentives for landlords to pause commercial rent payments
- Homeowners and renters need a 12 month pause in housing payments, along with no foreclosures, evictions, or utility shutoffs during that same period. Such actions should also include a particular focus on immigrants and unhoused populations
- Students need their debt wiped clean, which will add \$100 billion in economic activity to the economy
- Cities need urgent help. The Federal Reserve should ramp up its acquisition of local municipal bonds so that cities have the funds needed to support communities

- Nonprofits, especially grassroots organizations providing desperately-needed community services, need a bailout. This economic tidal wave threatens small and medium-sized nonprofits, especially those led by people of color, and they need assistance equivalent to the roughly \$60 billion being set aside for airlines. These organizations provide critical support to domestic violence victims, unhoused persons, those struggling with substance abuse and more and those critical services are in danger unless these groups get support, and soon
- Ensure access to health services. The gaps in our health care system have never been more glaring. The \$130 billion in aid for hospitals should ensure that funds are used to remove barriers to accessing care for low-income people who may lack adequate health coverage

Speaker Pelosi has stated that another round of recovery legislation is already in the works. Greenlining's proposals, and the values they represent, should be considered in the follow up legislation, but even they represent just a beginning. The COV-ID-19 pandemic has illuminated glaring structural and racial inequities in American society. It's long past time we had a serious conversation about how to rectify them permanently.

# We can rebuild a better California in the wake of the coronavirus pandemic

The coronavirus pandemic has been a time of heroism: medical professionals saving lives, workers checking people out at the grocery, public officials preparing their communities. Many of these heroic actions, though, are happening in spite of the economic and government systems that we had in place before the crisis.

As we recover and rebuild – and we will – we must take the opportunity to address these short-comings in California. We must recommit ourselves to providing real economic equity. We must create a government that works for the people. And we must track our progress toward these goals in a way the public can see and trust.

Before the COVID-19 pandemic, Gov. Gavin Newsom's administration, the Legislature and local governments were all committed to creating a "California for All." One example is the Regions Rise Together initiative that California Forward and the leaders of our California Stewardship Network launched last year with the Office of Business and Economic Development and the Office of Planning and Research.

At inclusive gatherings throughout the state, we saw energized business, nonprofits and faith leaders come together with public officials to work on improving the economies in their communities. And racial equity was at the center of these conversations as modeled by the Fresno DRIVE process celebrated when we hosted last vear's California Economic Summit.

Despite these good efforts, California still has the highest level of real poverty, and there are profound differences in economic outcomes for people across different ethnicities and geographic regions. These inequities have been magnified during the crisis when we are often depending the most on those who have the least financial security. As we move forward with our efforts, we must double down on inclusive planning that provides economic equity for all.

The second deficiency in our state is the siloed structure of our budgeting process, which can stand in the way of developing a cohesive fiscal strategy that is flexible in the times of crisis. The complexity of constitutional spending restrictions and an almost infinite number of special funds means that it is nearly impossible to set priorities and adapt policy to achieve them.

The state is now seeing the prudence of recent reforms such as the creation of the Rainy Day Fund, which California Forward was among the first to propose in 2009 right after we were created by the state's largest philanthropies in the wake of the last economic crisis.

There will be more work to do to build on what we are learning in this moment. This is also true of regulations that are being relaxed such as those preventing medical professionals from putting their full training to work to serve the state. Many of these rules were not good ideas in good times, and we will be well served not to bring them back.

Finally, the state must use the period of recovery to recommit to measuring whether we are making real progress toward creating inclusive and environmentally sustainable economic growth. We have lots of policies in place to achieve those ends, but they are not often measured in terms

of outcomes and rarely changed to be more effective.

A central tool for doing this will be the California Dream Index, a project that we are working on with the state and a broad coalition of partners

that use evidence to drive better public policy in areas from racial equity to children's health. The intention is to align these efforts around a tight set of measures of economic mobility and security. This will give us a "North Star" as we rebuild more equitably. Finally, we hope that the period of recovery will be one of humility, when we recommit to working together across parties, regions and interests to truly create a better state for everyone who lives here. Only then will we rebuild a better California.

# How COVID-19 Is Affecting Construction Bidding & Jobsite Activity

tering a jobsite and possible infecting it and 14% stated they hadn't had any delays due to any of these reasons.

Getting materials and building supplies is also starting to potentially affect construction schedules with 22% of respondents acknowledging they or their subs have been notified that deliveries will be delayed or cancelled.

### **Timeline of Jobsite Delays and Disruptions**

While it appears that construction is continuing across most of the country, that could quickly change if stricter guidelines are enacted or if government agencies decide to make adjustments to what they consider essential work.

Also, if county and city building and planning departments start shutting down, it could put a halt to current and upcoming construction projects because permits aren't being issued and inspections aren't being conducted, regardless of whether construction is allowed to continue.

Here's a timeline of what we know so far regarding construction stoppage as a result of the coronavirus:

March 16, 2020 – PennDOT closed all district and county maintenance offices until March 30. All construction projects have been suspended until further notice.

Week of March 16, 2020 – The South Dakota DOT offices are closed until March 30. Construction was halted on all but two high priority projects and March 18 bid lettings were postponed until March 25. DOT staff are expected to be working remotely to perform essential functions and construction projects were expected to resume this week.

March 17, 2020 – The City of Boston was the first major city to shut down all construction activity, except for emergency work. Employers have until March 23 to secure their jobsites after which only skeleton crews will be allowed on sites to ensure safety until the suspension is lifted.

March 17, 2020 – Seven San Francisco Bay Area counties issued a shelter in place order until April 7. All construction projects must temporarily shut down with the exception of public works and all housing construction. The San Francisco Department of Building Inspection is resuming operation this week with limited services to keep those projects moving.

March 17, 2020 – Walt Disney World shut down all construction activity. There are a number of new attractions and resorts under construction including: the Star Wars: Galactic Starcruiser resort, TRON Lightcycle Run, Remy's Ratatouille Adventure, and Guardians of the Galaxy: Cosmic Rewind.

March 18, 2020 – Cambridge, MA issued a "Temporary Emergency Construction Moratorium on all construction activity on both public and private property until further notice."

March 18, 2020 – Shell Chemical Appalachia announced they were temporarily suspending construction on their petrochemical plant in Potter, PA. Construction on the \$6 billion ethane

cracker plant began back in November 2017 and had about 7,000 workers on the jobsite before the shutdown. Construction is expected to resume in phases once new mitigations measure are in place.

March 19, 2020 - Pennsylvania Governor Tom Wolfe ordered all "non-life-sustaining" businesses to close their physical locations to prevent the spread of the coronavirus. This includes all residential and nonresidential construction. Enforcement of this order was pushed back to March 23 at 8:00 a.m. to allow businesses to complete waivers to remain open. Businesses cannot reopen until their waiver has been reviewed and approved.

March 20, 2020 - In Pennsylvania, a revised list was issued that exempted emergency repairs for the construction industry from being considered nonessential as well as allowing all healthcare construction to continue.

March 23, 2020 - Washington Governor Jay Inslee ordered all nonessential businesses to cease operations starting at midnight on March 25 and running through at least April 8. This includes construction sites and project except for those deemed essential like infrastructure and healthcare facilities.

March 23, 2020 - Disneyland and Disney California Adventure have halted construction on all current and upcoming construction and renovation projects including: for work on Marvel's Avengers Campus, the Haunted Mansion, Mickey's House, Mickey and Minnie's Runaway Railway, Indiana Jones Adventure, Space Mountain, Tom Sawyer's Island, and Disneyland's Frontierland entrance.

March 23, 2020 - Michigan Governor Gretchen Whitmer ordered all noncritical businesses to close beginning at midnight on March 24 and running through at least April 13. This includes construction with a few exceptions such as "construction to maintain and improve essential public works like roads, bridges, the telecommunications infrastructure, and public health infrastructure. Construction workers may also undertake such projects as necessary to maintain and improve the safety, sanitation, and essential operations of residences. In addition, businesses may designate construction firms to provide necessary support to the work of the businesses' critical infrastructure workers."

Michigan State University, as a result of the governor's executive order has stopped work on all construction projects.

March 23, 2020 - Atlanta Mayor Keisha Lance Bottoms issued a stay-at-home order for the city starting March 24 and running through April 7, except for essential businesses and activities. Public works construction was on the list as being essential but it is unclear if any commercial construction can continue during this time.

March 25, 2020 - Washington Governor Jay Inslee issued a memorandum to the stay-at-home order stating that in general, commercial and residential construction was not considered essential. There are a few exceptions, including for construction related to essential activities identified in the original order.

March 27, 2020 - New York Governor Andrew Cuomo halted construction on almost construction projects. Only projects deemed essential by the state can continue work and include things like roads, bridges, hospitals and healthcare facilities, and affordable housing. Contractors who do not comply with the new measure could faces fines of up to \$10,000 in fines per violation.

## States With "Stay at Home" Orders and What Construction is Essential

### Alabama - Effective April 4

"Construction and construction-related services, including building and construction, lumber, building materials and hardware businesses, electricians, plumbers, other construction tradesmen and tradeswomen, exterminators; cleaning and janitorial, HVACR and water heating businesses; painting, moving and relocating services, other skilled trades, and other related construction firms and professionals for maintaining essential infrastructure"

#### Alaska - Effective March 28

"public works construction, construction of housing"

### Arizona - Effective March 31

"construction (including, but not limited to, construction required in response to this public health emergency, hospital construction, construction of long-term care facilities, public works construction, and housing construction)"

### California – Effective March 19

"Construction Workers who support the construction, operation, inspection, and maintenance of construction sites and construction projects (including housing construction)"

### Colorado - Effective March 26

"Construction, Including but not Limited To:

- Housing and housing for low-income and vulnerable people
- Skilled trades such as electricians, plumbers
- Other related firms and professionals for who provide services necessary to maintain the safety, sanitation, and critical operation of residences and other Critical Businesses or Critical Government Functions, and other essential services"

### **Connecticut – Effective March 23**

"Construction including:

- all skilled trades such as electricians, HVAC, and plumbers
- general construction, both commercial and residential
- other related construction firms and professionals for essential infrastructure or for emergency repair and safety purposes

• planning, engineering, design, bridge inspection, and other construction support activities"

### **Delaware – Effective March 24**

All construction can continue

### District of Columbia – Effective April 1

"Construction and building trades, including plumbers, electricians, exterminators, carpenters, "big box" supply stores, HVAC distributors, and businesses that sell supplies and materials for the maintenance of commercial and residential buildings and homes"

### Florida - Effective April 3

Construction activity can continue. Governor Ron DeSantis is planning to accelerate some highway infrastructure projects citing reduced traffic as a result of the pandemic.

### Georgia - Effective April 3

Construction work can continue. Back on March 20, Governor Brian Kemp suspended waiting periods for contractors to be able to use private firms for code inspections and plan reviews.

### Hawaii – Effective March 25

"Critical trades. Building and Construction Tradesmen and Tradeswomen, and other trades including but not limited to plumbers, electricians, exterminators, cleaning and janitorial staff for commercial and governmental properties, security staff, operating engineers, HVAC, painting, moving and relocation services, and other service providers who provide services that are necessary to maintaining the safety, sanitation, and essential operation of residences, essential activities, and essential businesses and operations"

### Idaho – Effective March 25

"Essential infrastructure, including:

- Public works construction
- Commercial construction
- Construction of housing (in particular affordable housing or housing for individuals experiencing homelessness)"

### Illinois – Effective March 21

Construction is considered essential.

### Indiana – Effective March 24

"Building, construction, and other trades, including, but not limited to, plumbers, electricians..."

### Kansas - Effective March 30

"Provide and Maintain Critical Infrastructure

- 1. Construct or repair roads
- . Construction, maintain, or clean buildings"

### **Kentucky - Effective March 26**

"Building and construction" were on the list of businesses that can stay open.

### Maine – Effective April 2

"construction and maintenance of essential infrastructure"
