# Increase funding to benefit California's science and innovation ecosystem

The COVID-19 pandemic has shined a spotlight on the important role science plays in addressing any public health crisis. It has also reinforced that basic research and scientific discovery require purposeful, proactive funding – and the government is part of that equation.

But such funding is not just about addressing a global health crisis. Science and innovation also drive development of the jobs of tomorrow, critical to ensuring we can compete on a global scale. President Joe Biden drove these points home during his recent State of the Union address, and support for science has been a bipartisan priority.

Congress now has an opportunity to make that happen by adopting bipartisan innovation legislation and increasing science funding in fiscal year 2023 spending legislation. Doing so would benefit not just our nation, but also California's knowledge economy.

The largest share of research performed at California's universities is funded by the federal government. California is also top ranked among national leaders in many metrics of science and innovation, including business research and development, aca-

demic lab space, inventions and patenting, science and engineering graduate students – and even federal and state R&D expenditures.

California's contributions to the digital economy are well known, as are our world-leading science powerhouses such as Caltech, Stanford and the 10 University of California campuses, and major labs such as NASA's Jet Propulsion Lab, the Salk Institute for Biological Sciences, and the Scripps Research Institute.

Our manufacturing and agriculture sectors also contribute nearly \$400 billion to the state economy every year, per U.S. Bureau of Economic Analysis data, with major sectors including computers and electronics, aerospace and pharmaceuticals. These sectors directly benefit from federal investments in materials research, crop science, chemistry and other areas.

Last summer, federal policymakers made progress on annual spending bills, where the bulk of federal science investments are funded, but that effort stalled amid other priorities and political battles. The recently passed appropriations package is not at the level of investment needed to meet either Biden's vision or that of the bipartisan legislators who crafted the bills.

## Administrator Guzman Announces 70% Increase in Industries Eligible for Women-Owned Small Business Federal Contracting Program

The U.S. Small Business Administration today published an updated list of eligible industries for federal contracting set-asides for the Women-Owned Small Business Federal Contracting Program (WOSB Program) based on a recent study analyzing industry gaps for women-owned businesses. The study, commissioned by the SBA, showed that women-owned businesses are underrepresented or substantially underrepresented in the federal marketplace across hundreds more North American Industry Classification System (NAICS) industries.

The updated list will support agencies in allocating set-asides for WOSB and economically disadvantaged women-owned small businesses (EDWOSBs) across more industries, potentially resulting in hundreds of millions of dollars in additional set-aside opportunities for women entrepreneurs.

"President Biden came into office with a commitment to put equity at the heart of everything we do, and advance reforms that open the doors of opportunity and prosperity for every entrepreneur," SBA Administrator Isabella Casillas Guzman said. "The pandemic disproportionately impacted women entrepreneurs who were challenged by early access issues to financial relief

and disruptions in childcare, among other issues. Thanks to the American Rescue Plan and actions of the Biden-Harris Administration, we have invested billions of dollars in relief to women entrepreneurs. And we are committed to doing more. This new rule expanding the WOSB Program will help more women seize potentially hundreds of millions of dollars more in federal procurement opportunities across 92% of all federal small-business contract spending. Small business ownership is an important pathway to independence and generational wealth building, and this change will help to further clear that path for more women entrepreneurs and reverse decades of inequity, discrimination and underinvestment that have held back America's women entrepreneurs for far too long.'

Per the Small Business ActSBA conducts a study every five years to identify industries in which small businesses owned and controlled by women are underrepresented or substantially underrepresented in the federal marketplace. Based on the results of the commissioned study, the SBA will increase the number of WOSB Program eligible industries from 444 to 759, which represents a 70% increase. These changes are

effective immediately and apply to new solicitations. The expansion of the program will provide a broader range of industries for contracting officers to offer restricted-competition contracting opportunities to SBA-certified WOSBs and EDWOSBs. Some of these additional industries include Temporary Help Services, Home Health Care Services, Electronic Computer Manufacturing and Air Transportation Support.

After consulting SBA's WOSB Program industry list, federal procuring agencies elect whether to limit competition to certified WOSBs or certified EDWOSBs. SBA's new industry list covers NAICS codes that account for 92% of all small-business prime-contract spending, representing increased opportunities as previously the list covered just 75% of that spending.

Plumbing dates back to ancient civilizations; these societies relied on channels and pipes to irrigate crops, remove waste, and provide potable water to inhabitants. Plumbing technology has since evolved immeasurably. However, one fact remains: plumbing is vital to the way we live and work today. This is especially true for commercial and residential construction sites, where plumbing contractors play an essential role between general and specialty contractors alike.

Regardless of the scope and size of the project, plumbing projects are always one of the top considerations for builders.

The plumbing contracting industry continues to grow at a promising rate. The Bureau of Labor Statistics has projected employment to grow 5% between 2020 and 2030. This growth and recent changes in the construction landscape present both challenges and opportunities for plumbing contractors. To achieve the greatest possible business outcomes, contractors must harness leading-edge strategies and purpose-built technology to deliver high-quality, consistent work.

Plumbing Contracting in 2022 and Beyond

As specialty contractors, plumbing contractors bring a specialized skill set, industry-specific processes, and unique workflows to every project. These processes and workflows are often some of the first ones introduced to a project. They serve as the base for other specialty contracting activities.

Within these projects, plumbing contractors must navigate requirements and processes from both general and specialty contractors. Doing so requires significant investment in monitoring timelines, building in efficiencies, and managing budgets to ensure the best results and greatest profitability.

The industry landscape looks different than in years past. The current market size is estimated to be \$107 billion. The industry is ranked fifth in the construction industry in terms of market size.

However, the construction industry is still recovering from the effects of the pandemic. The current 2022 growth rate for construction has been predicted to be around 3.9%. Contractors can expect to see the greatest impact on business development, contract management, planning and scheduling, and materials and workforce management in the supply chain. Plumbing contrac-

In addition, the U.S. House and Senate are gearing up to merge competing innovation bills passed by each chamber in a rare bipartisan feat, and the next spending cycle is just kicking off. Altogether, this bipartisan legislative moment presents an opportunity to increase funding that will drive the science and innovation ecosystem throughout our state, and the nation overall. Perhaps this effort can help heal some of our divisions too.

This is where the California delegation comes in. Our state's congressional delegation includes appropriators and federal legislators like Democratic Sen. Diane Feinstein and Reps. Ken Calvert, a Republican from Corona; Pete Aguilar, a Democrat from San Bernardino; Mike Garcia, a Republican from Santa Clarita; and Norma Torres, a Democrat from Pomona. Each is in a position to advocate for these funding increases.

They can make the case that these bipartisan efforts are worth the investment – not just for our nation, but also for our current and emerging scientists and innovators throughout the state who could use the boost to discover the next breakthrough in science that could save lives. We need the scientific workforce of the future.

Congress could also increase funding for the Space Grant and Sea Grant college programs. Working with hundreds of scientists at dozens of California universities and community colleges, these federal programs provide local opportunities for space and oceanic research, industrial partnerships and educational opportunities for California students.

If we let this moment slip away, a once-in-a-generation opportunity will be lost, leaving important investments on the table. Congress should pass the bipartisan innovation legislation and ensure that we increase spending in the next fiscal cycle. You never know when the next pandemic or major crisis might hit. We need to be prepared.
