Top Sustainable Construction Materials to Build a Better Future

One of the things that often comes up when discussing the future of construction is sustainability. The building sector is one of the largest contributors to greenhouse gas emissions (GHG), with occupied buildings being responsible for nearly 40% of global GHG emissions, according to Architecture2030.

Sourcing and manufacturing building materials also contribute a great deal to climate change. According to a report by the United Nations Environment Programme:

Some 40-50% of total flow of raw materials in the global economy is used in the manufacturing of building products and components, adding significant amounts and energy and greenhouse gas emissions to the life cycle impact of buildings. In addition, scarcity concerns over mineral resources and especially water provide for an additional urgency to extend the narrow focus on energy use in buildings and the associated greenhouse gas emissions.

The construction industry clearly has to do better to protect the environment. This is, after all,

the only planet we can live in (that we know of), so promoting sustainability will serve us — and future generations.

The good news? Construction pros are already taking steps in the right direction. Builders are now exploring sustainable construction materials to replace things like concrete, which is a major source of emissions.

This post rounds up some notable examples of sustainable construction materials. Have a look and see if you can use them in your projects.

1. Bendable Concrete

Also known as Engineered Cementitious Composite (ECC), bendable concrete is a type of concrete that can withstand bending. Unlike conventional concrete, which is brittle and can easily crack or break, bendable concrete is five hundred times more resistant to cracking and is more effective at absorbing shock.

This is because ECC contains small, polymerderived fibers that increase the material's ductility. While bendable concrete is made up of the same ingredients as its traditional counterpart, it's these fibers that make ECC more flexible and durable.

5 Organizations Empowering Marginalized Communities In California

This list, presented in no particular order, highlights some institutions working to improve the lives of marginalized populations in the Golden State.

Kicking off the list at #1 is East Bay Housing Organizations, or EBHO. Its mission is to ensure that all people in Alameda and Contra Costa counties have a safe, healthy, and affordable place to call home. The group's Resident

Organizing Program seeks to empower tenants to become affordable housing advocates. This committee runs leadership trainings and engages residents in local policy and neighborhood decisions

EBHO's Faith and Justice Committee develops and maintains collaborative relationships with faith communities, leaders, and inter-religious organizations. The committee's goal is to advance housing rights through the engagement of these groups in policy advocacy campaigns and participation in the movement for housing justice

Taking the #2 spot is the Chinese Progressive Association. This nonprofit works to educate, organize, and empower the low-income and working-class immigrant Chinese community in San Francisco to build collective strength with other oppressed communities to demand better

living and working conditions and justice for all people.

"Organizing has always been key to liberation efforts for several oppressed groups, whether it be through planning solidarity marches, mutual aid efforts, or even approaching government leaders. There are several groups doing this work in Asian-American communities including the AAFC, Stop AAPI Hate, the APEN, the Chinese Progressive Association, Womankind, Filipino Cultural Center, the Southeast Asian Community Alliance, and others. Lai Wa Wu of the Chinese Progressive Association said that participating in such groups is a great way to be an active ally to Asian American communities."

Calling All Contractors: City of San José to Launch Unique Construction Academy in Spring 2021

"Building Our City With Our Community"

Vice Mayor Chappie Jones is encouraging contractors across Santa Clara County to participate in the San José Public Works Department's upcoming Construction Academy's Construction Contracting Seminar Series (Seminar Series) beginning in the Spring. It is a unique program available in only a handful of cities across the nation. It was initiated in 2019 as an effort to prioritize small and local business and provide them with opportunities to financially participate in construction projects. This could lead to significant rewards considering the City's five-year Capital Improvement Program is valued at over \$4 billion.

Vice Mayor Chappie Jones, Chair of the City's Small Business Advisory Task Force, shared "Our measurement of success is when we have a

strong and vibrant small business community in San José that is winning contracts and creating wealth and employment in our communities." By completing the Seminar Series, participants benefit by learning how to navigate and manage a public works construction contract from bidding to project completion.

Matt Cano, Director of Public Works for the City of San José noted, "As stewards over a multibillion dollar capital improvement program, we have a responsibility to not only construct quality projects, but also to engage our community in the construction of these projects, thus increasing opportunities for local residents and businesses."

The Seminar Series will occur weekly for six weeks from May 5 to June 16 from 4:30 to 7:00 p.m. Attendance will help contractors streamline

their processes, avoid pitfalls, and place them in the best position to bid on and complete a public works project. Registration is available at www. sanjoseca.gov/constructionacademy.

In addition, two free virtual Opportunity Awareness events are scheduled for April 21, 2021 from 9:00 to 10:00 a.m. (Session A) and 4:00 to 5:00 p.m. (Session B). Attendance is optional and participants are encouraged to register for one session. Both sessions will contain the same agenda and programmatic information. These events will allow contractors to learn about new public works bid solicitations and they will offer networking opportunities with City staff, prime, and subcontractors. Registration is available at www.sanjoseca.gov/constructionacademy.

The program was initiated in coordination with various San José City departments, the Silicon

Valley Small Business Development Center, local chambers of commerce, and the City's Small Business Advisory Task Force. Three cycles of the Construction Academy have been successfully completed thus far. As the City continues to work to increase small and local business participation, Vice Mayor Chappie Jones remains optimistic and shared, "I am encouraged by the progress the City of San José has made. With the advice and guidance from the San José Small Business Advisory Task Force, City staff has been able to design programs that meet the needs of our City's small businesses. I look forward to continuing to expand opportunities for small business to work with the City."

U.S. EPA announces nearly \$200,000 to Small Northern California Businesses for Developing Environmental Technologies

The U.S. Environmental Protection Agency (EPA) announced \$2,499,229 in awards to 24 U.S. small businesses to develop innovative technologies that help support EPA's mission of protecting human health and the environment. The Small Business Innovation Research (SBIR) program is a competitive awards-based program, which funds technological research and development and revitalizes innovation. Two of the SBIR program awardees, Nikira Labs and Verdant Structural Engineers (VSE), are based in northern California. Each company has been awarded nearly \$100,000.

"Small businesses are confronting important environmental challenges head on with creativity and ingenuity," said EPA Acting Regional Administrator for the Pacific Southwest, Deborah Jordan. "I congratulate the small businesses from California and Hawaii who are receiving EPA funding this week. EPA is proud to support their efforts to develop innovative environmental solutions."

EPA is one of 11 federal agencies that participate in the SBIR program established by the Small Business Innovation Development Act of 1982. The small businesses in this week's announcement are receiving Phase I awards of up to \$100,000 for six months for "proof of concept" of their proposed technology. Companies that successfully complete Phase I can then submit a proposal for a Phase II award of up to \$400,000 to further develop and commercialize the technology.

Nikira Labs is in Mountain View, California. The company is proposing to develop a sensitive, fast, and highly-selective ethylene oxide analyzer suitable for field-deployment. This analyzer technology has potential for detecting ethylene oxide emissions to reduce health risks in both in the medical sterilization and petrochemical markets.

"This EPA SBIR award will help Nikira Labs develop novel pollutant monitors, which is critical in supporting such high-risk, high-reward technologies that address tomorrow's health and

safety needs," said Rupal Gupta, Nikira Labs' CEO and President.

VSE is in Berkeley, California. Their projects include carbon-storing (sequestering) straw-based structural insulated panels (S-SIP) for residential building applications in the U.S. These panels will reduce carbon emissions, toxicity, and end-of-life waste associated with building materials. VSE has extensive experience with environmentally sensitive building materials and methods such as straw bale, rammed earth, cob, adobe, and bamboo.

"Using less to produce our existing building materials has obvious limits in its potential, as an approach to reduce embodied carbon emissions," said Anthony Dente, PE, LEED AP, VSE. "Storing carbon in our buildings with bio-based insulation systems like straw, is a clear path to a low carbon or negative carbon building future. Verdant Structural Engineers are grateful to the EPA and SBIR grant program for the opportunity to use our knowledge and experience with cut-

ting edge straw building engineering and science to develop a reliable, repeatable, and affordable straw panel system."

EPA runs a yearly, two-phase process for the SBIR awards. Companies who have received the Phase I award can submit a proposal for a Phase II award of \$400,000 to further develop and commercialize the technology. Through this phased approach, EPA can evaluate whether the research idea is feasible; if the firm's research is high-quality; and if sufficient technical and commercial progress has been made to justify a larger Phase II effort.

Small-Business Loan vs. Business Credit Card: How to Choose

Small-business loans vs. business credit cards: Which is best for me?

Small-business loans are a good choice if you're looking to refinance an existing debt, buy real estate or equipment, or make any type of large investment, as these loans provide a larger sum of money. They typically are repaid monthly at a fixed interest rate, making them a good option for financing large investments over a long time

These loans, however, are tougher to get approved for than business credit cards, may require collateral and it can take a long time to get funded, depending on the lender. They're best for more established businesses because you'll likely need strong revenue and business finances to qualify.

Business credit cards are generally better suited to financing ongoing expenses and working capital. A credit line offers flexibility, and you pay interest only on what you borrow, up to your

Business credit cards can carry many advantages, such as rewards for spending, 0% introductory annual percentage rates, sign-up bonuses and the ability to build business credit. However, these revolving lines of credit may come with high interest costs and other fees.

Small-business loans: Pros and cons

Borrowing amounts are higher: Small-business loans guaranteed by the U.S. Small Business Administration have a maximum size of \$5 million, while online lenders provide up to \$2 million. This makes small-business loans better for a major expansion, such as purchasing or renovating real estate, buying equipment, financing inventory or refinancing debt.

Costs are lower: Traditional banks typically offer the lowest interest rates for businesses with strong finances. For instance, SBA loans backed by the Small Business Administration but issued by lenders such as banks — are likely to carry lower interest rates than business credit cards. SBA loan rates are set using the current prime rate. An SBA loan of more than \$50,000 and paid off in under seven years, for example, carries an interest rate of 6.5%, while a loan of \$25,000 or less that's paid off in over seven years carries a rate of 9%

Online lenders may also charge lower rates than business credit cards, with APRs starting at 6% for term loans and 8% for lines of credit — typically if you have strong personal credit and business finances.

Long repayment terms are available: Smallbusiness loan repayment terms vary by lender but can stretch as long as 25 years for some SBA loans. This results in much more affordable monthly payments for businesses looking to make a major investment in their business.

Let's say a business is approved for a \$30,000 loan. If the loan has a five-year repayment term at 10% APR, the business owner must make 60 monthly payments of \$637.

Check out NerdWallet's business loan calculator to see the cost and payments for business loans.

You may need collateral: Some small-business loans require collateral — assets such as equipment, inventory or real estate that the lender can seize if you fail to make payments. Collateral and personal guarantees are required as security on all SBA loans

Although a default could result in forfeiting the asset, putting up collateral is likely to get you a lower interest rate on the loan than what you'd receive with a business credit card or an unsecured online loan.

Qualifying is harder: Getting approved for a small-business loan likely is tougher than for a business credit card. In September 2017, big banks — those with \$10 billion or more in assets — approved 24.8% of small-business loan applications, while alternative lenders approved 57%, according to Biz2Credit.

To qualify for a traditional bank loan, you'll need good personal or business credit and collateral. For larger loans, you may need a down payment. Traditional banks typically require a lot of

documentation, including personal and business financial statements, profit and loss statements, income tax returns and a detailed business plan to prove you can repay the loan.

Many alternative business lenders also require a solid track record of business finances and an average to good personal credit score.

Time to funding is longer: It can take a few weeks or longer to get funding, depending on the lender, while you can get a business credit card within a week after approval.

Bank loans may require you to apply in person and fill out paperwork. You can complete applications at online lenders entirely online and get funded as fast as 24 hours to a few days. However, rates may be higher than at banks.

Business credit cards: Pros and cons

You might get rewards or cash back: Just like regular credit cards, business credit cards may offer you rewards or cash back on purchases

However, the rewards may be for business ex-

penses. For example, some cards offer cash back for spending on internet and cable, phone service, gas and office supplies. If a card offers 3% cash back on office supplies and you spend \$1,000 per month for your business, that's \$30 back in the form of a statement credit or in your bank account.

From art to infrastructure, the New Deal shaped Seattle's future

Every day is infrastructure week at our place.

In front of our apartment they're building the new State Route 520 bridge. That's right, it's not done yet. Enormous cranes, pile drivers, the removal of massive slabs of concrete, work boats, vehicles that clank like tanks in the night, workers in hard hats shouting to one another. They are working 24/6, with Sundays off. There is no real limit on the amount of noise they can make, day or night.

As I watch, I remember the opening of the old Evergreen Point Bridge in 1963, the last remnants of which are being hauled away now. We called it "the new bridge" for years. It's an odd feeling to outlast "modern infrastructure," something you remember being built. I felt the same about the Kingdome, the massive but ultimately ephemeral sports stadium located in the industrial district. It opened in 1976 and was torn down in 2000, before its bonds were paid off.

The old 520 bridge was outdated for seismic reasons. The new "new" bridge is more robust, and caters to changing needs. There's room now for bikes, pedestrians and, someday perhaps, even light rail. If earthquake faults played a role in

the new design, so too do the work habits of a changing region. Companies such as Microsoft wanted more capacity for cars and transit. Workers used to commute from the Eastside to Seattle for work, but back in the 1990s, the tide changed, with many tech workers living in the city and commuting to Redmond. The bridge was expanded to serve a growing "edge city."

This late 1930s apartment complex I live in is the product of an older infrastructure push. Unlike the 1963 bridge, it is still going strong. Hundreds of units of what we would call today "workforce housing" were put up in the late 1930s with the help of New Deal financing. Press reports when the complex opened touted it as the largest multifamily development west of the Mississippi, the Great Depression having put a major kibosh on growth. Times were tough in Seattle, too. Between 1930 and 1940, the city gained only 2,700 residents, and a series of Hoovervilles for homeless and unemployed people sprang up across the city. By the mid-1930s, Seattle's unemployment rate hit 27%. Still, as part of the recovery, Seattle prepared for the future by building public housing and expanding options for in-city working families.

Coming out of the 1918 flu pandemic, Seattle was already stagnating economically during the previous decade. The combination of increased racism and division, with the rise of the Ku Klux Klan and anti-immigrant laws in the 1920s, plus Wall Street recklessness resulting in the 1929 crash, put the U.S. into a major hole. Franklin D. Roosevelt's New Deal programs were a massive effort to put the country on a new footing. It wasn't perfect. There was waste, pork and racism mixed in with some of its policies. Many Black workers were left out of the initial design of Social Security, which exempted domestic workers as a way to earn votes from Northern and Southern politicians who did not want Blacks and whites treated equally. But the New Deal is still held up as an impressive model for sweeping change and recovery in a time of need.

In addition to providing public assistance to the unemployed, the New Deal delved into multiple levels of society. From Black theater troupes to mural art in almost every post office, it bolstered the arts and artists. It transformed the energy industry (and hurt the salmon) with massive Columbia River dam projects like Grand Coulee and Bonneville, which laid the groundwork for cheap power, light, irrigation and farming. The Civilian Conservation Corps improved parks; fought wildfires; built lodges, campgrounds and trails; planted trees; and tended forest lands.

New Deal work impacted infrastructure up and down the state. According to the University of

Washington's website on the Depression, the Works Progress - later Projects - Administration funded work for "28,000 miles of road, 1,000 bridges, 26 libraries, 193 parks, 380 miles of sewers, 15,500 traffic signs, 90 stadiums and 760 miles of water mains in Washington." One of those bridges was the innovative first Lake Washington Floating Bridge, connecting Seattle to the Eastside. The feds paid 40% of the bridge's cost. It would be hard to argue that these investments and this building spree weren't transformative.

You can hardly go anywhere in Seattle today without feeling the New Deal's legacy: The Naval Reserve Armory on Lake Union, now the Museum of History and Industry; the reconstruction of the Ballard Bridge; neighborhood playfields from Georgetown to Camp Long to Cowen Park; replacement of the Pioneer Square "totem" pole; the Washington Park Arboretum; improvements to the University to Washington campus; and Woodland Park Zoo are just a sampling of contributions. Thousands of workers were employed in the process of physical and social improvement.

Bendable concrete is also more sustainable. It can be infused with carbon dioxide, which strengthens the concrete while using less cement and lowering carbon emissions.

ECC's ductility also decreases the financial and environmental costs of buildings. Whereas traditional concrete breaks easily and typically require repairs, bendable concrete can withstand higher amounts of pressure. This means it doesn't have to be maintained or repaired as much, so builders spend less time, resources, and carbon output when using it.

Bendable concrete has been around for decades and has proven to be durable and effective. For instance, the ECC link slab that was used to replace a conventional expansion joint on a Michigan bridge deck has lasted over 10 years without maintenance or repairs.

2. Mass Timber

Mass timber products are created by mechanically bonding various types of softwood to form large prefabricated wood components. It can come in several forms, including cross-laminated timber (CLT), laminated strand lumber (LSL), laminated veneer lumber (LVL), nail-laminated timber (NLT), and glue-laminated timber (GLT).

Mass timber has been gaining traction in the United States, and builders are increasingly using it for things like roofs, floors, beams, columns, and more.

On the sustainability side, mass timber serves as a viable substitute for traditional construction materials like steel and concrete, which have a higher carbon footprint. Using mass timber instead of conventional building materials can significantly reduce emissions.

A study published in the Journal of Building Engineering compared the environmental impact between a reinforced concrete building and a hybrid CLT commercial building and found that "an average of 26.5% reduction in the global warming potential is achieved in the hybrid CLT building compared to the concrete building, excluding biogenic carbon emissions."

What's more, buildings made with mass timber can be constructed faster and with less waste, further reducing the environmental impact of projects.

You can see mass timber in action at T3 (Timber, Technology, Transit), an office building in Minneapolis. The structure is built with mass timber and is designed to be a high-performing building that can "respond to Minneapolis' ever changing climate."

3. Salvage Materials

Reusing and recycling materials have long been key tenets of sustainability. Construction pros can apply these green principles by opting to use salvaged materials in their projects. Doing so gives construction materials a second life and helps keep waste out of landfills.

In some cases, purchasing recycled materials can also lower costs and improve the aesthetics and functionality of a building.

The Kendeda Building for Innovative Sustainable Design at Georgia Tech is one example of a project that involved salvaged materials. Skanska USA Project Manager Jimmy Mitchell used several materials to construct the building.

Jimmy recycled old slate shingles from the roof of the Georgia Tech Alumni Association building and used them on the walls and floors of the new building's shower rooms and restrooms. He also made use of lumber from storm-felled trees on the campus, and leveraged them to make counters and benches inside the Kendeda building. Meanwhile, the heart pine joists, which were originally part of Tech Tower, were converted to threads used in the new building's staircase.

4. Bamboo



Another sustainable alternative to conventional construction materials, bamboo is highly flexible, allowing builders to use it for both structural and decorative purposes. It's easy to find and source bamboo, as the tree grows in various parts of the world.

What's more, bamboo produces very little waste. A whole stem of a bamboo tree can be used in construction, and any pieces left over are compostable, which means they naturally break down back to the earth.

The Tiing hotel in Bali used bamboo together with concrete to build textured walls that blended well with the location's natural surroundings.

In an interview with Dezeen, hotel architect Nic Brunsdon said, "The materiality of this project aims to work within the local context, construction techniques, resources and climate – a rugged regionalism... In a tropical climate, a clean finish would require much maintenance; here, the material will weather in, enhancing the character of the architecture and place."

5. Mycelium

The words "mushrooms" and "construction" don't typically belong in the same sentence, but mycelium fungi may start to change that.

Mycelium is the vegetative structure of a fungus and when dried, it is highly durable and resistant to mold, water, and fire. Like bamboo, mycelium is organic and compostable, so it leaves little waste and has virtually no negative impact on the environment.

When combined with materials like timber, sawdust, and demolition waste, mycelium can be molded into bricks used for constructing buildings and their parts.

Mycelium isn't used at a massive scale yet, but there are a few notable examples. In 2014, an organic brick structure knowns as Hy-Fi was built in Queens, New York. Created as part of MoMA's Young Architects Program, the building used organic, biodegradable bricks made out of mycelium.

6. Precast Concrete

Precast concrete is created offsite before being transported to the job site. Unlike site cast concrete, which is poured, molded, and cured onsite, precast concrete is cured in the manufacturer's facility and shipped to the construction site.

Precast concrete slabs are more sustainable because they take less energy and materials to produce. You can also reuse construction processes such as molds and forms, thereby reducing waste.

Some of the world's most famous structures use this material. For instance, the shells on the roof of the Sydney Opera house are made out of precast concrete.

7. 3D Printed Concrete

3D printing can have a major impact on construction productivity and sustainability. 3D concrete printing allows you to digitally design any shape and bring — or rather print — it to life in the real world.

Unlike traditional construction, which uses up plenty of energy due to having to transport materials and go through supply chain complexities, 3D printing allows builders to design and construct faster, thus saving time, money, and energy. And because the formwork is reusable, 3D printed concrete produces less waste.

This method is being used to construct the longest 3D printed bridge in the world. Located in the city of Nijmegen in The Netherlands, the bridge is being constructed at Europe's first industrial and commercial 3D printing factory established by Royal BAM Group nv (BAM) and materials company Saint-Gobain Weber Beamix (Saint-Gobain).

Founded in 2009 by CPA youth leaders, Youth MOJO is a leadership development program for high school students with a focus on low-income Chinese American young adults. Through the program, participants meet weekly and can develop and strengthen their leadership, public speaking, communication, advocacy, and organizing skills.

The #3 entry is **AbilityFirst**. Operating in the greater Los Angeles area, it has over two dozen facilities that support individuals with physical and developmental disabilities through after-school enrichment programs, job training, community employment, and affordable and accessible housing.

AbilityFirst runs one of the first fully accessible camps in the United States, Camp Paivika. Located in the San Bernardino National Forest, it offers overnight summer programs for children and adults with mild to severe developmental and physical disabilities such as autism, ADHD, cerebral palsy, epilepsy, and Down syndrome.

Coming in at #4 is **Grantmakers Concerned** with Immigrants and Refugees, an immigrant-focused philanthropy-supporting organization. It works with its member institutions, individual grantmakers in its network, partners in the field, and others to mobilize funder resources on the most pressing issues facing these marginalized populations.

The organization uses briefings, publications, and consultations to inform funders about policy developments and help them make the connection between their priorities and immigration. It connects funders from around the country to one another, with the hopes of catalyzing coordinated and collaborative grantmaking for maximum impact.

To close our list at #5 we have the **Greenlining Institute**, a policy, research, organizing, and leadership organization fighting for racial and economic justice. It works on various major legislative issues, such as environmental policy, health care, and more.

Headquartered in Oakland, California, Greenlining runs a Leadership Academy that works to train and empower the next generation of multi-ethnic leaders to create positive social change. It offers three programs designed for young leaders seeking to reach their full potential.

Tell us your story and that of your organization: I was a teen mother facing homelessness and was served by a local community action agency. My caseworker provided me services such as food, housing can child care so I can could continue attending school and graduate. I lost my child to Child Welfare during this time and the agency staff helped me get back on my feet and get my daughter

At this moment, I knew I wanted to do this type of work and help others like me with key services to help them get back on their feet and keep their children.

I have spent over 22 years in social services and community-based as staff promoted to director for small and large organizations. In 2016, I launched my consulting firm to support agencies in maximizing their performance & services for vulnerable residents in their communities.

Is there a major accomplishment in the past year or so that you would like to share?

My business has been instrumental in supporting agencies and organizations in responding to COVID-19 community needs and developing community needs assessments to assess the community priorities and allocate CARES Act funding for the most impacted.

Our team has grown and I have been able to increase our team members, as we have expanded to Southern California counties.

What is the achievement you are most proud of?
