Mayor London Breed and Board of Supervisors Announce \$10 Million Small Business Relief Fund to Support Small Businesses Impacted by COVID-19

City commits \$9 million to launch new zero interest loan fund and adds \$1 million to the City's Resiliency Fund, increasing support for workers and small business

Mayor London N. Breed, Board of Supervisors Budget Chair Sandra Fewer, Supervisor Hillary Ronen, and the Office of Economic and Workforce Development (OEWD) announced today their commitment to launch a new Small Business Emergency Loan Fund to support small businesses facing sudden revenue loss from COVID-19. The \$10 million fund commits \$9 million to a new Emergency Loan Fund, and an additional \$1 million to expand the COVID-19 Small Business Resiliency Fund. The Resiliency Fund has received more than 2,000 applications since launching on March 11th.

"The steps we have taken to slow the spread of coronavirus will save lives. But this is a scary time for small businesses and workers because the impact that this pandemic is having is severe to not just public health, but also our local economy and people's livelihoods," said Mayor Breed. "Our focus remains helping our small businesses through both the immediate challenges they're facing with this emergency loan fund, be we know that there is much more to be done over the coming weeks and months to help our businesses and our workers get back on their feet."

The Small Business Emergency Loan Fund will provide small businesses up to \$50,000 in zero interest loans. These loans will have a flexible repay-

How the Construction Industry Benefits from the CARES Act



Coronavirus Aid, Relief, and Economic Security Act

While lawmakers plan another round of stimulus legislation to combat rampant unemployment and help struggling businesses, there is still a lot to unpack for the construction industry around the last one—the \$2 trillion Coronavirus Aid, Relief, and Economic Security Act (CARES Act).

The largest stimulus of its kind in U.S. history, the CARES Act is designed to put money and resources into the hands of individuals and businesses as the nation grapples with the coronavirus pandemic. With cities, counties, and states issuing stay-at-home or shelter-in-place orders, construction projects from coast-to-coast have been put on hold, delayed, or canceled.

The impact, no doubt, will be staggering as construction businesses struggle to pay employees and cover overhead costs. While construction

has mostly been viewed as “essential,” there are still pockets of the country where construction sites have been shuttered.

The passage of the CARES Act comes after Congress passed the Families First Coronavirus Response Act (FFCRA). It took aim at helping small businesses and their employees navigate the need for paid leave during the coronavirus. The Act also sought to expand the Family and Medical Leave Act (FMLA) for the 59.9 million people employed by small businesses in 2019—roughly half of the country's workforce.

How the CARES Act Will Help Construction

Whether COVID-19 precautions are causing delayed shipments of materials or reducing the availability of craft workers, it appears that ongoing or planned construction projects will continue to be at risk for the foreseeable future.

With a goal of helping the U.S. economy recover from the coronavirus crisis, the CARES Act will provide cash to businesses to keep millions of workers on the payrolls. Just how will this \$2 trillion bill help all in the construction industry? Whether you're an architect or a cost estimator or a general contractor or a subcontractor, the CARES Act is aimed at softening the economic fallout of COVID-19.

With cash in short supply, contractors and suppliers will be eager for any financial help to get through the ensuing downturn. In the weeks following the pandemic shutdown, the numbers of

Americans seeking unemployment benefits have surged to record levels—nearly 17 million by April 9. The shutdown of the economy is having a rolling impact as rents, mortgages, and credit card bills come due.

Construction Priorities in CARES Act

The good news is that the CARES Act provides \$350 billion for small-business loans, more than \$100 billion for hospitals, \$250 billion for unemployment aid, and more. Working on behalf of the construction industry, the Associated General Contractors of America (AGC) said construction industry priorities included in the CARES Act included provisions to:

- Establish loan programs that will help many construction businesses pay employees and overhead costs, while continuing operations
- Provide advanced-refundable tax credit for employers implementing new federal paid leave mandates in the Families First Coronavirus Response Act
- Delay the payment of employer payroll taxes through January 1, 2021, which will provide relief for businesses' cash flow during this crisis
- Allow companies to “carry back” their net operating losses for up to five years, which would inject much needed cash into struggling businesses

ment schedule and the terms will be determined on a case-by-case basis, based upon each borrower's ability to repay. This Emergency Loan fund will expand access to cash for small businesses who may have difficulty accessing more traditional loan products, and help sustain them through the ongoing public health crisis. Applications will be made available by April 6, 2020.

"The shelter-in-place order -- while absolutely essential for public health -- has businesses scrambling to figure out how to stay afloat. San Francisco small businesses employ hundreds of thousands of workers. They are the lifeblood of our economy and the soul of our neighborhoods. We can't let them go under," said Supervisor Hillary Ronen. "I am so glad that I was able to work alongside the Mayor and her Director of Economic Development to make this happen and to get these dollars flowing quickly to businesses in crisis."

Mayor Breed, announced the City's Resiliency Fund to provide immediate relief to small businesses with an initial investment of \$1 million to provide over 100 businesses with grants up to \$10,000. Today's additional investment of \$1 million increases the fund to \$2 million to support over 200 small business across San Francisco neighborhoods that need immediate relief. This fund, together with community partners, will be administered by OEWD to businesses that show a loss of revenue.

"I am thankful for the much needed relief for our small businesses who are under tremendous stress at this time," said Supervisor and Budget Chair Sandra Lee Fewer. "Although this is critical support, we know that much more help is needed to keep our small businesses afloat. I encourage those who can to contribute to the Give2SF Fund and bolster these efforts to keep our local merchants thriving."

"Getting accessible capital in the hands of our small businesses community during this extremely difficult time is essential to their ongoing vitality," said Joaquin Torres, Director of the Office of Economic and Workforce Development. "The Small Business Relief Fund builds upon the City's immediate work to provide financial support and economic relief to our neighborhood and historically underserved businesses during a time when every resource matters."

"We're proud to live in a City that's led the country in safeguarding the public health, and thrilled that San Francisco is showing the same leadership in delivering economic relief to our small businesses," said Laurie Thomas, Executive Director, Golden Gate Restaurant Association. "This new \$10M small business city relief fund couldn't come soon enough. Our restaurants and small businesses need cash now to survive long enough to take advantage of slower state and

federal funding, and is going to be the difference for a lot of us."

Federal Relief – CARE Act

The Small Business Administration (SBA), through Economic Injury Disaster Loans, is also offering up to \$2 million in assistance for small businesses and nonprofits. These low interest loans can provide vital economic support to small businesses that have been disrupted by the COVID-19 pandemic. This includes a \$10,000 advance, which does not have to be repaid. An online loan application portal is available to business owners at <https://covid19relief.sba.gov/#/>.

Additionally, the new Paycheck Protection Program (PPP) for businesses with 500 employees or less, includes loans made by existing SBA lenders up to \$10 million to cover fixed costs with conditions for eventual forgiveness. All eligible

Confronting Racism and Supporting Asian American Communities in the Wake of COVID-19

Long before health officials had confirmed the first cases of COVID-19 in the United States, acts of discrimination and xenophobia against Asian Americans were rising rapidly. As the number of confirmed cases increase exponentially, racist hate crimes targeting Asian Americans are also

on the rise, escalated by racist language used by public officials and members of the media when discussing COVID-19.

During a March 11 incident in New York City, a Korean woman was punched in the face, grabbed by her hair, and yelled at for not wearing a mask while entering a building. Parents have reported increased bullying and racist taunting in K-12 schools. Universities have received criticism for normalizing xenophobia and providing inadequate support for Asian students who may be on its receiving end.

The rise in anti-Asian xenophobia has had tangible economic consequences for Asian small-

business owners. In mid-February, with only 15 confirmed US cases and before social distancing policies were in effect, small businesses in Manhattan's Chinatown reported sales drops of between 40 to 80 percent, as the virus spread in China.

The shift in public treatment of Asian Americans from a "model minority" to the "yellow peril" to scapegoat amid a public health crisis is not without precedent. Throughout history—from the Black Death to Ebola—xenophobia and public health policy have been strongly linked and have often involved scapegoating people of non-white races and ethnicities.

In light of this history, policymakers and public officials can take the following evidence-backed actions to mitigate the racism and xenophobia spreading in the wake of COVID-19, prevent further misinformation, and support vulnerable Asian American communities.

Use language supported by scientists and public health officials when referring to COVID-19

In 2015, the World Health Organization (WHO) issued best practices for naming new infectious diseases in response to cases when disease names provoked a backlash against members of particular religious or ethnic communities or

COVID-19 Emergency Loans: Small Business Guide

Here are the questions you may be asking—and what you need to know.

You can apply through any existing SBA 7(a) lender or through any federally insured depository institution, federally insured credit union, and Farm Credit System institution that is participating. Other regulated lenders will be available to make these loans once they are approved and enrolled in the program. You should consult with your local lender as to whether it is participating.

While the program is open until June 30, 2020, the government is advising borrowers to apply as soon as possible given the loan cap on the program.

1. Am I eligible?

You are eligible to apply for a PPP loan if you are:

- A small business with 500 or fewer employees
- Defined as “small” by SBA Size Standard that allows for higher employee threshold or is revenue based; or
- A small business with maximum tangible net worth up to \$15 million and the average net income for full 2 fiscal years prior to application does not exceed \$5 million

- A 501(c)(3) with 500 or fewer employees
- A sole proprietor, independent contractor, or self-employed
- A Tribal business concern that meets the SBA size standard
- A 501(c)(19) Veterans Organization that meets the SBA size standard

In addition, some special rules may make you eligible:

- If you are in the accommodation and food services sector (NAICS 72), the 500-employee rule is applied on a per physical location basis
- If you are operating as a franchise or receive financial assistance from an approved Small Business Investment Company the normal affiliation rules do not apply
- Small businesses that have minority shareholders (private equity or venture capital) can still qualify if those stakeholders relinquish rights

2. What will lenders be looking for?

Borrowers will need to complete the Treasury Department’s PPP Loan Application (PDF) and payroll documentation.

Lenders will also ask you for a good faith certification that:

1. The uncertainty of current economic conditions makes the loan request necessary to support ongoing operations
2. The borrower will use the loan proceeds to retain workers and maintain payroll or make mortgage, lease, and utility payments
3. Borrower does not have an application pending for a loan duplicative of the purpose and amounts applied for here
4. From Feb. 15, 2020 to Dec. 31, 2020, the borrower has not received a loan duplicative of the purpose and amounts applied for here (Note: There is an opportunity to fold SBA Disaster Loans into a PPP loan)

If you are an independent contractor, sole proprietor, or self-employed individual, lenders will also be looking for certain documents (final requirements will be announced by the government) such as payroll tax filings, Forms 1099-MISC, and income and expenses from the sole proprietorship.

3. How much can I borrow?

Loans can be up to 2.5 x the borrower’s average monthly payroll costs, not to exceed \$10 million.

- Payments deferred for six months
- 1.00% fixed interest rate
- Loan is due in two year

How do I calculate my average monthly payroll costs?



INCLUDED Payroll Costs

1. For Employers: The sum of payments of any compensation with respect to employees that is a:

- salary, wage, commission, or similar compensation;
- payment of cash tip or equivalent;
- payment for vacation, parental, family, medical, or sick leave
- allowance for dismissal or separation
- payment for group health care and retirement benefits
- payment of state or local tax assessed on the compensation of the employee

1. For Sole Proprietors, Independent Contractors, and Self-Employed Individuals: The net income not more than \$100,000 in one year.

How the Construction Industry Benefits from the CARES Act

- Suspend the limitation on pass-through business losses, which will allow owners of passthrough businesses to fully deduct any losses they incur this year
- Suspend the application of the limitation on interest expense deductions, which will avoid penalizing businesses for borrowing during this crisis
- Fix the so-called “retail glitch” from the 2017 tax reform law entitled the Tax Cuts and Jobs Act, which unintentionally increased the cost of many construction projects, such as improvements for restaurants, retail establishments, or commercial office property

Closer Look at Lending Programs

Experts say two major lending programs in the CARES Act are expected to benefit construction employers—a U.S. Small Business Administration (SBA) loan program and an Exchange Stabilization Fund loan program. The Paycheck Protection Program will be run through the SBA’s 7(a) lending program. Under normal circumstances, a 7(a) loan is available to small businesses, through an SBA lender, with a 75% federal guarantee on loans up to \$5 million.

On April 8, the Treasury Department issued new guidance to allow any U.S. firms with 500 or fewer employees to qualify for the Paycheck Protection Program—regardless of revenue. The AGC raised concerns that the SBA lending program would leave out many firms that employ 500 or fewer employees, but whose revenues are above the SBA rule.

Specifically, the new guidance means a construction business does not have to qualify as a small business to participate in the program.

Under the Paycheck Protection Program, the SBA can guarantee 100% of the loans through the end of the year. To qualify, the small business must have been operational as of Feb. 15, 2020 and had employees for whom it paid salaries and payroll taxes, or paid as independent contractors.

Under the \$349 billion initiative, small businesses are eligible for loans of up to \$10 million, which will not have to be paid back if they meet certain



requirements, including using 75% of the money to retain or rehire employees. Businesses can receive a \$10,000 loan advance that does not have to be repaid, according to The Washington Post. Earlier this week, Treasury Secretary Steven Mnuchin asked congressional leaders for an additional \$250 billion for the program, which has received overwhelming demand.

The good news is that the loan can be used for payroll support, such as employee salaries, paid sick or medical leave, insurance premiums, and mortgage, rent, utility payments, or interest on debt incurred prior to Feb. 15, 2020. Borrowers will have to self-certify that funds borrowed under the program are used for payroll, rent, utility payments, etc.

Also, the maximum interest rate is set at 4%, but all payments on the loan can be deferred for at least six months. All fees for the borrower and lender for participation in the program are waived and all requirements that the borrower post collateral for the loan are waived.

Loan Forgiveness and ESF Details

Small subcontractors who faced temporary shutdowns of construction projects will likely be interested in the loan forgiveness program and the Exchange Stabilization Fund Loan (ESF) Program.

Acting more like a grant than a loan program, the loan forgiveness program will only cover eight weeks of covered expenses. However, the amount spent on business expenses are forgiven as long as it was borrowed for payroll (salaries under \$100,000), mortgage interest, rent, and utilities. This feature is intended to encourage employers to rehire any employees who have already been laid off due to the COVID-19 crisis.

In addition, the legislation appropriates \$500 billion to Treasury’s Exchange Stabilization Fund (ESF). While \$46 billion is specifically earmarked for specific industries, the remaining \$454 billion is available for loans, loan guarantees, and investments in support of the Federal Reserve’s lending facilities to eligible businesses, states, and municipalities.

While many of the details will have to be worked out, the ESF program will generally be available to businesses that certify that alternative financing is not otherwise available. However, there are restrictions attached to these loans, such as borrowers are prohibited from engaging in stock buybacks, issuing dividends, and increasing executive compensation. Also, these loans will not be forgiven.

Lifeline for Construction Industry

With the signing of the \$2 trillion CARES Act, Congress has delivered a much-needed lifeline that will help construction firms and workers weather the storm. With small businesses making up a majority of the construction industry, the nearly \$350 billion for small business loans will help construction professionals access capital and maintain cash-flow.

Clearly, this bill is designed to help the construction industry right the ship in the wake of the COVID-19 emergency. If it is successful in helping revive or stimulate new demand for construction, many contractors will then be able to stabilize their workforce and protect health and retirement benefits.

Whether your construction business is focused on roofing or design work, now is the time to track the causes of project delays and additional costs on projects. By keeping track of COVID-19 impacts, your business will be more prepared as you seek relief through loans, tax credits, and assistance with payroll obligations.

created unjustified barriers to travel, commerce, and trade.

WHO specifically instructs people outside of the scientific community to avoid using geographic locations in disease names. Best practices, like in the case of COVID-19 (coronavirus disease of 2019), include incorporating the pathogen in the disease name.

Disseminate accurate and accessible COVID-19 information to the public

Getting accurate information in the hands of the public is critical during public health crises, when collective anxiety is already running high. WHO has warned against the large amount of misinformation circulating related to COVID-19. Public officials should promote evidence-based best practices for preventing transmission of COVID-19, such as handwashing and keeping a safe distance, and avoid stigmatizing language or fearmongering.

Any information should also be disseminated in multiple languages (PDF) and accompanied by community outreach to better reach elderly immigrant/non-English speaking populations who may face language barriers but are at a higher risk of falling ill.

Denounce rising discrimination and hate crimes against Asian Americans

Civil rights and racial justice organizations have issued a joint call to action denouncing the increase in discrimination against Asian Americans related

to COVID-19, and the Congressional Asian Pacific American Caucus drafted a letter urging public officials to help prevent the spread of misinformation that can increase public anxiety and incite violence amid a public health crisis. Public officials can also support the work of nongovernmental organizations by holding people who commit discriminatory acts accountable.

Enact policies that support vulnerable workers and small businesses through the crisis

More than 2 million Asian Americans and Pacific Islander (AAPI) workers work in the health care, transportation, and service industries and may be more vulnerable to changes in health or economic stability from COVID-19.

Last week, Congress passed the Families First Coronavirus Response Act, which took important first steps to make testing for COVID-19 available at no cost for people who are insured and to require employers to provide paid sick leave to employees with some exceptions.

Under the new law, health care providers can be exempted from providing paid sick leave for their employees, who may be most vulnerable to exposure to COVID-19. The new law also leaves out requirements for companies with more than 500 employees to provide paid sick leave. Closing loopholes and extending paid sick leave to all vulnerable workers is important to consider as additional legislation develops.

Policymakers will also need to take further action to expand unemployment insurance and support

small businesses experiencing closures and sales declines. Approximately two million American small businesses are owned by Asian Americans, and they lead other groups in hiring rates. California and New York have the most Asian-owned small businesses, and both states have now implemented shelter-in-place policies in response to increasing cases of COVID-19.

Expand community outreach for federal safety net programs

The Families First Coronavirus Response Act also increased federal funding for Medicaid and the Supplemental Nutrition Assistance Program (SNAP). Although this is crucial for responding to increased need for health care and food assistance, data show social services are not reaching low-income Asian Americans and Pacific Islanders who need assistance.

In 2014, Asian Americans represented 17.9 percent of New York City residents living below the federal poverty level, yet Asian American organizations received only 1.5 percent of total contract dollars from New York City's Department of Social Services. Since then, barriers to accessing social safety net services have increased for Asian American immigrant communities, as the "public charge" rule has discouraged immigrant families from participating in programs like Medicaid and SNAP. In 2018, Asian Americans made up 2.9 percent of households receiving SNAP, despite making up 4.7 percent of Americans with incomes below the federal poverty level.

Given these barriers, public officials should prioritize outreach to Asian Americans seniors who are at higher risk of falling ill from exposure to COVID-19, have higher poverty rates relative to all elderly Americans, and are more likely to face language barriers when accessing social services.

Provide resources for people affected by hate crimes and other acts of discrimination

Last Thursday, Asian American nonprofit organizations launched an online reporting center where people can report the location and details of discrimination they experience. Since then, the website has collected reports of more than 150 cases, ranging from microaggressions to verbal and physical assault.

As hate crimes and other acts of discrimination increase in the wake of COVID-19, public officials can support Asian American communities by providing resources that are harder for nongovernmental organizations to provide, such as access to mental health care for those affected.

Although many communities face risks to health and well-being, some Asian Americans are experiencing additional challenges. To confront anti-Asian racism now, policymakers and public officials can provide resources to those affected by mounting discrimination, disseminate accurate information, and act swiftly to enact policies to support communities who may be especially vulnerable during this crisis.

Community Outreach & COVID-19

Make Racial Equity Central to California's Public Health Response to COVID-19

As our federal and state governments work to mitigate the health and economic consequences of COVID-19, we must center racial equity in the distribution and implementation of emergency response funds. As Greenlining has noted, the COVID-19 pandemic has exposed our nation's pandemic of inequality and calls on us to both address immediate needs and address the underlying inequities that make those needs worse. We must think beyond just "getting back to normal," but also focus on the urgent needs of vulnerable communities.

California has been praised for taking early action to stop the spread of the virus and curb the economic downturn, but if we don't consciously prioritize low income communities of color, many families will not receive the support they need to survive and recover from this pandemic.

1. Expedite Access to Full Scope Medi-Cal for Elders (65+) Regardless of Immigration Status -

We thank Governor Newsom for including the Health4Elders proposal in the initial 2020-21 budget, but are concerned that in his April 2 press briefing he hinted that he might back off from this commitment. Elders in our families are a high risk group for experiencing severe complications and even death from COVID-19. The Health4Elders proposal would provide full-scope Medi-Cal to an estimated 27,000 low-income undocumented elders ages 65 and older by removing immigration status as an eligibility

exclusion. As part of the Health4All Coalition, we stand with the California Immigrant Policy Center and partners to urge the legislature to act immediately to remove the immigration status eligibility exclusion to full-scope Medi-Cal for undocumented elders as soon as possible to prevent harm during this pandemic. This is a life-and-death emergency and not a place to look for budget savings.

2. Prioritize Emergency Funding & Resources for Primary Care Clinics & Community Health Centers -

As health systems become overburdened with COVID-19 case loads, the state must support licensed community clinics and health centers, which provide essential health services to underserved communities and low-income neighborhoods regardless of a family's ability to pay for care. Local clinics and community health centers are California's health care safety net for many neighborhoods that lack access to amenities and provide essential care for California's ethnically diverse neighborhoods, women, and children. While full service hospitals and larger health systems are also important, local clinics get by with minimal support and urgently need assistance to respond in this emergency.

3. Expand Access to Free Telehealth & Internet Services for Low-income Families -

Telehealth services are critical during shelter-in-place to give families access to health screenings and to reduce the burden of in-person patient visits. The legislature should waive telehealth medical fees and copays during this time to encourage more Californians to seek preventative screening

and consultation and stop the spread of COVID-19. Furthermore, the need for telehealth emphasizes how vital it is for households to have affordable internet access. Internet service allows us to respond quickly in a crisis and get vital health and safety information. However, many low income households lack access to affordable internet services. We need an immediate response: ban disconnections for nonpayment and implement a statewide all-fiber infrastructure project to help bridge the digital divide and provide jobs to help soften the impact of the economic downturn caused by COVID-19.

4. Provide Oversight on Cost Containment & Excessive Medical Billing to Hospitals -

In an emergency, a patient may unknowingly be taken to a hospital that is outside of their medical network for treatment and get stuck with a huge bill not covered by insurance. AB 1611 (Chiu) would provide oversight and require that out-of-network emergency care services are to be offered at the same cost as a patient's in-network provider at the time of billing. We stand with Health Access and partners to urge the governor to sign this bill into law given the urgency of this issue. We must ensure that low income California families who are already negatively impacted by this financial crisis are not also burdened with excessive medical fees and debt.

5. Encourage Hospital Contracts and Procurement with Diverse Businesses -

As large health systems increase their spending to buy emergency equipment, supplies, and support routine organizational functions (e.g., legal, janitorial, communications, and food services)

they should prioritize contracts and procurement with minority-, women-, veteran-, and LGBTQ-owned businesses to support and protect local businesses from the economic downturn. Implementation of AB 962 (Burke) is a first step towards hospital transparency and accountability in supplier diversity, but we need action immediately and cannot wait for hospitals to be incentivized to support diverse businesses through reporting requirements.

As the health and economic impacts of the pandemic unfold, we need our elected officials to prioritize supporting the most vulnerable now more than ever. As proponents of progressive (and, some would even argue, "aspirational") policies like universal healthcare for all, we receive pushback that implementation is too costly, that the state cannot afford to insure and support everyone, or that it is too expensive to serve and protect all of us.

But right now we are witnessing the very real negative impacts of failing to invest in prevention and the equitable treatment of all Californians in an emergency. And we're also seeing the sudden availability of and willingness to use massive funding because it's clearly needed. California must lead in making racial and health equity a reality.
