Governor Gavin Newsom Announces Major Financial Relief Package: 90-Day Mortgage Payment Relief During COVID-19 Crisis

Governor Gavin Newsom announced that financial institutions will provide major financial relief for millions of Californians suffering financially as a result of the COVID-19 outbreak.

"Millions of California families will be able to take a sigh of relief," said Governor Newsom. "These new financial protections will provide relief to California families and serve as a model for the rest of the nation. I thank each of the financial institutions that will provide this relief to millions of Californians who have been hurt financially from COVID-19."

Governor Newsom secured support from Citigroup, JPMorgan Chase, U.S. Bank, and Wells Fargo and nearly 200 state-chartered banks, credit unions, and servicers to protect homeowners and consumers.

Under the Governor's proposal, Californians who are struggling with the COVID-19 crisis may be eligible for the following relief upon contacting their financial institution:

90-Day Grace Period for Mortgage Payments

Financial institutions will offer, consistent with applicable guidelines, mortgage payment forbearances of up to 90 days to borrowers economically impacted by COVID-19. In addition, those institutions will:

 Provide borrowers a streamlined process to request a forbearance for COVID-19-related reasons, supported with available documentation;

- Confirm approval of and terms of forbearance program; and
- Provide borrowers the opportunity to request additional relief, as practicable, upon continued showing of hardship due to CO-VID-19.

No Negative Credit Impacts Resulting from

Financial institutions will not report derogatory tradelines (e.g., late payments) to credit reporting agencies, consistent with applicable guidelines, for borrowers taking advantage of COV-ID-19-related relief.

Moratorium on Initiating Foreclosure Sales or Evictions

For at least 60 days, financial institutions will not initiate foreclosure sales or evictions, consistent with applicable guidelines

Relief from Fees and Charges

For at least 90 days, financial institutions will

waive or refund at least the following for customers who have requested assistance:

- Mortgage-related late fees; and
- Other fees, including early CD withdrawals (subject to applicable federal regulations).

Access to Capital & COVID-19

How to find capital to save your business during the COVID-19 pandemic

Small businesses must act now to develop a plan to escape the grip of the deadly COVID-19 pandemic that is decimating lives and economies throughout the world.

The stakes are high: your survival. Governors across the country have ordered schools and nonessential businesses to close their doors and told people to shelter in place. Companies are rapidly jettisoning workers daily, leading to 3.28 million people applying for unemployment benefits during the third week of March, 2020.

To save the economy, Congress approved a \$2-trillion relief package, which includes \$370 billion in government-guaranteed bank loans that may be forgivable.

As the new normal of social distancing sets in, small businesses, the 30-million strong that employ 47% of the U.S. workforce, must find a way out.

Capital is the respirator to revive small businesses as they prepare for life after COVID-19.

Former U.S. Small Business Administration (SBA) Administrator Karen G. Mills recently said the coronavirus would have a worse economic impact than the 2008 financial crisis.

"Many small businesses will not survive more than a month," she said.

Here are some recommendations to find capital.

Every small business that has been impacted by COVID-19 should apply for the SBA Economic Injury Disaster Assistance (EIDA) now. This program can provide up to \$2 million to a business as a direct loan from the government to pay vendors, employees and other bills. Expect it to take at least a month to get approved and funded, due to the volume of applications

Visit SBA.gov to learn about all your options, including the 7(a), 504 program and microloans.

HEDCO, a community development financial institution (CDFI) based in Hartford, is a missiondriven nonprofit committed to making access to affordable capital a reality for underserved businesses. Expect small community lenders to be overwhelmed with loan requests, so get your financial documents ready: three years of tax returns, current P & L and balance sheet, accounts receivable and payable aging report, debt schedule and a projected one-year cash flow

Consider the Community Economic Development Fund (CEDF) and Community Investment Corp. (CIC), two community-based lenders in Connecticut. The state of Connecticut recently announced it will offer low-interest loans up to \$75,000 to small businesses.

Visit the state of Connecticut Department of Economic & Community Development website (https://portal.ct.gov/DECD) for the details.

Look everywhere for capital. GoFundMe is a donation-based crowdfunding platform where businesses can raise capital, usually small amounts under \$10,000. Reward-based crowdfunding on platforms such as Kickstarter and Indiegogo are other options. Make sure you plan out the details and allocate your time wisely.

- Capital to cover the cost of retaining employees? Then the Paycheck Protection Program might be right for you.
- A quick infusion of a smaller amount of cash to cover you right now? You might want to look into an Emergency Economic Injury Grant.
- To ease your fears about keeping up with payments on your current or potential SBA

loan? The Small Business Debt Relief Program could help.

 Just some quality, free counseling to help you navigate this uncertain economic time? The resource partners might be your best bet.

Payment Protection Program (PPP) Loans

The program would provide cash-flow assistance through 100 percent federally guaranteed loans to employers who maintain their payroll during this emergency. If employers maintain their payroll, the loans would be forgiven, which would help workers remain employed, as well as help affected small businesses and our economy to snap-back quicker after the crisis. PPP has a host of attractive features, such as forgiveness of up

to 8 weeks of payroll based on employee retention and salary levels, no SBA fees and at least six months of deferral with maximum deferrals of up to a year. Small businesses and other eligible entities will be able to apply if they were harmed by COVID-19 between February 15, 2020 and June 30, 2020. This program is would be retroactive to February 15, 2020, in order to help bring workers who may have already been laid off back onto payrolls. Loans are available through June 30, 2020.

4 Tips to Manage Sales During the Coronavirus Outbreak

One of the biggest business news stories in the world right now is the coronavirus pandemic, and it's affecting all kinds of industries from travel to industry events to global supply chains. The stock market has entered a new wave of volatility, prominent business networking events have been canceled or postponed, cross-border travel restrictions are complicating or canceling people's international travel plans, and the entire country of Italy has shut down because of coronavirus.

clients to work with over the long term. Even if the coronavirus turns out to be a short-term panic, or if it's worse than expected and the U.S. economy goes into a recession, it's never a bad idea to invest in a well-stocked pipeline of sales prospects.

2. Reengineer your Solutions to Help with Coronavirus Concerns

Depending on what types of B2B solutions you sell, your prospects might already be having significant pain points and concerns about the coronavirus. Spend some time re-thinking and changing the angle on what are the key benefits of your products and services in a way that is relevant to coronavirus concerns. Is there a relevant sales pitch that you can make about how your B2B solutions can help your clients adapt to coronavirus and key benefits to help them get through the crisis?

For example, many companies are already announcing an aggressive shift toward remote working and encouraging people to work from home. If you sell cloud colocation solutions, refocus your marketing efforts to sell remote access to companies who can keep their offices functioning by having employees work from home.

Lots of other companies are having to cancel travel plans as big industry conferences and trade shows are getting postponed or canceled. If you sell a virtual event platform or collaboration software, this could be a great chance to show your prospects the value of being able to have their most important business conversations online, even if real-life meetings are currently not possible.

The same selling points for your product that already were relevant before the coronavirus might still work, but you might need to slightly adjust your sales pitch to frame your solutions for people's most urgent concerns. Your prospects might be dealing with several coronavirus pain points, such as...

- Worried about possible coronavirus-related disruptions to their business
- Adapting to new travel restrictions or coronavirus-related shutdowns in their supply chain
- Figuring out how to collaborate with remote workers in new ways
- Enhancing their cloud security or business insurance to cope with emerging potential threats

Do any of these pain points sound familiar to you, based on your clients and industry? If so, adapt these angles into your sales pitch. These are all possible angles to show how your solutions can help – during times of coronavirus and once life goes back to normal.

3. Get Creative with Sales Presentations

Coronavirus is forcing lots of businesses to cut back on travel and in-person meetings. That means web-based presentations are more important than ever. Start repackaging your sales pitch into a full-blown virtual presentation. Be prepared to do more of your pitch over the web instead of on-site meetings.

This might require a change in your sales process. Perhaps you are used to doing an initial discovery-type phone call as stage one of your sales cycle, and then your next call would be an on-site meeting. On-site meetings may not be an option, as your potential new client may be working exclusively from home, or just not meeting face to face with anyone until the crisis settles down.

Be ready to get creative and keep your sales advancing by doing things that you never thought possible. Such as...

- Taking your client on a virtual factory floor tour (using FaceTime or mobile conferencing apps)
- Doing an in-depth product demo that includes your technical team who typically don't get involved until later in the sale
- Sending your client a YouTube video of your product or solution in action, and then talking through it via web conference while watching the video together

Think creatively. Use various collaboration tools. And look for communication apps to talk with your clients. Don't worry if you can't be there in real life.

What a cost-analysis shows of going back to work during the coronavirus pandemic vs. California's stay-at-home policy

First with a tweet, then a news conference and interviews, President Donald Trump showed that he is considering trading American lives in the coronavirus pandemic for a healthier economy: "We can't have the cure be worse than the problem."

The pushback to Trump's statements was swift, with New York Gov. Andrew Cuomo saying that if the public must choose between public health and the economy, Americans will choose the former. Others, including Trump economic advisor Larry Kudlow rushed to Trump's defense, arguing that "the economic cost to individuals is just too great"

Is the economic cost too great? Or are policies like Gov. Gavin Newsom's "stay at home" order — similar to shelter-in-place — worth the economic cost because they provide more net benefits, in particular, in lives saved?

Calculating the costs and benefits of health policies can be complex. Aggressive policies like stay-at-home will save more lives, but they also cost more. Voluntary social distancing costs far less but also saves fewer lives.

Whether readers like it or not, policymakers routinely and appropriately assign a value to human life. The U.S. EPA, for example, assumes the Value of a Statistical Life is \$9.5 million. So a policy that saves 1,000 lives provides an economic benefit of \$950 million.

What is the economic value in California of stay-at-home policy compared with social distancing? According to CovidActNow.org, with social distancing alone, California would suffer 596,000 deaths. In contrast, the number of California deaths with a stay-at-home policy is estimated at 11,000, a reduction of 585,000. Based on a \$9.5 million Value of Statistical Life, the benefit in lives saved reaches \$5.6 trillion.

Some readers might argue for a lower Value of Statistical Life, since most deaths are elderly (for the record, I disagree) and a reduction in the expected death rate. Reducing the Value of Statistical Life by 50% (to \$4.8 million) and the expected death rate by 50% (to 1.1%), reduces the benefit in lives saved to \$1.3 trillion. Bottom

line: California's economic benefits from stayat-home range from \$1.3 trillion to \$5.6 trillion.

Now let's estimate the cost of California's stayat-home policy to calculate net benefits, i.e., benefits minus costs. The president and CEO of the Federal Reserve Bank of St. Louis expects a 50% loss in 2nd quarter GDP, \$414 billion in California. (FYI, the largest quarterly GDP decrease in the Great Recession was 5%.) Let's also assume that California will pay its population share of the federal coronavirus stimulus bill (\$244 billion), and the state (including private contributions) will pay additional unemployment benefits up to a maximum \$30 billion (based on a 2nd quarter unemployment rate of 30%), bringing total costs to \$688 billion.

What if the costs are even higher? Let's assume further that the state's GDP remains 25% below normal in the third quarter and 10% in the fourth quarter, that California is responsible for its share of a second \$2 trillion federal stimulus, and that unemployment is 15% and 6% in the third and fourth quarters, respectively. In this scenario, costs to the state increase to \$1.2 trillion. Bottom line: California's costs from its stay-at-home policy range from \$688 billion to \$1.2 trillion.

Stay-at-home provides minimum net benefits to the state of \$77 billion under the most conservative assumptions, i.e., the lowest estimated benefits and highest estimated costs. In short, even in this unlikely scenario, the "cure," a stay-at-home policy, results in an economic benefit. Under best-estimate assumptions, the net economic benefit climbs to \$4.9 trillion, an amount equal to nearly 18 months of economic output for the entire state.

National and state leaders who claim to be putting the economy first are in fact putting it last. Saving lives also saves the economy.

The sooner other elected officials recognize that the cure is not worse than the problem and follow the lead of California and 25 other states with stay-at-home policies, the greater the economic benefit, the higher the number of lives saved and the faster the economy will return to normal.

Governor Newsom Grants Additional Relief for Business Taxpayers

In accordance with the Executive Order issued by Governor Newsom last night to expand tax relief for small business taxpayers, the California Department of Tax and Fee Administration (CDTFA) announced today that all small businesses will have an additional three months to file returns and pay taxes administered by the department. Additionally, all businesses will have an extra 60 days to file claims for refund from CDTFA or to appeal a CDTFA decision to the Office of Tax Appeals.

CDTFA is providing a three-month extension for a tax return or tax payment to any businesses filing a return for less than \$1 million in tax. For the approximate 99.5% of business taxpayers below the \$1 million threshold for their current California sales and use tax obligation, returns for the 1st Quarter 2020 will now be due on July 31, 2020. The same provisions apply to the other tax and fee programs administered by CDTFA. Qualifying taxpayers are not required to file a request for extension or request relief from penalty or interest. This automatic extension will remain in effect through the reporting of taxes and fees due on or before July 31, 2020.

"This expands on the relief previously granted to small businesses, giving them an extra 90 days to file and pay any business taxes and fees administered by CDTFA without incurring any penalties or interest," said Director Nick Maduros. "By



including the \$1 million threshold, we're able to offer much-needed relief to small businesses across the state while still maintaining the integrity of our local finance system. Approximately 55% of the sales and use tax collected goes back to our cities and counties, which count on this revenue to provide essential public services."

In addition to the three-month extension of time to file and pay taxes, the Executive Order issued by Governor Newsom last night also provides business taxpayers with additional time to file claims for refund and appeals to the Office of Tax Appeals. Taxpayers looking to make refund claims with CDTFA during this period will have

an additional 60 days to file. Similarly, taxpayers seeking an appeal of a CDTFA tax determination to the Office of Tax Appeals will have 60 additional days to file the appropriate request.

4. Don't Panic, Don't Stop Selling

Avoid panic. And stop assuming the sky is falling. Keep selling and prospecting. Lots of people right now seem on the verge of panic about coronavirus. They have stocked up on toilet paper and canned goods. They seem to believe the economy will shut down. I don't claim to be an expert. But I think the worst fears are overblown. (This article features interviews with actual disease experts. It shares some helpful and calm perspectives on the myths and realities of coronavirus.) Look out for some short-term economic pain. But I believe that we are going to get through this public health crisis without a 2009-style economic crisis.

The stock market reacts to possible risks and uncertainty. Business travel gets canceled. Do you

work on Wall Street or in the airline industry or hospitality industry? Then you feel understandably concerned. But the rest of us need to avoid panic. Life may not totally go back to normal right away. So look for ways you can adapt and keep doing business.

Deals may get stalled in your pipeline. But make sure you keep them warm. And keep checking in with your leads. Some companies may hold back

on investment until the uncertainty resolves. But look for the first sign that the crisis is ending. You should make up for some temporary losses very auickly
