Construction's Resiliency Playbook: How to Future-Proof Your Workforce

There are plenty of admirable traits that are constantly linked to successful people and organizations. Creativity, innovation, and courage are often lauded as the characteristics that people and companies should possess in order to thrive and be competitive.

But one thing that's sometimes overlooked is the importance of resiliency. This may be because resiliency only kicks in when times are tough, so we don't see it as often. It's easy to be creative and brave when things are going well, but being resilient — i.e., having the ability to recover after adversity — is extremely challenging.

And if we learned anything from 2020, it's that resiliency is king. The organizations that survived and thrived in the past year were the ones that found ways to bounce back after being faced with unprecedented challenges. We've seen incredible resiliency in the construction industry. Owners, general contractors, designers, and everyone in between had to learn new workflows, adjust to different working conditions, and adopt forward-thinking mindsets. Doing all of that in a short amount of time is astounding, but construction professionals rose to the challenge, and the industry is stronger because of it.

That said, many challenges remain. The industry is still getting used to the new normal. And according to FMI, construction traditionally lags 12 to 18 months behind general recessions, which means we'll continue to face tough periods ahead.

As such, resiliency will be more important than ever, and construction professionals need a new playbook to achieve that. Building a resilient organization requires you to transform your teams, processes, and technologies, so they're in a position to easily recover when met with adversity.

Continued investment needed for small businesses

Not long before Congress passed its latest CO-VID-19 relief package, California authorized a comprehensive \$7.6 billion stimulus package of its own, with more than \$2 billion allocated for small businesses. That legislation built on previous actions to keep California's Main Streets afloat during the pandemic.

In all, it's an unprecedented investment in California's entrepreneurs.

With rising hopes that the pandemic may soon come to an end, the state's economic recovery plan must continue to invest in our most effective job and wealth creators: small businesses and the ecosystem that supports them.

California was one of the first states to go into lockdown – and while this was a necessary step for public health, the impacts on small businesses have been dramatic. At the start of the pandemic, California's 4.1 million small businesses employed almost half of all workers, but COV-ID-19's repercussions came quickly. An April 2020 poll by Small Business Majority found that

The state of California stepped in to help, providing, among other things, \$2.5 billion for a small business grant program, a \$100 million Main Street Tax Credit, and an interest-free extension for businesses filing less than \$5 million in sales tax. Recognizing how difficult it is for many entrepreneurs, especially women and people of color, to start a new business, the state also waived the \$800 minimum license fee for new businesses.

These actions undoubtedly saved thousands of small businesses and jobs. Yet, another poll in December 2020 found that 56% of small-business owners were still reporting reduced revenues compared to the same period the previous year. Six in 10 reported struggling to pay rent or mortgage on their commercial spaces. And 17% of business owners of color said they were likely to permanently close sometime in the next three months; 12% of white business owners said the same.

This highlights the fact that small businesses are still struggling and need continued support.

Many have been unable to access relief from the federal government – only 17% of small-business owners who received a loan from the Paycheck Protection Program got the full amount they requested. The numbers were lower for entrepreneurs of color – at 14% versus 25% of white business owners.

Fortunately, the California latest relief package includes \$2.1 billion in grants of \$5,000 to \$25,000 – quadruple the pandemic-related grant assistance previously available. In announcing the law, Gov. Gavin Newsom acknowledged that the "backbone of our economy is small business. We recognize the stress, the strain that so many small businesses have been under and we recognize our responsibility to do more."

For years, policymakers spoke about the importance of small businesses to our economy but did not follow up with significant action. The pandemic – and the specter of small businesses failing in mass – has changed that dynamic. California policymakers have made real investments in our small businesses in the last year. Now, as we shift from crisis to recovery, small businesses

PNC Announces \$88 Billion Community Benefits Plan

The PNC Financial Services Group, Inc. (NYSE: PNC) today announced a Community Benefits Plan to provide \$88 billion in loans, investments, and other financial support to bolster economic opportunity for low- and moderate-income (LMI) individuals and communities, people and communities of color, and other underserved individuals and communities over a four-year period beginning Jan. 1, 2022.

The Plan – developed in connection with the anticipated regulatory approval and closing of PNC's pending acquisition of BBVA USA Bancshares, Inc., including its U.S. banking subsidiary, BBVA USA – covers the geographies currently served by PNC and the new geographies PNC will expand into through the BBVA USA acquisition. The Plan incorporates, builds on and expands the pledges and plans previously announced by PNC and BBVA USA to help meet community needs, advance economic empowerment and address systemic racism.

Specifically, over the Plan period, PNC expects to:

- Originate at least **\$47 billion** in residential mortgage and home equity loans to LMI and minority borrowers and in LMI and majority-minority census tracts.
- Originate at least **\$26.5 billion** in loans to small businesses in LMI communities, majority-minority census tracts, businesses with less than \$1 million in revenue and small farms.
- Provide at least **\$14.5 billion** in community development loans and investments across all markets, including at least \$400 million for Community Development Financial Institutions (CDFIs) that help meet the banking and financial service needs of traditionally underserved communities.
- Increase to at least **\$500 million** PNC's charitable giving, including sponsorships and philanthropic grants. This includes the continuation of BBVA USA's existing multi-year grant and charitable sponsorship commitments with nonprofit organizations, and a commitment to maintain or increase the current levels of philanthropic support

provided to community groups in Birmingham in recognition of the history of the city as the headquarters city of BBVA USA and its predecessor bank.

"As a Main Street bank, we believe that our success will be proportional to the prosperity we help create for our stakeholders," said PNC Chairman, President and CEO William S. Demchak. "This plan reflects that belief and builds on our longstanding commitment to provide economic opportunity for all individuals and communities we serve, as reflected in PNC Bank's and BBVA USA's overall 'Outstanding' Community Reinvestment Act (CRA) ratings in each of our organizations' most recent evaluations." PNC Bank has consistently earned an 'Outstanding' CRA rating in every performance evaluation issued since enactment of the CRA more than 40 years ago.

PNC's Community Benefits Plan was developed by PNC, in consultation with BBVA USA, and was informed by numerous community listening sessions that PNC held with the National Community Reinvestment Coalition (NCRC) that included representatives from more than 150 NCRC member organizations from across the combined PNC and BBVA USA footprint. PNC also held listening sessions with the National Diversity Coalition, the Greenlining Coalition, the California Reinvestment Coalition, Faith and Community Empowerment, and members of their respective organizations.

"We appreciate the leadership and commitment of PNC Bank to collaborate with us and our members to develop the largest-to-date community benefits plan," said NCRC CEO Jesse Van Tol. "This plan is a significant commitment by one of the largest banks in the nation to increase investments, services and loans for low- and moderate-income communities and neighborhoods of color. It's rewarding and makes me hopeful when institutions and communities can come together like this to make a meaningful commitment that's intended to have a lasting impact on lives, families and neighborhoods."

PNC's Regional President and Community Development Banking teams will serve as key points of engagement in their local communities for identifying impactful local community development initiatives and acting as liaisons with local organizations. PNC will extend this model to the new markets it enters through its pending acquisition of BBVA USA.

"As we consulted with numerous groups across the country, we learned the concerns that are top of mind to our communities: focusing on home ownership as a foundation of wealth creation for current and future generations; finding solutions to help the unbanked and underbanked who have suffered disproportionately during this pandemic; and supporting small businesses and entrepreneurs by providing access to capital and credit on par with the access enjoyed by more affluent segments of our society," said Richard Bynum, chief corporate responsibility officer for PNC. "We believe that our strategic focus on fostering economic empowerment, education and entrepreneurism in traditionally underserved populations and communities truly reflects the concerns of our communities and addresses each of these areas.'

"For over three decades, I have been fond of saying, 'Banks are our neighborhoods' best hope. The PNC plan directly responds to that hope," said NCRC President and Founder John Taylor. "It will provide a much-needed influx of investment into critical programs that improve affordable housing, mortgage lending, small business development and economic development projects for low- and moderate-income people and neighborhoods coast-to-coast. This plan would have been impossible without the clear and unwavering commitment of PNC CEO Bill Demchak and other executive leadership at the bank, as well as the critical role our local community members played in our discussions with the bank."

The Community Benefits Plan builds on PNC's commitment to providing economic opportunity for all individuals and communities, including LMI and minority individuals and communities, as well as women, veterans and LGBTQ+ individuals and businesses. In addition, the Plan reflects PNC's commitment to addressing systemic racism, promoting social justice and advancing diversity and inclusion, not just within PNC, but within the broader financial system and its communities.

In 2020 the PNC Board of Directors formed a Special Committee on Equity and Inclusion in

order to provide oversight of these important issues. The Board's Special Committee will also be responsible for oversight of PNC's execution of the Plan.

PNC's plan to better meet the needs of the unbanked and underbanked includes the addition of 20 new branches and 25 remote automated teller machines in LMI communities across PNC's expanded footprint, and 10 mobile banking units primarily dedicated to servicing LMI communities. PNC also expects to increase its spending with diverse suppliers by at least 20% over the plan period.

PNC also plans to expand the reach of its innovative banking products and initiatives designed to meet the needs of LMI individuals, underserved communities and the elderly. This includes the company's recent announcement of its groundbreaking Low Cash Modesm digital offering, which addresses the \$17 billion that some studies estimate U.S. consumers pay each year in overdraft fees. Low Cash Modesm helps PNC's Virtual Wallet® customers avoid overdraft fees and remain in the banking system through unprecedented account transparency and control to manage through low-cash moments or mistimed payments. Low Cash Modesm launches nationwide in June and July. Pending regulatory approval and the anticipated close and conversion of BBVA USA customers to PNC's systems later this year, it will be available to BBVA USA customers with Virtual Wallet accounts.

In addition, PNC will expand into its new BBVA USA geographies its SmartAccess and Foundation Checking accounts—two products that meet the Cities for Financial Empowerment Fund's Bank On national certification. Bank On's 2021-2022 Standards require low cost, no overdraft, and full-functioning features. PNC is the only bank with two Bank On certified products.

"PNC is committed to continuing to reduce barriers to banking, increasing access to financial services and capital, and implementing financial solutions that position LMI and minority-owned businesses for effective growth, development, and sustainability," Bynum said.

Under the Community Benefits Plan, PNC also will create a Community Advisory Council that

First Small Business Loan? 11 Things to Consider

Applying for your first small business loan can be a stressful process. Here is how to ensure the process goes smoothly.

- For your first small business loan, consider traditional bank loans, government loans, merchant cash advances, business lines of credit, business credit cards and other short- and medium-term loans.
- When applying for your first small business loan, you should also create a budget, compare lenders, check your credit score and determine how much funding you need.
- You should also consider working with your accountant to ensure all of the proper paperwork, such as tax return and financial statements, are in order.
- This article is for small business owners considering taking out their first small business loan.

Is this your first time venturing into the small business loan frontier? Obtaining a small business loan is just one of the first steps to launching your business. Proper financial planning, however, is critical to your success.

There are two key things to keep in mind as a small business loan first-timer. If you're seeking a small business loan, the way you present your business idea, business plan and financial forecasts can be the difference between gaining or not gaining investors' or a bank's approval. But once you do get a business loan, how you manage your operations and where those funds go can make or break your entire business.

Types of loans to consider

Among the types of loans – also known as debt financing – you should consider for your first small business loan are:

- Traditional bank loans. These are harder to secure, but generally offer more favorable terms.
- Government loans. This includes loans from the Small Business Administration (SBA), which may have more favorable rates than bank term loans.

- Merchant cash advances. You repay these loans with a portion of your debit and credit card sales. These are paid in daily, weekly or monthly installments and typically have a high APR.
- Business lines of credit. You can use lines of credit repeatedly until they run out or you no longer need the funds.
- Business credit cards. You repay these just as you do a personal credit card.
- Long-term loans. Typically offer larger funding amounts that you can repay over longer periods.

Key takeaway: Types of first small business loans you should consider are traditional bank loans, SBA loans, merchant cash advances, business lines of credit, business credit cards and long-term loans.

The do's and don'ts of your first small business loan

From creating a budget to managing costs, there are several steps you can take to make the most out of obtaining and managing small business loans. Holly Nicholas Signorelli, a certified financial planner and CPA, advises aspiring entrepreneurs and small business owners to maintain realistic expectations. Based on more than 20 years' experience, Signorelli shared the following do's and don'ts of firsttime small business loans.

1. Do create a real budget.

About 90% of the time, clients come in with a huge budget made up of millions of dollars in profits, Signorelli said. But when you start to go through the line items, there isn't any real backup to substantiate the numbers. Instead, there is always some hype about the product, the market in general and, most of all, "the potential." Banks and investors don't want to buy your idea; they want to make a profit, Signorelli stressed. For them to believe in your idea, they have to believe there is a profit. With very few exceptions, they are not going to invest in your idea if it doesn't make sense, or if it feels too good to be true, Signorelli said.

2. Do have budget references.

Make sure that every single line item has a reference behind it, Signorelli said.

Today, we'll talk about building resilience in your workforce. People and teams are the true heartbeat of the industry. We'll explore examples from thought leaders and leading companies to learn how they are creating resiliency in their workforce and future-proofing their businesses.

Workforce Challenges That Inhibit Resiliency

To build a resilient workforce, you first need to understand the factors that could inhibit their ability to bounce back after adversity.

In construction, a major challenge that people are facing is the lack of skilled craft workers. Research from the Associated General Contractors of America found that 81% of firms find it difficult to fill salaried and hourly craft positions.

Labor shortages mean that there are fewer people working on projects, which limits the number of jobs you can take on and increases lead time.

The skills gap also presents a number of challenges to the workforce. According to a report from the Autodesk Foundation and Monitor Institute by Deloitte, the shift toward technology, especially machine learning, artificial intelligence, and automation, could also widen the skills gap, especially for trade workers without a four-year college degree. While technology advancement is great, many construction professionals don't have the right skills to manage it. In fact, according to the recent 2020 JB Knowledge report, "Lack of Staff to Support the Technology" is one of the top struggles of tech adoption.

Needless to say, not having the right people and skills will hinder your firm's ability to succeed in the future. That's why it's critical that you invest the time and resources to build teams that can navigate the modern construction landscape.

Let's look at some of the ways you can do just that.


How to Build a More Resilient Construction Workforce

Build a Culture of Innovation

Innovative companies tend to be more resilient because these firms are always finding new ways to adapt and compete. That said, breeding innovation has to be a conscious and continuous effort. You can hire all the right people, upgrade your tech stack, and map out a strategy, but you won't become innovative unless it's truly a part of your company culture and you have your entire team behind you.

As Tauhira Ali, Construction Technology Group Manager at Milwaukee Tool, puts it, "No amount of strategy, technology, or executive vision will succeed unless employees are unified in their company mission and are all driven towards achieving mutual success. The companies that will build the future beyond 2021 are the ones who empower people and culture to produce results."

How do you empower your team and foster a culture of innovation? Begin by giving your



employees time to ideate and create. Many companies vocally encourage employees to "think outside the box," but team members are usually too busy with day to day responsibilities to work on anything else.

If you want your teams to innovate, make sure they have the time and space to do so. Or better yet, actively create space for out-of-the-box thinking. Make things official by hosting company-sanctioned events dedicated to innovation.

The Seattle-based ENR Top 600 specialty contractor McKinstry did just that. The company was founded in 1960, but despite being around for decades, McKinstry has never lost its focus on applying emerging technologies to today's business problems.

In 2020, McKinstry held a Hackathon, a twoday competition that brought together nearly 50 employees with different backgrounds and expertise. The objective was to cook up innovative solutions to reduce waste from the design and construction processes.

The Hackathon — a first of its kind at McKinstry — proved to be a success. Not only did it encourage people to come up with new ideas, but it also allowed team members to work with colleagues who had different backgrounds and expertise. It was both a learning and team-building experience that strengthened McKinstry's innovative culture.

Dace Campbell, Director of Project Management in Construction at McKinstry, said, "We wanted to accelerate our ability to do discovery and ideate around some of the initiatives on our technology roadmap. Rather than take six to 12 months before we could develop a solution, we wanted to tap into our employees and essentially crowdsource potential solutions faster. At McKinstry, we place a heavy emphasis on taking care of our people and encourage them to be constantly curious. The Hackathon aligned well with those values of innovation and putting people first."

After the event, participants were asked an openended question about their number one takeaway from the Hackathon. More than two-thirds of them volunteered that their top takeaway was the chance to collaborate with others with whom they don't work with on a daily basis. In this pandemic, many of us interact productively with coworkers on our teams, but staff are craving cross-team collaboration and happenstance interactions ("water cooler conversations") that they don't easily get in a virtual, work-fromhome setting. Collaborative events, even virtually, ultimately foster employee engagement and in turn, can strengthen the resiliency of an organization.

Focus Heavily on Diversity

Diversity leads to innovation and better business performance, both of which can help build resiliency. There's plenty of evidence — both quantitative and anecdotal — that prove this.

According to research compiled by SCORE, gender-diverse companies are 21% more likely to outperform in the market, while ethnically-diverse firms are 33% more likely to outperform. In terms of innovation, SCORE notes that "Companies with above-average diversity earned 45% of revenue from innovation" and "Businesses with more diverse management teams have 19% higher revenue due to innovation."

What exactly is it about diversity that makes businesses more successful, innovative, and resilient?

For starters, diversity brings together multiple backgrounds and perspectives. When you have a variety of experts and professionals working together, you're bound to come up with more ideas and make better decisions.

"I think the top strategy and mindset that construction firms will need in order to build resiliency and future proof their businesses is diversity," says Angela Battle, Director of Subcontractor Diversity & Development, at Sellen Construction.

Strong diversity and inclusion initiatives also make people feel better about working at your company. And when employees are empowered, they'll perform at a much higher level.

As Kim Bates, Corporate Service Leader, DPR, puts it, "When you have folks who are feeling good about themselves, their colleagues, and the culture of the organization, they're going to produce really great outcomes. This naturally garners innovation and creativity; this, coupled with a sense of belonging, is a win-win."

"Real figures, real research - get down and dirty on it," she said. "For example, if you are providing a service and your budget states that you can sustain XX amount of customers per month at XX amount of dollars, then the price of the service will be easy to show, given the average price of that service in your geographic area."

However, you need to back up why the customers would come to you versus the competition.

"That's 'down and dirty,' and you can't get too detailed; keep it short and to the point with backup," Signorelli said. "Think about it: When you are reading a budget, you don't want someone rambling about their pipe dream. You want to know that the person understands what it's going to take to make a profit and has a clear plan to bring in business.

In other words, you want details, but you want them to be short and concise.

3. Don't overestimate your income.

"In 20 years, I have never seen a budget where the income was as high as predicted in the first year," Signorelli said.

This is critical, because the lack of income in the first year is what causes 80% of small businesses to go out of business, she said.

"Once your budget is done, go back to it and reduce your income 25 to 50% less than what your due diligence led you to put on the report," Signorelli advised.

4. Don't underestimate your expenses.

"There are things that you underestimated, no matter how meticulous you were, and there are things that you forgot altogether," Signorelli said. "Just like income, you need to go back to your budget and take your expenses and increase them by 25 to 50%.

5. Do have extra funds.

As a small business owner, you must have enough savings, to make sure you can pay your bills during the first year, Signorelli said.

"It was hard enough to get your loan, but I promise you that six months into when you are not profitable, no one will want to loan you more money to get you through the next six months," she said.

6. Don't stress about finances.

To make it through the first year and build a profit, you want to focus on marketing and bringing business in, so you don't need to stress about finances, Signorelli said. Manifesting and building a business requires you, the owner, to believe in yourself and your new small business.

With the right budget, you will get the right amount of money from the right investor, giving you the freedom and confidence to focus on your dream and make it happen, Signorelli said.

7. Do compare lenders.

No two lenders - not even lenders that offer the same type of loan - have quite the same terms. If you find two lenders willing to offer you a loan amount favorable for your budget, one of these loans is likely to have a higher APR than the other. The high-APR loan, though, might have a shorter term, meaning that the burden of repaying your debt lasts longer with the other lender. You should also consider the lender itself - browse its customer reviews and determine the level of customer support you'll receive. A trusted lender willing to assist you may be better than a less-reputable lender with more favorable loan terms.

8. Do check your credit score.

With a low credit score, your chances of being approved for a loan decrease substantially. The minimum credit score needed varies by loan type. This can range from as low as 550 for most merchant credit advances to as high as 680 for traditional bank or SBA loans. If your credit score is too low for the small business loan you desire, there are actions you can take to potentially raise your credit score.

9. Do decide how much funding you need.

It's important to know how much funding you need so you don't get charged prepayment fees when you repay your loans. Some lenders charge prepayment fees if you pay part or all of your loan before your loan term ends. For example, if you take out a \$20,000 loan when you only need \$5,000 and then attempt to pay back the extra \$15,000 after realiz-

ing you only needed \$5,000, you'll be charged fees you could have easily avoided.

10. Do gather your paperwork early.

Applying for a loan is rarely as simple as filling out an application. It usually requires you to file large amounts of paperwork as well. As such, it's never too early to get all your documents in order. These documents can include tax returns and financial statements. You may want to speak with your accountant to determine what you'll need based on the loan for which you choose to apply, but it never hurts to compile everything possible so you're ready no matter what.

11. Do learn from your mistakes.

Yes, it's OK that you made mistakes, as long as you learned lessons from them.

"I worked for a great CPA right out of college for five years to learn all I needed to know to run a business," Signorelli said. "I still made mistakes in the first few years, but the foundation had been set and above all else, it was not an option for it not to succeed. It was my life, and whatever you are taking on must be your dream that you will move heaven and earth to make happen."

Key takeaway: When applying for your first small business loan, create a budget, compare lenders, check your credit score, determine the funding amount you need and more.
