Biden-Harris Administration Launches First Tech Hubs Funding Opportunity

The Biden-Harris administration, through the U.S. Department of Commerce's Economic Development Administration (EDA), launched the Regional Technology and Innovation Hubs (Tech Hubs) competition. This program will create tech hubs in regions across the country by bringing together industry, higher education institutions, state and local governments, economic development organizations, and labor and workforce partners to supercharge ecosystems of innovation for technologies that are essential to our economic and national security. The program was authorized by the CHIPS and Science Act and is a key part of President Joe Biden's Investing in America agenda, stimulating private sector investment, creating good-paying jobs, revitalizing American manufacturing, and ensuring no community is left behind by America's economic progress.

This first Notice of Funding Opportunity (NOFO) the Department is launching today will open applications for planning grants and Tech Hubs Designations. Later this year, the Department of Commerce will launch a second NOFO, for applicants designated as a Tech Hub to apply for implementation funding.

High-Speed Rail Completes Signature Structure in City of Fresno

The California High-Speed Rail Authority (Authority), in collaboration with Tutor-Perini/Zachry/Parsons, today announced the completion of the Cedar Viaduct in Fresno. The 3,700-foot viaduct will take trains travelling at 200-plus mph over State Route (SR) 99, Cedar and North avenues.

"At almost three-quarters of a mile long, the Cedar Viaduct is one of our largest and most visible structures across the alignment and one of the significant achievements to date on the program," said Central Valley Regional Director Garth Fernandez. "The completion of this structure was made possible by our dedicated project team and by the numerous women and men in Labor who brought the project to life."

Happy AAPI Heritage Month! Let's Learn About It.

Asian American and Pacific Islander (AAPI) Heritage Month is celebrated in May across the U.S. During this month, we celebrate the rich heritage and diversity of AAPI cultures. "AAPI" is a broad term that aims to encapsulate those whose ancestry and cultures come from the Asian continent and Pacific Island regions.

About AAPI Heritage Month

May was chosen to celebrate the AAPI community because it is the same month the first Japanese immigrants arrived in the U.S. in 1843. The month also marks the anniversary of the Transcontinental Railroad completion.

The Transcontinental Railroad construction brought more than 15,000 Asian travelers, most of whom were Chinese. Chinese immigrants made up about 90% of the railroad workers. They were largely employed by the Central Pa-

cific Railroad based out of Sacramento, California, and suffered many forms of oppression such as wrongful imprisonment, unfair wages, and dangerous working conditions. The railroad was completed in 1859.

In 1992, President George H.W. Bush designated May as AAPI Heritage Month to celebrate the accomplishments of people of API descent. However, there are important reminders to consider during this month.

Dr. Sunaina Maira, an Asian American Studies professor at UC Davis, described the purpose of AAPI Heritage month as a month to celebrate diversity, but not just for the sake of diversity.

"Heritage months can become sort of superficial and tokenistic celebrations of difference," Maira said. "We're not necessarily thinking about the struggles."

US Department of Labor announces 2023 themes to promote importance of advancing disability employment, honor landmark legislation's anniversary

To mark two significant events in 2023 for people with disabilities, the U.S. Department of Labor today announced its Office of Disability Employment Policy has selected themes to promote National Disability Employment Awareness Month and honor the 50th anniversary of the passage of the Rehabilitation Act of 1973.

ODEP has chosen "Advancing Access and Equity" as its theme for National Disability Employment Awareness Month in 2023. Observed each October, NDEAM celebrates the contributions of America's workers with disabilities past and present and showcases supportive, inclusive policies and practices that benefit employees and employers alike.

Each year, the agency chooses an NDEAM theme for use by organizations around the nation to recognize the importance of ensuring people with disabilities have equal opportunity to prepare for and succeed in employment.

Similarly, ODEP will use "Advancing Access and Equity: Then, Now and Next" to celebrate the passage of the Rehabilitation Act a half-century ago and its importance in prohibiting discrimination based on disability in employment by federal agencies, federal contractors and recipients of federal funds, and in the delivery of federally funded programs and activities. ODEP will use the theme to promote activities to mark passage of the act, the first federal legislation to address access and equity for people with disabilities.

High-Speed Rail Completes Signature Structure in City of Fresno

From the highway, traffic can see a dual span of cast-in-place arches that help support the weight of future high-speed trains traveling atop the deck of the structure. Each arch spans 179 feet and is nearly 40 feet tall. Each dual span of arches are staggered from either side of the bridge, so they can be seen from both sides of the highway.

The Cedar Viaduct is one of several structures along the high-speed rail line with arches. Just a few miles away, SR-99 drivers can see simi-

lar arches for the 210-foot span of the San Joaquin River Viaduct—the Authority's gateway to the Central Valley. The Cedar Viaduct is part of Construction Package 1, the first 32-mile stretch of high-speed rail between Avenue 19 in Madera County and East American Avenue in Fresno

Since the start of construction, the Authority has created more than 10,000 construction jobs, a majority going to residents from the Central Valley. This includes 3,429 that have gone to

residents from Fresno County, 1,946 from Kern County, 1,033 from Tulare County, 442 from Madera County, and 369 from Kings County.

The Authority has begun work to extend the 119 miles under construction to 171 miles of future electrified high-speed rail from Merced to Bakersfield. There are more than 30 active construction sites in California's Central Valley, with the Authority having environmentally cleared 422 miles of the high-speed rail program from the Bay Area to the Los Angeles Basin.

California's history is intertwined with amazing stories of AAPI immigrants and their resilience in the face of oppression. Currently in California, there are more than 6 million Asians or people of Asian descent and around 221,000 people

of Pacific Island descent. That is about 18% of the total population of California. When we celebrate this month, we are paying tribute to those who paved the way for AAPIs and those who are continuing to build it. Some common celebrations include festivals, sharing AAPI foods, and cultural music and performances.

The AAPI community includes so many diverse and beautiful cultures from the Asian diaspora, all of which should be celebrated and highlighted.

How you can get involved

Although we have made great progress toward inclusivity and equality, many social injustices continue to affect AAPI groups and thus our wider community as a whole.

Due to the rise in hate crimes during the CO-VID-19 pandemic in 2020, the Stop AAPI Hate campaign was organized to stand up against the vicious verbal and physical attacks many in the AAPI community faced. AAPI hate crimes in the U.S. have existed since the first Asian immigrants arrived. From attacks after 9-11 on

West, Southwest, and South Asian groups to redlined communities that experience decreased funding or gerrymandering, the discrimination and violence is visible throughout U.S. history. There are many resources we can currently use to combat the systemic oppression of people of API descent.

Transportation Budget Bill Signed by Governor DeWine



Governor Mike DeWine Signs Ohio Budget

Governor DeWine signed the largest biennial transportation budget in Ohio's history. Totaling \$13 billion in spending, House Bill 23 was approved in both chambers of the Ohio General Assembly.

Of the total amount, \$11.4 billion is directed to ODOT. ODOT's fiscal year 2024 budget amount is \$8.3 billion, for fiscal year 2025 funding is set at \$5.1 billion. The Brent Spence Bridge project accounts for nearly \$3 billion of the amount allocated for fiscal year 2024.

In addition, the Ohio Public Works Commission will receive \$60 million and \$64 million, respectively for the biennium. The other gas tax funding in the bill is directed to other programs at the Department of Development, Department of Natural Resources, and Ohio Turnpike, and local governments for roadway improvements. The bill also includes \$37 million in general revenue funds for public transit.

The House included \$1 billion in general revenue funds for a new Rural Roads program, however that program was removed by the Senate. Consideration of this program will likely continue in the general revenue budget bill currently pending in the House.

Beyond setting spending levels, HB 23 also includes changes to transportation related policy issues. For ODOT, the only policy issue of interest to OCA is a change to surety bond requirements. Language was added to allow for multiple surety bonds on projects that exceed \$500 million. The change was necessitated for the Brent Spence Bridge project. The bill also included many provisions on rail safety in response to the recent Norfolk Southern derailment in East Palestine, OH.

The policy issue that caused significant disagreement between the House and Senate was force account limits for local governments. As a bit of

background, force account limits are monetary limits on the amount of work local government employees can do. Projects estimated to exceed these monetary thresholds must be competitively bid. OCA routinely opposes increases to force account limits and was successful in removing attempts to triple the amounts in the last transportation budget.

Hoping to resolve the issue outside of the legislative process we began meeting with representatives from the County Engineers Association (CEAO) in December of last year to reach an agreement. Instead of simply focusing on threshold dollar amounts, the discussion focused on moving towards a "scope of work" model where limits are based on project size - length of bridge, size of culvert, etc. The House included language adopting the scope of work model for county engineers. The parameters recommended by the House were based on negotiations between OCA and CEAO though, there was an unresolved issue with the limitations for culverts. Despite the disagreement on culverts, the bill was approved by a vote of 74-21.

The bill was then sent to the Senate for its changes. After multiple hearings and discussion, the scope of work provisions for force accounts was scrapped entirely. Instead, current monetary amounts were increased by 252 percent or local government governing bodies (city council, boards of township trustees, county commissioners) could set their own limits with no cap. Also, the current inflation index for force accounts would change from using the ODOT Construction Cost Index capped at 3 percent biennially to an annual increase using the National Highway Cost Index without a cap. The Senate approved the bill unanimously.

San Mateo County Establishes Program to Remove Lead Paint from Residential Properties

With funding from a legal settlement with paint manufacturers, San Mateo County has entered into an agreement with local nonprofit Rebuilding Together Peninsula to establish a lead paint hazard remediation program for residential housing in the county.

The Board of Supervisors has approved the agreement, the latest step in a decades-long legal effort.

"This settlement finally holds these companies accountable while providing much-needed funding to clean up the harm they have caused to generations of Californians," said Warren Slocum, vice president of the San Mateo County Board of Supervisors.

"I'm proud to see San Mateo County moving forward in a partnership that will reduce the dangers of lead paint," Slocum said. "This is really about equity. We know that children from low-income households are far more likely to be exposed to the dangers of lead paint because their housing is likely to be older."

In 2000, the County of San Mateo joined a lawsuit led by Santa Clara County against former lead paint manufacturers for their role in creating a public nuisance by promoting lead paint for use in homes. Although lead paint was banned for residential use in 1978, it remains present in millions of homes in California.

In 2019, 10 California jurisdictions reached a settlement requiring Sherwin-Williams, ConAgra Grocery Products, and NL Industries to provide funding to clean up the lead paint that poisons tens of thousands of children in California each year. Exposure to lead can seriously harm children's health, including damage to the brain and nervous system, slowed growth and development, and hearing and speech issues.

The County of San Mateo's portion of the settlement is \$11.7 million, distributed in annual payments through 2025. The funds will be used to develop programs to remediate the dangers of lead paint from housing, with a focus on lower-income families and children.

The first year of the agreement with Rebuilding Together Peninsula will be dedicated to planning and program development, hiring, and establishing sub-contracts for lead testing and construction work. The pilot program will

involve three to five homes, which will expand to 20 to 25 per year once the program is full established.

Participation in the inspection and abatement program is free and voluntary for property owners

Established in 1989, Rebuilding Together Peninsula provides renovation and repair services for vulnerable homeowners, including seniors and veterans, individuals with disabilities, and families with children.

"We are excited to work with Rebuilding Together Peninsula to begin the process of inspecting and cleaning homes in our community," said Donna Spillane, □County Health's deputy director for administration and finance, who is overseeing the program. "This program will eliminate a serious threat to the health and well being of children in the county."

San Mateo County is estimated to have more than 50,000 units of pre-1950 housing and more than 150,000 units of pre-1980 housing. Homes built before 1950 tend to have significantly higher levels of lead in paint than homes that were built after 1950.

Criteria for selecting homes for inspection and remediation have not yet been established, and more information will be available as the program develops.

Jose Mendoza, FiestaBowls

Innovation and persistence to reach its small business goals were the navigation tools that kept a San Francisco venture afloat during the pandemic.

FiestaBowls, located between 18th and 19th streets, is an example of the tenacity of the Mission's business community. In challenging times, this community found ways to carry on in the pursuit of their dreams. This year, the Mexican snack business was one of the initial recipients of a loan from the Racial Equity Lens (REL) fund. Fondo Adelante, MEDA's Community Development Financial Institution (CDFI), led the design and implementation of this innovative loan fund. This initiative focuses on low-interest loans for BIPOC-owned small businesses.

"The idea behind the Racial Equity Lens Loan Program is to support our businesses in the neighborhood with strong relationships with the community, and that may not qualify for an affordable business loan through other financial institutions," says Pablo Solares, Director of Fondo Adelante at MEDA. "We charge between 7% and 9% in interest in contrast to the over 20% charged by credit cards."

Innovating to survive

The story of FiestaBowls began three months before authorities ordered public health closures in spring 2020. Like most businesses, owner José Mendoza and his brother then had to close for two months. On their "soft" return, they had to resort to their inventiveness and work capacity to remain open.

"We lived for months without any money coming in for us," says José. "Everything (income) was going to pay bills, food, rent ... but the goal was for the business to continue."

As the COVID-19 emergency faded in San Francisco, FiestaBowls' owners began adding new items to their menu. They finally had the opportunity to meet their clientele and adapt to meet their needs.





The village steps in to help

As part of the requirements to obtain the REL loan, FiestaBowls' owners received technical assistance from MEDA's Business Development team. They attended the six-week information sessions alongside other San Francisco merchants

"Many of them [the merchants] gave examples of what worked and didn't work, especially around their ideas on how to attract new customers," explains José. "We are always learning, with an open mind. There are people who may not want to hear opinions on how to operate their business, but we believe that any opinion helps us."

Today, FiestaBowls showcases an innovative business with a selection of products recognized by multiple generations of residents. Along with FiestaBowls now thriving, these enterprising entrepreneurs this year opened El Rey Taquiza Artesanal. This new business is also on Mission Street, located between 21st and 22nd streets.

"FiestaBowls is a business that has been very involved in the Mission District since it started just before COVID-19," says Pablo. "They have been part of our MEDA family through multiple programs and marketing initiatives, their products maintain our neighborhood's cultural identity and Jose (the owner) is invested in growing as a successful business owner through our business coaching workshops."

Milagros Escuela, MamaArepas

Milagros Escuela is the owner of MamaArepas, along with her husband, Fidel Lozada. They have worked tirelessly to bring Venezuelan Arepas to every dining table in South Florida since 2015. Made out of corn dough, Arepa is a typical food in several Latin American countries. It is different in each region and is very important in the traditional Venezuelan cuisine.

Milagros and Fidel's journey started at home, making arepas for their family and friends and getting requests for more. As they saw the demand and the business opportunity, they contacted the State of Florida. They wanted to understand the requirements to operate a fully compliant food manufacturing business. They also set out to properly formulate each of their arepa products (corn, cheese, plantain). All this, to ensure the quality and safety and to consistently deliver the great taste their followers expect

As they grew a steady clientele, they moved the production to a shared commercial kitchen. They rented this for six hours every day. Soon, MamaArepas started to sell better at brick-and-mortar locations like Sedano's, Broward Meat & Fish Stores, Bravo Supermarket, and other meat stores. The demand became so high the company needed a commercial kitchen of its own. This would help increase its production and have capacity for faster growth.

Growing Joys and Pains

As Milagros and Fidel secured a bigger space of their own in Hialeah, the company's overhead increased as well. So did the need for capital to initiate their market expansion outside of South Florida. They'd also need equipment to produce more arepas in less time with the flexibility to innovate new products.

MamaArepas needed a loan. That is when Milagros and Fidel learned about the Community Fund of North Miami Dade (CFNMD). They connected through another non-profit organization helping them expand their market. They applied for funding with CFNMD. Through this process, they realized the importance of having all business documentation up to date. They also had to be ready to have the business fully analyzed and understood, in order to get funding approval.

With the loan proceeds, MamaArepas bought new equipment. This effectively moved them from an artisanal to a more industrialized operation. They created two jobs and received the first order from a new distributor in the State of New York. The company has also updated and improved the labels and introduced new products. Finally, they implemented a sales strategy to bring the Venezuelan arepa to other communities around the country. Their long-term goal is to export to other countries.

Tips for Cooking Up Your Business Growth

Milagros has some advice for other entrepreneurs starting their business or newly arrived in the United States.

For the entrepreneurs looking for funding for their business, Milagros advises to keep all the documentation up-to-date and organized. This way, when they request funding from a lending institution, "they can show that they are doing things correctly and in a clear, honest and transparent way" through their bank statements, company licenses, tax returns, financial records and other documents.

Women Made Up Majority of Home-Based Workers **During Pandemic**

Women, already the majority of home-based workers in 2019, increased to a slightly larger share of a growing home-based U.S. workforce in 2021, after the onset of the COVID-19 pan-

Working from home was among the safety measures adopted during the COVID-19 public health emergency (which has since been lifted) to reduce transmission of the novel coronavirus. As a result, the percentage of home-based workers in the United States tripled from 5.7% of all workers in 2019 to 17.9% in 2021 — an increase of nearly 19 million workers, according to American Community Survey (ACS) 1-year

This shift has had social and economic impacts including on caregiving roles, actual or perceived workplace productivity, professional advancement opportunities and commuting burden.

Majority of Home-Based Workers are Women

In 2021, the majority (52.8%) of workers were men but women made up the majority (51.4%) of home-based workers.

Despite the increase in home-based workers, the share of women who worked from home each year in 2019 and 2021 was broadly similar.

Working from Home More Common in Some Occupations

Certain occupations may lend themselves to home-based work more than others. ACS data show a strong relationship between occupation (organized into five groups for this analysis) and the percentage of workers who worked from home (Figure 2).

In 2019, a relatively small percentage worked from home in every occupation group but the highest share was in management, business, science and arts occupations like insurance underwriters, mental health counselors and marketing managers.

The percentage of home-based workers rose for each occupation in 2021 but the biggest share (about 28%) of home-based workers was still in management, business, science and arts occupations


In both 2019 and 2021, production, transportation and material moving occupations (bakers, machinists and taxi drivers) had the lowest percentage of home-based workers (2.3% and 5.3%, respectively).


Women Working From Home Varies by Occupation Group


In 2021, women made up the majority (52.2%) of U.S. workers in management, business, science and arts occupations; service occupations (56.7%); and sales and office occupations (62.2%)

Meanwhile, men made up 94.9% of the nation's workers in the natural resources, construction and maintenance occupations and 75.7% in production, transportation and materials moving occupations (Figure 3).
