Making the Case for Digital Transformation in Construction

The challenges in today's construction landscape are well documented, from supply chain issues and rising inflation to workforce shortages and a potential economic slowdown. Digital transformation is an essential catalyst to counterbalance these challenges and provide the construction industry with opportunities to increase efficiency, productivity, and design. However, adopting new technology alone will not solve our problems. Contractors must leverage a multi-functional digital transformation strategy focusing on innovation and organizational change to improve business value and solve their most challenging problems.

The main goal of digital transformation is to streamline business operations, increase productivity, and reduce costs while providing a safer jobsite for all and quality projects for clients.

What is digital transformation in construction?

Gartner defines digital transformation as anything from IT modernization (for example, cloud computing), to digital optimization, to the invention of new digital business models. However, to advance digital transformation in construction, we must expand that definition to include leveraging innovative solutions that improve the industry's efficiency and effectiveness. The approach needs to involve changes in the way

construction companies operate and interact with stakeholders, such as clients, suppliers, and regulatory bodies and include the implementation of digital communication tools, such as project management software, and the adoption of collaborative processes, such as integrated project delivery (IPD) and lean construction. For examples, research from McKinsey shows that collaborative contractual relationships result in an 8% to 9% improvement in productivity and a 6% to 7% improvement in cost savings.

Current state of digital transformation in

According to the McKinsey Global Institute, digital innovation and transformation can significantly improve productivity (about 15%) and reduce costs (around 6%). While the construction industry has made significant strides in digital transformation, industry fragmentation, the complexity of projects, and lack of standardization are a few factors that are contributing to slower adoption. However, advancing digital transformation is imperative to stay competitive in today's fast-paced, technology-driven world. By embracing technology and optimizing operations, construction companies can reduce costs, improve productivity, and deliver better project outcomes.

Key pillars to a successful digital transformation

People, process, and technology are the three key pillars that are critical for a successful digital transformation.

Biden-Harris Administration Invests \$30 Million to Advance American-Made Clean Energy Technologies and Accelerate Push for Net-Zero Federal Buildings

During remarks at the American Institute of Architects' annual conference in San Francisco. Robin Carnahan. Administrator of the U.S. General Services Administration (GSA), today announced that GSA, in collaboration with the U.S. Department of Energy (DOE), will invest \$30 million from the Inflation Reduction Act to

increase the sustainability of federal buildings by testing novel technologies through the Green Proving Ground (GPG) program.

The GPG program evaluates emerging and sustainable technologies in real-world settings and will accelerate the agency's efforts to achieve net-zero emissions in federal buildings while creating good-paying clean energy jobs. These new, American-made technologies will help in-

crease federal electric vehicle supply equipment, protect air quality, reduce climate pollution, and enhance building performance.

This year the GPG program has selected 20 emerging and sustainable technologies for real-world evaluation in GSA's real-estate portfolio, a four-fold increase over previous years thanks to funding from the Inflation Reduction Act. This includes enabling the GPG program, which typically evaluates 4-5 technologies per year, to increase its capacity and take other steps to advance President Biden's goal to achieve a net-zero emissions federal buildings portfolio by 2045.

"This significant expansion of the Green Proving Ground program is a prime example of how President Biden's Investing in America agenda is driving the next generation of clean energy jobs and innovation," said Administrator Carnahan. "Across the country, we're turning federal buildings into testbeds for clean

energy innovation - which will mean more good jobs, savings for taxpayers, and a healthier planet for our kids."

"GSA's Green Proving Ground program helps unlock the technologies and cost savings we need to meet President Biden's Federal sustainability goals, including achieving net zero emissions by 2050," said Federal Chief Sustainability Officer Andrew Mayock, with the White House Council on Environmental Quality. "Today's announcement is the latest action demonstrating how the Federal Government will lead by example on climate.'

This year's GPG program focuses on seven technology areas:

Electric Vehicle Supply Equipment (EVSE) technologies are critical to supporting the transition to an all-electric fleet by 2035. Four EVSE technologies will be

Racial Equity Benefits All Americans



Treasury Department will host the third meeting of the Treasury Advisory Committee on Racial Equity (TACRE). TACRE is comprised of 25 experts drawn from academia, business, nonprofits, philanthropy, and other fields who help the Treasury Department ensure we are thinking about how our policies impact racial equity and hold us accountable for the commitments we've made. With Juneteenth approaching, this week's TACRE meeting is an ideal time to take stock of our work to date.

As I look back at the last two-and-a-half years of the Biden-Harris Administration, I am proud of the way our actions have advanced racial and economic equity, from the American Rescue Plan Act (ARP) enacted in the early days of the Administration to the ways we have implemented the Inflation Reduction Act (IRA) over the past few months. We have seen historic gains in employment and wages among Black and Hispanic workers, as well as on other key economic metrics.

To name just a few, both Black unemployment and the gap between Black and white unemployment recently reached their lowest levels on record. From 2019 to 2022, median weekly earnings increased 4 percent for Black workers and 2.4 percent for Hispanic workers after accounting for inflation.[1] And the Black and Hispanic supplemental child poverty rates—which account for government benefits—reached their lowest levels since 2009.[2]

But an underappreciated aspect of these policies designed to support those often left behind by economic policy is the impact they have on all working-class Americans regardless of race. All Americans—including rural, white, and other communities—have benefited from the President's focus on equity. In his quest for economic justice, Reverend Martin Luther King, Jr. often spoke of the challenges and experiences shared among poor white people and marginalized Black people and of how detractors sought to sow division between them to prevent unified action. Today, our politics continue to distract us from the fact that workingand middle-class Americans of all races and creeds still face a set of shared economic challenges. In his famous sermon The Drum Major Instinct, Reverend King called on us to overcome our instinct to focus on how we or our group can get ahead of oth-



ers and to instead to work toward collective justice for all of those in need.

The economic data from the last two years demonstrates clearly that policies designed to support those in greatest need ultimately benefit everyone. This mirrors what social scientists call the "curb cut effect,"[3] the idea that laws designed to benefit the disabled by requiring curb cuts ultimately benefit a wide variety of groups—both disadvantaged and not—from parents with strollers to workers loading and unloading goods.

Let me highlight how this is true looking at three important indicators of economic wellbeing: (1) employment; (2) access to housing, as measured by eviction rates; and (3) access to high-speed internet, which is essential to small business formation and online education.

Expanding Employment

When President Biden took office, our country was still in the grip of a once-in-a-generation public health and economic crisis, with unemployment peaking at nearly 15 percent. Beginning with the American Rescue Plan, President Biden made it a priority to get Americans back to work. The ARP gave small businesses and governments significant resources to keep Americans on the payroll during the worst stretch of the pandemic and to invest in workforce training and other programs to support American workers in the long run.

I've seen these investments firsthand, on trips across the country to places like Orlando, Florida; Bethlehem, Pennsylvania in the Lehigh Valley; and many other communities. Last year, I met a woman named Diamond who almost lost her home during

the pandemic. Her access to federal eviction prevention funds helped her keep a roof over her head and enabled her to enroll in job training and transition to a new career to better support her family. And there are countless more stories[4] about how the President's response to COVID helped American workers weather the pandemic and ultimately emerge even stronger.

More recently, Treasury has implemented provisions of the IRA that provide bonus incentives for clean energy and manufacturing investments in low-income and former coal communities—helping to generate employment opportunities in these areas and enabling them to participate in the gains of the clean energy transition.

evaluated: turnkey electric vehicle charging infrastructure from Loop Global, optimized charging through charge management software from bp pulse, a battery-buffered DC fast charger from ADS-TEC Energy, and vehicle grid integration (VGI) technology from General Motors LLC.

- Germicidal Ultraviolet technologies use next-generation LEDs and Far-UVC light to disinfect air without increasing ventilation. The GPG program will evaluate technologies that support healthier buildings while reducing energy use from Far UV Technologies, R-Zero and PURO (subsidiary of Applied UV Inc.) with the Academy Energy Group.
- Greenhouse Gas Accounting technologies are essential to achieving 24/7 carbon-free electricity and net zero operational emissions. Cambio AI and nZero will aim to go beyond annual greenhouse gas reporting to operationally focused carbon management,

including near-real-time 24/7 carbon-free electricity insights and impacts.

- Grid-Interactive Efficient Buildings deliver cost savings by leveraging technologies and strategies that provide continuous demand management and load flexibility. The energy management platform from COI Energy aims to optimize energy use through machine learning.
- High-Performance technologies help reduce operational and embodied carbon emissions. The GPG program will evaluate automated aerosol-based duct sealing from Aeroseal; an Internet-of-Things (IoT) lighting system from Signify North America Corporation; and bio-engineered, lowembodied-carbon concrete from Biomason. DOE will seek commercial partners to validate Toggled, a plug load control solution, and a thermostatic radiator cover and hybrid electrification solution from Kelvin.
- Onsite Renewables are essential to meeting the Administration's net zero opera-

tional emission goals. The GPG program will evaluate an energy storage technology from Yotta Energy that is the size of a large laptop and installed in place of ballast beneath a rooftop photovoltaic system. The program will also pilot a wind turbine from Accelerate Wind that can be installed at the edge of the building roof and complement rooftop solar.

Window Retrofit technologies help improve the performance of a building's exterior envelope. The GPG program will evaluate three technologies: (i) vacuuminsulated glazing from Pilkington; (ii) R14 interior window retrofit system from Vitro Architectural Glass; and, (iii) a secondary window framing system from Indow.

Some of these technologies will be tested at GSA's Applied Innovation Learning Labs to identify replicable combinations of technologies that deliver netzero operational emissions.

The GPG program leverages GSA's extensive real estate portfolio to evaluate innovative building technologies in real-world settings. The evaluations are intended to validate the technical and operational characteristics of the technologies and their potential for future wide-scale adoption. GSA anticipates that the results of this year's evaluations will be available in 2025. Evaluation results help GSA make sound investment decisions in next-generation building technologies. Since 2011, GPG has evaluated 104 technologies, 23 of which have been deployed across more than a third of GSA's federally owned portfolio, avoiding 116,000 annual tons of CO2 and delivering \$28 million in annual cost avoidance. Wherever they settle, highly skilled immigrants contribute to the local tax base, start

new businesses, and create jobs for local residents—all of which are crucial to communities in need of economic revitalization. Federal immigration policy, however, currently channels an outsized portion of highly skilled immigrants to America's largest, fastest-growing, and most prosperous cities. A Heartland Visa program would help a wider array of cities attract skilled immigrants to boost economic development, strengthen their workforce, and fuel local innovation and entrepreneurship.

Immigrants contribute billions of dollars to the Ohio economy each year and fill critical jobs in industries such as health care and manufacturing. Top 4 Takeaways: Governor Newsom's Proposals to Build More, **Faster Heard in the Legislature**

This week. Governor Gavin Newsom's ambitious infrastructure permitting and project review reforms to build California's climate resilient future were heard by both the Assembly and Senate.

The Administration made a clear case: without reforms, California will risk funding for critical infrastructure like safe drinking water and clean energy.

Here's U.S. Secretary of Energy Jennifer Granholm in California yesterday discussing the need for permitting reform:

"A lot of environmental activists have used these [environmental] laws, of course, to protect the environment, and used it for the purposes of delay. But now we know what has to happen... We spent \$165 billion as a nation last year just cleaning up after these extreme weather events, it is on our doorstep, so we can no longer delay. The very environmental species that we are seeking to protect with these laws are going to be damaged by climate change if we do not act with alacrity. So, bottom line is: I think every state — including California — and the federal government, have to get our act together to realize that you will protect the environment if you act on climate.'

Here are the top 4 takeaways from the four legisla-

1. THE GOVERNOR'S PROPOSALS ARE URGENT.

"The proposals that the Governor brings forward. we don't bring forward lightly into the budget process but because we have to take action now," said California Natural Resources Secretary Wade Crowfoot, "It is reasonable for us to expect that the more punishing drought is just around the corner or the more damaging flood or the more destructive wildfire. From our perspective, this isn't the case of reforming our systems over years or months, the urgency we bring to this is weeks."

"Whether it's housing, whether it's transportation, whether it's public works, whether it's critical water infrastructure, whether it's renewable energy almost all of that is going to run through our department for some permitting purpose," said California Department of Fish and Wildlife Director Chuck Bonham. "Every day we delay permitting renewable energy projects is compounding our ability to achieve our goals."

"We're in strong support because water and other infrastructure upgrades are urgently needed," said California Chamber of Commerce Policy Advocate Brenda Bass. "Projects like canal repairs, water treatment facilities, water storage options, groundwater recharge projects will all benefit from streamlining. Projects need to move in a timely manner to save taxpayer dollars."

2. \$180 BILLION IS ON THE LINE.

"Over the next decade the state will have the opportunity to invest \$180 billion over the next 10-years and create as many as 400,000 jobs across the state - a level of construction and investment not seen since the Governor Pat Brown era," said Senior Counselor to the Governor on Infrastructure and Clean Energy Finance Gayle Miller. "These bills will in fact make a difference as to the timing

and delivery of projects—we have seen the broadband planning and delivery decrease from 33 to 11 months by implementing many of the proposals you will see here today.'

"The Governor's infrastructure package represents another ambitious effort and aims to maximize taxpaver dollars and deliver results while creating hundreds of thousands of good jobs and working towards achieving California's world-leading climate goals. This package would expedite a number of transportation projects, from routine highway maintenance and safety projects to innovative and complex transportation improvements that take years," said California State Transportation Agency Secretary Toks Omishakin. "Contracting out more quickly accelerates projects, shows the state's readiness and makes them more competitive for federal grant funding through notices of funding opportunity.'

3. CREATES GOOD PAYING JOBS.

"We represent 70,000 hardworking men and women in California and when we build these construction projects in California, we pull people of color, women, and second chancers into the middle class," said California State Council of Laborers Executive Director Joe Cruz. "We need to accommodate all new growth, we need to accommodate big projects that keep our state competitive, but more importantly we got to change people's lives and we want the opportunity to talk about what those projects mean to everyday people."

"Infrastructure is actually the fabric that holds us together. Right now, California's infrastructure is broken, which includes roads, highways, water, bridges, energy – and of course, the human element of our workforce, which is not to be understated in the infrastructure discussion," said California Manufacturers and Technology President and CEO Lance Hastings. "We really are at that tipping point and if federal dollars are going to be the thing that brings us all together, we can't underestimate that."

4. STATE MUST BUILD MORE, FASTER TO REACH CLIMATE GOALS.

"Housing is a crisis and that's where we are with climate – and you have to stop letting perfect be the enemy of good," said Scott Wetch, on behalf of the State Association of Electrical Workers (IBEW). the California State Pipe Trades Council, the Western State Council of Sheetmetal Workers, California Coalition of Utility Employees and the Elevator Constructors Union. "This is an opportunity that you cannot fumble so we would absolutely urge your aye vote."

"We believe this is just the first step and more reforms are needed on the front and back end of CEOA including local land use constraints to get us to 86 gigawatts of clean energy online by 2045 to meet our climate and energy goals," said Cara Martinson, on behalf of Large Scale Solar Association. "We share the sense of urgency and believe projects that reduce GHG emissions should be ex-

The DB team should anticipate participating in the full project timeline, with responsibilities to include compiling a complete project design package that meets the performance parameters outlined for each energy efficiency measure. The energy efficiency measures include chiller replacement, installation of a dedicated HVAC system, interior/exterior lighting improvements, retro-commissioning, new variable speed motors, and controls

PROCEDURES: The prequalification process will result in the selection of finalists who will be prequalified and will be issued proposal documents for this Project. The prequalified proposers will submit price and technical proposals. The technical proposals will be scored according to an established scoring system. The price will be divided by the score to determine a price per technical point. The prequalified proposer submitting the lowest price per technical point will be the apparent low proposer for

After receipt of the prequalification documents, the University will review and determine a preliminary point score for each submittal. Requests for clarifying information and additional data will be made at this time, if required. After receipt and review of the clarifications and additional data each prequalification submittal will receive a final point score.

Scoring of proposers will be determined by the application of an established rating system, requirements of which are contained in the Prequalification Questionnaire.

A proposer who receives 70 or more points out of a possible 100 points based on the established rating system will be invited to participate in the Request for Proposal step

Proposers will be notified whether or not they have been pregualified after the University evaluates the prequalification submittals.

Natural Behavioral Solutions is an Applied Behavioral Analytical (ABA) company which uses naturalistic approaches to learning in order to teach children and adults ages 1 through 22 years-old with disabilities or behavioral concerns achieve independence in their home, school, and community.

This quote by Brooke Hampton on the Natural Behavioral Solutions website captures the spirit of their approach:

"Speak to your children as if they are the wisest, kindest, most beautiful and magical humans on the Earth, for what they believe is what they will become"

Amanda Messina-Godfrey, Founder, Executive Director, and Board-Certified Behavior Analyst (BCBA) therapist received small business guidance from the Renaissance Entrepreneurship Center to help her business grow.

In Contra Costa County, Amanda found that there is both a large market for behavioral services and a shortage of ABA providers. She felt there was an opportunity to bring her unique approach to Hercules and Contra Costa County. Built on the philosophy that every child is unique and is owed a support system that helps them grow and thrive, Natural Behavioral Solutions provides behavioral assessments, 1-on-1 in-home behavioral intervention, tele-health behavioral intervention, parent and caregiver education, and social skills groups.

"Renaissance helped me reignite my passion for getting my business moving forward. What was most beneficial was the Start Smart training and the 1:1 consulting to revamp my financials. When I consulted with Tatiana (Renaissance's Program Manager), she recommended the Dream Fund to help me acquire the funding needed to get my business to the next step. I am excited to continue getting the training I need from Renaissance," said Amanda.

Amanda has been a BCBA therapist since 2018 and has been in the field since 2015. She started her business in 2020 but was unable to take on clients due to a lack of funds (most of her services require a 3-month reimbursement period from the insurance companies) and had been operating at a loss. Amanda enrolled in Renaissance East Bay's Start Smart training and was able to develop a strong Business Model Canvas that defined her mission statement, target market, need for capital, and growth plans

Amanda explained that she enjoyed taking the Start Smart course but gained the most from the 1-on-1 time with her consultant. Since Amanda came to Renaissance having already opened her business but having no sales and operating at a deficit for two years, the Start Smart class and the personalized consultations provided the knowledge, skills, and new ideas she needed to pivot her plans and determine how to move forward profitably. In addition, after consulting with Renaissance's Program Manager, Amanda applied to the Dream Fund and was thrilled to receive a \$5,000 award.

With the knowledge she gained from the Smart Start program, she plans to launch her clinic in Hercules, CA in the next few months including hiring two full-time and one part-time behavioral technicians to assist with therapeutic services as prescribed by the clinical team. The clinic will be open for in-person, in-home, and online virtual sessions to assist those needing therapeutic services. Amanda's company has been operating at a loss for the past two years, but with the training, 1-on-1 consultations, five-year plan, and the Dream Fund, she is excited to soon be providing Contra Costa County residents with the help they need.
