8 Innovations that Will Change Construction As We Know It

Construction innovations are progressing rapidly, and the industry now has a tremendous amount of resources to advance construction technology. Construction tech funding hit a record high of \$2.1 billion in 2021—a 100% increase from the year before.

These investments in innovations pay off significantly; research shows that firms that are rated as “digitally savvy” outperform companies by as much as 48% on revenue and 15% on net margin. And this is true across many fields, including AEC.

There’s never been a more exciting time to be a part of the construction industry. As it continues to change at an accelerated pace, innovations will bring about even more developments and advancements. Here are 8 innovations we believe will shape the future of the industry as we know it today.

1. AI and Machine Learning for Construction Workflows

Optimized workflows are essential to well-running projects and teams in the AEC industry.

California High-Speed Rail Releases Final Environmental Studies to Finalize Project Alignment into San Francisco

The California High-Speed Rail Authority (Authority) released the Final Environmental Impact Report/Environmental Impact Statement (Final EIR/EIS) for the approximately 43-mile San Francisco to San Jose project section in Northern California. If approved by the Authority’s Board of Directors in August, this project section and its environmental document will complete full environmental clearance for high-speed rail in Northern California.

“We’re making true progress on nearing full environmental clearance for the entire Phase 1 high-speed rail project,” said Authority CEO Brian Kelly. “With 380 miles from the Bay Area to northern Los Angeles County already complete, today’s release brings us into San Francisco and nearly 423 miles to be environmentally cleared. We look forward to the Board’s consideration of this document in August.”

The Authority’s Board of Directors will consider certifying the San Francisco to San Jose project section Final EIR/EIS and approving the Preferred

Alternative between San Francisco and Scott Boulevard in Santa Clara during its two-day board meeting August 17 and 18. If approved, this project section will move a step closer to being “shovel ready” for when preconstruction and construction funding becomes available.

Under both high-speed rail project build alternatives to be considered by the Board of Directors, an interim rail station is planned at 4th & King streets in San Francisco – until the connection to Salesforce Transit Center is made – along with a station at Millbrae that offers a direct BART connection to San Francisco International Airport. Both Caltrain stations would undergo alterations to accommodate high-speed trains, including modifications to existing tracks and platforms.

Both alternatives include constructing a light maintenance facility, straightening tracks to improve travel times and installing rail corridor safety improvements. The Preferred Alternative for Board consideration, identified in the Final EIR/EIS as the portion of Alternative A to Scott Boulevard in Santa Clara, includes an East Brisbane Light Maintenance Facility and excludes

the additional passing tracks proposed in the other build alternative studied in the Final EIR/EIS, Alternative B.

The Final EIR/EIS includes:

- An analysis of alternatives, including impacts and effects.
- Mitigation measures proposed to reduce environmental impacts and effects.
- Public comments received on the Draft EIR/EIS and Revised/Supplemental Draft EIR/EIS and responses to comments.
- Revisions to the Draft EIR/EIS made in response to comments.

Mayor Garcetti signs proclamation making Juneteenth a City holiday

Mayor Eric Garcetti was joined by Councilmember Curren Price to sign a proclamation making Juneteenth an official City holiday.

“We need every Angeleno to learn the full story of our past, no matter the ugliness of some of its chapters – and that means recognizing the lasting legacy of slavery in our country,” said Mayor Eric Garcetti. “While we can’t dislodge structural racism overnight, it’s our responsibility as a city to acknowledge hard truths and advance reforms, and by declaring Juneteenth an official holiday, we’re making it clear that the ending of slavery should be remembered as a watershed moment in American history.”

Following the proclamation signed by the Mayor today, the City Council is set to issue a supporting resolution to be voted on no later than Friday, June 17. The holiday will be recognized as a City holiday on June 19 every year. Should the 19th fall on a Saturday, the holiday will be observed on the preceding Friday, and if it falls on a Sunday, it will be observed on the following Monday. This year, the holiday will be recognized on Monday, June 20.

Juneteenth is commemorated on the anniversary of June 19, 1865, when Union Army General Gordon Granger issued an order proclaiming freedom for enslaved people in Texas, which was the last state of the Confederacy with legalized slavery. On June 17, 2021, President Biden signed the Juneteenth National Independence Day Act to designate June 19 as a federal holiday commemorating the emancipation of enslaved African-Americans.

“This is a long-awaited bittersweet moment,” said Councilmember Curren Price. “Juneteenth marks the end of our nation’s darkest days by acknowledging its historical significance and offering a sense of vindication. Juneteenth for the Black community serves as a brighter chapter. Our freedom day. Our true day of emancipation. This will now be a day of remembrance for our City.”

“Juneteenth is an important day for our country - a reminder of the racism, discrimination, and social

injustices that persist more than 150 years after the abolition of slavery,” said Council President Nury Martinez. “Beyond recognizing this day as a holiday and giving Angelenos the space to reflect, it’s about action and focusing on the work that still needs to be done.”

“As an ethnically diverse City, we take pride in recognizing the rich histories of all our cultures. For decades and within the Black community, Juneteenth has been a day full of celebrations and

recounting stories of how far the community has come,” said Los Angeles City Councilmember Paul Koretz. “While acknowledging how much more is to be done, it brings me great pride to officially recognize this holiday in the City of Los Angeles and the countless contributions of Black Angelenos.”

However, due to the complexity of construction, workflows have the tendency to be disconnected and manual in nature. The three most significant areas within optimized construction workflows are communication, data, and transparency. AI is making it easier to succeed across all three of these areas, resulting in greater productivity and profits. The fact that Accenture proclaimed AI has the potential to increase industry profits by 71% by 2035 doesn’t hurt either.

Machine learning is also helping construction pros optimize their workflows and aid decision-

making. Predictive analytics is quickly establishing its foothold in the construction industry’s core stack of technology tools. By leveraging current and historical data as well as machine learning, companies can make predictions about future outcomes. These predictions can then be used to make more informed decisions and strategize next moves.

Predictive analytics and machine learning are especially valuable in today’s world of complex construction projects and operations. Companies need a precise way to mitigate risks, take advantage of opportunities, and prepare for challenges. This information also gives workers the freedom

to focus on higher-value activities that are more likely to move the needle.

BAM Ireland is an excellent example of this benefit. The multinational construction company leveraged Construction IQ as its predictive analytics tool for all projects. Doing so led to a 20% improvement in on-site quality and safety and a 25% increase in time spent on high-risk issues.

Pype’s Smart Plans leverages AI to manage core construction documents, including spec books and submittals. The software platform reads through these unstructured drawings to extract contract compliance items, ensuring no requirements are left behind.

AI and machine learning can also increase safety at construction sites by automating safety observations and inspections. Josh Kanner, Founder and CEO of Newmetrix, says that construction pros can utilize these technologies to create computer vision models that can identify safety issues.

“You don’t need to have people walking around, you can actually have the machine help you understand what those scenarios are. So now you’re able to get hundreds of additional observations a week, and thousands a year,” says Josh.

A successful project manager understands that risks happen and has a thorough plan in place to handle anything that goes wrong. The PM, as well as the team, has to sit down and identify as many risks as possible before the project begins, so their action plan is actionable when initiated.

That being said, some risks are incredibly difficult to identify and mitigate. PMs ahead of the game will think about solutions to reduce this risk – including technology that incorporates artificial intelligence and machine learning.

Innovations currently exist that can identify a range of risks, from safety issues to potential trade clashes.

4. Entrepreneurial Qualities

Managing construction is much like operating a business. Each project is distinct in its own challenges and teams who grace it. People look up to project managers to plan and initiate processes, monitor work and quickly rebound if a setback appears. Having an entrepreneurial mindset is necessary to reach success as you are managing multiple projects that have a range of scopes,

clients and teams working together to create a cohesive and dynamic environment. With entrepreneurial qualities, construction project managers are better equipped to ride the highs and lows of the construction project and become stronger leaders.

5. Skips Micromanagement

When it comes to micromanagement, top PMs throw that idea out the door. The sheer size of projects and the number of teams can make micromanaging everyone a waste of productivity and time. A successful project manager must trust that the workers have the skills to complete the project on time, and the workers need to have trust in their PM regarding the assignment and distribution of given tasks. Although it can feel difficult not to have 100% control over every construction activity, skip getting caught up in the day-to-day minutia and instead focus more on the end goal.

6. Enthusiasm While on the Job

One of the often-overlooked skills of a construction PM is their overall demeanor while at the worksite. Construction crews are scattered throughout the site trying to complete work and meet deadlines as stress can build in team members and lower morale. A project manager who is upbeat, enthusiastic and motivated can raise the spirits of their workers and boost confidence. In turn, this results in better work productivity as a motivated and happy team will feed off that enthusiasm. With the right leadership, staff will end up working harder to meet deadlines as well as key performance indicators.

7. Communicates Effectively

Many construction mistakes are due to human error because of poor communication. Also, poor communication established with team members can also cause additional problems to be overlooked or solutions not relayed correctly to fix pending issues.

PMs who have outstanding communication skills on and off the worksite can effectively express themselves clearly to the team so everyone can better collaborate together. Employing the right technology can also aid in communication, as working with field collaboration technology helps PMs keep in constant contact with their team members wherever they are located.

8. Can Say No

Sometimes construction owners want to make massive project changes, or adjustments in the schedule as scope creep begins to enter the project. Their expectations for the construction work isn’t always feasible based on specifications, and a smart project manager can be honest and open about such matters. If scope creep appears, or if the owner wants things that teams can’t possibly provide, the PM has to say, “No” so as not to make a promise that they can’t deliver.

Mayor London Breed Announces Citywide Street Repaving Plan to Improve 500 City Blocks

Mayor London N. Breed and Supervisor Myrna Melgar announced the City's \$77.2 million Street Resurfacing Program for the coming year that targets paving 500 blocks in neighborhoods citywide, making travel safer, smoother, and more accessible for people who drive, bike, take transit, walk, and with disabilities. The street resurfacing budget of \$77.2 million is funded by local and state funding.

Currently, nearly two-thirds of San Francisco blocks are rated at good or excellent by the regional Metropolitan Transportation Commission's (MTC) independent pavement condition rating system. The City's overall Pavement Condition Index score is 74 out of 100, which exceeds the Bay Area average of 67.

"The continued investment in our roads to keep them in good repair is paying off," said Mayor Breed. "We have seen a steady improvement in street conditions over the past decade, and that helps everyone in our city, whether you are driving, biking, walking, or riding transit. This kind of investment is an essential responsibility of government while also generating jobs that benefit workers and the local economy."

To support the City's resurfacing plan, yesterday the Board of Supervisors voted on and passed a resolution that sets the list of blocks proposed for paving under San Francisco's share of state Road Maintenance and Rehabilitation Account (funds from Senate Bill 1 or SB 1.) San Francisco will

receive \$28.8 million of that funding for the new fiscal year that starts July—an amount that accounts for more than one third of the budget for the City's Street Resurfacing Program managed by San Francisco Public Works.

"We passed SB 1 to improve our transportation infrastructure across California, including our transit and roads. These infrastructure investments are crucial for our community," said Senator Scott Wiener, co-author of SB 1. "It's great to see San Francisco taking such an active role in road improvement."

In 2017, the California Legislature approved the Road Repair and Accountability Act (SB 1), the largest transportation funding measure in California history. The landmark investment secures \$54 billion over the next decade to repair roads, freeways, and bridges in communities across California. In addition to SB 1 money, funding sources for roadway improvements include the vehicle registration fee, the local half-cent transportation sales tax, and Certificates of Participation, a funding mechanism that leverages General Fund monies. The goal is to use all the funding sources to resurface 500 blocks in the new fiscal year, using a combination of Public Works in-house street repair crews and private contractors managed by Public Works to do the work.

Alfredo Garcia, Watsonville Diesel

Alfredo Garcia (pictured right with Carmen Herrera-Mansir of El Pajaro CDC and Tyler Blackney from Representative Alejo's office) has an impressive resume of 20 years when it comes to the diesel trucking industry.

- He started at Harnell College where he studied diesel technology,
- He graduated to Salinas Valley Ford at 22.
- After two years he took advantage of a better opportunity at International in Watsonville; they have shops and dealer in a few dozen states and Mexico. He worked there for four years.
- He spent eight years at Monte Vista Christian School in Watsonville taking care of their transportation needs, the fleet, and any license needs for school bus drivers.

Sometime in 2009, a friend who owns a building had a tenant that was moving out and asked if Alfredo was interested in the space. He had saved \$50,000 over the years and decided to give it a try.

Large trucks are required to be inspected annually and every 90-days. Alfredo believes there was a need for a company that does the inspections and services the trucks, e.g. maintenance, dry train, brakes, small fabrication jobs. He opened Watsonville Diesel on September 1, 2009.

The first and second years were hard. His business development strategy consisted of knocking on doors. By 2012, he had a small shop with two employees, and wanted to grow his company. He asked everyone where he should look for more business, where could he find business assistance. An owner of a small shop told him about Vinicio Vinedes of El Pajaro Community Development Corporation.

"You should talk to these people," said the shop owner. "Everyone goes to Vinicio."

Alfredo is constantly in learning mode, so he immediately contacted Vinicio. They worked together to expand the company's target market and drum up more business. Vinicio also helped Alfredo apply for a loan to expand the shop. That didn't pan out because the company was new and Alfredo's credit was low.

But Alfredo saved money and has been working on his financial statements with Vinicio. Now he has lots of customers, opened a second location in Hollister to service the Hollister Fire Department, is working with city to get business loan, and hopes to become an international dealer.

Watsonville is home to 600-700 farms that run trucks, but parts are hard to find. Salinas is 35 minutes away and San Jose is over an hour. If he's a dealer, he can hold \$1.5 million in inventory and add to his staff of 8. It's not all business with Alfredo. He wants to give back to his community and provide opportunities for youth in a city. Lots of high school students love cars and want to learn what he's doing. The teachers send him students and he does a mini-training. Then if they're interested, they go to technical school for 18 months, learn the systems, get certified and if they're good enough Alfredo will hire them. About a dozen students come to his shop annually. He's hired two of them.

Pedro Zerpa, Fusion Peruvian Grill

Pedro Zerpa is used to working hard to achieve his goals. An immigrant from Peru, he worked his way up from dishwasher to head chef of a San Francisco restaurant with no formal culinary education. After 15 years as a chef, Pedro was ready to strike out on his own, and found a space in San Mateo that he was able to rent with his family's help. He ran his restaurant, Fusion Peruvian Grill, for 3 years, before realizing how much he could increase his profits by expanding his restaurant into a bar. He obtained the liquor

license, but lacked the money to build out a bar area. Due to some past credit problems, Pedro was not eligible for a bank loan, and was referred by the Mission Economic Development Agency (MEDA) to Working Solutions, a nonprofit micro-lender that works with start-ups and other businesses that do not qualify for traditional financing.
