How to Avoid Delays in Construction Projects: 7 Steps You Can Take

For contractors, it's costly and disheartening when project milestones aren't met on time. It's important to know how to avoid delays in construction so you're not left scrambling.

Becoming aware of what's causing delays is essential for eliminating them. Below are seven things you can do to keep your project on schedule.

1. Provide accurate estimates

Budget inaccuracies always come back to bite you. Without the right funding, you can't purchase the materials you need or pay your crew.

To avoid budget-related delays, do your research when you're bidding to learn how much the project will cost. During the project, you can use automated workflow software to generate regular updates about whether you're within budget.

You should also stay aware of overall market trends. Talk with your distributor to find out what you can expect for prices.

2. Manage materials more efficiently

Having the right material in the right place at the right time is key for job site productivity. Each

job site is different, though, so you'll want to consider potential traffic chokepoints before you begin work.

For example, a limited number of loading docks and elevators can create logistical challenges in high-rise buildings. Conquering these obstacles requires close coordination with your distributor. You can take advantage of services like job site boxes and just-in-time deliveries to manage your materials more efficiently.

3. Communicate effectively

Effective communication between the field, the office and the customer can help you avoid delays in construction projects.

Instead of relying on ad hoc communication pathways, establish a communication structure and follow an organized schedule. Then, use mobile app technology to make sure everyone can view up-to-date information about change orders, redesigns and job progress.

4. Review designs thoroughly

If there's an error in the design phase of a project, it may not show up until execution. Fixing these issues can drastically affect the project timeline.

This is where it becomes crucial to review designs before a project starts and check the speci-

fications. It's also why design-build projects that bring designers and contractors together from the start of a project are becoming increasingly popular.

5. Streamline approvals

Waiting for approvals can prevent your crew from moving forward on a project. The good news is that these inefficiencies are easily avoidable with structured workflows and automatic notifications.

Often, a person doesn't realize their approval is holding up an entire process. Providing reviewers with deadlines and letting them know how their review affects the overall project timeline can motivate them to complete approvals faster.

6. Clarify project scope

Unexpected scope changes can happen during construction projects. If the owner changes their mind about a crucial area, the rest of the project can experience major setbacks.

While many of these changes are out of your control, you can encourage the project owner to have a clear vision of the project scope before your crew begins working. If changes do need to be made, make sure realistic timelines are established.

7. Prepare for weather delays

Some delays are beyond anyone's control. A rainy day can slow construction activity or bring it to a dead halt.

Add flexibility to your schedule so that weather-dependent activities like pouring concrete don't stall the project. You can also keep water pumps, waterproof gear and other safeguards around the job site to help you begin work faster after inclement weather.

Prefabrication in a climate-controlled facility can also be extremely helpful for reducing the impact of weather delays.

Know how to avoid delays in construction

Construction delays happen, but it's up to you to do all you can to be proactive. Be mindful of the factors above when approaching your next project.

California State Assembly Advances Groundbreaking Legislation To Limit Algorithmic Bias

The California State Assembly passed The Automated Decision Systems Accountability Act (AB13), taking a major leadership role in regulating algorithmic decision making systems. AB 13 would encourage businesses and public entities in California that provide benefits or services using artificial intelligence (AI) and automated decision

systems to establish processes to test for biases during its development and usage. This is a major step forward in requiring that businesses and public entities take responsibility to ensure that racial inequities do not result from their algorithms.

Among the first legislation of its kind in the country, AB 13 will protect Californians from biased and inaccurate automated decision systems by requiring algorithmic accountability for

"high-risk" public sector algorithms that impact Californian's legal rights, employment opportunities, health and access to economic opportunity. The bill now advances to the Senate.

Vinhcent Le, Technology Equity Legal Counsel of The Greenlining Institute and Board Member of the California Privacy Protection Agency said the following on the bill's passing out of the Assembly:

"Inaccurate and biased government AI costs taxpayers millions of dollars, harms disadvantaged communities, and erodes trust in government. AB 13 is an important step in modernizing government systems and ensuring that algorithmic biases don't harm our state's most vulnerable residents. We are incredibly proud that California is leading the way to fairer, more equitable technological practices."

How to Get a Business Loan in 5 Steps

Knowing the steps to getting a business loan can help reduce frustration and increase your chances of approval.

1. Determine if you qualify for a business loan

What's your credit score?

You can get your credit report for free from each of the three major credit bureaus: Equifax, Experian and TransUnion. You can also get your credit score for free from several credit card issuers and personal finance websites, including NerdWallet.

Banks prefer to offer their low-rate business loans to borrowers with credit scores above 680 at least, says Suzanne Darden, a finance specialist at the Alabama Small Business Development Center. If your credit score falls below that threshold, consider small-business loans for borrowers with bad credit or loans from a nonprofit microlender.

How long have you been in business?

Lenders will consider how long your business has been operating. You need to have been in business at least one year to qualify for most on-line small-business loans and at least two years to qualify for most bank loans.

Do you make enough money?

Many lenders require a minimum annual revenue, which can range anywhere from \$50,000 to \$250,000. Calculate your revenue and find out the minimum a given lender requires before you apply.

Can you afford the payments?

Look carefully at your business's financials — especially cash flow — and evaluate how much you can afford to apply toward loan repayments each month. Some online lenders require daily repayments, so make sure to factor that in.

To comfortably repay your loan each month, your total income should be at least 1.25 times your total expenses, including your new repayment amount, Darden says.

For example, say your business's income is \$10,000 a month and you already pay \$7,000 toward rent, payroll and other costs. According to this rule, you should be able to afford a \$1,000 monthly loan payment since \$10,000 is 1.25 times \$8,000 of total expenses.

Do you have collateral?

You can get secured and unsecured business loans from many lenders. A secured loan requires business collateral, such as property or equipment, that the lender can seize if you fail to repay the loan.

Putting up collateral is risky, but it can also raise the amount lenders let you borrow and get you a lower interest rate.

Lenders may also require a personal guarantee — even for unsecured loans. This means you'll personally repay the loan if your business can't, and may let a lender come after things like your house or car in instances of nonpayment.

2. Decide what type of loan you need

Lenders will ask why you need to get a small-business loan. Your answer will likely fall into one of three categories and determine which type of business loan is right for you:

- You want to start a business. Lenders require cash flow to support repayment of the loan, so companies in their first year typically can't get business loans. Instead, you'll have to rely on other types of startup financing, like business credit cards and personal loans.

In various US states, energy efficiency programs offer rebates to businesses for installing new lighting and control systems as well as financial assistance. You can look for energy efficiency programs implemented by your municipality, county, or state as well as some non-profit organizations.

Programs for disadvantaged, minority, and veteran business owners provide financial assistance. They can increase the efficiency of dwellings, save money, and reduce environmental pollutants. Setting up the Project for the Next Subcontractor in Line

Construction projects are a combination of several contractors bringing their skill sets together to create a final building project. The journey through this process of a general contractor and subcontractors working together is critical when looking at the sequence of tasks each contractor performs.

In many ways, construction projects are like a football team making a play to move the ball forward to the goal line. In football, the quarterback hands the ball to the running back and the line strategically blocks the defense. In construction, the general or site superintendent must communicate a good play in the scheduling. Subcontractors need to know where their scope of work starts and finishes to move the project toward its goal. Let's look at some examples.

- The surveyor must establish clear elevations and reference points for the excavator to dig the foundation and the proper offsets for the concrete contractor to pin the foundation in the hole.
- Once the foundation is dug, the excavator needs to make sure the trucks can get around the site to set forms and pour footings or make the accommodations for a pump truck. A proper tracking pad must be installed to eliminate mud from being tracked into the street.

- Backfilling the foundation should create a good staging area to work around the building. Proper grading should drain rainwater away from work areas, so it does not puddle on the site. This makes the site dry faster after a rain. Excess soil should be trucked off site. Topsoil used for final grading should be stored out of the way of any site work or incoming underground utilities with proper erosion control measures in place.
- At this point, an onsite dumpster should be placed for all trades to clean up at the end of each day. A clean job site helps the trades be safer and more efficient and presents a professional image to any on-lookers and visitors.
- Many variables play into each project when coordinating each task. Stubbing in the sewer and water before pouring concrete floors is necessary, yet sometimes this may take place before footings are poured. Starting the exterior wall at the electrical service can begin the installation of the service panels and bring the permanent electrical service in earlier.
- The type of building design will determine which trade starts first. Steel stud framing may have to be erected before setting the roof's bar joist. Masonry walls with beam pockets may need to be built before steel I-beams can be set. Beams and columns may need to be set so knee

walls can be built on top of them. Having each subcontractor perform their scope of work properly helps the next subcontractor in line. Avoiding contractors working on top of each other helps the project move forward.

As a general contractor, my company built several buildings that used 16-gauge structural steel studs on the exterior walls. We would assemble and weld these walls up in panels on large steel sawhorses on the site. Every so many feet, per the plan, we would double up a stud where a steel bar joist would sit once our walls were in place. Having the setting plates, we would tack weld them to the top of the wall over each double stud as we were welding up the wall panels on the sawhorses. This saved the steel erector a step and made their job easier. It also lessened the chance of the iron worker knocking the walls out of plumb.

- Some interior mechanicals have less flexibility in how their systems must be installed than others, requiring those mechanicals to be installed first. Plumbing waste piping and sprinkler main runs are usually set first. HVAC ducts follow afterward, yet coordination between each trade is critical. Typically, electrical has the most flexibility, yet challenges can exist at the service panel and fixtures such as lay-in light fixtures.
- Tradespeople trust the work in place before they install the final finishes. The



installation of cabinets and doors must rely on plumb walls, straight soffits, and the proper rough openings. Floor finishes rely on the concrete flatwork to be flat and have a good finish surface. Rough-ins of floor drains, waste, water, and electrical are critical for the correct positioning of equipment.

Construction projects are a combination of many skill sets working together as a team. Management is not only looking at the task at hand, but they are also looking at the next step, five steps down the line, and the final project. Hats off to all the talented tradespeople that work together to build America.

How To Successfully Determine Your Risk Response Strategy In Construction

The proper practice of managing risks is every construction contractor's road to a successful business. Risks related to the construction industry are vast and varied given the industry's inherent nature. As such, project success very much rests on how well construction contractors stay on top of the risk-managing game, particularly when it comes to crafting superb risk response strategies.

Iron-Clad Risk Management Practices Take Place in Every Phase of a Construction Project

No matter how well-rounded risk response strategies are, effective risk management should be a process that stretches from the start to the end of a project's duration. A construction project goes through a series of phases, depending on the procurement method that the investor has opted for, and risk management should essentially begin with contractors deciding to bid for projects.

Research has shown that sound project management practices help contractors achieve project deliverables. They are made up of a range of processes and sub-processes, and typically, a decision to sign off on a construction project is followed by a project charter. It is a short, concise document that outlines relevant project needs, stakeholders, high-level risks, and so forth, and it takes into consideration the organization's risk appetite, risk tolerance, and risk threshold.

Taking input from the project charter and other external and internal factors, a project management plan is produced. It contains various subsidiary plans, ranging from scope and schedule management, to cost and stakeholder management, to risk management. All these subsidiary plans dictate how subsequent planning activities are to be done, such as how to develop a schedule, ways to manage the stakeholders, strategies to estimate project costs, etc.

All the planning activities we have touched on fall under the project planning phase, and then executing and monitoring phase kicks off once

the planning is done and baselines are set. In this phase, almost all management activities are performed according to the project management plan; risk responses are implemented and monitored, risks are monitored, scope is controlled and validated, quality is managed, and so forth. Any necessary changes and updates, such as newly-identified risks to the project management plan and baselines are managed systematically.

Avoid, Mitigate, Accept, or Transfer?

The four options of risk response strategies: Avoid, Mitigate, Accept, and Transfer are no stranger to construction contractors, but these strategies may do more harm than good if executed properly. To really work out which of the four risk response strategies to choose for a specific risk, the number-one measuring rod should be where the risk fits in among the three domains of risk appetite, risk tolerance, and risk threshold.

The risk appetite of an organization broadly defines the type and degree of risk it is willing to accept. Risk threshold is given as a measurable unit, usually a percentage, and it reflects a range within which a specific risk can be accepted or avoided. Risk tolerance is similar to the risk threshold, but it is measured in a specified value, which can be in the number of days or a monetary value.

The avoidance option, as the name suggests, means taking any necessary course of action to avoid the possibility that a risk may pose a threat to an organization. Generally, contractors only go for this option when dealing with health-threatening risks. That being said, for a company with a low-risk appetite, this option may seem to fit its strategic objectives.

Contractors may opt for the mitigation option for risk events that exceed their corresponding risk thresholds. For instance, a risk that may cause a delay of greater than 10 days can be mitigated—if it surpasses the company's relevant risk tolerance level—to bring down the risk impact below the acceptable level.

On the other hand, risks can be accepted if the impacts are somewhere within the range of the company's risk threshold. The transfer

alternative shifts a risk to a third party, and this can involve signing up for a contractor liability insurance plan to transfer liability risks to the insurer.

Many Factors Influence a Company's Risk Appetite, Risk Tolerance, and Risk Threshold

The risk appetite, risk tolerance, and risk threshold of a company pivot on a range of factors, such as relevant historical data, level of competition within the market, company's portfolio, and inputs from top management. Other considerations may include risk culture and norms of the organization.

Contractors should at least know what their risk appetite, risk tolerance levels, and risk thresholds are. Organizations that put too much effort on avoiding risks can end up functioning well below their risk appetite, and this can actually throw away many opportunities that may help the organizations grow and achieve their business objectives.

Risks lurk beneath the surface of almost every business venture, and all the business decisions that we will have to make will rarely come without some sort of risk. It is the innate characteristics of construction projects that make this particular endeavor a very risky one to take on. Among all other construction project management disciplines, continuous risk management deserves a top priority on every contractor's to-do list, and understanding your risk appetite, risk tolerance, and risk threshold will make you a high-performing contractor.

- **You want to manage day-to-day expenses.** A business line of credit could make sense. This flexible kind of funding lets you tap into financing as needed to cover expenses like payroll or unexpected costs like repairs, offering a useful safety net as needed
- **You want to grow your business.** Consider a government-backed SBA loan or traditional term loan, which often have higher borrowing maximums — SBA loans can reach \$5.5 million, for example. Many lenders also offer specific products to fit a growing company's needs, such as loans for equipment or vehicle purchases.

3. Compare small-business lenders

There are three main sources for getting small-business loans: online lenders, banks and non-

profit microlenders. Each typically has multiple products, but one may be better in certain instances than others.

When to get a business loan from online lenders:

- You lack collateral.
- You lack time in business.
- You need funding quickly.

Online lenders provide small-business loans and lines of credit from about \$1,000 to \$5 million. The average annual percentage rate on these loans ranges from 6% to 99%, depending on the lender, the type and size of the loan, the length of the repayment term, the borrower's credit history and whether collateral is required.

These lenders rarely have APRs as low as those at traditional banks, but approval rates are higher and funding is faster than with banks — as fast as 12 hours.

When to get a business loan from banks:

- You've been in business at least two years.
- You have good credit.
- You don't need cash fast.

Traditional bank options include term loans, lines of credit and commercial mortgages to buy properties or refinance.

Through banks, the U.S. Small Business Administration provides general small-business loans with its 7(a) loan program, short-term microloans and disaster loans. The SBA provides loans up to \$5.5 million, with 7(a) loans averaging \$533,075 in fiscal year 2020, according to the Congressional Research Service.
