#### **Getting Ready for Change**

Introducing new technologies can mean major changes within the organization. In addition to managing resistance (a natural inclination people have about change), you also need to ensure that your organization is financially ready to make changes.

Many contractors find it difficult to do these things. Research by Autodesk and Dodge Data & Analytics found that the top challenges to tech adoption include managing the cost of the software and dealing with organizational resistance to change.

## Mayor Garcetti breaks ground on airport Metro connector

Mayor Eric Garcetti broke ground on the Airport Metro Connector (AMC) Project, a \$898.6-million endeavor that will directly connect the Metro system to the Los Angeles International Airport (LAX) when complete in 2024.

"Everyone traveling to or from LAX should have access to modern, reliable public transportation that gets them to their destination on time," said Mayor Eric Garcetti. "The Airport Metro Connector is a historic step toward reimagining how travelers experience our airport — a turning point that will be a source of jobs and economic growth, reduce congestion, and help our airport realize its potential as a world-class gateway to Los Angeles."

The Airport Metro Connector Project (AMC) is the ninth station along the Crenshaw/LAX Line currently under construction. When complete, it will connect directly with the Los Angeles World Airports (LAWA) Automated People Mover project — a train connecting travelers directly to airport terminals that is expected to be complete in 2023. The new AMC station located at Aviation Boulevard and 96th Street includes platforms to access Metro Rail trains, an expansive 16-bay bus plaza, a bike hub, a private vehicle dropoff zone, and direct access to the LAX people mover. The station will also feature a new Metro customer service center, interactive information kiosks, public restrooms, and commercial space for tenants.

"This is an exciting project that will serve as the "Gateway" to LAX for future generations — just as LAX has long served as the gateway to Southern California for so many millions of people," said Metro CEO Stephanie Wiggins. "The AMC station will also provide multiple connections to the Metro system and will help airport-area employees and travelers easily get to wherever they need to go in our region."

The rail station portion of the project will contain two platforms that will be accessed via escalators and elevators, ADA compliant swing door faregates, and a full roof covering over the entire platform. The project has been designed to achieve a Leadership in Energy and Environmental Design (LEED) Gold rating with sustainable features that include 550,000-plus kilowatts of solar panels, large native landscaping areas, and electric bus charging stations.

LAX is in the midst of a \$14.5 billion Capital Improvement Program, the largest airport project of its kind in the nation. The overhaul touches all nine passenger terminals and builds new facilities, including an Automated People Mover train; a Consolidated Rent-A-Car facility; and the Intermodal Transportation Facility-West, a 4,300 stall parking structure.

After Mayor Garcetti helped lead the coalition to pass Measure M in 2016, the largest local transportation funding program in North American history, Metro is expanding its rail transit system with 15 new and expanded lines, fixing streets and freeways, and putting more than 777,800 people to work for decades to come.

## Google, Walgreens and H&R Block Want to Be Your Bank

Companies are working with partner banks to offer FDIC-insured accounts through their own apps and platforms.

When you think about Google, Walgreens or H&R Block, what comes to mind is probably searching the web, picking up a prescription or getting your taxes done - not writing checks, building an emergency fund or setting up automatic bill payments. But these companies are part of a growing trend of nonbank brands offering banking services

Making banking services available gives retailers, brokerages and other companies another way to engage with customers, with the aim of building lovalty and keeping those customers within their ecosystems for longer. For customers, it can mean convenience and a better tech experience - but also extra costs and the potential for confusion.

To be clear, these companies aren't actually becoming banks. That would require obtaining a bank charter — a process that can be long and expensive and would subject the company to extra regulatory scrutiny, says Francisco Alvarez-Evangelista, a research associate at the Aite Group, a financial services analysis firm.

Instead, they are partnering with existing banks that are chartered and regulated and offer federal insurance for customer deposits. The partner banks handle the regulatory and security responsibilities and do the work of actually managing checking, savings and other accounts, while the

companies focus on branding, marketing and customer engagement.

#### Banking offerings from nonbanks Google

Unveiled in late 2020 and projected to roll out this year, the much-hyped "Plex" accounts are mobile-first checking and savings accounts directly integrated into the Google Pay app. Google is partnering with about 10 financial institutions, ranging from big national banks to regional banks and credit unions, and customers will be able to choose which one they want to open an account with

Google's wide reach and vast data-collection capabilities may lead consumers to wonder about whether or how the tech giant will use banking or transaction information from Plex accounts. But the company says such data is private.

"We take privacy of financial information very seriously and took a privacy-forward approach to Google Pay," said Josh Woodward, director of product management at Google Pay, via email. "Google Pay does not sell your data to third parties or share your transaction history with the rest of Google for targeting ads."

#### Walgreens

Walgreens announced in March that it will launch a bank account in the second half of 2021 in partnership with MetaBank. The pharmacy

Civilians have a lot of thoughts about military personnel. Some of these thoughts are positive, others are negative and still many may be based on years of news media, movies and television shows taking creative license with veteran characters.

Those same sources give military members some pretty strong misconceptions about the civilian working world, too. These misguided views of a business or industry may be keeping veterans from even considering them.

In "Military Veteran Employment: A Guide for

the Data-Driven Leader," authors Nathan Ainspan and Kristin Saboe wrote and compiled chapters designed to help show employers why hiring veterans is in their best interest.

A chapter written by Eric Eversole, a vice president at the U.S. Chamber of Commerce and president of Hiring Our Heroes, talks about who makes up the U.S. military and how employers can work to attract vets while dispelling veteran misconceptions

#### 1. Sell Your Industry to Veterans

There's a good chance that young veterans may not know much about what your business or industry does. Moreover, they probably don't know what a future career in your industry could mean for them or what opportunities exist in the field.

Many service members come from a middleclass, middle-income background. Many joined at a relatively young age with little experience in the working civilian world. It's important to reach out to this untapped talent pool to ensure they understand what your area of the job market can offer.

#### 2. Train People to Understand the Military

A lot of civilians have had little to no contact with the military. Even when they have experience with the military-veteran community, it's hard to tell how much they know or understand about the lifestyle, culture or anything else that comes with military life.

Recruiters and hiring managers would be wellserved by learning certain things about military culture, rank and the structure of the military (which is also laid out in the book, "Military Veteran Employment: A Guide for the Data-Driven Leader"). Bridging that knowledge gap can affect the ability to hire and retain veterans significantly, Eversole writes.

#### 3. Provide Mentoring and Networking **Opportunities**

The most successful and veteran-friendly companies will give hired vets the chance to learn

chain said in a news release that the account – which comes with a debit card and is covered by the Federal Deposit Insurance Corp. through MetaBank - will complement its current services and enhance its loyalty program and customer personalization. The company said customers will be able to sign up in-store as well as online.

#### H&R Block

The tax-prep chain has expanded the capabilities of the H&R Block Emerald Prepaid Mastercard account beyond simply having tax refunds loaded onto it. Issued in partnership with MetaBank, the card allows customers to make purchases, receive direct deposits, share finances with a

partner, withdraw cash, pay bills and perform other money management tasks. There are fees for some of the card's services, such as reloading cash and making ATM withdrawals.

#### Potential upsides and downsides

These brand-supported accounts may appeal to consumers for several reasons. Among them:

- Familiarity. If you're already using Google Pay for purchases or the Walgreens app for shopping and prescription refills, for example, you can manage your bank accounts through an interface you're used to. If you have an H&R Block card because a refund was loaded onto it, you can run more of your financial life through it.
- User experience. Bank apps and websites aren't always very user-friendly. Businesses that are more consumer-oriented may be able to leverage their technical talent to create a better user experience than traditional banks.

There are also risks or potential downsides, including:

- Costs. Signing up for a bank account because it's integrated with an app you use means you might not be comparison shopping. The interest, if any, on your deposits may be comparatively low, or the fees you pay for services may be comparatively high. Interest rates are fairly low across the board right now, but there are still some institutions that able to offer higher-thanaverage rates.
- The partner bank. Your money is ultimately held by the partner bank, and it is that bank's policies and procedures that could dictate whether the account meets your needs. When problems arise, you may be dealing with the bank's customer service rather than the brand's, which might not be the best experience.

Alvarez-Evangelista notes that it is in companies' interest to partner with banks that provide good service. From the brands' perspective, "the biggest risk is reputational," he says. "If one of these programs fails or doesn't meet the expectations of consumers, the retailer is associated with it."

from knowledgeable sources within their company or industry. This is critical in the development of the veteran, not just for their duration at the company, but for the rest of their career.

A mentor can help newly separated veterans understand what their near- and long-term opportunities are at any given point in their career. Networking opportunities allow veterans to grow within a group and give them a sense of the community they need to thrive.

#### 4. Manage Veteran Expectations

Just as the military would not take a 20-year corporate executive into the military as a full-bird colonel, separating veterans entering the civilian world should not expect to jump right into their new lives at the same level they worked in the military. It does happen, however, and more often, veterans will decline a good position thinking they should be hired at that level.

Companies, Eversole writes, should be honest with potential veteran employees about why they should be hired at the level for which they're being considered. At the same time, the company can create realistic expectations about promotion opportunities and tell vets how they can succeed in the business.

#### 5. Don't Forget Non-Veteran Employees

When your company shifts its focus to attracting veteran talent and accommodating that talent to best foster its abilities in the future, non-veteran employees may start to see undeserved preferential treatment.

A little communication is all that's needed in this situation. Companies should take time to explain to their entire workforce about their plan to hire and retain veterans and why the plan is good for the company as a whole.

# Ready for New Construction Technology?

Gauging your organization's readiness for change "is one of the most important factors in successfully implementing technology and innovation in construction," remarks Tony.

At Kraus-Anderson, Tony says they consider the following factors when determining if they're ready for change.

The company's existing portfolio. "It's very important that we know what our current portfolio of projects looks like," says Tony. According to him, Kraus-Anderson has a Business Technology Investment Committee (BTIC) that reviews the firm's portfolio on a monthly basis.

This committee includes the President, Head of IT, Head of Finance, EVP of Operations, General Council and President of Realty

Organizational goals. Tony and his team "have a very strategic vetting process" to ensure that any technology requests align with the company's divisional and organizational goals. "Individuals or groups must submit their request to their leadership and (if approved) to the BTIC for approval," he explains.

Budget. They also look at their budget, and when implementing solutions they make sure that there are funds available to carry out their plans.

Process and analysis. Tony says that they go through a specific course of action when it comes to adopting technology.

He explains, "We follow a process from ideation, approval, process reviews, implementation, closeout, and monitoring for all technology implementations. Having dedicated IT project management and business analysis is critical for knowing when the organization is ready for change."

Customer needs. They also examine their customers' needs and discern whether the technology that they're considering can actually enhance the customer experience with Kraus-Anderson.

Throughout all this, it's important to note that it's the management and executive teams — not IT — who are the ones owning the decision-making process. This ensures that any tech initiatives truly align with the firm's objectives and strategy.

#### Developing a Process for Smooth Technology Implementation

When it comes to technology implementation, determining the "what" (i.e., the solution to adopt) is just the first step. Equally important is ironing out why and how you're going to roll out the technology.

As Kraus-Anderson, Tony says that the company's Business Technology Investment Committee has developed a process for reviewing and monitoring decision points for successful technology implementation.

This process involves what Tony calls conducting a "Divisional Self-Assessment." At this stage, individuals requesting for new technology "must review and submit how their request for new technology aligns with their divisional and organizational strategic goals to divisional leadership."

In other words, they need to conduct a self-assessment and communicate how a new solution fits in with the overall objectives and direction of the firm.

From there, divisional leadership will review the request. If approved, Tony says that "the request for new tech would need to have a lightweight business case that includes defining the problem to be solved, alignment of priorities, dependencies, benefits, and high-level costs. This is submitted to the BTIC for approval."

If the committee approves the request, a dedicated project manager will start to get involved. According to Tony, "the project manager creates a detailed IT project plan to manage the scope, objective, requirements, communication plan, resources and decision-making matrix, testing plan, change management and cost."

In some cases, projects need "a detailed process improvement (Lean) review before we gather IT requirements," he adds.

#### Managing Data, Metrics, and Benchmarks Around Technology Implementation

Another important component of technology implementation is the management of data, metrics, and benchmarks.

As Tony puts it, "Having a data strategy is extremely critical in the success of any technology program. At Kraus-Anderson, we strive to bake our data strategy into all of our key decision making processes."

The company strives to ensure that their new technology programs align with their data strategy. According to Tony, they use two components to accomplish this.

"We have a Conceptual Model which represents our conceptual data strategy and our ideal future state. It defines our data logic and design as we adapt and change," he explains. "Then we have an Enterprise (Application) Architecture that aligns programs, applications and tools to our Conceptual Model."

Once technology has been deployed, you also need to set benchmarks so you can measure the success of your initiatives.

Tony lists the following three benchmarks they use at Kraus-Anderson to define the success of their tech efforts:

- Did we do what we said we are going to do (time, resources, budget)?
- Did we enhance or create a better customer experience?
- Are we helping the organization create revenue, mitigate risk or create some bottom line savings?

These benchmarks, adds Tony, are reviewed by the BTIC during the committee's monthly meetings.

#### Tech Implementation Should Be a Wellthought Out Process

Always remember that adopting and implementing construction technology can be a complex task. As such, you must ensure that your organization is ready for change.
