## Biden-Harris Administration Invests \$60 Million to Create a Climate-Ready Workforce

The Department of Commerce's National Oceanic and Atmospheric Administration (NOAA) opened a competitive funding opportunity for the Climate Ready Workforce for Coastal States, Tribes, and Territories Initiative to connect people across the country to good-paying jobs, such as landscape technicians, heat health outreach specialists and climate equity officers, that tackle the climate crisis and boost local resilience. NOAA will invest \$60 million total from the Inflation Reduction Act for the initiative — a \$50 million competitive funding opportunity and \$10 million for technical assistance to support applicants and grantees.

This announcement comes as a new Department of Energy report released yesterday found that last year, clean energy jobs increased in all 50 states and the District of Columbia, and is part of a larger job creation trend in sectors that tackle the climate crisis.

"A climate-resilient nation requires a climate-ready workforce," said U.S. Secretary of Commerce Gina Raimondo. "Thanks to President Biden's Investing in America agenda, we're launching the Climate-Ready Workforce Initiative to provide major funding and assistance to qualified public, private and other organizations so they can train workers and help them find good paying jobs that will strengthen climate resilience and enhance their local economies."

NOAA aims to grant between 10-20 awards under this competition, at amounts ranging from \$500,000-\$10 million each. NOAA is seeking qualified state, tribal, territorial and local governments, institutions of higher education, and non-profit organizations in coastal states or territories to lead partnerships to train and place workers in quality jobs that enhance climate re-

silience. Letters of intent are required and due by November 30, 2023 with applications due by February 13, 2024.

The Climate-Ready Workforce for Coastal States, Tribes, and Territories Initiative — released under the Inflation Reduction Act (IRA) — is jointly run by NOAA's National Sea Grant College Program and Climate Program Office,

and leverages support from NOAA's Office for Coastal Management.

"There's a major need across coastal and Great Lakes communities for workers who are ready to address the challenges of climate change," said Jonathan Pennock, Ph.D., director of the Na-

## Treasury Department Releases Fact Sheet Detailing Investments in the Economic Future of Latino Communities

The U.S. Department of the Treasury released a fact sheet detailing actions the Department has taken and their impact on Latino households, businesses, and communities. This fact sheet comes as part of the first Treasury Department summit on investing in the economic future of the Latino community.

When President Biden came into office at the height of the COVID-19 pandemic, what was already a health and economic crisis was made worse for Hispanic and Latino households and businesses, as well as other underserved communities, by a lack of adequate investment. This long-standing underinvestment constrained economic opportunities and contributed to economic disparities, such as lower home ownership rates.

Over the past two and a half years, the Treasury Department's work to center equity in its pandemic recovery efforts delivered real results for the Latino community that aim to expand opportunities for all Americans to fully participate and compete in the 21st century economy – creating a blueprint for equitable implementation of other Biden-Harris Administration priorities and initiatives

**Key Treasury Department Actions:** 

Building the capacity of local governments to address systemic barriers to health, housing, and financial well-being for Latino households: The Treasury Department prioritized equity in its spending guidelines for the American Rescue Plan's (ARP) State and Local Fiscal Recovery Fund (SLFRF) – the largest-ever infusion of direct pay to state, local, and Tribal governments. To address both the disproportionate impacts of the pandemic and

historic underinvestment that left some communities more vulnerable, the Department provided a broad menu of services to enhance health, housing, employment, and economic equity in low-income and high poverty communities. For example, the Department provided Puerto Rico's central and municipal governments approximately \$4 billion in SLFRF funds to respond to the public health and economic impacts of the pandemic, provide premium pay to essential workers, maintain vital public services, and invest in water, sewer, and broadband infrastructure.

Investing in financial institutions with a track record of delivering capital to Latino communities and businesses: Through the Emergency Capital Investment Program (ECIP), the Treasury Department has invested \$1.6 billion in Latino-owned and

## California Announces First Investment by Program Designed to Create More Inclusive Venture Capital Ecosystem

The state of California's Infrastructure and Economic Development Bank (IBank) announced the first investment by a new state program, Expanding Venture Capital Access. The program — the first venture capital (VC) program administered by the state — was designed to create a more inclusive VC ecosystem. Unshackled Ventures received \$4.1 million as the state's first investment

Founded by immigrant entrepreneurs, Unshack-led Ventures invests in visionary immigrant founders, providing the "friends and family" capital that immigrant entrepreneurs often lack, while also providing full support for the founders' immigration process, including sponsoring visas and offering a community of resources. These investments generate innovation and U.S. jobs.

"We are thrilled to announce this first investment from our new venture capital program," said IBank Executive Director Scott Wu. "In spite of California's dominance in the VC industry, venture capital remains inaccessible to many entrepreneurs. Increasing inclusion in who receives VC funding starts with increasing inclusion in who manages VC funds — and both are critically important in the state's push toward equity."

While California is home to many of the world's top venture capital firms, the VC community is demographically concentrated, making it challenging for underserved investors and startups to access funding. Studies have shown that startups led by inclusive teams have generated better investment returns than teams that lack diversity.

The new venture capital program's primary focus is investing in underrepresented VC fund managers, including those in geographic areas that are socio-economically disadvantaged or that receive very limited VC funding. The program is also looking to make investments that promote climate equity and climate justice.

"We looked at where there were unmet needs in the VC world and you don't have to dig deep to see that we needed to expand access to venture capital beyond the usual suspects," added Wu. "This program allows us broaden our reach to those who haven't had the same access to opportunity."

"This is a momentous first step for the state of California's venture program," said IBank Deputy Director of Venture Capital Derrick Tang. "The team at Unshackled belongs perfectly within our mission — to help entrepreneurs gain access to a California dream, and help support an inclusive economy that is prosperous and representative of the people of our state."

"We founded Unshackled Ventures nine years ago with a simple mission — to help unrecognized and excluded immigrant entrepreneurs succeed faster," said Manan Mehta, Founding Partner of Unshackled Ventures. "We believe immigrants represent a national advantage, and by partnering with the state of California, the

state with the largest immigrant population in the country, we are confident that our efforts to drive more innovation and inclusion will result in more economic prosperity and American job growth."

The Expanding Venture Capital Access program is funded by \$200 million from California's \$1.2 billion allocation from the U.S. Treasury's State Small Business Credit Initiative (SSBCI), which provides capital to fund small businesses, including those that are socially and economically disadvantaged startups and investors. The program is administered by IBank — part of the Governor's Office of Business and Economic Development (GO-Biz) — in partnership with Cambridge Associates.

## Remarks by Deputy Secretary of the Treasury Wally Adeyemo at the Black Economic Alliance

As Prepared for Delivery

Thank you so much, Sam, for inviting me to address the Black Economic Alliance's board today. You have been an incredible partner to the Biden-Harris Administration as BEA's President, serving as a sounding board for our proposals to advance racial equity, a thought partner who has brought new ideas to the table, and a fierce advocate who has championed our agenda and kept us accountable for our commitments to Black families, neighborhoods, and businesses.

I'm grateful for the chance to spend time with you as our country celebrates Juneteenth for the third time as a federal holiday, though the history of this celebration dates back to the 19th century. During his first year in office, President Biden

signed the Juneteenth National Independence Day Act, after years of advocacy from Black leaders like Representatives Barbara Rose-Collins and Sheila Jackson Lee, giving this day the recognition it deserves as a foundational moment in our nation's history.

Though it would take nearly another century for Black Americans to have the right to fully participate in our nation's political system and economy, Juneteenth represents a vital first step on that journey.

When President Biden took office, the COV-ID-19 pandemic was still ravaging communities across the country and causing untold economic hardship that hit Black Americans especially hard. The Black unemployment rate peaked at

16.8 percent in May 2020—meaning that more than one in six Black workers were unemployed. As jobless rates climbed, millions were put at risk of losing their homes to eviction. This risk was especially acute in Black communities, where Black renters have historically accounted for about one-third of eviction filings.[1] The President, Secretary Yellen, and our whole economic team knew that we were at a pivotal moment that could determine the economic trajectories of millions of Americans for decades to come. We viewed it as our responsibility to do everything in our power to prevent the economic scarring that can come with these shocks, the long-term damage that too often prevents people from ever getting fully back on their feet.

The President signed the American Rescue Plan into law to help our economy get out of this deep hole and back on the path to growth. And he made sure it included provisions that would give communities of color the support they needed to get through the pandemic and build a better economic future afterwards. This includes programs like the Emergency Rental Assistance Program, of which 46 percent of assistance went to Black families to prevent evictions, and programs like the State Small Business Credit Initiative, which includes \$2.5 billion in funding and incentives to support underserved small business owners. And these Treasury programs come on top of hundreds of billions in small business support

tional Sea Grant College Program. "Sea Grant's innovative approach of providing science solutions to communities, along with the Climate Program Office's support of high-priority climate science will help tailor workforce solutions to address community needs."

These partners will work collaboratively with NOAA to support regional economies and their associated workforces in distinct sectors and industries by developing training and placement programs that help workers enter or advance into quality jobs focused on enhancing resilience to climate-related impacts.

"A skilled, diverse and fairly compensated workforce is essential to help bolster the nation's climate resilience," said Wayne Higgins, Ph.D., director of NOAA's Climate Program Office.

"Through this competition, we will partner with employers, trade organizations and communitybased organizations. We will help partners leverage climate services so they can place training participants in good jobs that enhance climate resilience."

NOAA strongly encourages applications for projects that reach historically underserved communities and individuals. As a program included within President Biden's Justice40 Initiative, this opportunity will place special emphasis on supporting frontline communities — those who are the most vulnerable to and will be the most adversely affected by climate change and inequitable actions because of systemic and historical socioeconomic disparities, environmental injustice or other forms of injustice. Projects supported under the Climate-Ready Workforce initiative will con-

nect people with and train them for equitable, quality public and private-sector jobs.

provided by the Small Business Administration through programs like PPP, Economic Injury Disaster Loans, and many other lending programs.

These actions have led to historic economic gains for Black Americans over the last two-and-a-half years. In recent months, the job market has never been more favorable for Black workers. In April, Black unemployment fell to a record low of 4.7 percent—the first time it has even fallen below 5 percent.[2] At the same time, the gap between Black and white unemployment also hit its lowest level on record, at just 1.6 percentage points. That compares to more than three times that in 2020 and more than seven times that in 1983.[3] At the same time, the number of Black active business owners in the U.S. increased 9 percent from the first quarter of 2021 to the end of 2022.[4]

We helped avoid much of the economic scarring that has so often accompanied downturns. Our anti-eviction policies succeeded in preventing what many feared would be a tsunami of evictions in Black communities. In 2021, eviction filing rates in Black neighborhoods were just 5.3 percent—compared to a historical average of over 12 percent.[5] Our actions helped put an economic floor under millions of vulnerable Americans, especially in communities of color.

The Black Supplemental Poverty Measure—which accounts for government benefits—fell from 18.2 percent in 2019 to 11.2 percent in 2021,[6] while Black child poverty hit its lowest level since 2009.[7]

These are meaningful milestones that are indicative of our commitment to serving America's communities of color and to changing the landscape of economic opportunity. But recovery from the pandemic is not enough. Going forward, President Biden has put in place a legislative blueprint to create generational economic growth and wealth.

To start, the President's actions will help close the digital divide. Roughly 40 percent of Black households in America lack fixed, high-speed broadband access.[8] In both the rural South[9] and dense urban areas alike,[10] Black Americans are about twice as likely as their white counterparts to lack high-speed internet access. President Biden has given us the tools to address this disparity, including \$10 billion through the American Rescue Plan's Capital Projects Fund. Treasury is responsible for implementing this program and since last June we have awarded nearly \$7 billion for broadband projects that are connecting millions of Americans to high speed internet across the country. Coupled with the workforce investments we are making through the American Rescue Plan and CHIPS Act, this will turbocharge the gains Black workers have already made. For example, the CHIPS Act includes dedicated funding to support STEM programs at Historically Black Colleges and Universities and Minority Serving Institutions to help people of color enter the STEM workforce and benefit from the opportunities the CHIPS Act will create

Alongside programs like SSBCI, Treasury has taken action through policy and collaboration with the private sector to expand capital access in Black communities.

Under the Emergency Capital Investment Program, we've invested nearly \$9 billion into financial institutions with a track record of reaching and serving communities of color-including community development financial institutions and minority depository institutions—to expand and enhance their lending activities and operations. Over \$3.1 billion of that amount was invested in minority depository institutions. We have been thoughtful about the way we have implemented this program, strategically incentivizing "deep-impact lending," such as loans to lowincome and minority borrowers and underserved small businesses, to help level the playing field for borrowers that face the greatest barriers to accessing capital. Meanwhile, Treasury's Community Development Financial Institutions Fund (CDFI Fund) has deployed historic amounts of grants to CDFIs and MDIs under this Administration, including \$1.73 billion to more than 600 CDFIs earlier this year, in April the largest program in history.

And thanks to our work with the Economic Opportunity Coalition (EOC), a group of nearly 30 private sector organizations and foundations working to support the Administration's economic agenda in underserved communities, we were recently able to announce that EOC members are putting over \$1 billion in deposits into

these financial institutions to help ensure that can fully take advantage of our capital investments.

We are also taking concerted steps to help ensure the economic opportunities created by the Inflation Reduction Act (IRA) and the transition to the clean energy economy are shared by all Americans, especially communities of color. For example, the investment tax credit for solar and wind projects includes a substantial bonus for facilities built in low-income communities. I've heard from Black communities directly—in roundtables at Treasury and on trips to places like Atlanta—about the ways this provision will enable them to make investments that will lower energy costs for their residents and create new jobs and economic opportunities.

According to outside estimates, the IRA will support as many as 9 million clean jobs.[11] We are working hard to ensure that communities of color are positioned to share equitably in these gains.

In my view, there are deep commonalities in the challenges facing different low-income communities—from rural white Americans who have been increasingly left out from economic opportunity to communities of color who too often never had it to begin with. Recently, I wrote a short blog post detailing the ways the approach to racial equity we are taking not only helps Black Americans but struggling white Americans too, as well as underserved communities across the country.

Latino-majority shareholder depository institutions. Based on preliminary analysis, the Department projects that investments across the entire ECIP portfolio may increase lending in Latino communities by nearly \$58 billion over the next decade. Additionally, in April, the Community Development Financial Institutions Fund (CDFI Fund) announced over \$1.73 billion of grant awards through the Equitable Recovery Program (ERP), which included many awards to community development financial institutions (CDFIs) that have strong track records of lending to minority borrowers and in majority minority census tracts. A key part of those ERP awards includes 70 grants totaling \$226 million to CDFIs in Puerto Rico – the largest infusion of ERP funding to any single state or territory.

• Growing Latino-owned businesses by expanding financing and technical assistance: According to outside research, Latinos start more businesses per capita than any other racial and ethnic group in the United States. Nearly one-quarter of all new entrepreneurs in 2021 were Latino. The State Small Business Credit Initiative (SSBCI) includes \$2.5 billion in funding and incentive allocations to support the provision of capital to underserved busi-

nesses – with \$1 billion of these funds to be awarded to the jurisdictions who are most successful in reaching underserved businesses. In addition to awards to states, tribes, and other territories, earlier this year Puerto Rico was approved for up to \$109 million in SSBCI funds to provide credit and investments in small businesses.

- Supporting Latino workers in Puerto Rico: To boost workers and small businesses across the Island, the ARP significantly expanded Puerto Rico's version of the Earned Income Tax Credit (EITC), quadrupling benefits for workers through the first federal enhancement to Puerto Rico's EITC since the credit was established nearly 50 years ago.
- Connecting Latino families with tax **credits:** Following the passage of the ARP, the Treasury Department implemented the expanded Child Tax Credit (CTC), under which tens of millions of eligible families received between \$250 and \$300 per child in monthly support from July to December 2021. Data released last year by the Census Bureau showed that the expanded CTC was the leading driver behind a 46 percent decline in child poverty in 2021 - cutting the annual child poverty rate to its lowestever recorded level including record lows in Hispanic child poverty. For Puerto Rican families in particular, the ARP broadened tax benefits at an unprecedented scale by

permanently expanding the CTC in Puerto Rico from families with three children to all families with at least one child. In 2022, the Treasury Department and the White House engaged in extensive outreach to ensure as many families as possible in Puerto Rico received the CTC, resulting in direct assistance to more than 250,000 families, a six-fold increase over the prior year, with an average benefit was \$4,700 per family.

- Helping Latino families remain homeowners: The reach of Homeowner Assistance Fund (HAF) resources to economically vulnerable and traditionally underserved homeowners has exceeded prior federal mortgage assistance and foreclosure prevention programs. As of December 2022, 57 percent of HAF assistance was delivered to very low-income homeowners, and 20 percent of homeowners assisted self-identified as Hispanic.
- Helping Latino families avoid eviction: The Emergency Rental Assistance (ERA) program was the first nationwide program aimed at preventing eviction through direct assistance to renters. As of December 2022, extremely low-income renters have received close to two-thirds of ERA assistance. Research has found that nearly one-third of rental assistance funds went to Hispanic households.
- Increasing federal business with Latinoowned companies: Procurement with gov-

ernment agencies plays an important role for many minority-owned businesses. The Biden-Harris Administration has set a goal to increase the federal government's contracts with minority-owned and small and disadvantaged businesses to 15 percent by 2025. At the Treasury Department, there has been a 23 percent increase in the dollar amount of prime contracts awarded to Hispanic owned businesses since FY 2020. In FY 2020, the Department awarded a total of \$100 million to Latino-owned businesses. By FY 2022, the Department has awarded over \$123 million to Latino-owned businesses. The Treasury Department has also designated two minority-owned financial institutions as financial agents of the gov-

While significant progress has been made, much more remains. Among other initiatives, in the coming months, the Treasury Department will continue leading the implementation of key provisions of the Inflation Reduction Act, which will help create good-paying jobs and ensure all Americans benefit from the growth of the clean energy economy, particularly communities that have been left behind and harmed by pollution. As the Treasury Department continues to tackle both immediate and long-term structural challenges of the American economy, equity and racial justice will remain at the forefront of its work.

## Ke'Anna Dodds, RUE Kitchen

Ke'Anna Dodds is a classically trained private chef from Vista, California, who has worked for world-renowned chefs such as Wolfgang Puck and many others. Her business was thriving, and she was working with a growing number of regular clients.

Then the pandemic hit.

I couldn't work anymore because I couldn't just go into people's homes. Nobody wanted to be around anybody. So, I had to figure out another way to make an income.

She decided to dust off the ingredient list for her homemade, vegan barbeque sauce. Ke'Anna first developed the sauce for her brother's sports fundraiser when she was 15 years old. The sauce was a hit and the food sold out immediately once word spread how great everything was. From then on, she was always asked at any family or friend gathering to make her special sauce.

She decided to professionally bottle the sweet glaze sauce and craft two new flavors—an all-purpose marinade and Caribbean jerk sauce. She launched the three products online, and RUE Kitchen was born.

Soon after launch, her condiments caught the attention of vegan social media star Tabitha Brown. The influencer used one of Ke'Anna's sauces in a video broadcasted to her more than four million followers. "I kind of blew up overnight, and I could not keep up with production," Ke'Anna says.

As exciting as it was to receive the attention, she quickly realized she needed a manufacturer to keep up with demand.

Her business was drowning in unfulfilled orders, with some customers waiting up to two months to receive their sauces.

Ke'Anna knew she needed capital to immediately upgrade her commercial production

equipment and contract a manufacturing facility to fulfill the orders.

So, she started searching for a business loan.

#### Obtaining the "right" startup capital

When food entrepreneurs seek funding, it can be challenging to accurately estimate how much money they'll need to fulfill inventory demands.

Ingredient prices can fluctuate daily, and they were even more volatile when Ke'Anna launched her business during the pandemic as supply chains were crippled. As a result, some of her sauce ingredients became unavailable, and replacements sometimes altered the taste or tripled the overall price. "It can be a little chaotic," she says.

People either want a percentage of your company, and they want to tell you what to do, or they want to give you way less than what you're asking for. And most banks are very cautious of taking risks with early-stage food businesses. And at the time when I was starting, we were going through a world crisis, so people were really trying to hold on to their money.

If you're pursuing funding for a food business, Ke'Anna recommends carefully calculating the ingredient costs in price projections to leave room for growth and other factors. "At the end of it all, you may not realize that you needed that much money," she explains.

Calculating how much you need can be complex but finding startup capital is an even more significant challenge.

I don't know if I would have been able to keep the company going or if I would have just lost my drive and quit altogether because it just would have seemed like every door was shutting on me.

to "give her a fair shot." "I appreciate it," she says. "Everyone else was just trying to take me for everything I had."

#### The money she needed and fast

Ke'Anna says that after discovering EJF through a referral, she polished her business plan and applied for financing. "The Economic Justice Fund has been a blessing, for sure!"

EJF approved her company for a loan in February 2021 to fund the manufacturing costs and provided a second loan a year later to jumpstart inventory for her BBQ sauce.

She says receiving the funds so quickly after approval was a game-changer in helping her continue fulfilling orders.

## Without loans, she would have had to refinance her house

Receiving the capital to manufacture her sauces was crucial for Ke'Anna's RUE Kitchen to stay in business.

She says if she hadn't received the funds, her last resort would have been to refinance her

house and take out a loan on her home to keep the business afloat.

I've heard from other people who have received business loans...that it can take almost as long as the application process or longer to get the money once approved. Then it's three months later when you finally get the money. With the Economic Justice Fund sending the money within 24 hours of signing my loan agreement, I could start production with my manufacturer immediately.

While she says business is still akin to a "roller coaster," she is excited about the future. You can find her vegan sauce products on her website, in select stores, and through online sellers, including Amazon and Walmart. Her next goal is to get RUE Kitchen sauces on the shelves of major big box retailers around the country.
