

New report shows rebounding growth in clean energy jobs

More than 50,000 new energy efficiency jobs were created in 2021.

On June 28, the U.S. Department of Energy (DOE) released the 2022 U.S. Energy and Employment Report (USEER), a qualitative study designed to analyze annual employment trends across energy sectors. According to the report, while overall energy jobs experienced growth in 2021, the energy efficiency (EE) sector, which employs over 2.1 million workers and is the largest source of clean energy jobs in the country, has not bounced back to pre-COVID-19 levels.

The energy efficiency industry was severely impacted by the pandemic, losing approximately 271,719 jobs in 2020. Since then, the sector has started to recover, adding 57,741 new jobs around the country in 2021 with a growth rate of just under 3%.

The energy efficiency industry has historically provided a good source of well-paying, accessible jobs for U.S. workers in building trades such as construction, HVAC, and manufacturing of high-efficiency equipment and materials. With the nation pledged to reach economy-wide net

zero emissions by 2050, supporting the development of these jobs will play an important role in diversifying our energy sources, protecting our environment and stimulating economic growth in the near future.

“Amidst the unique challenges of a nation coming out of a global pandemic, America’s energy sector stands out with considerable job growth across nearly all industries,” U.S. Secretary of Energy Jennifer M. Granholm said in a press release. “DOE’s USEER report shows that jobs critical to our clean energy transition are on the rise and poised for continued expansion thanks to the historic investments from the president’s bipartisan infrastructure law.”

Energy efficiency jobs are expected to grow.

Several federal initiatives could help with investments for energy efficiency jobs and programs. Under the bipartisan infrastructure law that President Biden signed in November, DOE will receive \$62 billion to expand access to energy efficiency; to deliver reliable, clean and affordable power to more communities; and to support the development of clean technologies, including through workforce development and training.

Governor Gavin Newsom signed a \$308 billion state budget that provides direct tax refunds for 23 million Californians to help address rising costs, tackles the state’s most pressing needs, builds our reserves, and invests in California’s future.

2. Don’t go into crippling debt over a hospital visit

3. A real “Pro-life” agenda

Fun fact – California is actually a pro-life state. We’re protecting reproductive freedoms and supporting Californians throughout their lives. In this budget, we’re investing over \$200 million in reproductive care. We’re making a company’s willingness to move OUT of anti-choice states and TO the reproductive freedom state of California a factor in awarding state business tax credits. But we’re not stopping at reproductive care. We’re investing in a child’s entire lifespan. From birth to college and beyond. California workers found better paying jobs, but experts warn recession puts them at risk

As California emerges from the pandemic, the state's workers are slowly recovering after hundreds of thousands of them left their jobs last year.

Fed up and burnt out, workers quit or changed jobs in droves in search of better pay, benefits or workplace conditions, part of what many are calling the "great reshuffling" across the state and country.

A panel of experts Wednesday said the reshuffling of jobs has produced "mixed signals" in California's economic recovery. They said many workers had switched jobs but stayed within the same sectors, often gaining higher wages, yet job openings and resignations remain at historically high levels.

CalMatters Reporter Grace Gedy moderated a discussion hosted by the Milken Institute and CalMatters about California's economic recovery from the pandemic.

Irena Asmundson, a researcher at the Stanford Institute for Economic Policy; Natalie Palugyai, Secretary of the California Labor & Workforce Development Agency; Sarah Bohn, vice presi-

dent and chair in policy research at the Public Policy Institute of California; and Rachel Michelin, president of the California Retailers Association, described the impact the "great reshuffling" is having on workers, employers and the state.

And they discussed how California could maintain its reputation for a growing, productive workforce and stave off a potential recession.

Here are three takeaways:

Workers who changed jobs often won better pay

As the economy recovers, the "great resignation" is more like a "great reshuffling," with workers changing jobs within the same industry, said Bohn. With demand for workers on the rise, wages have increased an average of about \$4 per hour, she said, but with inflation it doesn't feel like a raise and for some it may feel more like a pay cut.

The pandemic fundamentally shifted the way retailers do business, added Michelin. Retailers adjusted to COVID spikes by adopting curbside pickup, deliveries and managing supply chain woes, she said.

They also boosted worker pay, she added, alluding to some warehouse and distribution center jobs that pay \$23 an hour. She said businesses

also invested in worker training and education.

The panelists said that most of the workers who changed jobs were not highly educated and held lower-paying positions in construction, warehouses, and retail.

A looming recession puts workers' wins at risk

With a potential recession on the horizon, the panelists said California's growth may be at risk.

Bohn said that while that state has been in "a unique period of budget surplus," employers' efforts to draw in workers with better pay, flexibility and increased training could be at risk.

Asmundson warned of structural faults in the economy. She used, as an example, disparities in taxes people pay for homes because of California's Proposition 13, which capped property tax increases.

Some panelists warned that many workers can't afford housing because their take-home pay doesn't cover it. Add to that inflation and federal efforts to raise interest rates.

"Recessions happen when there's an imbalance in the economy," Asmundson said. "Recessions happen when people pull back at the same time and when people start to be laid off."

A long road ahead for permanent change

The experts were uncertain wage and benefits gains in the reshuffling are here to stay without some broader worker protections in place, especially for low-income earners.

Palugyai said it's hard to quantify the impact of the great reshuffling as an overall net good or bad.

"A lot of this reshuffling is causing marginal changes for workers," she said. "A dollar or two here and there — it's not getting what these workers need long term to grow."

The last two years have been a wake-up call to employers to improve workplace conditions and training opportunities, she said, and to listen to workers as thousands across the country attempt to unionize.

Asmundson said that one of the biggest lessons learned in the pandemic was the importance of equity in housing, work and beyond. She pointed to the state's falling population rates and the concentration of homeownership among older, white, retired Californians.

"There's already this jobs and housing imbalance," she says, "so we have to fix that issue by all working together."

Additionally, the budget reconciliation legislation under consideration in Congress could include billions of dollars in federal tax incentives and other funding for energy efficiency upgrades and clean energy technologies across the country.

These investments could significantly expand the efficiency and renewable energy sectors, supporting the creation of thousands of jobs and significantly reducing our country's commercial and residential emissions and energy consumption.

Other green sectors also show notable job growth.

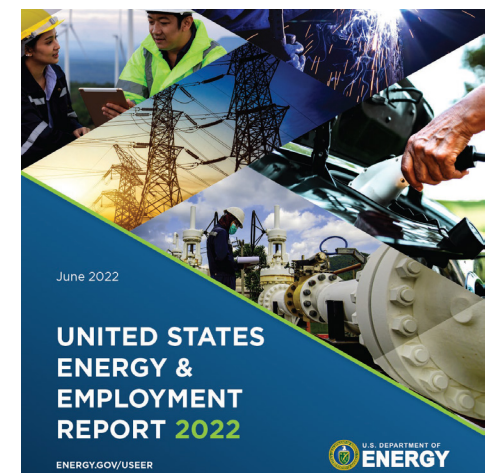
According to the report, total U.S. energy sector jobs increased by 4% in 2021, outperforming overall U.S. employment, which rose only 2.8% during the same period. Overall, the energy sector added 300,000 jobs, increasing from 7.5 million jobs in 2020 to 7.8 million in 2021. About 3 million of these jobs, around 40% of all energy jobs, are in areas aligned with net zero goals, furthering the U.S.'s work toward carbon neutrality.

Other energy industries, such as the electric vehicle and renewable energy sectors, also experienced significant job growth:

- Electric vehicles jobs increased by 26.2%, adding 21,961 new jobs.
- Hybrid electric vehicle jobs increased by 19.7%, adding 23,5777 new jobs.
- Solar energy jobs increased by 5.4%, adding 17,212 new jobs.
- Wind energy jobs increased by 2.9%, adding 3,347 new jobs.
- Transmission, distribution and storage jobs increased by 1.9%, adding 22,779 new jobs.

The library was built in 1916, is one of seven historic San Francisco Carnegie libraries, and received landmark status in 2002. The library was renovated in 1997 to provide seismic and accessibility upgrades which resulted in loss of historic architectural features including the historic entry and monumental stairway. The new project will provide a complete renovation, restoration of lost architectural features such as the main stair and entry, and repair of the historic façade. The main historic building will receive an expansion on the west side of the building which will include new reading space as well as a basement that will house building utilities. The project will provide new program areas including a Community Room and a Teen Room. All building systems will be renewed including primary and secondary power service, HVAC and plumbing systems, distributed power, telecom, security, audiovisual, fire alarm and fire sprinklers, and new rooftop solar panel systems. 

Mayor London Breed Statement on State Budget Includes Investments of Nearly \$55 Million in Community Projects

Mayor London N. Breed released the following statement about the state budget agreement reached between Governor Gavin Newsom, the Senate and the Assembly. This budget, which includes funding for a number of Mayor Breed's priorities, such as homelessness, behavioral health, affordable housing, transportation, and resiliency, also includes nearly \$55 million in state funding for local community projects secured by San Francisco's state delegation of Assembly Budget Chair Phil Ting, Senator Scott Wiener, and Assemblymember Matt Haney.

"The state budget will help to support the needs of so many San Franciscans by providing relief to our low-income communities, protecting all of us from future downturns, and ensuring that our homelessness and affordable housing crises are being prioritized," said Mayor Breed. "Included in this budget are vital resources which will help us to bring parks, public plazas, safe streets, recreation, and cultural spaces to our communities. I want to thank Governor Newsom and our State Del-

egation for their work to secure this critical funding, especially Assemblymember Ting who led the Budget Assembly process and continues fighting for San Franciscans most in need, Senator Wiener who has long been an advocate for investing in diverse communities across the City, and Assemblymember Haney who immediately identified the priorities and needs of his constituents. The projects funded here will make a real difference in the lives of our residents and families."

Examples of key priorities funded in the Budget include:

\$6 million – Japantown Peace Plaza

San Francisco's Japantown is one of the last three remaining Japantowns in the United States. For over 110 years, over 5 generations, the Peace Plaza open space has been the cultural heart of Japantown and is a key destination site for cultural festivals and community celebrations, as well as the home to culturally significant community organizations, institutions, artists, businesses, and buildings. Along with the State's commitment of \$6 million, the City will be supporting the renovation with \$25 million of the 2020 SF Health and Recovery Bond and is awaiting confirma-

tion of Fiscal Year 2022-23 Community Project Funding from Speaker Nancy Pelosi.

\$5.5 million – LGBTQ History Museum

The LGBTQ History Museum will be located in San Francisco's Castro District, which attracts residents and tourists who seek the neighborhood's rich history and vibrant queer culture. This first in the nation museum will celebrate and recognize the City's LGBTQ community's history, while serving as a gathering space for the community to host events and artists to display their works. Last year, San Francisco Mayor London Breed invested \$12 million to acquire a permanent site for the LGBTQ History Museum in the City's budget. The City and County of San Francisco has been evaluating various sites over the last year, and has funded an economic analysis to ensure the project's success.

\$5 million – San Francisco Wholesale Produce Market

The San Francisco Wholesale Produce Market (SF Market) is the only non-profit wholesale produce market of its scale in the nation. The SF Market's critical food infrastructure supports

dozens of independent merchant businesses, over 500 direct jobs, a reliable market for growers and family farms across 38 California counties, and a variety of community programs that address significant food security issues. The SF Market is in the midst of a multi-year Reinvestment and Expansion Plan intended to modernize its aging campus and ensure its continued operation. Through San Francisco's Fiscal Year 2021-22 Capital Budget, Mayor Breed committed \$3 million to early stages of this Plan – work that is now underway. Together with the state allocation, these funds will support renovations to both the SF Market's core operational facilities, and improvements to the public road network surrounding the market's campus. This combined investment in the SF Market, and related public infrastructure, supports economic development and food security for the entire Southeast Corridor of San Francisco.

\$5 million – Sunnydale Community HUB

The Sunnydale neighborhood is home to one of the highest concentrations of young people in San Francisco, as well as one of the highest

concentrations of poverty. This funding will help with the construction of a community recreation center serving a public housing community in the southeastern part of San Francisco to provide safe and accessible space to families, children, and youth for sports, recreation, cultural events, as well as health and wellness programs and activities. The City has already committed over \$10.5 million towards this project.

\$4 million – Portsmouth Square

Portsmouth Square, located in Chinatown, is one of San Francisco's most significant historic, cultural, and civic spaces. For decades, it has been the symbolic heart of the Bay Area's Chinese American community. It is the location of countless events, ceremonies, and festivals, but it is also known as "Chinatown's living room"

for how significant it is to the day-to-day life of the neighborhood. This state funding will go towards building a new community clubhouse, a new playground with adult fitness equipment, flexible outdoor event space and stage, lighting improvements, and enhanced accessibility which includes elevator modernization to connect the park to the underground garage. The City is supporting this project through other funding sources such as the 2020 Health and Recovery Bond with \$54 million and developer impact fees of \$10.8 million.

\$2.7 million – Sloat Boulevard (between Skyline Blvd. and Great Highway)

The San Francisco Municipal Transit Agency (SFMTA) has worked with community stakeholders and neighbors to develop a pedestrian improvement plan that will create a safer and

more accessible street for all users, including people walking and biking. The section of Sloat Blvd. is on San Francisco's High-Injury Network and the design includes protected bike lanes and new traffic signal to improve efficiency and safety. This will be implemented through SFMTA's Quick Build Program, which guides staff to move forward with quick, near-term safety enhancements on high injury corridors.

SUCCESS STORIES

Davin Vculek and Joe Blanton, Krush Burger

Davin Vculek and Joe Blanton, owners of Sacramento-based Krush Burger, had worked in the regular restaurant industry for years and actually met through the industry – Blanton was working for a large vendor of the major restaurant company where Vculek was a food purchasing manager (and executive chef). Both say they had been looking into how to get into the business of owning their own restaurant and decided that the food truck route was the best way to get into the industry so they created Krush Burger.

They started with one idea – serve great burgers – one truck and one employee, but as essentially the only food truck in Sacramento they immediately garnered local attention. “It was our good food and our good service that allowed us to capitalize on the local media attention,” Vculek said. Krush Burger grew quickly, adding a second truck (while replacing their first truck with a whole new top-of-the-line vehicle) and then reached back into Davin and Joe’s past and added two “brick and mortar” outlets.

Moving into the fixed facility restaurant world while keeping a foot in the food truck world is

a bit unusual, especially considering the occasional enmity that can bubble up between the two industry sectors. But Blanton points out that much of what many more typical restaurateurs think about food trucks is not exactly accurate.

“It’s true our startup costs are less, but it’s also true that we have to deal with a lot more local bureaucracy. Trucks move, so we need to have all of the proper permits for each county and each city where we operate,” Blanton said.

The other main difference is how to attract a customer base. In regards to their regular restaurants (two existing in Sacramento and Davis, a third to open up in Dubai – yep you read that right, Dubai – and a fourth coming next year to Roseville) the customers by definition know where to go to get a great burger and sweet potato tots and a good local beer. With food trucks, the onus is on the owners to communicate directly with their customer base to inform them of exactly where they will be at any given time.

Blanton said without Krush Burger’s significant social media presence the task of keeping the customers in the know would be quite difficult. “We had to find our own customers so that they could find us – literally – so we had to actively

market ourselves,” Blanton said. “Many restaurants just open the doors and wait for people to show up. We couldn’t do that.” Krush Burger now has more than 8,000 twitter followers and a significant Facebook presence. In fact, last year the company ranked in the top 15 of ALL burger chains in the country (yep – McDonald’s included) for the size and scope of its social media operation.

As Krush Burger expanded, Vculek and Blanton realized they need a bit more working and equipment capital and that’s where SAFE-BIDCO came in. The company recently inked a \$235,000 federal SBA loan through SAFE-BIDCO and was tapped by the SBA itself recently as one of five “Small Businesses of the Year” for the northern California region.

“SAFE-BIDCO was fantastic to work with and very supportive,” Vculek said. “They really helped us navigate the process.”

Baking was something Rafaela already had experience in, so when she became mom and needed a flexible work schedule to be with her child, the idea of having her own business looked quite promising. She soon realized however that sometimes we need a little more than inspiration, we need guidance in order to transform that first good idea into a business.

“During the last few years, I worked with farmers markets and farms and in the catering business, in food businesses in general, so when I thought in creating a business, all my previous experience plus my passion for food came together to become a project, to create my own cooking business.” Rafaela explained during an interview with us. “It was very hard at the beginning, the first few months I spent researching, googling everything I could, but there is so much information out there that you do not know where to start. I was getting nowhere. Once, in a farmers’ market I used to work, I met Sonia (So-

nia Chang, our Food Cottage consultant) and she told me about the NEW Women Business Center and the Cottage Food Program they had, and that was the push I needed for everything to start to happen.”



The same month Rafaela started her classes, she finished the process for registering her business and acquiring the licenses and permits she needed to start operation as a Cottage Food Vendor. Rafaela told us, “If it wasn’t for the WBC and all the guidance of the cottage food

program, I would probably still be going around in circles without getting any result.

This is precisely one of the main focuses of all our training programs, to provide not only information, but guidance on the process of creating your own business with your ideas and your vision, but with the necessary support and training that can let you really feel the certainty to succeed. Rafaela told us she was a little anxious at the beginning—she didn’t know how people would react to her products—fortunately, however, she had a marvelous reception and is quickly creating a loyal clientele who will follow her, and her delicious products, to all the venues she and other members of the Cottage Food Pop-up Group go to every week. Her sweet dream has come through and is called, Bayleaf Mama.
