# Culture of CARE program to bolster inclusion in the construction industry

On July 6, the Associated General Contractors of California (AGC of California) launched Culture of CARE, a collection of resources designed to aid construction industry companies and organizations' understanding and implementation of belonging and diversity, equity & inclusion's (DE&I) best practices.

"Cultivating an inclusive environment in the construction industry is imperative to attracting and retaining a diverse workforce now and in the future," said AGC of California Chief Executive Officer Peter Tateishi. "Our Culture of CARE initiative allows our industry to work together to address long-standing underrepresentation in the construction workforce and provide an environment where every worker feels welcome and included."

"CARE" stands for "cultivate, attract, retain, and empower." The program offers actionable tools and resources to help contractors gauge current company culture and provides learning resources for both the office and in the field. Specific resources include:

- Facilitator guide: Tips and best practices for delivering training sessions at your office or jobsite.
- Toolbox Talks: Informational discussion guides on topics such as racism, gender identity, sexual orientation, and more.
- Learning resources Assets your organization can adapt for heritage months, research tools, supplier diversity, and more.

Belonging survey: An anonymous questionnaire that assesses workers' overall sense of belonging and identifies disparities across demographics. AGC of California's DE&I team will assist companies with analysis of results, which are presented in a succinct and informative way.

Creating a culture that supports DE&I is integral to attracting and retaining an engaged workforce. According to Deloitte, 46% of companies who foster a diverse, equitable and inclusive organization reported an increased competitive advantage. And 69% of Gen Z said they would

### **Budget Buys Time for Transit to Build New Business Model**

California transit agencies this week received expected but nonetheless welcome financial news as the fiscal 2023-24 state budget signed into law by Gov. Newsom while aboard a BART train includes \$1.1 billion in flexible transportation funding to help support their operations. The state investment, which largely follows the contours of a budget agreement released by the Legislature earlier this month, will help transit agencies avoid a nearterm 'fiscal cliff' that likely would have led to deep service cuts as early as this year by Muni, BART and other agencies whose fare revenues remain well below pre-pandemic levels. The new budget also restores a previously imperiled \$4 billion commitment for local transit capital improvements, with an option to flex these funds toward transit operations. The Bay

Noting the \$5.1 billion for public transit included in the new budget, Gov. Newsom said in an Instagram video released this morning, "That's a significant improvement from where we expected the budget to land...But in return we're also demanding more accountability. We're demanding more collaboration. We're demanding a new approach, a new business model for public transit. Not just for Bay Area Rapid Transit but for public transit writ large."

"MTC truly appreciates the hard work done by so many to craft a budget that recognizes the importance of public transit to maintaining California's economic growth and to meeting our mobility, climate and equity goals," said Commission Chair and Napa County Supervisor Alfredo Pedroza. "Members of the Bay Area legislative caucus, including Senate Budget Committee Chair Nancy Skinner, Assembly Budget Committee Chair Phil Ting and Sen. Scott Wiener, have been incredibly engaged in this year's budget work; and their attention has been matched by Assembly Speaker Anthony Rendon, Senate President Pro Tem Toni Atkins and others from around the state. Gov. Newsom's call for public transit to develop a new business model for a new era is smart and well stated. Our Commission is eager to work with the governor and with the Legislature to step up the pace on the transit transformation work that's already started here in the Bay Area."

The new budget will allow California transit agencies to use up to a combined \$1.1 billion from select sources, including the state's Capand-Trade program for greenhouse gas emission allowances, over the next three years to support operating costs (fuel, drivers, mechanics, etc.) as well as to cover capital expenses associated with the transition to zero-emission transit as required by the Air Resources Board's Innovative Clean Transit rule. # Future of Tech Recap - LA Tech Week 2023

The LAEDC's Future Forum, as part of LA Tech Week 2023, centered on the power of technology in driving innovation and building an equitable economy. New technologies, such as digital platforms, artificial intelligence, and big data analytics, have the potential to revolutionize economic development. They can improve access to information, services, and workforce opportunities for marginalized communities, bypassing traditional barriers like physical distance or lack of funding. By harnessing technology's potential, the aim is to create more inclusive and sustainable economies that benefit everyone.

Stephen Cheung, President and CEO of the LAEDC, and Chris Manriquez, Vice President for Information Technology and Chief Information Officer of California State University Dominguez Hills, also welcomed the participants. Mr. Manriquez highlighted the university's commitment to transformative education, community collaboration, and technological advancements. Mr. Manriquez stressed the importance of technology and its role in shaping the future economy, emphasizing the need for critical thought, education, and regional cooperation.

Jessica Ku Kim, Chief Deputy of the Los Angeles County Department of Economic Opportunity, represented the newly formed department, which aims to deepen economic and workforce development services. During her keynote, Ms. Kim emphasized the significance of technology in the digital economy, highlighting the impact of technology during the pandemic. She acknowledged the resilience of high-skill, highwage jobs and the challenges faced by marginalized communities due to the digital divide.

Ms. Kim discussed the department's focus on supporting local businesses, investing in employers that offer living wages and career advancement opportunities. The County aims to build resources and partnerships to promote equitable capital access. The department also recognized the importance of workforce development, ensuring individuals had the necessary skills for rapidly changing technology-driven industries. Kim encouraged employer partnerships and participation in regional discussions to meet the demands of a fast-changing economy. She mentioned LA County's investment in technological infrastructure, including a worker and business portal to simplify access to resources. The department also planned to invest in digital navigators and resources for communities with limited digital literacy and access. Kim emphasized the need for collective investment in socioeconomic empowerment, particularly in disinvested communities.

Ms. Kim expressed the County's commitment to making impactful investments, working with partners, and delivering services to the community. She invited participants to connect with her and the department for further collaboration.

The Future Forum featured a panelist discussion with:

- Krystal Rawls Director, Workforce Integration Network (WIN), CSUDH
- Tim Ryder, General Manager, Microsoft
- Moderator: Todd Terrazas, President, A LA Community

Mr. Terrazas opened the panel with a recent Goldman Sachs report stating that generative AI is expected to drive a significant increase in global GDP by up to 7 percent and productivity growth over the next decade. Generative AI can generate text, images, and other media, revolutionizing content creation, creativity, and productivity. However, it raises ethical concerns regarding quality, authenticity, and ownership of generated content. The panelists focused on harnessing AI's positive potential while ensuring fairness, safety, and broad benefit. Each panelist then introduced themselves and shared their perspectives on AI. Ms. Rawls emphasized the importance of collaboration across various sectors to ensure the successful implementation of AI. Ms. Cohen highlighted the need for effective regulation and governance to manage the risks associated with AI, drawing from lessons learned from the invention of the internet. Ms. Jones discussed the advancements in creating digital humans and their applications in fields like entertainment, education, and storytelling. And Mr. Ryder discussed the opportunities and challenges of AI in manufacturing, emphasizing the need to bridge the gap between skill requirements and workforce development.

The conversation then discussed the broader implications of AI, including bias in datasets and the importance of governance and ethics, such as those that were not present at the start of the Internet's rollout. The panelists acknowledged the inherent biases in data and stressed the need for transparency, ethical policies, and human oversight in AI systems. They discussed the importance of organizations having robust ethics policies and being accountable for their data practices. There was an emphasis for the need to involve diverse perspectives and communities to address biases and ensure fair and inclusive outcomes.

## San Francisco releases analysis report on the impact of Community Benefit Districts

The Office of Economic and Workforce Development (OEWD) released an Impact Analysis of Community Benefit Districts (CBDs), also known as Business Improvement Districts (BIDs). The analysis was conducted to measure the impacts and progress of CBD/BIDs, demonstrate the program's value and contribution, identify opportunities to strengthen public and private partnerships, and educate members of the public and government on the program. The report highlights the partnership with CBDs and their contributions including over \$32 million in assessment revenues annually of which 70% support cleaning, safety and economic development services.

Community Benefit Districts are public-private partnerships in which property and/or business owners elect to make a collective contribution to the maintenance, development, and promotion of their mixed-use neighborhood through a special assessment to the property or business. CBD/BIDs are uniquely positioned to address hyper-local, neighborhood-specific needs.

"Community Benefit Districts are a great example of what can be accomplished when we work collaboratively with community partners to address our most pressing challenges, and to identity priorities at the neighborhood level to improve the wellbeing of our residents and help our economy," said Mayor Breed. "CBDs are important partners, not only to ensure our neighborhoods are clean and safe, but to help us identify how we can continue to provide culturally sensitive programming and connect people to the social services and resources they need to thrive."

"It's been heartening to see Community Benefit Districts evolve since I first authored Article 15 to enable their formation here in San Francisco," said Board President Aaron Peskin, whose supervisorial district hosts the most CBDs in the City. "When done right, they can provide critical support for supplemental services that San Franciscans care deeply about: safer, cleaner and more activated streets and public spaces."

The 2023 Impact Analysis focused on 15 locally managed property and business districts that are based on specific geographic areas within San Francisco in operation in 2022. The information and data gathered from the report is through 2020-2021. These 15 CBDs/BIDs cover approximately 8 percent of San Francisco's land area, and approximately 20% when only accounting for commercially zoned land. CBD/BIDs in San Francisco directly sustain over 320 jobs and invest over \$32 million for a range of services including

the Bay Area's share of these funds and then to determine the ultimate distributions to Bay Area transit agencies.

The restoration of the full \$4 billion in capital funds for fiscal 2023-24 and 2024-25 will help keep on track major Bay Area projects such as BART's Transbay Core Capacity initiative to boost service frequencies through the Transbay Tube linking San Francisco and Oakland, and

the BART extension to be built by the Santa Clara Valley Transportation Authority from Berryessa/North San Jose through downtown San Jose to a new terminus in Santa Clara. The Major Projects Advancement Policy (MAP) adopted by MTC last year identifies these projects as the primary recipients of future transit capital dollars that will flow to MTC for distribution.

# Plan to Strengthen Semiconductor Supply Chains as Part of Investing in America Agenda

Department of Commerce Announces Strategic Vision and Application Process for Semiconductor Supply Chain Projects, Nearly 400 Companies Interested in CHIPS Incentive

The U.S. Department of Commerce shared the Biden-Harris Administration's strategic vision to strengthen the semiconductor supply chain through CHIPS for America investments. To advance this vision, the Department announced a funding opportunity and application process for large semiconductor supply chain projects and will release later in the fall a separate process for smaller projects. Large semiconductor supply chain projects include materials and manufacturing equipment facility projects with capital investments equal to or exceeding \$300 million, and smaller projects are below that threshold.

The announcement leads into the Biden-Harris Administration's Investing in America tour, where Secretary Raimondo and leaders in the Administration will fan across more than 20 states to highlight investments, jobs, and economic opportunity driven by President Biden's Investing in America agenda and the historic legislation he's passed in his first two years in office, including the bipartisan CHIPS and Science Act.

"After the pandemic exposed holes and bottlenecks in our semiconductor supply chains that sent shockwaves across our economy, the CHIPS and Science Act is a historic opportunity to ensure our microchip supply chain resilience," said Secretary of Commerce Gina Raimondo. "Thanks to President Biden's Investing in America agenda, we're already seeing billions in private sector investment bolster the semiconductor supply chain. We're laying out our vision for how we'll build on that progress by responsibly making investments to ensure resiliency and success for the clusters we will create."

Alongside the funding opportunity for larger supply chain projects, the Department also released a "Vision for Success" outlining strategic objectives for investments in the semiconductor supply chain, building on Secretary Raimondo's February speech at Georgetown University on core CHIPS for America objectives. The goals in the vision paper include: (1) strengthening supply chain resilience, including by reducing chokepoint risks flowing from the geographic concentration of critical semiconductor inputs; (2) advancing U.S. technology leadership, including by incentivizing major U.S. manufacturing equipment and materials suppliers to increase their footprints in the United States and attracting non-U.S. suppliers of the world's most advanced equipment, materials, and subsystems to establish large-scale footprints here; and (3) supporting vibrant U.S. fab clusters, including by ensuring that each CHIPS-funded cluster is supported by an ecosystem of reliable suppliers. Read more here about these goals in the supply chain Vision for Success paper.

This vision, in addition to the statements of interest the Department received, will inform implementation and ensure CHIPS funding crowds in private capital - not replace it - across the semiconductor ecosystem. It also positions the Department to steward taxpayer dollars as efficiently and effectively as possible. Since announcing the first funding opportunity, the Department of Commerce has received nearly 400 statements of interest from companies seeking to build semiconductor projects across 37 states, demonstrating widespread enthusiasm from the private sector to continue investing in America. The recently released funding opportunity also maintains the Department's emphasis on building the construction and facility workforce that will support resilient domestic supply chains, including through partnerships with labor, educational institutions, workforce development organizations, and others.

#### **Application Processes and Timelines**

As part of the bipartisan CHIPS and Science Act, the Department of Commerce is overseeing over \$50 billion to revitalize the U.S. semiconductor industry, including \$39 billion in semiconductor manufacturing incentives. The first funding opportunity seeks applications for projects to construct, expand, or modernize commercial facilities for the production of leading-edge, current-generation, and mature-node semiconductors. This same funding opportunity is now open to materials and manufacturing equipment facility projects with capital investments equal to or exceeding \$300 million.

Large-scale supply chain projects that are now eligible will follow the five-part application process laid out in the first funding opportunity: statement of interest, pre-application (optional but recommended), full application, due diligence, and award preparation and issuance. Applicants will be evaluated based primarily on the extent to which the application addresses the program's economic and national security objectives, but they will also be evaluated based on commercial viability, financial strength, project technical feasibility and readiness, workforce development, and broader impacts.

An additional funding opportunity will be released in the fall for supplier projects below the \$300 million threshold with a tailored application that smaller businesses can navigate. Read more here about both funding opportunities.

Current CHIPS manufacturing incentives application processes and timelines:

- **For leading-edge commercial facilities:** Both pre-applications (optional) and full applications are being accepted on a rolling basis.
- **For current-generation and mature-node commercial facilities:** Pre-applications (optional but recommended) are currently being accepted on a rolling basis and full applications will be accepted on a rolling basis starting June 26, 2023.
- **For larger materials and manufacturing equipment supplier facility projects with capital investments equal to or exceeding \$300 million:** Pre-applications (optional but recommended) will be accepted on a rolling basis starting September 1, 2023, and full applications will be accepted on a rolling basis starting October 23, 2023.
- For all potential applicants: The Department continues to accept statements of interest on a rolling basis to further inform the program of interest and make for efficient application review.

Forthcoming CHIPS manufacturing incentives applications processes and timelines:

For smaller materials and manufacturing equipment supplier facility projects below \$300 million: The Department will release an additional funding opportunity in the fall with details on the application process and timeline. For more information about this forthcoming funding opportunity, see here.

**For commercial R&D facilities:** The Department will subsequently release a separate funding opportunity with details on the application process and timeline.

### International Coordination with U.S. Partners and Allies

As CHIPS for America invests across the supply chain, the Department of Commerce will prioritize robust international engagement. Through bilateral and multilateral dialogues, and business-to-business and government-tobusiness forums, the Department will work with likeminded partners to strengthen and diversify the global semiconductor supply chain.

The Department's CHIPS-related international engagement to date has included engagements with the Republic of Korea, Japan, India, and the United Kingdom, and through the Indo-Pacific Economic Framework, European Union-United States Trade and Technology Council, and North America Leaders' Summit. The Department will continue coordinating closely with U.S. partners and allies to advance these shared goals, advance our collective security, and strengthen global supply chains.

# **6 Keys To Subcontractor Prequalification Success**

As a general contractor, you have to be selective when it comes to the subcontractors you work with. You want to choose companies that have a dependable skilled workforce, strong management, financial stability, and can perform quality work to your company's standards. To do this, you need to have an established subcontractor prequalification process in place.

As with any business decision, picking subcontractors to work with requires you to do your due diligence. You should be prequalifying every subcontractor you're considering working with to reduce risks that could impact your business, such as subcontractor default or substandard work.

Maybe you have a stable of subcontractors you routinely do business with, but what happens when you decide to take on a project in another state or all of your regular subcontractors are unavailable? At some point, you are going to work with a subcontractor that you have little to no experience working with. Prequalifying subcontractors before you solicit pricing or subcontractor bids can lead to mutually beneficial partnerships for years to come.

Here is some of the key information you need to obtain on your subcontractor prequalification forms:

#### **General Information**

You want to get some basic information such as company ownership, current management, number of employees, and the states in which they have contractor licenses. You also want to find out about the size and scope of the projects they typically work on and whether they are certified as a Minority Business Enterprise.

#### Safety Records

At the very least, you need to get their OSHA 300 information and whether the subcontractor has had any citations issued and their Experi-



ence Modification Rate for the previous three years. You can also inquire about their training program and whether or not they hold regular safety meetings.

#### Surety & Bonding Capacity

Find out the subcontractor's current surety provider, agent's name, and contact information. Be sure to ask about their bond rates for specific volumes along with their single project bonding capacity and their aggregate bonding capacity.

#### **Financial Standing**

Determine if the subcontractor has ever filed for bankruptcy and ask for their Dun & Bradstreet number if they have one. You can also ask them to provide other financial information such as current year revenues, total and current assets, net equity, current liabilities, and average monthly billings.

#### **Litigation History**

The first thing to determine is whether the subcontractor company, or any of the owners, has any active litigation. Find out if the subcontractor has had any labor law violations, had their license suspended or revoked, and if they've had any judgments filed against the company. You should also ask about any contract defaults and whether they've ever been terminated from a contract.

#### Ask for References

Ask your potential subcontractors to provide three to four reference contacts that can attest to both the quality and dependability of their company and employees and can also verify the company's creditworthiness.

#### **Final Thoughts on Prequalifying Subcontractors**

General contractors should make their subcontractor prequalification process easily accessible. Create an online prequalification form that can be easily found on your company's website. Have a link to the form prominently featured on the page where you have your subcontractor opportunities or currently bidding projects listed.

If you are a subcontractor looking for more opportunities, you should contact general contractors in your area and ask to get prequalified with their company. You don't have to wait until they have a job that meets your company's capabilities. Be proactive and get prequalified first. This way, you'll get contacted by the general contractor first when they have an upcoming project requiring services your company provides.

public safety, cleaning, beautification, wayfinding, outreach and connecting unhoused to resources. marketing, and etc. to improve and strengthen their mixed-use neighborhood commercial areas, annually

#### The Impact Analysis found that:

- Based off FY 19-20 data available at the time of authorship, CBDs removed over 2,000,000 pounds of litter and garbage from their service areas
- Over 30 public art installations produced by CBD/BIDs since 2017, at the time of authorship.
- CBD/BIDs continue to increase the number of placemaking projects and initiatives they lead.
- Over 70% of CBD assessment revenues were focused on clean and safe services.
- Nearly 50% of operating CBD/BIDs were established in the last 10 years.

- CBD-led analysis of their clean and safe programs enables more effective and impactful services.
- The city can and should strengthen partnerships with CBD/BIDs to leverage the localized expertise of these organizations, which will lead to greater effective service delivery results for both.
- The city can leverage CBD/BIDs in their outreach and connecting people to social services programing. This is a relatively new performance area for CBDs, but nearly all CBD executive directors believe their direct services or partnerships with CBOs should continue.
- CBDs adapted immediately to small business needs at the onset of the Covid-19 pandemic and continue to serve as hyper-local resource hubs for businesses and area stakeholders.

The city should look to CBD/BIDs for hyper-local economic development needs and insights.

### High-Speed Rail Recognizes Summer Graduates of Central Valley Training Center

The California High-Speed Rail Authority (Authority) recognized 11 students who completed the Central Valley Training Center's 12-week, pre-apprenticeship program at a graduation ceremony at the Selma Arts Center.

The pre-apprenticeship training program is aimed at serving veterans, at-risk young adults, minority, and low-income populations in the Central Valley. The no-cost program provides hands-on construction industry training for those looking to work on the nation's first high-speed rail project.

"Continued progress on the high-speed rail project is thanks to the men and women who are on our constriction sites each day," said Garth Fernandez, Central Valley Regional Director. "We're proud to be working with our partners and help train the workforce that will bring high-speed trains to California."

At the Central Valley Training Center, students are exposed to more than 10 different construction trades and exit the program with more than a dozen industry-specific certifications. Graduates receive job placement assistance, including coordination with the highspeed rail project and its contractors.

Since the start of the training center, 134 students have graduated, with more than 1,000 inquiring about the program.

Since the start of high-speed rail construction, the Authority has created more than 11,000 construction jobs with a majority of those going to residents from the Central Valley. In addition, there are more than 30 active construction sites across 119 miles under construction in the Central Valley.
