The U.S. Department of Transportation is proud to be a leader in the Federal government, earning an "A" rating from the Small Business Administration (SBA) on the FY2022 Small Business Procurement Scorecard. Here at DOT, we've made supporting small businesses a top priority. Our Office of Small and Disadvantaged Business Utilization (OSDBU) led by Director Bradley Mims, and the Office of the Senior Procurement Executive (OSPE) led by Dr. Willie Smith, work closely together and their efforts are instrumental in achieving an "A" rating for the 14th consecutive year. OSDBU and OSPE provide a wide range of ongoing support to help small businesses compete for DOT contracts.

The Small Business Procurement Scorecard is an assessment tool to measure how well federal agencies reach their small business and socioeconomic prime contracting and subcontracting goals; provide accurate and transparent contracting data; and report agency-specific progress for small businesses, small businesses owned by women, small disadvantaged businesses, service-disabled veteran-owned small businesses, and small businesses located in Historically Underutilized Business Zones (HUBZones).



Through the efforts of the OSDBU, small businesses are ensured fair access to DOT contracting opportunities, technical assistance, and capacity building activities. The office also assists businesses in competing in federally-assisted highway, transit, airport, and highway safety projects nationwide.

About the achievement, OSDBU Director Bradley Mims said, "We pride ourselves in helping a diverse base of small businesses grow and develop their core competencies, including supporting women, service-disabled veterans, HUBZone firms and disadvantaged business owners. This accolade is an honor and well-deserved through

disabled veteran-owned businesses and those in Historically Underutilized Business Zones or "HUBZones.


The department is one of 10 agencies to achieve an outstanding grade of A+ on the FY2022 scorecard. Of the 24 federal agencies rated, the department is the only agency that achieved all of its small business goals at the prime and subcontracting level.

Supervisors Award Nearly \$1 Million to Help Local Businesses Through Construction Project

The County will soon start taking applications for a grant fund for small businesses along Middlefield Road in North Fair Oaks that are struggling financially due to a road improvement project delayed by record winter rains and other challenges.

San Mateo County Supervisors on Tuesday voted to direct nearly \$1 million to the Middlefield Road Small Business Assistance Program.

Eligible businesses may apply for grants totaling up to \$10,000 to help make payroll, pay rent and keep the doors open during a project that promises significant benefits but has taken longer than expected.

"The pandemic, the change in the workforce, and the ongoing construction has created the perfect storm. Our businesses need help now," said Supervisor Warren Slocum, who proposed the relief grants in his district.

"When the project is complete, families will enjoy wider sidewalks, new streetlights, free public WiFi, small businesses to frequent, and so much more," Slocum said. "Many of these businesses just need a short-term financial boost so they can stay afloat long enough to see the benefits."

At Cuco's Burritos, "This grant would be very helpful to keep us afloat through the construction," said Mariela Peralta, who estimated businesses is down up to 60 percent due to access issues. "Every week we are struggling."

With business down at Shawarma Palace, coowner George Saman closed the restaurant to walk-in traffic temporarily to focus on catering until the street and parking situation improve. Saman said he hopes the funds would help his business stay open long enough "to enjoy the fruits when the street is complete.... It's going to be beautiful." The project involves a transforming a busy stretch of Middlefield Road through North Fair Oaks into a destination with a downtown feel. In addition to road work, the project includes placing utilities underground and installing modern infrastructure that includes technology upgrades and more.

The complex project involves partnerships with a large number of private and public entities. Record winter rains contributed to delays that are causing the longer-than-expected impacts.

To qualify for grants, small businesses must meet a number of specific criteria that includes:

- Physically located and operating on Middlefield Road between Douglas Avenue and Fifth Avenue with a customer-serving storefront in the project limits.
- Fewer than 25 employees.
- Suffered proven economic losses due to construction work.

Other criteria include being independently owned and operated or, if a franchise, half of the franchise ownership by county residents.

Outreach and application assistance will be provided by the Office of Community Affairs, which is already working with eligible business. First distributions are expected by the end of this month.

Establishments ineligible to receive a grant include cannabis businesses or businesses that support cannabis businesses, liquor stores and tobacconists, smoke or vape shops.

The Board voted 4-0 to approve the grant program. Supervisor Ray Mueller was not present for the vote.

Construction Employment Increases In 45 States From June 2022 To June 2023

Construction employment increased in 45 states in June from a year earlier, while 33 states added construction jobs from May to June, according to a new analysis of federal employment data released by the Associated General Contractors of America today. Association officials said the job gains were welcome, but that widespread construction labor shortages mean many firms would likely have hired even more workers if they could find qualified candidates.

"Unlike some other parts of the economy, construction is showing no letup in activity," said Ken Simonson, the association's chief economist. "But with an industry unemployment rate of only 3.6 percent, contractors in many states have had a tough time in recent months finding

enough workers to execute all of their projects."

Between June 2022 and June 2023, 45 states added construction jobs, while industry employment declined in five states and held steady in the District of Columbia. Texas added the most construction jobs over the year (30,500 jobs or 3.9 percent), followed by New York (10,100 jobs, 2.6 percent), Louisiana (9,700 jobs, 7.5 percent), and California (9,300 jobs, 1.0 percent). Arkansas had the largest percentage increase in construction jobs over 12 months (11.8 percent, 6,700 jobs), followed by Kentucky (8.0 percent, 6,600 jobs), Nebraska (7.8 percent, 4,400 jobs), Louisiana, and Oregon (7.5 percent, 8,600 jobs).

Missouri lost the most jobs (-1,800 jobs, -1.3 percent), followed by Colorado (-1,500 jobs, -0.8 percent), North Dakota (-500 jobs, -1.9 percent), Connecticut (-500 jobs, -0.8 percent), and

Vermont (-300 jobs, -1.9 percent). North Dakota and Vermont had the largest percentage loss, followed by Missouri, Colorado, and Connecticut.

For the month, construction employment increased in 33 states, declined in 15 states and D.C., and was flat in Delaware and Massachusetts. Texas added the most jobs over the month (11,000 jobs, 1.4 percent), followed by California (6,000 jobs, 0.7 percent), Florida (4,000 jobs, 0.7 percent), Maryland (3,900 jobs, 2.4 percent) and Indiana (3,800 jobs, 2.4 percent). The largest percentage gain occurred in South Dakota (4.3 percent, 1,100 jobs), followed by Mississippi (4.1 percent, 1,900 jobs), Alaska (2.5 percent, 400 jobs), Maryland, and Indiana.

Virginia experienced the largest decline in construction jobs in June (-3,200 jobs, -1.5 percent), followed by North Carolina (-2,900 jobs, -1.2

percent) and New York (-2,100 jobs, -0.5 percent). Iowa had the largest percentage loss for the month (-2.0 percent, -1,700 jobs), followed by D.C. (-1.9 percent, -300 jobs).

Association officials called for a mix of immigration reforms and new investments in construction-focused education and training to help address chronic labor shortages in construction. Federal officials can provide short-term relief by creating a temporary work visa program for people with construction skills. Public officials also need to address the significant federal funding gap that exists between programs to encourage students to go to college and those that expose students to career opportunities in fields like construction.

- o $\,$ 25% of apprentice hours shall be worked by Disadvantaged Workers 1, if available.

New Hire: General contractor and/or its subcontractor must hire at least 1 New Hire Apprentice 2 (NHA) for the first \$1M of construction bid value. For each additional \$5M (beyond the first \$1M), at least 1 additional New Hire Apprentice shall be hired. Each NHA must work at least 500 hours, unless waived by Social Justice Committee.

Contractors can obtain up to half credit towards the above goals by utilizing LIA apprentices "off-site" (i.e., non-MAPLA projects). Contractors using lower tiered subcontractors are responsible for ensuring their compliance with the local workforce hiring goals. The goals apply to contractors at all tiers who work on MAPLA covered projects.
