

What Is Data Federation and What Does It Mean for the Construction Industry?

As the saying goes, teamwork makes the dream work. This has never been truer than in construction where collaboration between multiple project teams throughout a project’s lifecycle is essential to moving projects forward through completion. Nonetheless, the “dream” is often not reality. In fact, 60% of general contractors see problems with coordination and communication between project team members as a key contributor to decreased labor productivity. Additionally, according to research from AGC, about 72% of construction firms say projects are taking longer than planned.

To move projects forward, organizations need to constantly share the most current information with each other. If essential project data and information lives in separate environments, project teams resort to using manual processes to relay information.

An effective way to achieve seamless data sharing and collaboration is through technology supported by a common data environment or a single platform to manage project information. This enables separate teams and companies to connect their workflows and transfer information from one phase to the next. The process that enables this is called data federation.

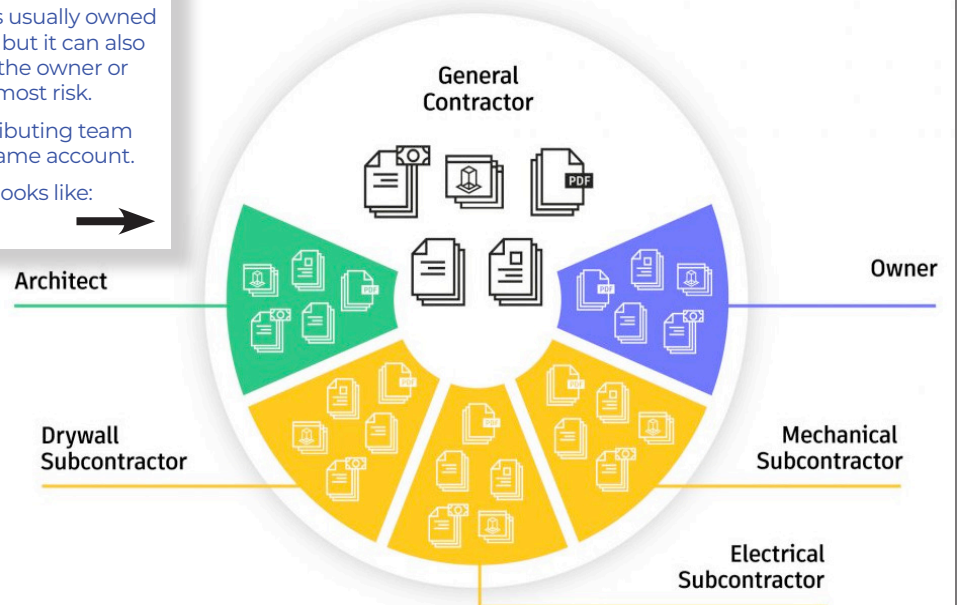
Data federation is not a new concept in construction, especially when it comes to sharing model-based information across multi-trade teams. However, with new technology capabilities available, data federation is making a significant impact on how data is shared across a project’s lifecycle. So, let’s take a closer look at data federation

These days, many firms opt to consolidate project data and workflows by using a single account hub that houses everything. This account is usually owned by the general contractor, but it can also be placed in the hands of the owner or the party who carries the most risk.

In any case, all other contributing team members plug into that same account.

California Adds Jobs for the Ninth Consecutive Month While Unemployment Rate Continues to Decline

Job growth and dropping unemployment continues in California. In June, the state added jobs for the ninth consecutive month, dropped unemployment for the twelfth consecutive month, and made large employment gains for the sixth consecutive month:

- Over the past twelve months, California has created 850,600 new jobs, one in every 7.5 jobs in the nation.
- In June, California created 19,900 new jobs, and the unemployment rate went down to 4.2 percent.
- California has now recovered 93.6 percent (2,582,900) of the 2,758,900 nonfarm jobs

Governor Newsom Signs CA Budget Directing Billions to Critical State Programs that Will Benefit Communities of Color

Yesterday, Governor Newsom signed SB 154, the California 2022-2023 Budget Bill, into law. The \$300 billion budget outlines how the state will spend the historic \$98 billion surplus. While final details of the budget are still being negotiated, The Greenlining Institute is encouraged to see a strong commitment from the Legislature and Governor to reinvest in California families who are struggling in the midst of inflation, critical resource shortages, worsening climate impacts, and lingering effects of the COVID-19 pandemic. Given these challenges and the widening racial wealth gap, we strongly urge the Governor and Legislature to prioritize communities of color in subsequent trailer bill negotiations which will determine the details on where the funds will be spent.

“Legislators must direct the funds from California’s historic budget and surplus into the communities that need it most. This year’s massive surplus is the direct result of extreme wealth concentration that continues to benefit wealthier communities, at the expense of communities of color still recovering from the worst impacts of the pandemic and climate crisis,” said The Greenlining Institute’s President and CEO Debra Gore-Mann. “Billionaires and millionaires in

California made historic capital gains last year, while low-income communities of color fell further behind, leading to an even larger racial wealth gap. It is absolutely critical to make equitable investments in communities of color now, to build resiliency to withstand future economic and health crises, and will be most beneficial in the years to come.”

Highlights of the budget include:

- **\$19.3 Billion Climate and Energy Package.** We support the \$19.3 billion investment over five years for a total of \$21 billion. We look forward to the outcome of the Climate-Energy Budget Plan negotiations, which will detail how those funds will be spent to support Water-Drought Resilience, Wildfire Resilience, Sea Level Rise, Extreme Heat, Biodiversity and Outdoor Access, Energy, Zero-Emission Vehicles, and other climate-related actions. We appreciate seeing continued investments for climate equity programs including Transformative Climate Communities and the Regional Climate Collaboratives, and we look forward to working with the administration and legislature as negotiations continue to increase funding for Community Resilience Centers to fully meet the climate resilience needs of frontline communities. These incremental investments ensure stable funding alloca-

tions to build community resilience to climate change in our most vulnerable communities, combat carbon emissions, and bring California one step closer to achieving its climate goals.

- **Rebates.** We support the agreement made between the Administration and the Legislature, providing direct rebates to nearly 23 million Californians to combat high gas prices and the skyrocketing cost of living. This \$17 billion investment will put payments up to \$1,050 in the pockets of residents to cover the rising cost of rent and utility bills. This, in addition to a suspension of the state sales tax on diesel, will provide Californians struggling the most with economic relief.
- **Utility Debt Relief.** We applaud the inclusion of \$1.2 billion in the budget for the California Arrearage Payment Program, which will provide greater relief to low income residents facing mounting utility debt.
- **\$10.8 Billion Transportation Package.** The budget includes \$10.8 billion in total funding over four years, for a comprehensive transportation infrastructure package, including funding for transit, fleet replacement, active transportation, climate adaptation, and equity programs. This represents

the first steps towards fully funding a multi-year clean transportation package in an effort to advance California’s climate goals through advanced infrastructure.

- **Health Equity and Racial Justice Fund.** We support the inclusion of \$75 million annually to fund the Health Equity and Racial Justice Fund, which will support community-based organizations, closing health disparities and addressing the public health impacts of systemic racism. While we are encouraged by this funding, we are disappointed to see that the Governor and Legislature did not allocate funding towards the formation of an Office of Racial Equity, which would have created a holistic equity-first framework within state agencies to combat systemic racism.

The Greenlining Institute looks forward to working with the Governor and Legislature in the coming weeks to ensure the final details of the budget prioritize equity and direct maximum benefits to the communities that need it most. and how it can revolutionize collaboration in construction.

What is Data Federation?

Data federation is the process of collecting data from multiple teams and then converting it into a common output that can be easily viewed and shared. It uses a virtual database that takes data from different sources, then

transforms it into a common model to provide a unified view.

To better understand data federation, let’s compare it to how most organizations are currently addressing the issue of disconnected data.

These days, many firms opt to consolidate project data and workflows by using a single account hub that houses everything. This ac-

count is usually owned by the general contractor, but it can also be placed in the hands of the owner or the party who carries the most risk.

This model (see page 1) works, and it’s certainly better than manually sharing information; however, it also has some downsides, including:

It raises privacy and security concerns. Because teams are all plugging into one ac-

count, there’s a risk that the wrong people can access sensitive information. Addressing this requires robust and flexible user permission settings, which can be challenging to enforce.

lost during March and April of 2020 due to the COVID-19 pandemic.

- Employed Californians rose by 75,000 persons, the state's sixth consecutive large employment gain.
- California's year-over seasonally-adjusted job increase for June increased by 850,600 (a 5.1 percent increase) compared to the U.S. annual gain of 6,282,000 jobs (a 4.3 percent increase).

Brenda Buenviaje, Brenda's French Soul Food

Brenda Buenviaje had worked as a chef for years but lacked business experience. When she wanted to open her own restaurant in 2007, not just

banks turned her down but "friends, co-workers, my own parents were like, 'No thank you,'" she said. Opportunity Fund said yes, taking out a lien against her condo to secure the \$100,000 loan.

"It felt miraculous because the failure rates for restaurants are so notoriously high," Buenviaje said. She used the money, along with a small business loan, to buy and renovate a restaurant on Polk Street that became Brenda's French Soul Food.

Three years later, she'd repaid the loan when the space next door became vacant. She borrowed from Opportunity Fund again to expand, and then again in 2014 to open a third location on Divisadero Street.

She and her wife run three San Francisco restaurants (Brenda's French Soul Food, Brenda's Meat & Three, and Libby Jane Cafe), which employ about 100 people (up from four when she started), and are eyeing a fourth spot in Oakland's Temescal district.

"It's been an all-around lovely experience," she said, adding that Opportunity Fund's "mission is to help small businesses grow communities, and that's exactly what they did."

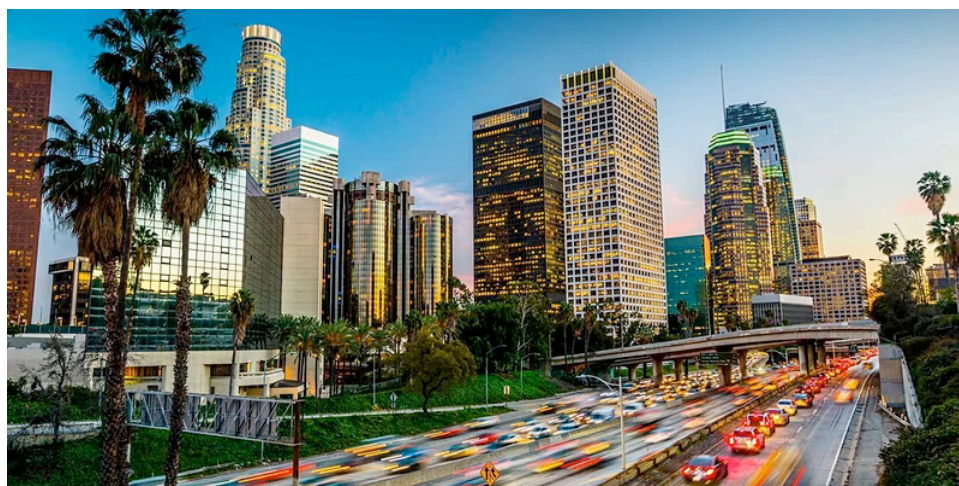

6 Concrete Takeoff Tips for Estimators & Contractors

When you're estimating your next concrete job, regardless of whether you're putting together a quick quote or submitting a formal bid, you need to nail your takeoff. If your material takeoff measurements and calculations aren't accurate, you'll overestimate or underestimate the project.

If your material quantities aren't complete and accurate, it will impact your material cost estimates and directly impact your labor cost estimates.

What is a Concrete Takeoff?

A takeoff is simply a complete list of all materials needed, and the quantities of each, based on the plans and specifications. A concrete takeoff would include all the types of concrete required, including their compressive strength, measured in pounds per square inch, and the amount needed, typically calculated in cubic yards.

In addition to the concrete takeoff, you'll need to do takeoff on other items required to complete the job like formwork, rebar, reinforced welded wire mesh, prestressed cables, anchor bolts, and vapor barriers.

Review Plans & Specs

Thoroughly review the plans and specifications to ensure accurate measurements and takeoffs, so you aren't working with incorrect construction costs when calculating your bid. Getting precise measurements and quantities is essential in accurately bidding on a project. Digital takeoff software can ensure correct measurements are obtained to submit a complete bid.

Make sure that you are taking measurements from the right place. There will be times when the project documents instruct you not to scale the drawings or use the written or calculated dimensions provided in the specifications. This often occurs when electronic documents are used because enlarging or shrinking the size of the drawing to print them can result in the scale being incorrect, adversely affecting your bid. If you have any doubt about where to take your measurements from, ask the architect for clarification.

As you review the plans and specs, look for any inconsistencies between the plan drawings and specifications, omissions of information, and anything else that looks off. For example, maybe the project documents don't specify a vapor barrier for the slab on grade of a building, or perhaps the foundation walls are calling for the concrete to be 2,000 psi when you know it should probably be double that. Again, if something looks wrong, contact the architect or engineer to get the correct information.

Understand the Scope

If you're a general contractor responsible for the entire project, the scope of work is laid out in the project documents, and you will likely do takeoffs for each trade to ensure that the estimates and bids submitted by your subcontractors are accurate.

If you're a concrete contractor, you'll need to review the plans and specs to determine the scope of the concrete work required on the project.



Pouring concrete for your worksite takes a significant amount of care and attention to detail. You need to make sure you have your shapes and joints planned out and your workers are prepared to make sure the concrete sets exactly how you want it to. During certain seasonal extremes, you will need to take extra measures to ensure your final product turns out the way you want.

When bidding to a general contractor, review the bid invite to ensure you bid just the work they are asking for, which might be more or less than what you expect.

For example, if you're accustomed to performing the site prep when doing concrete work, you want to make sure the general contractor isn't subbing that work out to someone else. On the flip side, perhaps the general contractor wants you to be responsible for the site prep, but you don't have the capacity to do it and may need to subcontract that work out yourself.

Check the Scale

Before you start doing your concrete takeoff measurements, be sure to make note of the scale on each plan sheet and whether different scales are being used for various details on the same sheet. When it comes time to do your measurements and calculate your measurements and materials correctly, you'll need this info.

If you are performing your concrete takeoff manually, you'll need to keep track of the scale for each section on your own. If you're using digital takeoff software, you can set the scale to ensure your measurements are accurate as it automatically calculates them.

Take Your Measurements

Now that you've reviewed the plans and specs, verified the scope, and noted or set your scale. It's time to start taking measurements. For manual takeoffs, that means printing off the plan sheets you'll need, breaking out the scale ruler, colored pencils, and highlighters. Don't forget to

count any items you'll need in addition to measuring the area and linear feet of where the concrete is going.

With a digital takeoff solution, it's a matter of pointing, clicking, and dragging your mouse to get measurements for the area by getting the length and width or linear feet depending on what materials you are taking off. Using takeoff software for your concrete jobs can save a ton of time in getting your measurements and doing calculations since you can set the height, or thickness, of a slab to get the volume of concrete needed.

Calculate Materials

Once you have all your measurements and counts, you can start calculating how much materials you'll need and then determine your costs. To figure out the volume of concrete you'll need, multiply the length by the width of the area you measured and then multiply that by the height, or thickness (L x W x H). If your measurements are in feet, this gives you the volume in cubic feet, so you would need to divide that number by 27 to get that number in cubic yards.

Again, if you are using a digital takeoff solution, it will calculate all of this for you, and you can also add in your unit prices to get your total material costs based on your takeoffs. When calculating material costs, whether manually or digitally, be sure and check with your supplier to get current pricing. Price volatility has been a concern of late, so it's essential to not just assume that prices are the same as they were on the job you just finished.

Double-Check Your Work

After completing your takeoff, go back and double-check your measurements and calculations. It never hurts to have an extra set of eyes to review or spot check to ensure everything was measured correctly and all your calculations for material quantities and prices have been done correctly.

Taking the extra time to do this may seem like a hassle at first, but once you've made it part of your process, it will easily improve the quality of your bid submission.

Final Thoughts on Concrete Takeoffs

Your concrete takeoffs lay the groundwork for your estimates and bids. If they're incomplete or incorrect, it can screw up your numbers. Accurate takeoffs help you determine the exact quantities needed for all your concrete materials and supplies. They're also required to determine your labor and equipment needs for your concrete job. If you miss items during takeoff or don't get accurate measurements, you'll either overestimate the project and not win the bid or you'll underestimate and risk winning a project that won't be profitable.

Takeoff software like PlanSwift by Construct-Connect is a great option to ensure that you get accurate measurements for your estimates. It's also a huge time saver over doing takeoffs manually. These tools are only as good as the user, so it's important that estimators get the proper training and are comfortable using the software.
