Rework Busters: How to Save Time, Money, and Frustrations

"Not good enough; do it again!"

... is no one's favorite sentence to hear on the job. As humans, we like to move forward, not backward, and nothing frustrates us like having to retrace our steps and complete a task we thought we'd already checked off the list.

Nonetheless, when the work at hand is a multimillion project or even a multi-billion dollar megaproject, the fallout of construction rework can be more than simply frustrating—it can be downright devastating to the schedule and budget of a project. Nowhere is this truer than in construction, where rework plagues owners, managers, and trade contractors. It also is a productivity killer, stealing hours, days, and even months from projects. In some cases, it causes such severe missed deadlines and budget overruns that builders fail to meet contracts and face legal consequences, or at the very least, loss of good name and potential future business.

If that sounds like a professional nightmare to you, as it does to most people in construction, you'll be glad to hear that there is an answer. In fact, a lot of rework can be avoided if only you understand the most common causes and how to prevent them.

Common Causes of Construction Rework: Identifying the Problem

First and foremost, it pays to understand why rework crops up in the first place. By that, we mean it literally pays to know the root of rework. Who is responsible? What processes aren't up to standard? Why is information lost in translation, and how does decision-making play in?

Here are a few of the most common reasons for rework in construction:

- Missing documents and details: Not having the information or the correct information you need when construction teams need it most
- Poor or ineffective procurement methods: Failing to get supplies in time or getting the wrong materials and supplies altogether
- **Poor quality:** Workers lack the proper training and skills to complete the work to a high standard
- Poor quality materials: Building supplies that don't meet technical or structural requirements

- **Poor supervision:** Lack of proper oversight of subordinates
- **Failure of structural design:** A poor or incomplete design in the first place that does not meet engineering standards
- **Poor communication:** The inability or barriers for teams to speak to one another in the field, especially when project information is all stored in a central space
- No collaboration: A work environment that fails to encourage proper teamwork and might even create adversarial relationships between different stakeholders
- Misunderstanding of client requirements: Not understanding what the client is looking for or failing to correct the problem
- Ineffective management or decision-making: Higher-ups who don't have the correct information to make the best decisions
- No standard systems or processes: A failure to implement quality control and ensure the process and results measure up
- **Schedule pressures:** Rushing to meet a deadline and failing to adhere to designs, quality, or safety standards

However, the most significant factor to rework in construction is design changes, errors, and omissions. According to quality.org, "Up to 70% of total rework experienced in construction and engineering products are a result of design-induced rework."

According to a meta-study conducted by the Islamic University of Gaza in collaboration with the Berlin School of Technology, "almost 80% of costs of deviations were related to design and 17% were construction related."



Black women in California are overburdened and underserved, new poll finds

A new poll finds 2 out of every 5 Black women in California are just one paycheck away from financial instability.

The first-of-its-kind survey of 1,258 Black women across the state revealed 37% work two or more jobs — and 62% of them said the second job is "essential" and they would "not be able to make ends meet" without it.

The Evitarus research firm polled the women last spring for the California Black Women's Collective Empowerment Institute, a research nonprofit in Carson, near Long Beach.

The findings could be important for political strategists. Of the Black women surveyed, more than 80% voted in the November 2020 elections.

In general, the results quantify how Black women's views on politics, economics, family issues and everyday life may vary from other demographic groups.

For instance, nearly a third of the Black women surveyed said they had experienced emotional or psychological abuse in the prior 12 months. And half said they feel unsafe when interacting with law enforcement.

Survey respondents also listed their top concerns as discrimination, financial instability and health disparities.

"We show up for everyone," said Kelly Tom Griffin, president of the California Black Women's Collective Empowerment, during an online presentation of the study earlier this week.


"Black women in California are engaged and connected, and yet ... they are struggling socially and economically while serving as the primary breadwinners of their households."

No trickle down

More than 75% of Black households are headed by single Black mothers, and in 80% of Black households women are the breadwinners, according to a separate 2022 report by the collective.

About 1.1 million Black women live in California, according to a Census Bureau estimate.

Most California Black women voters view Newsom favorably

Women and girls represent 51% of the state's Black population.

Some of the survey's eye-opening findings reveal burdens Black women face:

- 2 in 5 Black women find it challenging to pay for basic expenses
- 4 in 5 Black women report difficulty dealing with inflation
- 8 in 10 Black women report a top concern is being discriminated against or mistreated because of their race or gender
- 4 in 10 Black women said racism and discrimination have limited their income and earning capacity

These results indicate that the Legislature's policies aimed at protecting women aren't necessarily helping Black women, said Assemblymember Lori Wilson, a Democrat from Suisun City who serves as chair of the California Legislative Black Caucus.

"It's not really trickling down to Black women," she said after the presentation, "and what (this data) shows is we have a whole segment of our population that is missing out."

Wilson said she plans to discuss the survey results with her colleagues in the Legislature as they debate budget priorities.

"What matters is how we as a community use the insights of Black women to inform our own thinking," added Thomas Parham, president of California State University, Dominguez Hills. "Despite facing significant economic and social burdens, Black women continue to lead our families, our communities, and in the Democratic process."

The poll is the first public project of the California Black Women's Think Tank. Created by the California Black Women's Collective Empowerment Institute, it is housed at Cal State, Dominguez Hills. Gov. Gavin Newsom signed legislation last year funding the think tank with \$5 million.

Griffin said the California Black Women's Collective Empowerment Institute will make policy recommendations based on the findings, with an eye toward equal pay for equal work, making housing affordable and protecting Black women and girls from violence.

Newsom over Harris

Researchers also polled the women on their opinions of certain state and federal elected officials, finding 73% had a favorable opinion of Newsom — higher than the 69% favorable opinion of the Democratic Party and the 66% who viewed Vice President Kamala Harris favorably.

Presentation participants did not comment on the political results. Newsom's office declined comment, and his campaign spokesperson did not respond to CalMatters' request for comment.

The survey's margin of error was plus or minus 7.5 percentage points, said Shakari Byerly, Evitarus' managing partner.

John Nienstedt, who runs Competitive Edge Research & Communications, a pollster commonly used by San Diego-area Republican candidates, said he appreciates the effort and intent of the study.

"It's important to inform policy — in this case on the challenges faced by Black women — by gathering solid data in order to make evidence-based policy decisions," Nienstedt said.

He said his firm's research of San Diego County residents generally supports the statewide findings.

"For example, our barometer shows the Black community is more impacted by the rising cost of living than other communities of color and whites," he added.

Nienstedt said one drawback of Evitarus' findings was a lack of reference points to other groups.

"In other words, the challenges being faced by Black women voters may be very different, or no different, than those being faced by other groups," he said, "but the research can't tell

assistance and funding to secure new commercial leases. Small businesses that are eligible can apply to receive up to \$25,000 for a first storefront location or up to \$50,000 to expand to an additional location. Small businesses in neighborhoods that have experienced slower economic recovery or serve low to moderate income neighborhoods can receive training and assistance on how to secure leases with favorable terms

Business Training Grant Program

This program supports an equitable economic recovery by instituting programs and services to advance racial and economic justice. New and existing entrepreneurs who complete 14 hours of training and counseling under a pre-qualified program may be eligible to apply. Providing the training prior to the funding incentivizes businesses to devise ways to remain successful and profitable. The training topics include financial management, marketing, licensing and permitting, human resources, as well as business development. Small businesses that are eligible and apply could receive \$5,000 to \$50,000 in grants. The City is collaborating with funded nonprofit partners who provide culturally accessible pro-

Since the launch of the Business Training Grant in June 2022, \$4.7 million have been distributed among approximately 409 small businesses so far citywide. Approximately 90% of the awards went to women and minority-owned businesses.

"Cultivating a robust small business ecosystem and vibrant commercial corridors is crucial for our community's well-being and economic prosperity. With these new grants and the city's larger portfolio of services, we prioritize strengthening businesses, filling storefronts, and promoting an equitable economic recovery," said Sarah Dennis Phillips, Executive Director of the Office of Economic and Workforce Development. "Together, we are building a resilient foundation that empowers entrepreneurs to contribute to thriving neighborhood corridors, enriching the lives of residents and creating a vibrant and prosperous future for all.'

us that. Without that information, it's difficult to justify targeting policy proposals to Black women."

'I am tired'

Evitarus researchers also included personal comments by survey participants which, they said, further highlight the need to study this population of voters.

"I am at my limit," said a 21-year-old Los Angeles resident. "Every turn is a blockade because I am a Black Woman ... I am a high-performing individual and cannot get ahead. Banks don't loan to us. Corporations tokenize us, and often only consider us when it comes to DEI marketing ... I don't have access to quality healthcare, includ(ing) mental health. I am tired."

DEI refers to diversity, equity and inclusion, often a catch-all term to describe policies and programs that promote representation and participation of people from various minority groups. In the survey, a 64-year-old Black woman in Los Angeles listed her concerns: "unsafe public transportation, being able to find an affordable car ... finding a Black female physician ... (I) need to see a doctor for health and I'm worried about illness."

She added that physicians "are dismissive of Black women over 50."

A 38-year-old woman from the Inland Empire said her family still struggles with the pandemic's aftereffects.

"There was little to no help with the long-term effects from Covid," she said. "I lost my business and while there was a lot of support for larger businesses, there was little for small businesses, which feed our families. We have been struggling since as the bills continue to climb."

Byerly said her research shows women in rural California were more harmed by inflation and rising housing costs than women elsewhere.



"One of the things that's most striking about these findings is the heavy burden, particularly on women in rural areas, notably in the Central Valley and Sacramento and far northern region, as well as younger women," she said. 8 Ways to Reduce Construction Rework

Communication and data also play a significant role here. According to a report from Autodesk and FMI, miscommunication and poor project data account for 48% of all rework on US construction jobsites. On average, professionals spend four hours a week dealing with rework-related activities, such as managing the mistakes on a project that result in rework, assessing the associated costs, and determining why the mistakes happened.

Furthermore, this lack of information and bad data results in poor decision-making. In another study from Autodesk and FMI, decisions made using "bad data" are estimated to have cost the global industry \$88.69 billion in rework alone, accounting for 14% of all rework performed in 2020.

The takeaway? Designers and contractors sow the seeds of rework in the very earliest stages of a project. When data is incorrect, or there are miscommunications, this further increases the likelihood of rework on a project. Understanding what causes rework, however, isn't enough to ensure you avoid it in the future. You must also have the right approach to effectively mitigate the potential of rework.

How Much Does Construction Rework Add Up? (Spoiler Alert: A Lot)

First, for the motivation part: understanding what happens if you choose not to address rework is a critical place to begin. Whereas the consequences of spotty dishes are minuscule—a lost half hour at most—the consequences of construction rework can significantly undercut your bottom line or even bankrupt you if the owner or other major project stakeholder is unhappy enough to litigate.

Even if the worst doesn't happen, though, rework still results in:

Lost Money

According to some estimates, between 4-6% of the total project cost is rework-related, and that's only counting direct costs or reported rework. This estimate fails to capture all the little side projects and do-overs that suck up extra worker hours, materials, and other financial resources. When considering both direct and indirect factors combined, the cost is closer to 9%.

Lost Time

Staying on deadline is just as important as staying on budget. Productivity is one of the biggest challenges to meeting final project deadlines and intermediate markers. Smooth workflow results in a much better chance of meeting projected deadlines, yet this is more of a distant dream than a reality for most companies.

Unfortunately, rework is one of the biggest productivity sucks. It can sometimes negatively impact productivity by up to 300%. The result is that a full 30% of all work performed by construction companies ends up being reworked. Ouch.

Massive Frustration

Losing time and money, much like hearing "do it again," is a source of serious malcontent for everyone on a project. Construction rework takes a toll on morale, with workers and contractors having to tear down work they thought they had already checked off and start over.

In turn, worker frustration can negatively impact productivity and motivation. That kickstarts a new cycle of lost time and money, and so it goes.

8 Ways to Reduce Rework in Construction

As we know from exploring the causes of construction rework above, most of it results from missteps in the early stages of a project or from systemic problems that plague a project throughout its lifetime. Below, we've identified eight intelligent ways to reduce rework.

1: Adopt Connected Digital Solutions

As mentioned, bad data and missing information add to significant construction rework annually. Paper and outdated systems like Excel spreadsheets and lengthy email chains often contribute to the problem. They do not reflect changes in

real-time, and workers are forced to trek long distances into an office to find the information they need-by which time it's often too late to make good use of it.

Instead, digital solutions, particularly cloudpowered construction platforms, help automate tedious and typically error-ridden administrative processes like submittals. Big bonus, they help create a single source of truth for all project data, communications, and documents, ensuring everyone has the correct info at the right time.

2: Focus on Collaboration in Design

Consider this: a typical \$100 million project takes an average of 30 months in design and preconstruction. A lot can happen during this time, particularly from a design standpoint. If design creep isn't managed and addressed early on, it can lead to significant rework during actual construction.

Integrated design is critical to addressing changes early because it connects the design phase with downstream tasks like scoping, estimating, and buyout. It ensures data flows smoothly into these various processes and through to construction. This, in turn, leads to improved accuracy in project estimates, proactive risk management, and more effective resource allocation.

Integrated design also keeps field teams in the loop, improving collaboration on-site. When field stakeholders have the latest design specs, it reduces surprises and rework.

3: Invest in Preconstruction

Consider investing in preconstruction planning your defensive strategy. You're more likely to mitigate the risk of rework and other cost-related challenges in preconstruction than in later project stages.

For example, consider estimation. When project estimates are more accurate, finances and resources can be better managed during a project.

The right technology is an essential part of your preconstruction investment. Like integrated design solutions, good preconstruction technology

streamlines connected activities and workflows like estimations, design, and document management. Connected workflows also allow real-time adjustments, resulting in quicker and better builds and reduced costs.

4: Qualify Trade Partners

The construction labor shortage is a threat to the industry—and even if you already have a strong network of subcontractor relationships, it's critical to stay prepared. Working with overstretched or underqualified specialty contractors opens projects up to risk projects cannot afford to take on, including poor quality, mistakes, rework, schedule overruns, and more.

That's why it's essential to have a subcontractor prequalification process in place—one that focuses on loss prevention and helps you proactively reduce the scale of defaults when risks become realized. The best and easiest way to do this is to deploy prequalification software to mitigate risk. It makes it easy to create, save, and track subcontractor risk mitigation plans on your projects.

5: Bring BIM into the Field

Failure to visualize and coordinate designs derails many projects, even before they are built. If you want to reduce construction rework due to design errors, employing the visual power of building information modeling (BIM) is critical. It allows everyone to see the plans, deploy clash detection, and update and collaborate on designs in real-time.

Today, most large projects use BIM as a vital tool in the design and preconstruction phases. But these powerful visuals are often not accessible or at least easily viewable during construction when work is installed. Nonetheless, putting effective BIM tools in your field teams' hands creates more visibility and reduces the chances of errors and rework. Poor collaboration, rework, and safety issues can be addressed with the right BIM tools.

Groundbreaking financing program paves the way toward expanding access to zero-emission appliances in California

California utility commissioners are paving a path towards a new financing program that will help millions of Californians adopt energy efficient zero-emission appliances, cut pollution, and accelerate the state's transition to clean energy. The California Public Utilities Commission (CPUC) directed major energy providers to create a joint proposal for inclusive utility investment (IUI) financing for residential customers at its August 10 hearing in a 4-0 vote. If the proposal is adopted, this program would support low- and moderate-income households who are not able to afford clean energy upgrades or qualify for traditional loans.

In 2020, the Building Decarbonization Coalition (BDC) commissioned Towards an Accessible Financing Solution, a landmark report that artic-

ulated the policy roadmap and implementation considerations for tariffed on-bill programs in California. The report demonstrated how IUI financing can provide affordable financing opportunities for low- and moderate-income households who do not have access to capital to create safe and healthy homes. Since then, BDC has educated policymakers and worked with energy providers and subject-matter experts to develop the IUI proposals.

"We applaud the California Public Utilities Commission for encouraging the expansion of inclusive utility investment financing. This equitable financing strategy will unlock access to capital for low- and moderate-income Californians who have traditionally been unable to afford clean energy upgrades and appliances. And it will enable large-scale decarbonization, which is critical for California to reach its 100% clean energy target by 2045," stated Beckie Menten, Senior Regulatory & Policy Specialist, Building Decarbonization Coalition.

Also known as tariffed on-bill financing, IUI is a groundbreaking financing model that leverages utilities' ability to place charges on a bill as a means of financing clean energy investments at a customer's property. Because IUI financing is attached to the property itself via the utility meter rather than to the building occupant, the program does not require credit score screenings. This expands access to capital for those who may have low FICO scores. For renters, IUI financing can cover the cost of installation and provide the benefits of clean, efficient appliances. IUI pro-

grams are designed to keep monthly repayments lower than estimated bill savings, helping to ensure that customers benefit financially from the efficiency of the new technology.

As the state advances towards its clean energy goals, it will need IUI programs that remove cost barriers for Californians to upgrade their homes with clean, electric appliances. Accelerating building decarbonization in the state will help reduce emissions, deliver cleaner air, lower energy bills, and create climate resiliency in the face of extreme heat.

The CPUC has requested a joint proposal by investor owned utilities to be submitted within 270 days of the approval of the decision.

Ballot proposal and court ruling open new front in California's never-ending tax wars

For 45 years – ever since California voters passed the iconic Proposition 13 property tax limit in 1978 – powerful interest groups have fought a running political and legal battle over restrictions on new taxes.

Those who want to raise taxes – public employee unions, particularly – have dueled with anti-tax groups such as the Howard Jarvis Taxpayers Association over restrictions imposed by Prop. 13 and subsequent measures.

Prop. 13's curbs on property taxes have survived several attempts to repeal or modify their provisions, but the battle continues over other aspects of the issue.

Next year's ballot will likely include another skirmish in the perennial tax war, a measure sponsored by the California Business Roundtable and anti-tax groups that, if passed, would require any new state or local tax to be approved by voters.

It would counteract the state Supreme Court's 2020 refusal to overturn an appellate court ruling declaring that citizens' initiative tax proposals do not have to meet the two-thirds vote requirement that local government ballot measures face.

The two-thirds vote requirement for special taxes had been installed in the state constitution by Proposition 218, a 1996 measure backed by roughly the same interests that are sponsoring next year's initiative.

For years, it was assumed that the two-thirds vote applied to all special tax measures, but in 2017, a decision by the state Supreme Court, dubbed "Upland" because it dealt with taxing marijuana in that Southern California city, obliquely cast doubt on that assumption.

Writing the 5-2 majority opinion, Supreme Court Justice Mariano-Florentino Cuéllar declared, "Multiple provisions of the state constitution explicitly constrain the power of local governments to raise taxes. But we will not lightly apply such restrictions on local governments to voter initiatives."

He thus implied that special purpose taxes placed before voters through a citizens' initiative may not be subject to the two-thirds vote requirement for taxes sought by governments themselves.

Cuéllar's seemingly offhand remark touched off a flurry of cases, culminating in the Supreme Court's refusal in 2020 to overturn an appellate court's flat declaration that local taxes placed before voters via initiative need only simple majority approval.

The 2024 measure would not only reinstate the two-thirds vote for local special taxes, regardless of origin, but also require voter approval of state tax increases and make it more difficult to impose fees.

However, just as the pro and con campaigns begin to form, a decision issued by a state appellate court in Southern California last week provides a new point of conflict.

Unsurprisingly, the appellate court upheld the validity of a 2020 increase in San Diego's hotel taxes, placed on the ballot via initiative, that received 65% voter approval, just shy of two-thirds. Revenue from the tax would expand the city's convention center and also support homelessness programs and road repairs.

"We have concluded that Measure C, as a citizens' initiative, was subject to a simple majority vote," Associate Justice Richard Huffman wrote.

However, the decision sidestepped another aspect of the case – whether the involvement in the Measure C campaign by a member of the city-owned Convention Center Corp., Jaymie Bradford, made the tax an official act, not a true initiative exempt from the two-thirds vote requirement. The court sent that issue back to Superior Court for a ruling.

Ever since the state Supreme Court opened the door to easier passage of local tax increase initiatives, pro-tax forces have shifted to that process while anti-tax opponents have contended that the initiatives are often shapes

The appellate court thus opened another front for the contending forces to clash, especially if the 2024 ballot measure fails. It's a battle that never truly ends.
