

Construction Hardware: The Top Tech Changing How You Work

Starting with the simple brick and hammer, there is a long history of using tools and innovation to get more work done.

While bricks and hammers remain, technology has constantly evolved and truly transformed the construction industry. Take the iPad, for example. When it was first introduced in 2010, it started to rapidly replace the need for paper-based plans and processes. And since then, change has been constant.

Today's construction technology is more advanced than ever. From cameras to sensors, we explore some of the most cutting-edge construction hardware transforming the future of the industry.

1: Construction Cameras

Cameras have changed the way we look at and experience a build. In the past, jobsite cameras grew from the use of early "webcams," which were adapted for use in construction as early as the 1990s. They've been used across various industries, but as they have become more innova-

\$25 Million in Federal Funding Awarded to Advance High-Speed Rail in California

The California High-Speed Rail Authority (Authority) was notified that it has been awarded \$25 million in federal grant funding to advance the project beyond the 119-miles under construction and into downtown Merced. This grant was awarded through the Rebuilding American Infrastructure with Sustainability and Equity (RAISE) discretionary

grant program, and \$25 million is the maximum grant award.

"This grant is vital for the Authority to advance its initial electrified service between Downtown Merced and Bakersfield. It reflects the strong state-federal partnership now in place to see the nation's first true high speed rail service commence right here in California," said Authority CEO Brian Kelly. "Next week, our Board will consider awarding the

contract to advance the design work for this transformative project."

The funding from the U.S. Department of Transportation will provide more than half of the expected \$41 million cost for the Madera to Merced design contract. That contract will be brought before the Authority's Board of Directors during their two-day Board meeting next week for consideration.

This is the second grant the high-speed rail program has received under the Biden Administration since November 2021. Last fall, California's high-speed rail project was awarded \$24 million for crucial safety, efficiency and construction projects in and around the City of Wasco and State Route 46. Construction in the region will build safe, multi-modal connectivity projects around Wasco to prepare for future high-speed rail service.

The Authority is also pursuing \$1.3 billion in federal grant funding to double-track the 119 miles currently under construction and purchase new, clean, electric train sets capable of speeds

in excess of 200 miles per hour. The funding requested by the Authority will help accelerate construction for electrified high-speed between Merced and Bakersfield by the end of the decade.

Since the start of construction, the California high-speed rail project has created more than 8,000 construction jobs, a majority of which go directly to those living in the Central Valley. There are currently 119 miles under construction in the Central Valley with more than 30 active construction sites.

Transparency is key to pay equity for contract workers

In summary

Senate Bill 1162 — the Pay Transparency for Pay Equity Act — is a critical step to ensure that companies, policymakers and the public have the data they need to ensure contract workers are no longer a hidden part of California's workforce.

In the past year, three major workplace discrimination lawsuits that include contract workers (also known as temps, vendors, contingent workers and contractors) have been thrust into the spotlight. Riot Games settled for \$100 million in a class-action gender discrimination suit. The State of California expanded its gender harassment lawsuit against Activision Blizzard to include contract workers who experienced sexual harassment, assault and discrimination. And a jury recently ordered Tesla to pay \$137 million in damages to a Black contract worker who was subjected to intense racism and discrimination.

Despite these high-profile suits costing companies millions of dollars, the average contract worker remains unknown and unprotected from exploitation.

Contract workers play a vital role in California's top companies. It's time to close the loopholes

that shield a \$35 billion staffing industry from the same rules and regulations that every other private company has to follow. The American Staffing Association states that in 2021, staffing firms employed 1.9 million workers in California. Despite employing nearly one-tenth of the California workforce, the staffing industry often has been exempted from reporting on its workforce at both a state and federal level.

Senate Bill 1162 — the Pay Transparency for Pay Equity Act — is a key step to ensure that companies, policymakers and the public have the data they need to ensure contract workers are no longer a hidden part of California's workforce.

Californians have seen how this underground economy plays out in the construction trades. One study finds between 12.4% and 20.5% of construction workers are victims of payroll fraud. Their employers have cut corners by evading taxes, avoiding payments such as workers' compensation, Social Security and Medicare, and failing to adhere to basic safety standards. These ploys not only hurt the workers they're failing to support; they affect the economy and society they're operating in by making the state pick up the pieces.

While the trade and tech industries seem worlds apart, contract workers in both are being mistreated and unsupported. Christopher Colley, a

contract worker at Google and member of the Alphabet Workers Union, ensures that Google's ad algorithms work — a service that helped generate about 81% of Google's \$257 billion in revenue in 2021. Despite Google's commitment to ensure its contract workforce makes \$15 an hour, Colley makes \$10 an hour while providing skills that have helped the company achieve a valuation of \$1.483 trillion — the fourth-largest market cap in the world.

Labor advocates spoke one-on-one with contract workers at myriad tech companies (the majority of whom asked to remain anonymous for fear that the contract would not get renewed), who shared that many of them receive no benefits, no companywide holidays, no sick pay and no vacation days in their contract.

Contract workers often found out that they were making a fraction of the pay their directly employed counterparts were making, for almost identical responsibilities. Similarly, in the construction trade industry, workers who aren't protected by unions are vulnerable to economic and physical exploitation, such as repeated exposure to asbestos, which leads to cancer and other serious diseases. Contract workers are too often underpaid, undervalued, overlooked.

Though we don't yet have statewide data on contract workers, research indicates that our growing contract workforce is made up of our most

marginalized residents. TechEquity Collaborative's Contract Worker Disparity Project found that contract workers, who are disproportionately Black, indigenous, Latinx, Asian, women and nonbinary people, often are doing the same work as their directly employed peers while making less money, receiving fewer benefits and experiencing career immobility. Temp Worker Justice found that contract work perpetuates poverty rather than providing a pathway out of it.

We in the labor movement know that it's past time for contract workers to be brought into the fold, to be protected by the policies that our lawmakers have worked so hard to implement for workers in California.

This issue isn't just about contract workers' rights — it is about all workers' rights. It is about understanding and addressing the wage gaps that people — disproportionately women and people of color — experience because they've been locked into a line of work that doesn't value their labor.

We need the Pay Transparency for Pay Equity Act so we can finally shine a light on this overlooked and underprotected class of workers.

California's Unemployment Rate Falls to Record Low Level

California's unemployment rate fell to historically low levels in July, while adding the state's largest job gain since February and second largest since August 2021.

"Californians are getting back to work with record low unemployment," said Governor Gavin Newsom. "We have historic reserves and we're putting money back in peoples' pockets as we continue to lead the nation's economic recovery."

The number of employed Californians rose for the seventh consecutive month, the state added 84,800 nonfarm jobs, and the private sector achieved full recovery from the pandemic-induced recession:

- In July, California's unemployment rate dropped 0.3% to 3.9%, establishing a new record low going back to the official data series that started in 1976.
- The unemployment rate also dropped below the pre-pandemic level of 4.1% in February 2020 and the number of unemployed Californians fell to a 33-year low in July,

falling by 46,000 persons to 759,000 persons — this number has fallen for the 13th consecutive month.

- California added 84,800 nonfarm jobs in July — the state's largest job gain since February and second largest since August 2021, bringing the total nonfarm employment in the state to 17,618,100 jobs.
- The state accounted for 16.1% of the nation's new jobs in July.
- California has recovered all of the private-sector jobs lost during the pandemic-induced recession.

- Number of employed Californians rose by 23,000 persons, the state's seventh consecutive month of employment gain.
- Year-to-date, California has created 477,600 — 14.5% — of the nation's 3,296,000 new jobs.

Low-income communities and communities of color will undoubtedly benefit from the Inflation Reduction Act. This legislation paves the way for critically needed federal investments to combat inflation and worsening climate disasters.

The bill promises to invest more funding into clean energy than we've ever seen, moving us closer to our goal of reducing carbon emissions by 40% by 2030, and will introduce tax incentives aimed at broadening access to clean energy technologies and reducing energy costs for millions of families. These are critical steps in the right direction.

However, this bill is far from perfect. Our extractive economy is built on expensive and dangerous fossil-fuel consumption, hurting low-income communities of color first and worst. The political horse-trading and giveaways to oil companies in the bill will fall squarely on the backs of our communities. And what we're left with—a watered down version of what this bill should have been—dismisses the realities many Americans face.

The Inflation Reduction Act is just one piece of the political puzzle, not a standalone solution. It is the floor, not the ceiling, of what is needed to truly improve the lives of all Americans. States must also demonstrate their commitment to addressing climate change by providing climate investments that directly and meaningfully benefit low-income communities of color.

The Greenlining Institute Urges Regulators to Include Racial Equity in the Nation's Landmark Community Reinvestment Act

The comment period on a historic update to the regulations implementing the Community Reinvestment Act closed. The Greenlining Institute urges regulators to seize this opportunity to ensure banks play their role in addressing the harm inflicted on communities that were redlined. Redlining was the practice of systematically denying financial services to low-income communities and communities of color that banks perpetuated prior to the CRA's enactment in 1977, which outlawed the practice.

In May 2022, federal regulators including the Office of the Comptroller of the Currency, the Federal Deposit Insurance Corporation and Federal Reserve Board proposed amended regulations to the CRA's implementation and announced a public comment period that closed today. Despite regulators' stated commitment to leveraging the CRA to advance racial equity, the Notice of Proposed Rulemaking failed to include race as a consideration in the updated regulations.

"We have seen major changes in banking since 1977—nationwide banks, bank consolidation into megabanks, and internet banking or fintechs. The CRA must keep pace with the evolution of the banking sector," said Debra Gore-Mann, Greenlining's CEO & President. "A strong CRA is still vital to America's low-income communities of color. And, we must continue to hold financial institutions and the entire regulatory system accountable to the harm they've done."

Greenlining submitted a comment letter outlining its analysis of, and key improvements to the regulators' Notice of Proposed Rulemaking. Highlights of the letter include:

- **Racial Equity:** Greenlining recommends assessing bank performance through percentage of home lending to Black, Indigenous, and people of color borrowers, using race to determine additional assessment areas, analyzing lending by race and ethnicity in underserved neighborhoods in all CRA exams (including community development financing and retail lending), and considering a bank's creation and deployment of Special Purpose Credit Programs. These recommendations should both increase transparency of the context in which banks are doing business, and reward or penalize banks for failing to meet the needs of BI-POC communities.
- **Climate resilience:** Climate change is a risk multiplier that exacerbates racial and economic inequality, and it is progressing at an alarming rate. The agencies must update CRA regulations with this reality in mind so that the banking system meets the changing credit needs of all communities. The proposed rule includes a new definition of "disaster preparedness and climate resilience" and lists eligible investments that would provide meaningful support to communities. Greenlining supports this change, and provides additional climate resilience

strategies for consideration. Greenlining also recommends strategies for scrutinizing investments in fossil fuels.

- **Assessment Areas:** Currently, a bank's CRA obligations are only within assessment areas where a bank's main office, branches and/or ATMs are located. However, increasingly, banks make a significant number of loans outside of those areas. The NPR proposes to create assessment areas where a large bank does not have branches, but has made a significant number of loans. Greenlining supports this change and also proposes that the regulators require additional assessment areas, especially rural areas, Native American reservations, and counties with high percentages of people of color.

"How can we expect our nation's anti-redlining law to work without addressing this country's history of systemic racism?" she continued. "Regulators must strengthen and modernize investments in communities that were historically exploited and continue to experience severe climate and economic inequities. Our future depends on it." said Gore-Mann.
