

High-Speed Rail Authority Celebrates Progress, 10-Year Partnership with Construction Trades

The California High-Speed Rail Authority (Authority) recognizes 10 years of collaborative partnership with the men and women of the skilled craft unions diligently working to bring the first electrified high-speed rail system to the United States.

This partnership is possible thanks in part to the establishment of the Authority's Community Benefits Agreement, signed and executed in 2013, that promotes employment and business opportunities during construction while advancing training opportunities to targeted and disadvantaged workers.

"Since the Community Benefits Agreement, this project has created more than 11,000 well-paying construction jobs in the Central Valley, with more than 70% of the workers residing in the Central Valley," said Authority CEO Brian Kelly. "Moreover, we worked closely with the Fresno Economic Development Corporation and the trades to expand workforce training to the men and women of the Central Valley looking to work in the construction industry."

High-speed rail construction and labor jobs by the numbers:

- 11,474 jobs created (as of July 31, 2023).
- 1,359 average daily site workers

- 3,808 jobs going to residents from Fresno County.
- 2,141 from Kern County.

"We would like to thank the Authority and the Authority's CEO Brian Kelly for providing tremendous opportunity for the members of our building trades unions to work on such a monumental project transforming transportation infrastructure and communities in California," said Chris Hannan, president of the State Building and Construction Trades Council of California. "We look forward to continuing our work with the Authority and our affiliates to build out our nation's first high-speed rail system in California. Happy Labor Day to all!"

The Authority's Community Benefits Agreement has helped create thousands of good-paying union jobs to date, with more than 1,300 skilled workers dispatched to a high-speed rail construction site each day. Nearly 75% of the jobs created on the project go directly to individuals from disadvantaged communities. The agreement applies to current and future construction segments of the 500mile Los Angeles to San Francisco project.

"Transportation creates good-paying jobs. Construction creates good-paying jobs. And high-speed rail has been able to keep these jobs local and put residents in our home region of the Central Valley to work," said Chuck Riojas, of the Fresno, Madera, Kings and Tulare Counties Building and Construction Trades Council. "We are proud of our ongoing partnership with the Authority and we look forward to seeing the project continue to grow and create more jobs in the Central Valley and across the state."

Governor Gavin Newsom and the Legislature reached an agreement on the Governor's package to build more clean energy, make the grid more reliable, and help achieve our 100% clean electricity goal. Today marks a critical step in California's work to combat the climate crisis and ensure our grid is powered by clean energy 24×7 .

Here's the challenge: Electric retail sellers, like utilities, procure electricity for customers; it's how we all power our homes. But these sellers may not buy the clean energy – like offshore wind or long-duration storage – that we need to achieve a 100% clean electric grid. Red tape and

Driving Community-led Climate Projects: What Are Environmental and Climate Justice Block Grants

THE INFLATION REDUCTION ACT:

BLOCK GRANTS

The climate crisis is a crisis of environmental justice; low-income communities and communities of color that have faced decades of redlining. disinvestment, and discrimination are often on the frontlines of the worst climate impacts. Repair means giving those communities the direct tools and financial and political power to steer toward a better future.

The Environmental and Climate Justice Block Grants (ECJ) Program within the Biden administration's Inflation Reduction Act is a step forward in repairing some of these harms by building power and resilience in disadvantaged communities and investing in their transition to clean energy.

This first-of-its-kind \$3 billion federal program aims to empower disadvantaged communities to determine and design their own visions of pollution reduction and clean energy investment. It does so by providing highly flexible funding that goes directly to nonprofit organizations serving disadvantaged communities-meaning projects are designed by and for communities to address their unique needs and build resilience and political capacity.

The vast majority of the ECJ funding will go to implementation grants, or as the Environmental Protection Agency (EPA) refers to them "Change Grants". So, how can communities take advantage of this funding? Applications for Change Grants will be available later this summer or fall, so communities interested in taking advantage of this funding opportunity should start preparing now.

While many IRA programs allow nonprofit organizations to apply or partner to receive funds, ECJ focuses on community-level project design and implementation. This means that rather than a utility, business, state, or local government making the decisions on which projects matter most, disadvantaged community members get to be the decision-makers

Since many traditional decision-makers have, over time, exacerbated the racist and classist planning patterns that have rendered commu-

nities at risk, centering power and funds in the communities themselves is a critically important reparative step. Communities need to be firmly in the driver's seat. Unlike other IRA programs that have a goal of providing 40 percent of program benefits to disadvantaged communities, every ECJ dollar and project is intended to provide a benefit directly to disadvantaged communities across the nation.

Despite the fact that many disadvantaged communities are already suffering most acutely from the impacts of climate change, they have received fewer federal funds to combat existing pollution, continue to need to spend energy to fend off polluting industry expansion, and are less well-positioned to capture clean energy resources to prevent future pollution. The ECJ program aims to change this pattern by empowering and resourcing communities to implement their own plans for pollution mitigation and renewable energy investment.

But first, how does the program define and identify disadvantaged communities to ensure these historic funds are targeted toward communities that stand to benefit the most?

Eligibility: What are disadvantaged communities

The ECJ program defines disadvantaged communities as those that are overburdened by pollution while also being underserved in resources and infrastructure. The White House Council on Environmental Quality developed a tool to identify disadvantaged communities nationally, which takes into account factors like the impacts of climate change, energy burden, health impacts, existing and legacy pollution, transportation systems and access, income level, and more. Notably, the tool does not explicitly include race in its criteria despite race being the prevailing indicator of pollution burden.

Pollution burdens, negative health impacts, and failed transportation and energy systems overwhelmingly impact Black and Brown communities. This is due to America's racist planning, polluting, and investment history. We have often called for tools that identify environmental justice communities to include race, given the reality of the pollution burden in this country. Though the ECJ program is not rooted in racebased considerations, we will continue our call for reconstructive climate work on race, as well as on other metrics. And the ECJ program can do very important work for communities in the context of this larger history.



electric grid and phase out the very pollution that causes extreme weather in the first place. We're taking action to build the clean energy we need, faster."

What Senate President pro Tempore Toni G. Reem Assil, Reem's California

In 2010, the dream of Reem's was born at the doorstep of a street corner bakery in Beirut Lebanon Founder Reem Assil says, "The scent of za'atar, yeasted bread, and sweet orange blossom syrup right out of the oven and the sounds of laughter and chatter in Arabic all around me conjured up memories of my childhood and my yearning to create home and community in the US. It was in watching the bread flying out of the oven, literally into hungry people's hands, and witnessing the life inside those bakery doors despite the political turbulence outside of them that I realized my people are masters of bread and hospitality: the lifeline of our history and what has kept us resilient over many generations despite colonization, war, drought, and famine in the Arab world."

On a soul-searching trip to Lebanon and Syria, Reem decided to bring this experience to the Bay. She wanted to bring more than just a bakery. Reem wished to recreate the sights, sounds, tastes and aromas of the streets of Damascus and Beirut, and at the same time a space that feels familiar and inviting to all cultures. She wanted to create a sense of home.

Reem's business truly began in 2014 when she participated in many pop up shops selling baked flatbread to go. In 2015, she officially launched her business as a participant of La Cocina. Her one farmers market location grew to five. Soon enough, they were serving bread and street food fare to hundreds of people a week. Looking to expand given the bakery's rapid growth, Reem entered and won the national OpenTable contest to fund a dream restaurant. Six months later, Reem's California was open. In 2017, Reem opened her first bakery

at her dream location: a corner of a transit center in the heart of the Fruitvale in one of the most diverse communities in Oakland.

Since then the restaurant has been the subject of local and national acclaim. It even became a Food & Wine Magazine Restaurant of The Year for 2018, partly through adapting to her customers' tastes. For example, she wanted to establish a vibrant breakfast and pastry menu, but her pastries and breakfast items didn't take off in Fruitvale as she had hoped. The bakery stopped opening for weekday breakfast service. Reem stated "we wanted it to be this morning bakery, but people didn't understand Arab breads and pastry to be a breakfast food. They wanted something more like lunch. So we pivoted and met customers where they were at. And we became this vibrant lunch and brunch spot. And right around 2019 we got this opportunity that we weren't necessarily looking for, but we were looking for bigger kitchen space because our catering program by then had grown."

Reem received her first loan from Pacific Community Ventures in December 2019. Initially, she had not met all qualifications for a loan upon opening her first location. In March 2020, Reem earmarked the 2019 loan for an opportunity that became available to open her second brick & mortar restaurant in San Francisco. The location was on 24th St. Mission District, which was a former community anchor, Mission Pie. This opportunity came 3 days prior to the country shutting down due to Covid-19 pandemic. The Reem's team faced the challenge of identifying the best options to keep production running. They were unable to maintain it as a restaurant.

Reem then gained an opportunity to partner with World Central Kitchen, a non-profit organization.





The idea was to become a feeding hub for the community for about a year. The partnership produced over 100,000 meals in a year for the houseless populations, frontline workers. It also provided employment to those who needed it on the Oakland side. During this time, in December 2020, the main oven in Reem's Mission location exploded, and it was beyond repair. As a result, the restaurant temporarily paused its operations. It started conducting a series of Pop Up services, farmers markets, and meal kits while they replaced the oven. Reem eventually used the funding from PCV for working capital, hiring new staff, and equipment.

Thoughtful Expansion: Creating More Jobs and Building a Stronger Business

Reem's commitment to her community is exemplified by the quality jobs she provides for her employees. The bakery and kitchen invests in employee training and development plans. It gives workers opportunities to grow and advance within the company. Their second location is open from 9am to at least 9pm six days a week and serves their famous mana'eesh and wraps for lunch and dinner. Reem is excited to offer an extensive Arab pastry program, which includes khobz sim sim, baklava, and kenafah.

Reem has shown incredible business acumen and conducts thorough analysis of both her market base and business finances. That's why she was thrilled to become a PCV Good Jobs Entrepreneur Fellow in April 2023. She joined a group of 14 like-minded business owners who are committed to promoting racial and gender wealth-building outcomes through their businesses.

Reem wants to grow her business while creating opportunities for her employees to advance within the company by transitioning to a cooperative model and preparing for worker shared ownership. She plans to do this by providing training and development opportunities through a core salaried team. This will free her as the owner to focus on the vision and marketing aspects of the business. To support her growth strategy, Reem has multiple small business advisors, including Mike Vanecek, CFO at TMC Financing, and CPA Miles Mochizuki. Reem has also invested in a strategic operation focused on the recruitment, development, and training of her employees.

As a restaurant, Reem's has received a tremendous amount of recognition from local and national publications. This includes features in over 60 articles in major publications like the New York Times and Bon Appetit Magazine. Reem's was also voted as one of Food and Wine's Top 10 Restaurants in 2018. She earned back-to-back James Beard Nominations for Best Chef: West. Reem's media presence has helped to build a platform for her brand centered on Arab hospitality and the intersections of food and social justice. This has attracted visitors from all over the country who are eager to experience the brand and her story.

Reem is currently working on obtaining funding through The Real Peoples Fund for a new project and wants to create strategic partnerships that can help her have social impact. She wants to reach those with the most barriers to employment while creating economic opportunities for those in need.
