Biden-Harris Administration Invests More than \$100 Million in Recycling Infrastructure Projects Through Investing in America Agenda

The U.S. Environmental Protection Agency (EPA) announced more than \$100 million from President Biden's Investing in America agenda to expand recycling infrastructure and waste management systems across the country, representing EPA's largest recycling investment in 30 years.

EPA has selected 25 communities to receive grants totaling more than \$73 million under the newly created Solid Waste Infrastructure for

Recycling funding opportunity. In addition, the agency is making available approximately \$32 million for states and territories to improve solid waste management planning, data collection and implementation of plans.

The grants support the implementation of EPA's National Recycling Strategy to build an economy devoted to keeping materials, products, and services in circulation for as long as possible – what's known as a "circular economy."

"President Biden's Investing in America agenda tackles our most pressing environmental chal-

lenges including climate change and lead in drinking water, and today we add another historic investment to better manage waste in communities across America," said EPA Administrator Michael S. Regan. "By investing in better recycling, EPA is deploying resources to provide recycling services across the country, including in disadvantaged communities, while preventing waste that contributes to the climate crisis, supporting local economies and creating goodpaying jobs."

"Recycling helps us protect our environment while creating jobs and promoting economic growth," said Senator Tom Carper, Chairman of the Senate Environment and Public Works Committee. "Thanks to the Bipartisan Infrastructure Law, this unprecedented investment will provide communities across our country with the opportunity to improve their recycling programs and implement more sustainable waste-management practices. I applaud EPA for the hard work in getting this funding out the door, and I look forward to working together to advance policies that strengthen our nation's recycling infrastructure."

President Biden's Investing in America agenda, a key pillar of Bidenomics, is growing the American economy from the middle out and bottom up – from rebuilding our nation's infrastructure, to driving over \$500 billion in private sector manufacturing and clean energy investments in the United States, to creating a manufacturing and innovation boom powered by good paying jobs that don't require a four-year degree, to building a clean-energy economy that is lowering energy costs for hardworking families, combatting climate change and making our communities more resilient.

EPA's Solid Waste Infrastructure for Recycling Grant Program is also advancing the President's Justice40 Initiative, which aims to ensure that 40% of the overall benefits of certain federal investments flow to disadvantaged communities that are marginalized, underserved, and overburdened by pollution. Approximately \$56 million out of the \$73 million – or 76% – of the total funding for communities will go toward projects that benefit disadvantaged communities.

SBA Administrator Isabel Guzman to discuss implications for Black contractors following the Ultima Services Corp. v. **U.S. Dept. of Agriculture decision**

The U.S. Black Chambers Inc. (USBC) hosted a fireside chat with the Small Business Administration (SBA) Administrator Isabel Guzman to discuss the recent decision issued by the U.S. District Court for the Eastern District of Tennessee (Greenville Division) on the Ultima Services Corp. v. U.S. Dept. of Agriculture case. The court ruled in late July that the SBA's 8(a) Business Development program could no longer rely on race as a justification for stating a business' social disadvantage and need to use the 8(a) program, this program is critical in connecting entrepreneurs of all backgrounds to contract opportunities in a competitive marketplace.

Following the case, all new applications to the 8(a) program were put on pause, followed by a release of public guidance explaining that the program will now require all current participants who are certified under the presumption of social disadvantage to re-certify using a social disadvantage narrative.

USBC urges its members and chamber leaders to refer to the available resources including a Guide for Writing a Social Disadvantage Narrative and SBA's "Social Disadvantage Narrative" Information Session Webinar hosted on August 30, 2023. Sharing these resources and reviewing them closely is essential for helping impacted businesses navigate this change that was released in response to the case.

Ron Busby, Sr., President and CEO of the U.S. Black Chambers Inc. stated the following:

"While we are disheartened to witness yet another attack on federal programs intended to connect our business community to contract opportunities, especially through once-in-a-generation investments in infrastructure and manufacturing efforts, we underscore our commitment towards ensuring that Black firms are equipped to navigate the updated 8(a) processes and guidelines. We will not hesitate to engage our vast network of public-private partnerships and will continue to work alongside our partners to provide timely updates, resources, and guidance for our impacted businesses in the 8(a) program following the recent developments."

The SBA's 8(a) Business Development program provides businesses with an opportunity to participate in a nine-year program that provides training, technical assistance mentoring, and guidance for small firms to effectively compete in the federal procurement marketplace. This program has been critical to providing Black firms with economic opportunity in government contracting. Read more about the 8(a) program. "The work for racial equity has always been important, but this moment requires imagination, vision, coordination, strategic insight and diligence.

Born and raised in the Philippines, Viquiera holds a bachelor's degree in creative writing from the Ateneo de Manila University and a master's in international development and economics from Fordham University. Over the years, he has worked with social justice organizations involved in youth and education development, food and hunger justice, and disaster relief. He is also passionate about great poetry and fiction novels, and spends his free time reviewing novels by authors of color and organizes book clubs

Solid Waste Infrastructure for Recycling Grants for Communities

The recycling grants for communities will support improvements to waste management systems across the country and will range from \$500,000 to \$4 million per grant. Selected projects include purchasing new fleets of recycling collection vehicles and bins to provide curbside recycling services for communities currently lacking access; upgrades to material recovery facilities to reduce contamination; enhancements to composting and organics programs and infrastructure; and construction of various types of facilities that improve recycling, composting, and reuse infrastructure for materials such as plastics and food waste.

Solid Waste Infrastructure for Recycling Grants for States and Territories

The recycling grants for states and territories will provide funding to all 56 states, territories, and the District of Columbia via grants ranging from \$360,000 to \$750,000; with the highest grant amounts supporting those states and territories that need it the most. These grants represent important steps toward achieving the EPA's National Recycling Goal and Food Loss and Waste Reduction Goal. Funded activities include improving post-consumer materials management programs through developing or updating solid waste management plans and strengthening data collection efforts.

Additional Background:

The announcement for states, territories, and communities is the first round of funding from this new grant program. In the coming months, EPA will announce the selected recipients of the recycling grants for Tribes and intertribal consortia, as well as the recipients of EPA's new Recycling Education and Outreach grant program.

The Bipartisan Infrastructure Law provides \$275 million total from fiscal year 2022 to fiscal year 2026 for grants authorized under the Save Our Seas 2.0 Act - the largest investment in recycling in 30 years. The recycling grants are supplemented with additional funding provided through EPA's annual appropriations. EPA has selected these entities to receive funding for recycling infrastructure projects and anticipates making all the awards announced today once all legal and administrative requirements are satisfied.

Work and Lifestyle of Young Adults **Changed During the Pandemic**

Young adulthood (ages 18-34) is characterized by many life changes that may include starting employment, going to college and new living situations. But in recent years, this life stage has been affected by the COVID-19 pandemic, which has brought about large-scale societal transformations.

A new U.S. Census Bureau data visualization explores these changes across a myriad of social characteristics of young adults from 2019 to 2021 including working from home; college enrollment; living arrangements; and computer and internet use.

Between 2019 and 2021, the share of young adults ages 18 to 34 who:

- worked from home increased by 12.0 percentage points.
- had a broadband internet subscription increased by 2.4 percentage points.
- were enrolled in college or graduate school decreased by 0.7 percentage points.
- lived alone increased by 1.1 percentage points.


Other highlights of changes in the social characteristics of young adults from 2019 to 2021:

- The percentage of young adults working from home in Massachusetts increased 19.5 points from 4.8% to 24.3%.
- The percentage of young adults who owned a laptop or desktop computer in Mississippi increased 5.2 points from 72.1% to 77.3%.
- The number of young adults enrolled in public undergraduate educational institutions decreased 12.9%, from roughly 12.6 million in 2015 to 10.9 million in 2021.

Young adulthood is often a time of many changes, including in education, work, and living arrangements. This data visualization focuses on the characteristics of young adults (aged 18-34) during the period of time overlapping with the Coronavirus (COVID-19) pandemic.



All estimates are based on a sample survey and are subject to sample variability and nonsampling error. Comparative statements in this visualization have been tested for statistical significance. However, unstated differences between groups and time points are not tested for statistical significance.
