OAKLAND, Calif. – The California High-Speed Rail Authority (Authority) has received the prestigious 2023 Employer of the Year Award at the Women's Transportation Seminar (WTS) – San Francisco Bay Area Chapter's annual gala. The award recognizes the Authority's work, efforts and initiatives in fostering success for women and minorities.

"We are proud to recognize the Authority with the Employer of the Year award for their commitment to advancing women in transportation, which is reflected by their leadership team, of which 67% are women, and their workforce, of which 50% is female," said Jasmin Mejia, WTS San Francisco Chapter President. "We celebrate the Authority for leading by example."

In 2019, a report from the Mineta Transportation Institute revealed women make up less than 15% of all transportation workers, while U.S. Bureau of Labor and Statistics reports indicate women made up just 7% of the rail industry.

"The Authority is taking the lead on empowering women to take leadership roles in the transportation industry," said Northern California Regional

Deputy Director Morgan Galli. "It's an honor to be part of an organization being recognized for prioritizing and cultivating a diverse and inclusive workforce to deliver this groundbreaking, first-in-the-nation, environmentally sustainable transportation option."

More than half of the Authority's total workforce is female – as well as most of the executive team, many were appointed under the Newsom Administration. Major initiatives and programs led by women at the Authority include strategic delivery; legal counsel; strategic communications; legislative affairs; information technology; planning and sustainability; administration and human resources; diversity, equity and inclusion; engineering; and regional leadership.

Earlier this year, the Authority was recognized by WTS International as Employer of the Year and by the WTS Sacramento and Los Angeles chapters in 2022 as Employer of the Year. In January 2023, the Authority's "I Will Ride" program received the prestigious Rosa Parks Diversity Leadership Award, which recognizes a transportation organization that has contributed significantly to promoting diversity, inclusion and multicultural awareness.

## Latino small business owners are the fastest-growing group of entrepreneurs in U.S.

On the weekends, Salinas food truck owner Orlando Osornio, 30, and his wife, Denise, sell mile-high tortas, filled with California fusion-inspired ingredients: hot Cheetos, bacon, mango-habañero sauce, or pineapple. Some come for the birria torta or the chicken-bacon-alfredo torta.

A line of customers winds its way around the side of his tent as meat sizzles on the grills. On the other side of the mesh, Osornio and his crew pack and stack toasted buns as fast as they can.

Two years ago, when Osornio, who is Mexican-American, was contemplating launching Tortas al 100, he knew one thing: He didn't want to apply for a loan. Osornio had racked up "about \$30,000" in credit-card debt as a teenager and when life smacked him in the face in his early 20s, he got serious about paying it down and fixing his credit score.

That experience, he said, was what prompted him to forgo applying for a small business loan. Instead, Osornio estimated he and his wife spent at least \$50,000 of their salaries on the burgeoning business, including food, four grills, a tent and more during its first year of operation.

Latino small business owners like Osornio are the fastest-growing group of entrepreneurs in the U.S., even as they battle systemic racism that has resulted in lower incomes and loan rates. Over the past 10 years, the number of Latino business owners grew 34%, compared to 1% for all business owners in the United States, according to a recent study from Stanford University. And more Latinos than ever are applying for small business loans to launch or grow their operations.

**Becoming an economic force**

The growing success of Latino small business owners comes as Latinos are increasingly becoming an economic force in the U.S. The same

# New Report Shows California Leading Surge in Business Openings in 2023

California is playing a major role in helping to lead that growth,” said Keith Hall, National Association for the Self-Employed (NASE) President and CEO*

Keith Hall, president and CEO National Association for the Self-Employed (NASE), the nation’s leading advocate and resource for the self-employed and micro-businesses, reacted to the Yelp Economic Average report released last week “2023 US business openings on track to beat last year’s all-time high” showing California as one of the leading states responsible for the surge.

In California, there has been an increase of over 14 percent since last year in new business openings, accounting for 70,713 above last year’s record-breaking numbers. The Los Angeles metro area is helping drive the highest number of new openings in the state.

“The number of small businesses opening over the last two years broke records, and Yelp’s new report signals our community’s growth is far from being over. California is playing a major role in helping lead that growth,” said Keith Hall, president and CEO National Association for the Self-Employed (NASE), the nation’s leading advocate and resource for the self-employed and micro-businesses. “The surging growth in the small business community across the United States, including new operations and existing businesses who are expanding and growing, clearly signaling the determination of our country’s entrepreneurial spirit that is rapidly reshaping the American workforce.”

**The new report by Yelp Economic Average found that:**

National business openings on Yelp from January through July 2023 have surpassed openings from the same time period last year, a year which hit an all-time high for new businesses. This strong national growth is reflected across all categories on Yelp and for the first time, every U.S. state,

including DC, surpassed new business openings compared to pre-pandemic levels (2019).

Entrepreneurs are already breaking records this year. In fact, each month in 2023 has seen growth of at least 15% in new businesses compared to its respective month over the past four years, with every month setting a new all-time high since 2019. The first seven months of 2023 have seen a 25% increase in new businesses compared to the same period in 2022, and a 46% increase compared to the same period in 2019.

Hall continued, “Last year’s all-time high in new business openings is on course to be broken again this year, underscoring the importance of policymakers in Washington to continue adopting ‘pro-small employer, anti-red tape’ policies in support of this exploding business demographic. Small businesses have unique attributes and challenges that call for bipartisanship in support of policies that bolster these new, and existing, small businesses – an increasingly important lifeblood for our nation’s economy.

“NASE applauds and welcomes these new entrepreneurs into our ranks, and we are committed to advocating as their voice in Washington to create and foster a favorable policy and economic environment for small businesses to expand, save and grow.”

Over the past 40 years, the National Association for the Self-Employed supports the small business community through advocating for strong self-employment economic policies, as well as financial support to its small business members. NASE has awarded over \$1,000,000 since the inception of the association’s Growth Grant program. # 6 Reasons Your Document Management is Slipping

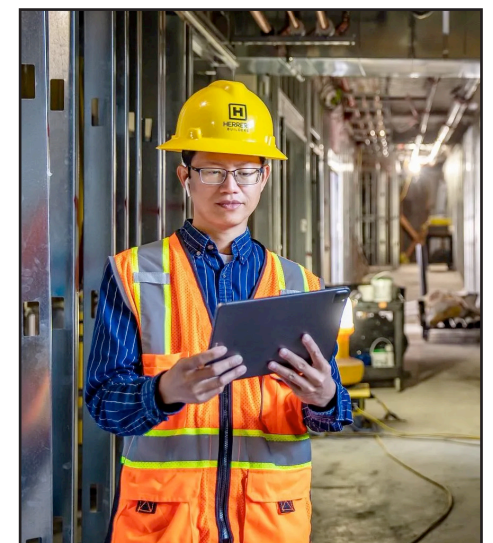

## ODOT Announces Proposed U.S. 23 Corridor Safety Improvements

The Ohio Department of Transportation (ODOT) announced a proposed approach to improving safety along the U.S. 23 Corridor from Waldo in Marion County south to Worthington in Franklin County.

ODOT is looking at ways to improve safety and reduce congestion by reducing the number of traffic signals and intersections along the U.S. 23 corridor. This corridor already has 40 traffic signals and 30% more traffic than the roadway was designed to accommodate, leading to increased congestion, unpredictable travel times, bottlenecks, and more importantly higher crash rates. This area is among the fastest growing not only in Ohio, but the nation, meaning without any action the problems will continue to get worse.

“Safety has been my top priority since taking office, and this area has high rates of crashes and fatalities which is unacceptable,” said Governor Mike DeWine. “In addition to safety concerns, the sheer number of stops and traffic signals has grown over time and reduced the free flow of travel along this stretch of road. It is important that all urban areas of the state have a strong, clear network for freight and passenger travel. This is just the first step towards improvement.”

### U.S. 23 Corridor Safety Improvements

“Our engineers have been working to improve travel along the U.S. 23 corridor for several years now. While we’ve made improvements, more clearly needs to be done,” said ODOT Director Jack Marchbanks. “We can’t do this alone. We’ll be engaging the public in the coming months to ensure that those who live, work, and travel here have a voice in its future.”

ODOT will hold a series of public meetings with key stakeholders like business and community leaders as well as members of the public. These meetings will include discussion of different concepts that could be pursued. These concepts range from traditional freeway interchanges, restricted crossing U-turns, overpasses and underpasses, and connector road interchanges along the U.S. 23 corridor.

Additional public meetings are planned for early 2024 to help with a feasibility study. By the end of next year, ODOT hopes to have a full report on next steps.

Stanford study found Latino-owned businesses contributed about \$500 billion to the economy in annual sales.

A 2019 report to Congress based on data from 2017 found almost 60 million Latinos in the United States already account for \$2.3 trillion in economic activity in total, which on its own would rank as the eighth largest economy in the world. And Latinos are projected to make up 30% of the U.S. population by 2024, meaning the group's contributions are only likely to grow.

Latino-owned businesses employ more than 3 million people, the 2019 State of Latino Entrepreneurship report by the Stanford Latino Entrepreneurship Initiative (SLEI), a Stanford University research initiative centered around Latinos in business, found. All told, Latino-owned businesses account for about 4% of U.S. business revenues and 5.5% of U.S. employment.

However, Latino-owned companies remain smaller than white-owned firms, averaging only \$1.2 million in revenue compared with \$2.3 million brought in by a white-owned company.

That is a problem, said Jerry Porras, a professor of organizational behavior and change emeritus at Stanford Business School, co-founder of the Latino Business Action Network, a nonprofit out of Stanford University focused on empowering Latino business owners, and co-director of SLEI.

"I think that there's really a positive story when you look at Latino businesses across the country," said Porras. "The number is smaller as a base but its growing very rapidly. Latinos are oriented towards starting businesses and are doing it at a significant rate."

If Latino-owned employer firms were given the same chances, Porras said, they would generate an additional \$4 billion in revenue and 1 million jobs.

### Younger than other entrepreneurs

Across the U.S., Latinos are represented in all the major industry sectors, owning businesses in manufacturing, education, health services, finance, construction and more.

Latino business owners tend to be younger than non-Latino business owners. Roughly 33 percent of Latino entrepreneurs are younger than 45, compared to just 22% of non-Latino entrepreneurs.

For every 100,000 Latino adults in the United States, on average 510 became entrepreneurs each month in 2018.

However, research by the Institute on Assets and Social Policy, an institute that studies economic opportunities for people of color, evidences that historic disenfranchisement of people of color has led to those very people having less generational wealth than white people.

Furthermore, policies that favor the affluent have continued to widen the gap, particularly between white families and black or Latino families.

While the income gap between blacks and whites closed somewhat between 1970 to 2016, Hispanics fell even further behind at all income levels, the Pew Research Center think tank found in 2018. Even top-earning Hispanics earned only 65% as much as whites in 2016, down from 74% in 1970.

And Hispanic people on average continue to make lower salaries than white people, research out of Stanford showed.

In the end, this combination means Latinos typically have lower credit scores, which, in turn, can mean higher interest rates or being turned down for loans.

According to a report submitted to the U.S. House Financial Services Committee in 2019 by UnidosUS, a nonpartisan think tank focused on the Hispanic community, banks originally had loan officers who determined the "trustworthiness" of a loan applicant. As such, people of color were often discriminated against.

In the following decades, banks lost their loan officers to the war effort, and soon invented credit scores as a stand-in. However, these, too, had their issues as they were built on longstanding disparities and have resulted in communities of color, young adults, people with low income and immigrants having disproportionately low credit scores.

According to the 2017 Small Business Credit Study by the Federal Reserve Banks, of applicants denied credit, 45% of Latino applicants were denied for insufficient credit history and 37% were denied for having too low a credit score. (Applicants could choose more than one response.) In comparison, white applicants were turned away at rates of 33% and 26% for the same reasons.

"I think the Latino story in some ways follows the story of why black families have less wealth than white people today," said Urban Institute research fellow Steven Brown. "There is a lack of the same kind of resources that help build wealth.

Brown cited restricted access to homeownership under policies such as "redlining" as a primary way Latinos were kept from building generational wealth. For decades, black and Latino neighborhoods were unfairly deemed too risky for loans and mortgages through redlining. That left people in those neighborhoods reliant on speculators or private sales.

"When Latinos have been able to buy homes, they have historically been relegated to neighborhoods where the homes didn't have as much value so they're unable to build as much wealth and pass it on," said Brown.

In more recent years, as Latinos have become more prominent in U.S. culture, their economic standing is also rising. A 2019 study of 61,000 small-business loan applications submitted to Biz2Credit's online marketplace found that the number of credit applications from Latino-owned businesses rose 23 percent from 2018 to 2019.

### Outpacing US economy

And over the last year, Latino-owned businesses reported an average revenue growth of 14%,

outpacing the growth of the U.S. economy, the Stanford report showed.

While revenues climbed, though, the average credit scores of Latino business owners dipped to 588 from 594 last year, according to Biz2Credit.

### Bombera Brings the Heart and Soul to Oakland's Cool Culinary Scene

#### Building a Culinary Haven:

Born out of the success of her first solo venture, Cosecha Café, Rice-Cisneros envisioned Bombera as a continuation of her culinary exploration. "After 10 years, it was time to move on to a full-service restaurant," says Rice-Cisneros. "Bombera has more service, a more complex menu, a full bar program and more emphasis on handmade items." Creating that restaurant was a big undertaking which saw the chef/owner take a more hands-on approach to the overall dining experience. No QR code menus or fussy encounters, Bombera is all about a shared experience rooted in savoring the moment. "We want Bombera to reflect what we have done in California as Mexican-Americans for the past 200 years—connecting California and Mexico." That's translated through the menu which features a delightful, bright medley of vegetable-forward dishes like charred beets a la Tulum (lime, green Chile, whipped pumpkin and sesame seed butter) and spicy carrots with toasted almond Misantra (Riverdog Farm carrots, almonds, and frijol blanco gigante). This along with core staples like carne asada and duck carnitas (using Liberty Ducks) continues Bombera's emphasis on local ingredients at reasonable price points—ensuring accessibility and deliciousness for everyone.

#### The Importance of Community:

Growing up as a second-generation Mexican-American in Downtown Los Angeles, Rice-Cisneros learned firsthand the value of having a vibrant and supportive community. Her multicultural neighborhood shaped her palate and culinary identity. "I thought being from Los An-

geles was a disadvantage because I did not grow up in Napa or France. I grew up in Eagle Rock and in Chinatown; it wasn't an orchard, a farm, or a winery. I thought I was behind in my culinary training," says Rice-Cisneros. However, her experiences inspired her to open Bombera and bring that same sense of multiculturalism. "I wanted a connection to the community and its people," says Rice-Cisneros. "That's what gets me out of bed every morning. It helps me focus and brings me energy every day."

#### Empowerment and Inclusivity:

It's that sense of togetherness that's at the heart of Bombera. Raising her network with her, Rice-Cisneros has retained her team for over a decade, a testament to her dedication to providing a platform, and voice, to females in the industry. "I want opportunities for women of all ages and to give them a chance to express their point of view," says Rice-Cisneros. A member of Les Dames d'Escoffier (a philanthropic organization aimed to inspire and support women in food, beverage, and hospitality), Rice-Cisneros champions for women in the gastronomic landscape down to her location, a former firehouse. [Fun fact: Bombera literally translates into the female version of firefighter]. It's fitting given the kitchen's propensity for cooking over flames, something that pays homage to the restaurant's location, but also, the previous generation and grandmothers who were masters of fire and traditional cooking.

Antonio "Tony" Camara opened it up in 1972 to provide a great haircut at a great price. This core value is still at the heart of the shop, shares Raland Camara, one of the original owners' four sons. The boys grew up helping out, a first job often sweeping the floor. Raland has been running the shop since both parents have now passed, and he also works as an engineer at Northrop Grumman. He proudly notes how the business helped put all four brothers through college.

His mother found the SBDC through a newspaper article and reached out for assistance. "They have been very helpful to me as I took an active role in running the shop with my mom's health issues during the pandemic. They were great advisors.

"They helped guide me in terms of licenses and product resale, with COVID support processes and strategy. We weren't successful in getting government funding due to the income tax structure of the shop. The advisors were helpful in identifying this issue and clearing up the confusion."

Yet Raland and the business have persevered, working with the SBDC off and on – more so lately in planning 50th anniversary celebrations including partnering with the National City Chamber of Commerce as well as getting creative with marketing. "I would advise reaching out to the SBDC because they just might be able to help you in an area that you just might not expect. I originally reached out for funding support and ended up getting solid advice in terms of running the business."
