

#### SBA Seeks Funding Proposals from Non-Profits and Local Institutions to Provide Entrepreneurship Training For Service Members, Military Spouses and Veterans

The U.S. Small Business Administration (SBA) is inviting funding proposals from non-profit organizations, state, local and tribal government agencies, and institutions of higher learning to provide "Boots to Business" entrepreneurship training to service members, military spouses, and veterans.

The funding competition, offered by SBA's Office of Veterans Business Development (OVBD), will enable delivery of the global Boots to Business program. The program provides entrepreneurial education and training to military service members and spouses (including members of the Reserve and National Guard) via the U.S. Department of Defense's Transition Assistance Program (TAP).

"More than 50,000 active duty service members and military spouses have completed Boots to Business and are leading the charge to create the next great generation of veteran entrepreneurs," said Barbara Carson, Associate Administrator, SBA Office of Veterans Business Development. "I look forward to working with SBA grant awardees to introduce service members and military spouses to the vocation of small business ownership."

Eligible, interested parties should submit their proposal for Program Announcement No.B2B-2017-01 at http://www.grants.gov/web/ grants/view-opportunity.html?oppId=291244 by 11:59 EST on February 17, 2017. For more information, contact John Lira at john.lira@sba.gov (link sends e-mail).

SBA anticipates awarding between one and four cooperative agreements from this grant announcement. A maximum of \$2.5 million in funding is available annually for up to five years. The initial award is for 12 months. At the end of the initial grant period, SBA has the option to continue the grant annually, up to an additional four years.

Among other criteria, successful applicants will have a demonstrated history of providing quality entrepreneurship and/or business management training to transitioning service members or veterans.

### Minority Business Development Agency Releases Report on Contracting Barriers Impacting Minority Firms


The U.S. Department of Commerce, Minority Business Development Agency today released a new report, Contracting Barriers and Factors Affecting Minority Business Enterprises: A Review of Existing Disparity Studies. The report, which spotlights disparities in state and local government contracting between minority-owned and nonminority-owned business enterprises, provides an in-depth review and analysis of disparity studies, summaries, and reports.

"Our goal in releasing this report is to advance the dialogue surrounding contracting disparities and use the findings as a catalyst for creating policy and innovative solutions. It's critically important that MBEs, advocacy groups and policy makers have access to this information," said MBDA National Deputy Director Albert K. Shen. "This report also underscores the power of data and the fact that we still have a lot of work to do to ensure MBEs have fair and equal access to contracting opportunities."

Some of the key findings from the report prepared by Premier Quantitative Consulting Inc., revealed the following: contracting disparity remains wide-spread; MBEs typically obtain a lower number and dollar value of contracts in proportion to the number of available MBEs in a comparable market; and that industry groups most affected include construction, professional services, architecture, engineering services, and goods and supplies.

### **Urban Transportation's Multimodal Future**

Networked alternatives for getting around are about to redefine our cities as much as the horseless carriage did a century ago.

Second perhaps only to waterways, road systems have had the greatest impact on the design

The car-centric redesign of the American city that began in the early 20th century was embraced with open arms by urban planners and citizens alike. Yet now, in the early 21st century, its limitations are clear. There is a rapidly growing awareness that simply expanding our roadways won't end congestion and gridlock.

The future, more and more urban transportation experts are coming to believe, lies in mobility-friendly networks in which cars are just one element -- and an ever-shrinking one as we move from a system in which the personally owned vehicle is king and toward a multimodal future of ondemand driverless vehicles, ride-sharing, expanded public transit, greater reliance on human-powered transportation and other alternatives.

How far could such a new mobility paradigm take us? Jerry Weiland, a 30-year veteran of General Motors who now leads the Rocky Mountain Institute's mobility program, believes that, over the long haul, the United States could reduce the number of urban/suburban vehicles on the road by up to 90 percent and in the process redefine cities just as the horseless carriage once did.

Whether or not this scenario plays out, it's clear that cities need a roadmap to guide the next generation of infrastructure investment decisions. Roads and bridges last a long time, and new infrastructure is costly. What should city leaders be thinking about when they look at repositioning their infrastructure for the future? "The first thing cities should understand is that all of the transportation infrastructure is about networks, whether it's bike-share, whether it's light rail, whether it's roads," says Cooper Martin, co-author of a 2015 National League of Cities' report, City of the Future: Technology & Mobility. "One line, one bikeshare station, one road doesn't cut it."

Martin illustrates this concept by describing how the original Washington, D.C., bike-share system played out when it was piloted several years ago. The city installed a limited number of stations around the city, then declared the system a

### **Mayor Lee Launches the Equity and Immigrant Services Campaign**

Mayor Edwin M. Lee today announced with community-based organizations, the Human Rights Commission, and the Office of Civic Engagement and Immigration Affairs the launch of the Equity and Immigrant Services Campaign, a multi-pronged effort for the continued support of immigration legal services.

This year, Mayor Lee dedicated \$3.8 million to serve the legal needs of the City's immigrant community. Following the presidential election, Mayor Lee met with many of the community-based organizations that serve San Francisco's immigrants and heard the concerns and needs for more resources. These community-based organizations are the gateway for many families to get the services they need such as, legal representation, health care, and education. Subsequently, Mayor Lee moved forward with dedicating an additional \$1.5 million on top of the \$3.8 million already funded to expand and bolster immigration-related legal services in fiscal year 2016-2017. In total, Mayor Lee has pledged nearly 14 million dollars for immigration-related services over the next two years and has committed to increasing those funds if needed.

"San Francisco is a Sanctuary City and will not waiver in its commitment to protect the rights of all its residents," said Mayor Lee. "This year's 1.5 million dollars will be critical in expanding and bolstering the services our community-based organizations provide to support and protect our immigrant families."

As part of Mayor Lee's ongoing strategy to protect the rights of our City's immigrant communities, city departments will partner with community-based organizations such as the San Francisco Immigrant Legal Education Network (SFILEN) and The San Francisco Immigration Legal Defense Collaborative (SFILDC) to expand education,

outreach, and provide multilingual legal services, full scope representation for detained and non-detained clients and assessment, as well as fee-waiver and loan assistance for mix-status families and individuals seeking naturalization. This partnership will provide services in more than 20 languages and dialects and represent a diverse set of cultural experts who can serve a broad range of ethnic and linguistic enclaves in San Francisco

We are proud of San Francisco today, of our local community advocates, our Mayor and elected officials for standing by the immigrant community and our city's values. This investment will allow us to ramp up existing services and systems of protection while also empowering our migrant community with the affirmation that San Francisco is a Sanctuary City and a city for all," said Lariza Dugan Cuadra, Executive Director of the Central American Resource Center (CARECEN). The Central American Resource Center will be the fiscal lead for the San Francisco Immigrant Legal Defense Collaborative that will be funded by this effort to hire additional immigration attorneys.

Mayor Lee was joined by members of the San Francisco Unified School District, the San Francisco Public Health Department and several community-based organizations representing the spectrum of cultures living and working in San Francisco. Also in attendance was Mr. Hung Wai, a Chinesespeaking citizen who benefited from naturalization services and Ms. Yulissa Tula, a Spanish-speaking citizen who benefited from legal defense services. Both Mr. Wai and Ms. Tula shared their stories with the Mayor and were thankful for the services that were offered by the City.

Dr. Suzanne Barakat, a Family Medicine Resident at UCSF/San Francisco General Hospital, lost her brother and sister in law, and sister in a

The report also dedicates a chapter to Disparity Study Basics, a guide for those embarking upon a disparity study. This should be helpful to state and local governments, since the Federal Government provides over \$536 billion, with disadvantaged business enterprise spending requirements, to states each year. Conducting a local study can determine if disparities exist and prompt states to take corrective action and eliminate the risk of losing federal dollars. ### **Over One-Third of Small Businesses Lost Employees** in a Year, and Most See Employees Come and Go, New JPMorgan Chase Institute Data on the Volatility of Payroll Expenses Reveals

The JPMorgan Chase Institute released its newest report recently on the financial health of small businesses and employment challenges they continue to face. The first-of-its-kind report reveals new information about small business employment growth and the volatility small business owners experience when managing payroll expenses.

"The Ups and Downs of Small Business Employment" reports that most small businesses experience substantial volatility in payroll expenses. Moreover, more than two-thirds (68 percent) of small employer businesses either reduced their number of employees or added less than the equivalent of one full-time employee in a calendar year. The typical small business saw payroll expenses grow by 8.5 percent per year. These payroll expenses were significant for small employer businesses, with the typical owner paying \$18,700 in payroll expenses a month, or 18 percent of all outflows for their business. Making their financial situation even more difficult to manage, small businesses with employees had only 18 cash buffer days, compared to 27 cash buffer days for small businesses overall.

"Payroll is a significant expense for employer small businesses and managing it has an impact on not only the health of their business, but also the people they employ," said Diana Farrell, President and CEO, JPMorgan Chase Institute. "With increased focus on the positive impact small businesses can have on the economy, it's critical to understand what these new insights mean for job creation and policies that aim to support both small businesses and their employees."

The Institute analyzed 65 million anonymized transactions from 45,260 small business customer accounts over the nine non-holiday months from February 2015 to October 2015. This unique dataset provides a granular view of payroll growth and volatility and their impact on employment at the individual business level.

#### Key Findings: The Ups and Downs of Small Business Employment


- Finding One: Payroll for most small employer businesses grew by less than the equivalent of one full-time employee in a calendar year, with median annualized payroll growth of 8.5 percent.
- o 36% of small employer businesses decreased their payroll expenditures.
- o 32% of small employer businesses increased their payroll expenditures by less than the equivalent of one full-time employee.

- o 31% of small employer businesses increased their payroll expenditures by more than the equivalent of a single full-time employee.
- Finding Two: Payroll expenses were a material outflow for employer small businesses, which held fewer cash buffer days than nonemployer small businesses.
- o Payroll expenses varied from a median of \$11,700 per month in the Restaurant industry to a median of \$36,600 per month in the High-Tech Services industry.
- Payroll as a percentage of outflows varies substantially across industries—payroll only comprised 10 percent of the outflows of a typical wholesaler or retailer, but 27 percent of the outflows of a typical High-Tech Services firm.
- The typical employer small business had only 18 cash buffer days, compared to 27 cash buffer days for the typical small business overall.
- Finding Three: Most employer small businesses experienced unstable payroll and employment volatility including job gains and losses and other spikes and dips in payroll.
- o 38% of small businesses experienced payroll changes that are likely more stable and small

   perhaps taking on a part-time employee or changes in hours worked by employee(s).
- o 62% of small businesses experienced changes in payroll that are less stable: large spikes and/ or dips in payroll (possibly paying employee bonuses or catching up on a missed payroll expense) and sustained gains and/or losses in full-time employees that increase payroll volatility.
- Finding Four: The typical small employer business experienced substantial volatility in payroll outflows, and volatility was highest for younger small employer businesses.
- While most firms had payroll volatility that tended to reflect large payroll gains and losses that were greater than the equivalent of paying one full-time employee, their overall net payroll growth rate was still less than the equivalent of one full-time employee.
- o Payroll volatility was substantially higher for firms less than two years old than for firms greater than two years old.
- Finding Five: Small employer businesses with more volatile payroll patterns tended to have fewer cash buffer days.

#### Finding One

Payroll for most small employer businesses grew by less than the equivalent of one full-time employee in a calendar year, with median annualized payroll growth of 8.5 percent.



Note: We calculated annual full-time equivalent (FTE) wages for a firm by dividing the total annual payroll for its 6-digit NAICS industry by the total number of employees in that industry. We identify FTE changes by comparing annualized payroll growth to this annual FTE wage measure. Annual payroll and employee data are from the US census Statistics of US Businesses.

- o Small businesses with dips, combined gains and losses, and both spikes and dips had the fewest cash buffer days.
- Small employers with spikes were one exception to this rule, which may reflect businesses that pay bonuses or commissions with growing revenues.



failure because few people were using it. But later, when the system was built out on sufficient scale, it flourished. The problem wasn't lack of demand but the need to create a network robust enough to be useful.


For many decades, until its own growth began clogging roads and intruding too heavily on neighborhoods, the individually owned automobile was just such a robust solution. Its success sets a high expectation in our minds for an acceptable replacement. "We have to devise a solution that's 100-percent fail-safe," Weiland says. "The new mobility has to offer people a complete answer, not a partial one. Otherwise you're not going to get rid of your car."


It's safe to say that the best fail-safe alternative solution is a multimodal transportation system in which many options -- bikes, transit, car- and ridesharing -- are readily available at a moment's notice along the direction of travel. With near real-time information, the traveler can seamlessly shift from one mode to another and choose the one most suited to his or her needs.

So how will our cities get to that seamless, fail-safe, multimodal future? Due to varying population densities, economic resources, legacy infrastructure and resident demands, no two communities will take the same approach. Certainly in rural communities -- and no doubt many suburban ones -- the personally owned car will remain the dominant transportation choice for some time.

But in more urban settings, networked alternative transportation choices are already proving to be very dependable alternatives. With improving integration across transportation modes and seamless payment solutions, their growth is all but secured. Our mobility-friendly, multimodal urban transportation future may be closer that we realize.

### **ReUNION: Education-Arts-Heritage premieres Breathing Freedom season**

ReUNION: Education-Arts-Heritage premiered its 2017 season of instructional television during the Martin Luther King Jr. holiday event from the nation's capital to the San Francisco Bay with five events. The theme is Breathing Freedom, marking the 150th anniversary of the first year after the passage of the 13th Amendment.

In San Francisco, a campaign ReLoading Black San Francisco was launched Sunday, Jan. 15 during Innovation&Equity17: 50 Most Important African-Americans in Technology with a goal of attracting 10,000 African-American technology professionals to the Bay Area in the next 12 months.

Masters of inclusion Dr. Gary May and Carra Wallace led a two-pronged analysis. Wallace, one of the nation's leading minority business advocates over the past eight years with the State and City of New York, moderated Money on the Table with the Honorable Malia Cohen, president of the San Francisco Retirement System and California State Treasurer John Chiang, who represented more than a half trillion in pension assets between them.

Cohen and Chiang concluded that their asset managers can use corporate governance reviews to address such issues as equal employment opportunity and supplier diversity, particularly with technology companies.

The issues were framed in three opinion articles Friday, Jan. 13 in the San Jose Mercury News and San Francisco Chronicle and Monday in The Hill, the newspaper of Capitol Hill. Of 174 "unicorns", or startups with more than \$1 billion in valuation, none were headed by African-Americans. The Chronicle article asked whether King would recognize today's San Francisco because of the severe economic inequality. Roy L. Clay. Sr., the Silicon Valley Engineering Hall of Fame member, was recognized in the The Hill for his contributions to technology beginning in the 1950s, before the women featured in the current hit Hidden Figures.

Dr. May, dean of the largest engineering school in the nation with 13,000 students at Georgia Institute of Technology, debunked claims that Silicon Valley companies can not find African-American talent. "They're not looking in the right places," said May. His school graduates more African-American engineers than any other, and counts ten percent of the African-Americans with doctorates in engineering as alumni.

The Journal of Black Innovation features Winning the Math Race in its February issue, featuring Dr. May's conclusions on how to increase the numbers of black students with engineering degrees. It also announces a nationwide innovation competition through National Bankers Association banks designed to match African-American industrial innovators with sources of credit and risk capital.

Dr. May, who came to Georgia Tech as a student in 1981 and has been on faculty since 1991, related a personal story about how the barriers can be overcome. When he showed up as a freshman, someone had written on his dorm room that his white roommate was a "n\_\_\_\_r lover." May's mother wanted to turn around right then, but the new freshman concluded that at least it wasn't the roommate making the sign and stayed for what has turned out to be more than three decades.

Joyce Hunter, deputy chief information officer of the U.S. Department of Agriculture described her STEAM Summer Camp which attracted 40 African-American students to agricultural science, particularly the technological aspects, despite their initial reluctance. From the first group, four actually entered college to study agricultural science. She noted that USDA will pay full tuition for any student who goes into agricultural science at the 1890 Land Grant schools.

Local engineer Frederick E. Jordan received special recognition as a Roy L. Clay Technology Pinnacle Award winner with a proclamation from Rep. Barbara Lee following a film on his iconic firm F.E. Jordan Associates produced by Francee Covington. Covington, president of the San Francisco Fire Commission, was on hand to recognize Jordan as well.
