# Authority Releases Request for Qualifications for Construction Package 2-3

On October 10 the California High-Speed Rail Authority (Authority) issued a Request for Qualifications (RFQ) for Construction Package 2-3 (CP 2-3), the next phase in the construction of the California high-speed rail system. Work on CP 2-3 will extend approximately 60 miles through the Central Valley from East American Avenue in Fresno County to one mile north of the Kern-Tulare County line.

As part of the Authority's commitment to small business participation, an Industry Forum was held in Sacramento on October 28. Approximately 200 people representing firms from around the world attended the forum to learn about CP 2-3, how to bid on the project, and for networking opportunities between prime and subcontractors.

At up to \$2 billion, CP 2-3 is the most valuable contract the Authority has yet offered. But with the big price tag comes very significant work. CP 2-3 is a design-build contract. Design-build contracts mean the chosen contractor must develop innovative means and methods to design the project and then construct it. This approach can lead to faster construction as the contractor is accountable for timing of design and construction work.

The selected design-build firm will be responsible for all work required to design and construct the CP 2-3 segment in the Central Valley. The work will include delivering final designs for bridges, culverts, trenches and tunnels, utility relocations, aerial structures, grade separations, tunnels, security and drainage.

CP 2-3 is expected to bring thousands of jobs to the Central Valley, an area with one of the highest unemployment rates in California and the nation. The route will also provide environ-

mental benefits, relieve roadway congestion and spur economic development.

"The Authority is delivering on its voter- mandated mission to build the nation's first high-speed rail system, which provides economic benefits to the Central Valley and creates thousands of jobs," said Jeff Morales, CEO of the Authority. "High-speed rail is a critical investment in California's transportation infrastructure to address population growth, congested roads and airports, and air quality."

The environmental clearance for the route is already underway and is anticipated to be final by summer 2014. The Statement of Qualifications from firms interested in CP 2-3 were due to the Authority on December 13

### Poll Findings: On Cuban-Americans And The Elusive 'American Dream'

Among Latinos, no group may have achieved the American dream as fully as Cuban-Americans.

Since arriving here, as a community, they've prospered. Surveys show they graduate from college at greater rates and have higher levels of homeownership than most other Latino groups.

But suggests that, for many Cuban-Americans, the dream is becoming elusive. The poll conducted by NPR, the Robert Wood Johnson Foundation and the Harvard School of Public Health finds that 45 percent of Cuban-Americans say their finances are not so good or poor. They see themselves as financially troubled at rates higher than other Latinos.

One of those who took part in the poll was Floresdilia Martinez. She's 24 years old, a second-generation Cuban-American. Martinez has looked for work ever since graduating from high school more than five years ago, without success. She says, "I would fill out application upon application trying to find a job. And no one ever called back."

Martinez's parents arrived in Miami from Cuba at a time when the economy was booming — her father in the 1960s, her mother a little later. For them, she says, finding work was easier. "Oh, yeah," she says. "My mom was working ever since she was 14."

Robert Blendon with the Harvard School of Public Health says Cuban-Americans are also worried about the future. In the survey, 60 percent of Cuban-Americans said they were worried about possible unemployment. "They are more so than other Latinos," Blendon says, "if they're employed or have an employed family member, to be worried about losing a job in the next year."

One reason for the economic worries among Cuban-Americans, Blendon suspects, is where they live.

It's been more than 50 years now since the Cuban revolution that prompted tens of thousands of Cubans to begin fleeing their homeland. Most arrived in Miami. Today, more than half of the nation's Cuban-Americans live in Miami-Dade County.

For years now, Miami's unemployment rate has been above the national average. Many homeowners still owe more on their mortgages than their homes are worth.

Nicholas Jane is a young Cuban-American, just 22, who took part in the poll. He's discouraged about his financial outlook and also that of his parents.

"My dad is the only one that has a steady job, and even he, between 2003, 2004, he was completely unemployed and he couldn't find a job. My mom has not been able to find a steady job, and neither have I. So, it's been tough," Jane says.

The financial uncertainty and job worries of Cuban-Americans have a lot to do with their concentration in an area still struggling to recover. But Guillermo Grenier, a sociologist at Florida International University in Miami, believes they reveal something else about Cuban-Americans: Their demographics are changing.

The wave of Cubans who arrived in the early 1960s, Grenier says, came as Miami was just beginning to transform from a small Southern city into an international metropolis.

"They've benefited from the growth," Grenier says. "Cubans are the Brahmins of the community in many ways.

But that earlier generation now is becoming outnumbered by Cubans who arrived more recently. In the past decade, more than 300,000 Cubans have arrived in the U.S.

"The Cubans arriving now are way poorer. They're getting hired at minimum-wage jobs. They get very little, very few benefits. And their English is not great," Grenier says. And even in Miami, Grenier says, you need English to climb the economic ladder.

This combination of factors — a slowly recovering South Florida economy and changing demographics — are making Cuban-Americans more like other Latino groups in the U.S.

For a young person like Nicholas Jane, who's graduating from college with a Bachelor of Arts degree later this year, what he's finding is not what he feels he was promised.

"The American dream, at least for Cuban-Americans of my generation, it just doesn't seem like it's plausible anymore. It's very hard not to get an anxiety attack from thinking about the future and thinking about, 'Oh, am I able to have a nice house?' and all these other things."

Researchers say data show that today Cuban-Americans do better economically if they leave Miami. Jane is taking that point to heart. After graduation, he says, he's not even looking for work in Miami. His most recent interview was for a job in Japan.

### Is our Mentoring Program working?

Q: I serve as the chair for the diversity and inclusion council. We are assessing our formal mentorship program. we've asked about mentees' experiences, impact on their overall development, and whether they'd recommend the program. We've also assessed the demographics. We found white males rated their participation lower than others.

- Does our program have shortcomings?
- What best practices and resources would you recommend for mentoring?
- I How do companies utilize sponsorships in conjunction with mentorship?

A: DiversityInc has found that in the companies with the most successful programs, mentoring is evenly applied. Our best practices include ensuring that there are cross-cultural/racial/gender/orientation/disability opportunities, especially for your Black, Latino and Asian senior executives. You should also be tracking demographics of your mentees versus the demographics of your talent pipeline. We ironically regularly find underrepresentation in mentoring of underrepresented groups. Mentoring programs directed at one group or another—or conspicuously omitting white men—are inherently unfair and will cause problems.

I do not believe sponsorship can be assigned; however, you can assign a goal for each senior executive to sponsor a

certain number of people—and direct them to your resource groups as a good way to find individuals to sponsor.

See Is Sponsorship the New Mentoring? Case Studies from EY\_ Deloitte, AT&T, Dell & Hilton. Seventy-two percent of The 2013 Diversitylnc Top 50 Companies for Diversity have a formal component to their sponsorship. This means involving senior executives and setting up guidelines and checkpoints.

Sodexo (No. 1 in the Diversitylnc Top 50) has one of the best formal mentoring programs we've seen, particularly because of the metrics used to gauge success as well as the ways in which the company has been able to quantify the ROI on mentoring (for every \$1 spent, there was \$2.28 in retention/ increased productivity realized).

### **Profile of Veteran Business Owners:**

### More Young Veterans Appear To Be Starting Businesses Climbs to top of Business World

#### At A Glance

Veteran business owner demographics and the economic and business environment are changing dramatically and rapidly. There is some evidence that the proportion of younger veteran business owners (under age 35) increased from 2008 to 2012, as did the share of veteran women business owners. (The share of women business owners appears to have increased among both veterans and non-veterans, but at a much greater rate for female veterans.)

What Share of Business Owners Are Veterans? Veterans made up 9.1 percent of all business owners in 2012.

**How Old Are Veteran Business Owners?** In 2012, 7.1 percent of veteran business owners were under age 35, an increase from 4.6 percent in 2008.


What is Their Gender Distribution? Most veteran business owners are male. The share of business ownership by female veterans is lower than in the overall population, but it is growing. In 2012, 4.4 percent of veteran business owners were women, up from 2.5 percent in 2008. In the overall population, 35.9 percent of business owners were women.

**How Well Are Minorities Represented?** The rate of minority business ownership by veterans was lower than non-veterans. However, Hispanic veteran business ownership appears to have increased: from 3.2 percent in 2008 to 6 percent in 2012.

What Industry Sectors Do They Operate In? Veteran business owners are more likely to be in the goods producing sector than their non-veteran counterparts.

**How Many Businesses Do They Own?** Veteran business owners were more likely than their non-veteran counterparts to own two or more businesses. In 2012, 10.3 percent of veteran business owners had two or more firms, compared to only 7.4 percent of non-veteran owners.

Veteran business owners and entrepreneurs make important contributions to business creation and growth in the American economy. Their active duty and reserve service often provide them with important skills and leadership abilities that are directly relevant to business ownership. Because the economic welfare of veterans is an ongoing concern of policymakers, various programs have been designed to help support aspiring veteran entrepreneurs and business owners. These efforts include specialized financial assistance from SBA and its resource partners, as well as busi-



ness development programs managed by SBA in cooperation with other federal agencies, such as Operation Boots to Business. SBA has also supported other efforts initiated by private-sector sponsors, nongovernment organizations or universities. Among these are a nationwide network of 16 Veterans Business Outreach Centers, the Entrepreneurship Boot Camp for Veterans with Disabilities (EBV) sponsored by Syracuse University and seven other schools of business at major universities, and Women Veterans Igniting the Spirit of Entrepreneurship (V-WISE). Congress has also enacted legislation establishing government-wide goals for federal procurement dollars going to service-disabled veterans, as well as special contracting tools to help agencies meet these goals.

A lawsuit set to be heard on June 23, 2014 before the 8th District Court, Clark County could be a deciding factor on whether veterans' disability can be used to satisfy a civil judgment. The civil lawsuit was filed by a high profile family attorney against several veterans groups on May 14, 2012 has alleged that these so-call militant military groups intentionally cause harm to him and his law firm through

defamation, RICO, disparagement of business and other claims.

While Mr. Willick has denied being a public figure in his civil complaint, his actions tell a different story. Mr. Willick has litigated trial and appellate cases in Nevada and claims that he has participated in hundreds of divorces and pension cases in the trial and appellate courts of other states, and in the drafting of various state and federal statutes in the areas of pensions, divorce, and property division. He has been called on to represent the entire ABA in Congressional hearings on military pension matters and written books on pensions. His views on a long standing national debate over controversy in military retirement has thrust him into the public limelight and at the forefront of family law practitioners who strives to influence what could be a bias resolution of these military retirement issues.

Mr. Gene D. Simes and Mr. Jere Beery find themselves in a precarious situation, as Mr. Willick has made it clear though his own words that he is going after them with the intent of publicly embarrassing them before a jury trial and hopes to get a "large judgment against them, their associates, and their heirs". Then he can see how much of this "judgment will be enforceable, one way or the other", if it gets to that phase, and the best that these two disabled veterans can hope is to find legal cover adequate to evade the judgment – while earning the reputation of a judgment-evading deadbeat.

These two highly decorated combat disabled Vietnam veterans are advocates who seek to preserve veterans' disability benefits awarded to injured soldiers. Both feel that this lawsuit is about trying to silence them for being out spoken on this politically charged debate. For one year and a half they have stood firm on their contention that Mr. Willick used hate speech to maliciously

incite an emotional reactions from veterans groups that sparked a series of publications written by Mr. Beery (a freelance writer) through Veterans Today, an online media source.

The outcome of this trial depends on whether they can find an attorney to represent them. According to Mr. Simes and Mr. Beery when they contacted the Nevada Legal Aide, it declined to represent them because attorney Willick sits on their board of directors, thus presenting a conflict of interest. This case could have a rippling effect on whether state courts will be able to court-order garnishment of veterans' disability compensation to settle any type of civil cases, contrary to federal laws. If Mr. Willick prevails, it could set a dangerous precedence that might jeopardize congressional protection of veterans' disability compensation, which dates back to early American revolutionary history.

### BofA Merrill Lynch Fund Manager Survey Finds Ongoing Rise in Optimism for 2014 Growth



#### **Rising Overvaluations No Bar to Overweighting Equities**

Investors start 2014 more optimistic about global growth prospects, especially for the U.S. but increasingly for Europe as well, according to the BofA Merrill Lynch Fund Manager Survey for January.

The proportion of investors who believe the global economy will strengthen this year has risen to a net 75 percent from a net 71 percent in December, continuing a trend of rising optimism that started in late 2012.

This optimism is reflected in rising expectations for corporate profits with a net 48 percent looking for an improvement, up from a net 41 percent in December. Among the regions, a net 29 percent of investors choose both the U.S. and Japan with the most favorable prospects for profits. Europe has improved to a net 8 percent expecting profit improvement from a net 4 percent expecting deterioration in the December survey.

As investors' growth convictions rise, investors' preference for Global Equities remains strong. A net 55 percent say they're overweight equities, continuing a trend which started in mid-2012 when a net 4 percent were underweight equities. Confidence in equities is maintained despite a net 7 percent of respondents believing equity markets are overvalued, the highest reading since 2000. The overvaluation view is driven predominantly by the views on U.S. equities where a net 72 percent say stocks are overvalued.

Global growth expectations also raised risk taking capacity. A net 4 percent of investors say they are undertaking a higher than normal level of risk in their portfolios, a near-record high. This rise in risk appetite is reflected in sector allocation where a net 42 percent of respondents are overweight in tech stocks, but a net 32 percent are underweight staples, the lowest in a decade.

"Until corporations reduce high cash levels, investors will run high cash levels and equity corrections will be extremely limited," said Michael Hartnett, chief investment strategist at BofA Merrill Lynch Global Research.

"Managers are positioned for a strong profit recovery in Europe, and the upcoming earnings season is key to maintaining this stance; given the high sentiment, any earnings disappointment will likely be punished by investors," said John Bilton, European investment strategist.

#### Demand for capex reach to record highs

Investors increasingly believe companies should be using their rising profits to grow their businesses – a net 67 percent believe companies are under-investing, a record high reading in the history of the survey. And when asked what companies should do with excess cash, 58 percent favored capex, while only 11 percent want cash preservation.

#### Global Emerging Markets remain a drag but stars align for Europe

Against the broader global background of rising optimism from growth and profits, Global Emerging Markets remain out of favor. A net 61 percent expect a sharp deterioration in profits in GEM equities, up from net 32 percent expecting the same in December.

Furthermore, investors believe the biggest "tail risk" to the global outlook is a China hard landing and commodity collapse – some 37 percent of investors take this view, compared with the 14 percent given to each of the EU sovereign/banking crisis and a geopolitical crisis.

As for Europe, a net 22 percent believe equities in the region are under-valued up from net 15 percent expecting the same last month. On a 12-month view, when asked which equities they would most like to overweight, investors picked Europe with a net 34 percent, the second-highest reading in the history of the survey.

Likewise, for the same timeframe, only Japan scored a positive with a net 12 percent would like to overweight, while a net 13 percent and a net 28 percent expect to underweight U.S. and GEM equities respectively.

#### Risk-taking near historic high

Risk-taking by investors is near historic highs. A net 4 percent of investors say they are taking higher-than-normal risks. That's up from a net zero percent in December and a net -4 in November. Since the start of this survey this figure has been solidly positive on only three previous occasions.

This appetite for risk is also reflected in investors' preferred sectors – Tech, Industrials and Banks top their overweight lists while Utilities, Staples and Telecoms languish in underweight territory.

#### **Fund Manager Survey**

An overall total of 234 panelists with US\$653 billion of assets under management participated in the survey from 10 January to 16 January 2014. A total of 185 managers, managing US\$524 billion, participated in the global survey. A total of 115 managers, managing US\$248 billion, participated in the regional surveys. The survey was conducted by BofA Merrill Lynch Research with the help of market research company TNS. Through its international network in more than 50 countries, TNS provides market information services in over 80 countries to national and multi-national organizations. It is ranked as the fourth-largest market information group in the world.

## Fairness in Lending

### Consumer Financial Protection Bureau To Hold Auto Lenders Accountable For Illegal, Discriminatory Markup

The Consumer Financial Protection Bureau (CFPB) released a bulletin explaining that certain lenders that offer auto loans through dealerships are responsible for unlawful, discriminatory pricing. Potentially discriminatory markups in auto lending may result in tens of millions of dollars in consumer harm each year, and the bulletin provides clear guidance to indirect auto lenders within the CFPB's jurisdiction on how to address fair lending risk.

#### Auto Loans by the Numbers

- \$783 billion: approximate amount of outstanding auto loan debt in 2012
- 15.7 million: estimated total number of consumer auto loan originations in 2012
- 3rd: auto loans are the third largest source of outstanding household debt after mortgages and student loans

#### Overview

When consumers purchase an automobile, they may receive financing from an auto dealership rather than directly from a financial institution, a practice known as "indirect auto lending." In this process, the dealer often facilitates indirect financing through a third party lender, such as a bank, credit union, or other financial institution and the lender provides the dealer with an interest rate that the lender will accept for a given consumer.

Often, indirect auto lenders allow the dealer to charge the consumer an interest rate that is costlier for the consumer than the rate the lender gave the dealer. This increase in rate is typically called "dealer markup." The lender shares part of the revenue from that increased interest rate with the dealer.

#### **Impact**

Interest rate markups generate compensation for dealers while giving them the discretion to charge consumers different rates regardless of consumer creditworthiness. Pricing differentials based on creditworthiness and collateral are already factored into the rate offered to the dealer by the lender. Lender policies that provide dealers with this type of discretion increase the risk of pricing disparities among consumers based on race, national origin, and potentially other prohibited bases. Research indicates that markup practices may lead to African Americans and Hispanics being charged higher markups than other, similarly situated, white consumers.

#### **Today's Bulletin**

The CFPB has authority to examine large banks, and credit unions – and their affiliates – that have assets over \$10 billion. The CFPB supervises more than 150 of the nation's largest financial institutions. The CFPB also has enforcement jurisdiction over many types of lenders. The Equal Credit Opportunity Act (ECOA) makes it illegal for a credit tor to discriminate in any aspect of a credit transaction on bases including race, color, religion, national origin, sex, marital status, and age. Today's bulletin provides guidance for indirect auto lenders within the CFPB's jurisdiction on ways to limit fair lending risk under the ECOA.

The CFPB recommends that indirect auto lenders take steps to ensure that they are operating in compliance with fair lending laws as applied to dealer markup and compensation policies. These steps may include, but are not limited to:

- Imposing controls on dealer markup, or otherwise revising dealer markup policies;
- Monitoring and addressing the effects of markup policies as part of a robust fair lending compliance program;
- Eliminating dealer discretion to mark up buy rates, and fairly compensating dealers using a different mechanism that does not result in discrimination, such as flat fees per transaction

Let me tell you a common story I hear. It starts with a woman in 2005 or 2006 who took out a mortgage to buy her first home. After two years, her teaser interest rate expired. Her monthly payments doubled so she could no longer afford them.

When she sought help from her lender, she found that a different company, a mortgage servicer, was handling the loan. When she tried to contact the servicer to figure out a way to save her home, she got passed from one representative to another, each giving conflicting information about her options. She sent in the same paperwork multiple times. Finally, she thought her application for a loan modification was being considered, but before she heard anything further, her home was in foreclosure.

#### **Ending the broken system**

This happened again and again, all across the country. But this broken system ends Friday, when the Consumer Financial Protection Bureau's new rules take effect. The common-sense rules for banks and other mortgage companies do two main things: ensure that consumers are sold only mortgages they can actually afford to repay, and make sure consumers are not hit with surprises or given the runaround if they have problems paying their mortgage and are trying to avoid foreclosure.

Under the new rules, lenders must determine that borrowers can afford a mortgage before making the loan. Of course, mortgage lenders do not have a crystal ball: They cannot predict layoffs and health problems. But they must look at a consumer's income and assets, along with debt, and weigh this against the long-term monthly payments — not just a teaser rate. This back-to-basics approach is the very foundation of responsible lending. But in the lead-up to the financial crisis, it often did not happen.

For people who already have mortgages and are making payments, the new rules will act as a backstop. Mortgage servicers have to clean up their act by promptly crediting payments, tracking paperwork accurately and responding directly to consumers. If you fall behind on your mortgage, your servicer will now be required to reach out to see whether you need help. If you apply for a

loan modification, it will have to process your application and pro-

vide you with any help available.

#### Never again

Most important, these new rules put in place safeguards to help make sure the great mortgage meltdown never happens again. It wrecked our economy and did untold damage to millions of Americans. These rules will ensure that the past will not repeat itself.

There is a lot of misinformation out there about these rules. Our rules do not dictate who can and cannot get a mortgage. Lenders can make a loan to anyone as long as they reasonably determine that the consumer is in a position to repay. Down payments are still entirely up to the lender and home buyer. And we are not requiring loads of red tape: Lenders will likely ask a potential home buyer for proof of things such as income or assets — the kinds of things responsible lenders like our good community banks and credit unions have been asking for all along.

In the end, our new mortgage rules put behind us the irresponsible lending that disrupted the housing market and upended our economy. And they protect all homeowners against subpar mortgage servicers not doing their jobs. Americans deserve these basic protections.
