# **Bonding Education Program Kicks Off in Washington, DC**

On Thursday, October 17, the District of Columbia (DC) Bonding Education Program (BEP) kicked off at the DC Citywide Conference Center. The United States Department of Transportation's (USDOT) Office of Small and Disadvantage Business Utilization (OSDBU) in partnership with The Surety & Fidelity Association of America (SFAA) launched the DC BEP. The BEP is a hands-on, multi-component program designed to address the needs of the small disadvantaged business community in order to help the community become bond-ready, increase capacity, and ultimately compete for and participate on transportation-related contracts.

The federal transportation projects forecast is monumental in DC's Metropolitan Region. With upcoming projects such as the \$1.7 billion Dulles Metro Rail, \$900 million South Capitol Corridor, or \$1.2 billion Purple Line, OSDBU is offering the DC Region its first ever BEP.

Special to the DC's Metropolitan Region, this BEP is the first nationally that will convey a methodology consisting of cross mode communication, resource sharing, and connecting technical resources to transporta-

# **Debate:** Should The U.S. Break Up Big Banks?

### Too big to fail.

Those four words loomed large in 2008, as a crisis in the banking world threatened the global economy. Fears that the failure of large financial institutions would undermine the entire economic system led Congress to step in, passing a \$700 billion bailout package.

In the bailout's aftermath, Congress passed new financial regulations aimed at reducing the chances that it would happen again. But there's widespread concern that the nation's largest banks are still too big to fail — and that taxpayer money would have to come to the rescue in the event of another crisis.

Some argue that the way to solve the problem is to break up those banks — to put limits on the size of their operations.

But others say the new regulations have made the system safer, and that big banks are necessary to serve the needs of a global economy.

Four experts recently faced off on this question in an Oxford-style debate for the Intelligence Squared U.S. series. They argued two against two on the motion, "Break Up The Big Banks."

Before the debate, the audience at New York City's Kaufman Center voted 37 percent in favor of the motion and 19 percent against. Forty-four percent were undecided. After the debate, 49 percent supported breaking up big banks — an increase of 12 percentage points — and 39 percent opposed — an increase of 20 points. That made the side arguing against breaking up the banks the winners of the debate.

# Vets deserve better than VA's practice of rewarding failure

The Department of Veterans Affairs has received a lot of negative attention lately for failing to adequately deliver the care and benefits America promised our veterans.

In addition to the department's massive disability-benefits backlog, a disturbing pattern of preventable veteran deaths and other

patient-safety issues has emerged at VA hospitals around the country.

Sadly, the department's widespread and systemic lack of accountability may be encouraging more veteran suffering instead of preventing it.

Examples of the department's lack of accountability are numerous. But almost as plentiful — and even more shameful — are the many cases where VA employees and executives are being rewarded rather than punished for their incompetence.

Officials with the VA Pittsburgh Healthcare System have botched the handling of a deadly Legionnaires' disease outbreak at nearly every turn. Five veterans are now dead from the pneumonialike disease. But instead of giving those who failed to prevent the outbreak pink slips, VA gave them glowing performance reviews and huge bonuses.

According to the Centers for Disease Control and Prevention, up to 21 veterans were sickened between February 2011 and November 2012, but that didn't stop VA Pittsburgh Director Terry Gerigk Wolf from receiving the highest possible score on a VA performance review covering the bulk of the outbreak period.

Shockingly, Wolf's review makes no mention of the outbreak, and instead praises her for leading a "groundbreaking Civility Initiative" and helping improve her employees' resumewriting skills.

Memories of the outbreak seem to have eluded VA officials again when they nominated Wolf's boss, VA regional director Michael Moreland, for the Presidential Rank Award, America's highest civil-service accolade. For Moreland, the honor included a whopping \$62,895 bonus, which he formally accepted just three days after VA's inspector general reported VA Pittsburgh's response to the outbreak was plagued by persistent mismanagement.

Most people would find VA's celebration of Wolf and Moreland in the aftermath of a deadly outbreak they were too incompetent to stop hard to believe. Yet the situation is routine at the department, where failing executives have been collecting massive bonuses for years. Recent examples include the following:

A VA executive in charge of the nearly 60 offices that process disability benefits compensation claims collected almost \$60,000 in bonuses while overseeing a near seven-fold increase in backlogged claims.

A VA health official in New York pocketed nearly \$26,000 in bonuses while presiding over chronic misuse of insulin pens that potentially exposed hundreds of veterans to blood-borne illnesses.

Two April VA inspector-general reports identified serious instances of mismanagement





# Over 50 and Ready to Start a Business? Free Resources To Inspire You to Make it Happen

Over 50 and thinking of starting your own business? Looking for real-world, actionable information to start your own business?

Entrepreneurs over the age of 50 are one of the fastest growing groups of new business owners. Perhaps you are looking to turn a hobby into a business and finally have the resources to oso. Or you want the flexibility or supplemental income that running a business or being your own boss affords. With a lifetime of experience, skills and connections under your belt, why not?

### Making it Happen

Take, for example, Portland-based husband-and-wife team Dave Faul and Sandra Yates, who started Wash n' Roll Pet Grooming business after more than 25 years of employment in the women's apparel and real estate industries respectively. Both Faul and Yates were animal lovers, but when Faul suggested that they start a business washing dogs and cats in a van parked a client's curbs, Yates said, "Thinking he was nuts was an understatement." However, after three years in business, Wash n' Roll has expanded to two vans and serves the entire Portland metropolitan area.

Faul began research for a new business when he realized his job could evaporate in a corporate merger or store closure. He learned that the U.S. has a \$30 billion pet industry. He also looked at who spends a lot of those dollars. "The baby boomers, whose children are getting older or who are empty-nesters, are willing to spend money on keeping their fur kids happy," he said.

Sounds a common enough business venture, but mobile pet groomers weren't prevalent in the Northwest at the time. Faul attended a pet grooming school in Albany for six months, and Yates wrote a business plan.

In need of funding, they approached local bankers who said the business had to operate for two or three years before they could get a business loan; instead, the couple paid their own startup costs. They also received assistance from SCORE. SCORE members volunteer as counselors for small entrepreneurs. "They were really helpful," Yates said, "and it was surprising that it was all free."

Growing mostly by word of mouth, the business now has three part-time and three full-time employees.

### More Nuggets of Wisdom

Other entrepreneurs who have found success at 50+ talked to AARP and offered the following useful tips for aspiring encore entrepreneurs:

"Find a business mentor. I went to SCORE. Having a good mentor helps you cut through the BS. They will tell you like it is. Do you have a good idea? Will your concept work? Once you're 50, you don't want to waste your time." Annemarie du LeBohn, 51, launched a motivational speak-



ing business after a former career in corporate marketing.

"Develop your team, people who will help you take your business where you want it to go. For me, it's my business coach, website support and others. Take the risk and have fun. Unlike during my younger years when I wanted to prove myself and was driven to 'be successful,' this time around it's about leaving a legacy and pursuing dreams. It's about incorporating my business and retirement goals with my personal values." Barbara Hyatte Boustead, 61, a licensed clinical social worker for 37 years, runs Mary's Daughter to provide daily money management services to older adults and veterans.

"Know your product and know how to sell it. If you are familiar with the saying, 'selling ice to Eskimos,' you will be aware of the necessity as an entrepreneur to develop good salesmanship. You must develop the ability to sell, or better put, to convince people to buy. Also, think carefully about how to market your product, and be 100-percent confident about the merit of your product or service. My long career in the arts taught me one important lesson: if the main door is shut, look for the side or back door. They always exist and are much less guarded." Yuval Zaliouk, 74, a former orchestral conductor, who at age 50, (while still conducting) started Almondina Cookies, an online cookie business.

### FOR THE MOTION

Richard W. Fisher is the president and CEO of the Federal Reserve Bank of Dallas. In this role, Fisher serves as a member of the Federal Open Market Committee, the Federal Reserve's principal monetary policymaking group. He is a former vice chairman of Kissinger McLarty Associates, a strategic advisory firm chaired by former Secretary of State Henry Kissinger. Fisher began his career at the private bank of Brown Brothers Harriman & Co. and later became assistant to the secretary of the Treasury during the Carter administration, working on issues related to the dollar crisis of 1978-79. He returned to Brown Brothers to found their Texas operations in Dallas and, in 1987, created Fisher Capital Management and a separate funds-management firm, Fisher Ewing Partners. From 1997 to 2001, Fisher was the deputy U.S. trade representative with the rank of ambassador.

Simon Johnson is the Ronald A. Kurtz professor of entrepreneurship at MIT's Sloan School of Management. He is a senior fellow at the Peterson Institute for International Economics, a cofounder of BaselineScenario.com, a member of the Congressional Budget Office's Panel of Economic Advisers, and a member of the FDIC's Systemic Resolution Advisery Committee. He is also a member of the private sector Systemic Risk Council, founded by Sheila Bair. He is a regular contributor to The New York Times' Economix, Project Syndicate and Bloomberg. He is also a contributing business editor at The Huffington Post. Johnson is the co-author of 13 Bankers: The Wall Street Takeover and the Next Financial Meltdown (2011) and White House Burning: Our National Debt and Why It Matters to You (2013). From April 2007 through August 2008, Johnson was the chief economist at the International Monetary Fund.

### AGAINST THE MOTION

Douglas Elliott is a fellow in economic studies at the Brookings Institution. A financial institutions investment banker for two decades, principally at J.P. Morgan, he was the founder and principal researcher for the Center on Federal Financial Institutions, a think tank devoted to the analysis of federal lending and insurance activities. At Brookings, he focuses primarily on financial institutions and markets and their regulation. at the Atlanta VA Medical Center that led to the drug-overdose deaths of two patients and the suicide of another. True to form, VA doled out nearly \$65,000 in performance bonuses to the medical-center director who presided over the negligence.

In early May, I spent the day at the Atlanta VAMC, along with several members of Georgia's congressional delegation. Hospital officials told us that although they had identified specific employees whose actions had contributed to patient deaths, no one had been fired.

When I asked a roomful of Atlanta VAMC leaders if there were any other serious patientcare incidents Congress needed to know about, they said no, failing to reveal a previously unreported suicide the media would expose just four days later.

This alarming pattern of complacency has cast a dark shadow over VA medical centers around the country. For months, Congress has tried in vain to compel VA leaders to take meaningful steps to prevent deaths and adverse incidents. Unfortunately, department officials seem more intent on protecting and rewarding VA's worst-performing employees than sending a powerful message that substandard care for veterans will not be tolerated.

Our veterans deserve better. For VA's quality of care to improve, department officials must be willing to hold accountable anyone responsible for letting patients fall through the cracks. Rewarding failure will not help VA better serve those who served our country. It will only lead to more delays and more dead American heroes.

# How to Estimate the Cost of Starting a Business from Scratch

### by Caron Beesley



### How much does it cost to start your own business?

Of course, the answer depends on your business model and your chosen industry. However, a useful estimate based on a 2009 study conducted by the Ewing Marion Kauffman Foundation puts the average cost of starting a new business from scratch at just over \$30,000.

Many small businesses, particularly freelance, online and home-based businesses come in a lot lower than this, often needing only a few thousand to get started.

But averages aside, what can you do to calculate your specific startup costs? Read on.

### Understand the Types of Costs a Startup Will Incur

Before you do any estimating it's important to understand how startup costs are categorized. All startup costs (meaning the period before you start generating income) include two kinds of spending: expenses and assets.

- 1. Expenses These are the costs for operations that occur during the startup phase, although they will continue throughout the life of the business. Startup expenses include deductible items such as travel, payroll, rent, office supplies, marketing materials, etc. Expenses also include initial organizational costs like legal fees, state incorporation fees, etc. You can write off up to \$5,000 in business startup costs and another \$5,000 in organizational expenses in the year that you start a business.
- 2. Assets Also known as capital expenses or expenditures, these are the one-time costs of buying assets such as inventory, property, vehicles, or equipment as well as making upfront payments for security deposits. These startup assets don't usually qualify for deduction, however, some can be written off through depreciation at tax time.

You can read more about the difference between these two and why it's important to keep good expense records in SBA's Small Business Expenses and Tax Deduction Guide.

### Define What You Need to Spend Money On

To estimate your startup costs, start by creating two lists – one for your startup expenses and one for your assets. Your list should be informed by the aspects of your business that will have costs associated during the startup phase, such as facility improvements or the equipment and inventory you need. But don't forget to consider items such as brochures, business cards, and website development costs or any security deposits you need to make. Do you need the help of a consultant, tax advisor or lawyer to help you get started?

Next, categorize these items as essential or optional – do you really need to spend money on these before you start making any kind of income?

### Assign Costs

Now we come to crunch time – assigning costs to your startup "to do" list. This process is always going to be a best

guess, but be realistic and use past experience, research, and advice from other entrepreneurs to guide your cost estimates. Organizations such as SCORE and your local Small Business Development Center can provide free and valuable advice about how to calculate your startup costs.

If you use a smartphone, another option that you might find useful is the SBA Mobile App which includes a handy tool for calculating startup costs.

Whatever you do, don't underestimate your costs, or try to force your costs to fit the amount of money you have available. If the costs are too high, consider another approach to starting a business.

- · Could you run a home-based business?
- Instead of buying inventory upfront could you have manufacturers drop ship?
- · Could you subcontract rather than hire employees?
- What about buying surplus office equipment and furniture from the government at or below cost?

### It's All in the Timing

Remember, as mentioned above, startup costs are accrued before you have income to supplement your business. So develop your budget with this in mind. For example, startup expenses such as rent and payroll are only that until your business is operational, once you reach that point they become running expenses that you take out of your profits as deductible against your taxable income. So you may want to delay some of your depreciable costs until your business is up and running.

tasks and to direct others. This means you need the ability to break big ideas into easy, actionable steps for implementation. Big ideas are a dime a dozen. Knowing how to implement them is the game changer.

### #4 You don't believe in marketing.

Marketing makes the business world go round. If you don't believe it and embrace it, you'll never succeed. Be ready to dedicate effort and a decent budget to the task of marketing your company. And give your marketing time to work using a variety of mediums. There's no silver bullet.

### #3 You're easily winded.

Once you get past the adrenaline rush of starting your own business, you'll encounter a portion of the journey called the "middle mile." Frankly, the middle mile is where you face challenge and drudgery. Your feet will hurt and your breathing will be labored. Despite these inconveniences, you must place one foot in front of the other and press on.

### #2 You're a problem passer.

In business, there are problems that must be decisively resolved by the owner. Sometimes customers and employees will be unhappy with your decisions and that's OK. Successful entrepreneurs never postpone difficult choices.

### #1 You're on the quest for quick cash.

Profit is the result of productive business. It is not WHY you are in business. You are in business to solve problems and to serve others. If you find a way to deliver a better solution or service than your competitors, you will make plenty of money. But it doesn't happen overnight. If you want to make quick cash, business ownership may not be the right gig for you.

As the above pitfalls exemplify, starting a business isn't easy, and it certainly isn't glamorous. But, it can be extraordinarily worthwhile and satisfying. If any of the 10 warning signs above DON'T give you pause, you just may be a good entrepreneurial candidate.

# Kudos to the CBC Foundation, Inc.

In a recent article I posed the question, "Hey, Chocolate City, where da money at?" Well, the CBCF gave a resounding answer to that inquiry on Tuesday, Sept. 17.

Starting a new campaign to strengthen the economy in Black communities, the organization, under the leadership of Board Chairman, Congressman Chaka Fatah, D-PA, announced it would invest \$5 million with Black banks, "as part of a broader effort to increase the availability of loans for businesses and individuals in African-American communities." I applaud the CBCF for this initiative; it is a great example of how we can leverage the dollars over which we have control and stewardship.

Congratulations to the leadership group: A. Shuanise Washington, President and CEO, Congressional Black Caucus Foundation; Michael Grant, President, National Bankers Association; B. Doyle Mitchell, Jr., Board Chair, National Bankers Association and President, Industrial Bank; Russell Kashian, Professor, Department of Economics, University of Wisconsin Whitewater; and Ron Busby, Sr., CEO, U.S. Black

The CBCF said here's our money, and our members are doing the right thing with it.

"I commend the CBCF for its initiative and commitment to launch what could – and should be – a movement across this nation," said Grant of the NBA. "They initiated this effort without being prodded, begged, or persuaded. They did it of their own volition and understanding of how this economy works, as well as the very important aspect of building businesses and strengthening the asset base of Black owned banks. We cannot thank them enough."

Of course, after my kudos come my questions. As commendable as the actions of the CBCF are, they do bring forth questions in my mind regarding other institutions, organizations, and associations. I want to start with the NAACP because Ben Jealous recently announced his resignation, and while doing so lauded the organization's tremendous increase in fundraising under his leadership. Under Jealous, the donor base grew

from 16,422 in 2007, just before he started, to 132,543 last year. Revenue has grown from \$25.7 million in 2008 to \$46 million in 2012, according to him.

As we know, \$46 million is a lot of money. How much is deposited or invested in Black banks? With both Harbor Bank and Industrial Bank in the immediate vicinity of NAACP's national headquarters, I hope most, if not all, of those funds are already nestled away and doing great work in those two fine Black banks. The CBCF had \$5 million and they did the right thing with it. Has the NAACP done the same with its \$46 mil-

Hey, Marc Morial and the National Urban League, you're next. Where is your money? How many millions do you control? Any Black banks listed on your financial statements? I know there must be, in light of the fact that you work hard to establish new businesses and create more jobs. Surely the CBCF has nothing on you, right? This is not a trivial or unimportant question. Here in my hometown, in 1996-99, a Black-owned credit union was started just across the street from our local Urban League office building. Although asked to do so, the Urban League did not have an account at the credit union. I know this is 2013 and we are much more enlightened and conscious nowadays, but "I'm just saying," you know?

All right Al Sharpton, you're up next. How many millions does the National Action Network (NAN) have in Black-owned banks? With your clarion call for, "Jobs! Jobs!" surely NAN has taken the economically positive step of keeping its funds in banks that can help create those much needed jobs. I know your thing is politics, but politics is supported, guided, and controlled by economics, so I have no doubt that you have already carved out a niche in a Black bank and allowed your money to good work for our people.

Oh, I am running out of space. So what about the rest of our Black organizations? Rainbow PUSH Coalition, SCLC, Masons, Shriners, fraternities, sororities, social clubs, Links, Black entertainers, Black rappers, Black athletes, Black business owners? Are you even considering putting some of your millions into Black banks? Between Jay-Z and P. Diddy, who recently talked about losing a million dollars to another rapper, that's a few hun-

dred million right there. Add LeBron, Kobe, Tiger, Serena, and Venus; what an impact they could make on a Black bank balance sheet. Get the picture?

Finally, Black churches, where is your money? Is any of it sitting in a Black bank? Churches that are domiciled in cities where Black banks exist should all have accounts at those banks/ and or credit unions. Can you hear me talking, Durham, N.C., where the oldest Black bank resides? There is also Internet banking; not denying the importance of a local bank relationship, but some church funds could be invested in an out-of-town bank

This is too easy, brothers and sisters, and it's all about a Biblical principle: Good stewardship. It's now time for the altar call. Let the Black church say, Amen!
