6 Leaders in Construction Share Priority Data Skills to Plan for Now

Picture this. Project setbacks are no longer something to dread, instead, you're able to navigate them with ease. Your project is on track and your entire workforce, from jobsite managers to executives in the office, are seamlessly sharing real-time data—and making great decisions because of it. Every phase of construction is on time and on budget. Sounds like a dream, right? You might be surprised to learn that this dreamscape is closer to reality than you think.

So, what holds so many construction firms back from achieving this possibility? Harnessing the Data Advantage in Construction, a global industry report made in partnership between Autodesk and FMI, uncovers some answers to this pertinent question.

According to our research, over \$1.8 trillion in global construction waste may be caused due to bad data. The root of this problem is largely associated with deficiencies in the quality of data you make decisions from. In turn, this issue begs some important questions directly related to how skilled your workforce is in leveraging the plethora of data points.

As a leader or manager, ask yourself:

- 1. What kind of skills are needed to make sure my teams keep up with industry tech?
- 2. Should I be investing in my teams' data and tech skills? What does that look like?
- 3. What roles should I expect to fill as construction becomes more data-driven?

To help answer these questions, we spoke with several respected technology leaders in construction. They shared their thoughts on the importance of workforce upskilling and tips for embracing the data-driven world of construction. What we found was a range of ideas for getting more value from your data, how to properly govern data, and suggestions for fostering a data-first culture. Read on for their insights.

Data skills with high value

The volume of construction data has doubled in the last three years according to our research in the data strategy report mentioned above. We asked, "What data management or analytical skills do you think will be most important in the future of the construction industry?"

Understanding the value of data in decision-making

"In general, every person should understand the value of data and data-driven decision-making. This might include how to think about

what data is important for evaluating a particular business process or problem area, effective ways to visualize data, and even applying basic statistics concepts like correlations and standard deviations."

"Robust data collections and a single source of truth are critical for a successful project. The data needs to be timely and accurate. Users should be able to trust the

data. In addition to this, the data entries need to be automated. People should not have to enter the same data in multiple systems."

Knowing how to use new analytic technology

"Do not rely on the age-old reporting that your system is currently generating. Ask new questions about how

jobs perform. Ask questions about how teams and different combinations of teams, project types, and clients all interact. Start leveraging new analytic technology to tell you where it sees issues in your business and go from there. If you just stick to the same report you have always used, you won't see the value of the gold mine you are sitting on."

Entrepreneurs making inspired strides to galvanize, empower & bolster underrepresented young Latino business owners; Annual 'LatinX Travel Summit' convenes businesses and professionals in the fields of travel, music, tech, media, and health and wellness to drive awareness, visibility, networking, mentorship, resources and other support opportunities for young Latino entrepreneurs and Latin American-focused companies at large

What started out as two socially-minded entrepreneur's idea to foster, promote and highlight the beauty, power and diversity of young Latino entrepreneurs has blossomed into a bona fide movement—one that's capturing the hearts and minds of some of the world's leading multinational brands

When best friends Michael Watson and Pablo Segarra, both of Puerto Rican descent, were growing up together in the Bronx, New York, zation helping Latino Gen X and Gen Z professionals establish closer ties with each other and their origins through travel, tech, music and other cultural platforms. This is exactly what Watson, a former Global Director of a Fortune 500 company, and Segarra, a retired New York City police officer, have accomplished amid long-standing careers advocating for the Latin American and Caribbean community and culture and, more specifically, going over-and-above to advance young Latino entrepreneurship. This lamenting that, despite representing a significant sector of the U.S. population, this group of professionals disproportionally represents less than 5% of the U.S. population although the majority of Hispanics in the nation—a full 61%—are Millennials according to the Pew Research Center.

Case in point is Watson's current endeavor as CEO of Ventyour Inc.—the holdings company of the LatinX Travel Club young Latino entrepreneurship advocacy organization that he cofounded with Segarra. Despite their strength in

numbers, it has been well-reported that Hispanic Millennial small business owners face unfortunate challenges that are "unique to their age and cultural demographic groups" like staffing, scaling, accessing capital and lack of opportunity-creating personal contacts or relationships.

Also underscoring the disparities for this group is a Guidant Financial Millennials in Business study finding that only a quarter of Millennial small business owners are Hispanic—18% of which represented by Gen X specifically—which further fractionalizes down those owned by the Gen Z set, Hispanic women and other sub-groups therein. Also revealing from The Deloitte Global 2021 Millennial and Gen Z Survey is that a full 20%-one in five Millennials overall—feel discriminated against all of the time, or frequently, because of an aspect of their background. Further to that point, this survey also exposed that a majority of Millennials and Gen Zs believe we are at a tipping point on key societal issues to include inequality and discrimination.

LA County Introduces New LGBTQQ+ Certification for Small Businesses Seeking County Contracts

The County of Los Angeles is introducing a new certification status to enhance our Community Business Enterprise (CBE) program. The LG-BTQQ+ certification creates a new pathway for businesses owned by Lesbian, Gay, Bisexual, Transgender, Queer, and Questioning individuals to engage in County procurement opportunities. It is essential that County dollars are reinvested in our diverse business community that were most impacted by the pandemic. Through this and similar initiatives we ensure that County procurement becomes a tool to grow and support businesses throughout our recovery and beyond.

The LGBTQQ+ certification is the latest addition to the CBE, which helps ensure that businesses owned and controlled by economically and socially disadvantaged individuals are engaged in opportunities to compete for County contracts. The County's CBE Participation Goal for County Contracts establishes more inclusive practices into contracting and purchasing, setting a 25-percent participation goal for CBE-certified yendors.

To be eligible for LGBTQQ+ certification, a business must be 51 percent owned and controlled by at least one or more LGBTQQ individuals. They must also have an active certification with the National LGBTQ Chamber of Commerce or through the Supplier Clearinghouse as authorized through the California Public Utilities Commission (CPUC).

"The County wants to improve access to County contracts for LGBTQ-owned businesses. We want to make sure that public resources are fairly allocated as a part of helping to strengthen historically disadvantaged communities," said Supervisor Sheila Kuehl. "LA County stands for inclusion and equity in its contracting, including our vibrant LGBTQ communities."

"I am committed to ensuring that inclusive and culturally competent practices are integrated into all County contracting and procurement policies," said Chair Hilda L. Solis. "This is particularly important during the COVID-19 pandemic because of the impact on LGBTQQ and minority-owned businesses. I hope this initiative will further move the County toward true equity in contracting. It's long overdue."

"This is an important and necessary step toward a more inclusive LA County," said Supervisor Holly J. Mitchell. "From our procurement process to the direct services we provide, our commitment to acceptance, equity, and doing what's right must be unwavering. It's imperative that we have suppliers as diverse as the residents we serve."

"LA County is the most diverse county in the nation and our small businesses reflect that," said Supervisor Janice Hahn. "The CBE makes sure at least a quarter of our County contracts goes to diverse small businesses, including those owned by people of color and women. One group we were previously missing was our LGBTQ+ owned small businesses. That is why our Board of Supervisors recently voted to ensure these businesses would qualify for this important program."

"Diversity strengthens our business community," said Supervisor Kathryn Barger. "This initiative reiterates the Board of Supervisors' commitment to inclusivity and equity for all aspects of County service. LGBTQQ businesses bring creativity and ingenuity to the marketplace. As we revitalize our local economy, these businesses will play an important role in our path forward."

"Our department is committed to help entrepreneurs and small business owners find success through County contracting," said Rafael Carbajal, Director of the LA County Department of Consumer and Business Affairs. "We look forward to serving more LGBTQQ+ owned businesses through the Office of Small Business and helping them get connected to new opportunities in LA County."

"As we dive deeper into data, having governance and policies associated with how data is collected, used, and shared, is crucial. Doing so involves

the hiring of IT personnel with data analytics/architecture backgrounds to help wrangle the data. This is step one; without consistency, data is useless, and without governance, the associated risk is exponential."

Why and how to invest in data skills

Investing in skill development can help ensure your team is equipped to manage current and future challenges. Knowing where to start is often the hardest part. We asked, "Do you think construction companies should be investing in skill development (such as data management and analysis) to equip their workforce for the future? If so, where do you think firms should start?"

"We can start by understanding our current development plans and how we can provide simple introductory lessons. These lessons will help weed out the people that do not value these processes and empower the ones who do with more refined and developed courses. There are various ways to empower through education, whether it's through local university data analytics courses, solution-specific courses (from providers like mondoDB or PowerBI), or advanced certifications courses (from solutions such as Udemy, Codecademy, or various other certification courses). Education is key to being a highly functional and top-performing company."

Begin with a data strategy

"Companies should establish a data strategy and set goals, and work toward a data culture in the organization. That part is critical for becoming a data-driven company. Once the data strategy is established, the roles within data can be identified. As each organization works differently, the roles may have to be customized to suit the needs."

Support high-level B.I. and analytics training

"I think [companies] should be hiring people specifically for these roles. We should be investing in some high-level training for our project teams on the importance of good data collection as well as placing controls into the systems we use to prevent bad data from being entered."

"We should expect to support a large percentage of our staff in basic business intelligence/analytics tools so that anyone can quickly develop

How to Get a Small Business Loan in 2021

Sometimes it takes money to make money. It's cheesy to say, but oh so true in the world of business. When you're running a small business, having extra cash on hand can really come in handy. Whether you want some startup funding to get the ball rolling or need a little help to cover payroll while overcoming a temporary challenge, a small business loan can help you get the job done. Let's dive into how to get a small business loan, where to find one, and what your alternatives may look like.

Where to get a small business loan

If you're not sure where to start when looking for a small business loan for the first time, there are a few different paths you can pursue. Small business loans are often available at banks and credit unions, as well as online lenders or alternative lenders. Each one of these sources may have different offerings and requirements, so let's take a look at what you can generally expect when dealing with each.

Banks and credit unions

The same financial institutions you do your personal banking at may have small business loans available. Of course, you can look outside your usual bank or credit union as well. However, if you're in good standing with your bank regarding your personal accounts, that can work in your favor when applying for a small business loan. Both banks and credit unions tend to serve larger and more established businesses. but that doesn't mean small businesses can't fit into those categories. Especially, if the bank or credit union has loans backed by the U.S. Small Business Association (SBA)—these are known as SBA loans. Loans backed by the SBA lower the risk for the lender, so it can make it easier for newer small businesses to take out a loan.

Online and alternative lenders

Nowadays, you don't have to stick to traditional financing methods. Online lenders and alternative lenders (like peer-to-peer lenders) can offer similar products as banks or credit unions, they just do so without offering in-person access to

customers. If you prefer to do your banking in person, an online lender may not be the best fit. However, a lot of online lenders offer more flexibility than brick-and-mortar banks, which can be a good fit when starting a new business. There are also peer-to-peer small business lenders that can be found online where you can connect with investors looking to support small businesses. Peer-to-peer lending typically has less stringent criteria than when working with a big bank or credit union, but because the risk level can be high for lenders, you may have higher interest rates than you would find with a traditional business loan.

Types of small business loans

There are a few types of small business loans that may be available to you. Each has their own unique benefits and downsides, so you'll need to think carefully about which type is best for your business.

Business line of credit

A business line of credit works similarly to a credit card and you can use it to make purchases

for your business such as stocking up on inventory or paying for ads. This form of credit comes with a maximum limit you can borrow and what's helpful is that if you don't borrow the full amount, you won't pay interest on any money not borrowed.

Business term loan

A business term loan provides borrowers with a lump sum, as well as a fixed term and repayment amount. Payment will include both interest and principal payments.

Invoice financing

Some small businesses struggle with cash flow while waiting for invoices to be paid. If this is an area you struggle with, invoice financing (also known as factoring) can help by allowing you to sell your unpaid invoices to a lender at a discounted rate.

This well-aligns with a "Diversity in Innovation" Working Paper by the Harvard Business School (HBS) that documents the patterns of labor market participation by gender and various ethnic minorities in venture capital firms and as founders of venture capital-backed startups. It found that, from 1990-2016, Hispanics had been around a mere 2% of the entrepreneurial and venture capital labor pool, despite the fact that the group had much higher representation in education programs that lead to careers in the sector. The HBS survey documented a systematic and persistent lack of Hispanic American labor market participation in the innovation sector—through both entrepreneurs and the venture capitalists that fund them. In addition to documenting this empirical regularity, it found this is not driven by a lack of supply of highly trained Hispanics having cited that the representation of Hispanics in MBA programs has been substantially higher than their representation in the venture capital and entrepreneurial sectors for the past two decades.

Overtly sensitive to the extent to which Gen X and Gen Z Latino entrepreneurs have felt marginalized—and amid a glaring lack of formal

California High-Speed Rail Authority Releases 2021 Sustainability Report



Mayor London Breed Announces Over \$12 Million in Funding for Arts Organizations

Mayor London N. Breed and City Administrator Carmen Chu announced over \$12 million in general operating support grants to fund arts and cultural organizations. This year's Grants for the Arts (GFTA) funding is primarily dedicated to the general operating support for arts organizations and also aims to support community parades and festivals to help restore the City's cultural vibrancy and drive its economic recovery.

"We know that the pandemic has been hard on all of us, but it has been especially difficult for our city's artists and cultural organizations," said Mayor Breed. "The arts are part of what makes San Francisco so special and create an inclusive atmosphere for all who live in and visit our city. During this critical time in our economic recovery, we need to do everything we can to bring back our community festivals that are loved by so many, and support those who contribute to our city's vibrant culture."

As president of the Board of Supervisors, Mayor Breed spearheaded Proposition E, which was passed by voters in 2018 and allocated 1.5% of hotel tax revenue to the arts. Due to the loss of hotel tax revenues brought on by the COVID-19 pandemic, Mayor Breed allocated funding from the General Fund to backfill losses during this year's budget cycle. Mayor Breed's budget for Fiscal Year 2021-2022 also includes \$12 million for GFTA to support arts organizations, as well as parades and festivals.

"Cultural festivals and arts have always been an essential part of San Francisco's vibrant community. They draw people to San Francisco, bring communities together, and in many ways, define our experiences here," said City Administrator Carmen Chu. "Supporting our arts organizations during these challenging times is key to our City's recovery."

The City Administrator manages GFTA, a program that has provided a stable and dependable source for general operating costs to support the City's arts and cultural organizations since 1961. Since its inception, GFTA has distributed over \$400 million to hundreds of arts non-profits and cultural organizations. GFTA funds over 250 arts organizations each fiscal year, including those organizing and supporting parades and festivals throughout the City.

Committed to serving San Francisco's diverse communities, this is the first year GFTA implemented a funding process that used a strong equity lens to focus on art organizations deeply rooted in and serving diverse populations.

"Having art and cultural events around every corner in the City is why people live here and it's why people from all over the world visit San Francisco. Art and culture is the soul of San Francisco," said Vallie Brown, Director of Grants for the Arts. "As San Francisco slowly comes out of our long COVID nap, it's vital that we support our arts organizations and our community's parades and festivals."

The Dream

When Ricardo Rocha was a teenager growing up in Mexico, he had a recurring dream. He dreamt that he had his own business and that he spoke a foreign language.

Years later, Ricardo immigrated to California and worked in many jobs, such as picking berries, construction, and landscaping. But his teenage dream stuck with him, and he knew he wanted to do something more with his life. He enrolled in night classes at Cabrillo College while he continued to work in the fields. It was there that he fell in love with computers.

Having found his passion, Ricardo decided to pursue a career in IT. He began selling computers and offering basic tech services from a small office in downtown Watsonville. But his business knowledge was limited, and he ran into a lot of barriers. Then he found El Pajaro CDC's Business Incubator Program at Plaza Vigil, where he opened RVS Technology Group's first retail space. They also provided him with business coaching and technical assistance.

Another challenge Ricardo faced was funding. Whether it was his language limitations or lack of a credit history, banks refused to give him a second look. But with the help of El Pajaro, Ricardo was able to secure a loan through the Santa Cruz Community Credit Union.

Surpassing Expectations

Today, RVS Technology Group employs 12 fulltime staff and operates with a payroll of over \$30,000. And Ricardo did more than succeed in his business – he created an entire industry that was previously nonexistent in Watsonville.

Ricardo's determination and unwillingness to give up in the face of adversity put him where he is today. But he also knows he couldn't have done it without support from his community, so he does his best to give back. RVS employs young local people who are just starting their careers in tech, providing them with good-paying jobs, highly sought-after skills, and growth opportunities.

Teri Beckett is the founder, President, and Chief Engineer of SKS Engineering and Planning, Inc. As a civil engineer, ocean engineer, and arborist leading a team of four, Teri works to ensure coastal construction projects are environmentally compliant.

Early in her career, Teri served as an environmental projects manager in Everglades overseeing manatee protection, seagrass planting and protection, and dredge projects. In the 135-year history of the Port Everglades project, Teri was its first woman engineer. She soon branched out from environmental engineering into ecological restoration, striking out on her own to "build swamps for a living."

But five years after founding the firm, she lost her business partner to cancer. Then, in

2008, Teri herself received a breast cancer diagnosis.

The most difficult decision

The week after completing her chemotherapy treatments and a week prior to her daughter beginning kindergarten, Teri—a Bay Area native—moved her family from Florida to California. Despite her years of engineering and restoration experience, Teri now had to re-establish the positive reputation she'd built in Florida.

Despite having four business and personal accounts with her bank, her banker couldn't offer her a loan. Instead, Teri's banker referred her to Opportunity Fund: "Opportunity Fund saved me, basically."

Amidst re-starting her business in the Bay Area, Teri found time to lend her expertise to Hurricane Sandy recovery. Over five months, she managed a team that rebuilt 700 homes, working 12 hours a day, seven days a week.

Now, having firmly established her business in the Bay Area, Teri is tackling a contract with the Port of San Francisco. She used her most recent Opportunity Fund loan to purchase a small boat to navigate her latest job site.

Throughout unexpected health and associated financial challenges, Teri has stayed fiercely loyal to her employees, her community, and her vision for her small business: "If I'm working for somebody else and I'm not kept busy, I'm miserably bored. But I will work 80 hours a week if it's mine."

But eventually, she was ready to expand her farming operations in order to move production in-house and add new products. That's when she knew she needed additional support. Monica found ICA after working with its partner, La Cocina. In 2020, Monica participated in ICA's flagship program for growth-stage companies, The Accelerator.

At the culminating pitch event, Monica impressed the judges – including ICA's investment team. She secured a \$200K growth equity investment in Don Bugito from ICA's Growth Fund.

The infusion of capital has enabled Monica to make significant changes to her business.

Don Bugito gained a couple of new clients for its existing products. The company is also in the process of growing its in-



sect farm and scaling it up. Monica participated in some national trade shows as well, and resumed talks with her largest distributor.

Now, Don Bugito is in the process of launching two new agricultural products: a non-GMO, organic, insect-based plant food that protects plants from other insect attacks, as well as organic chicken feed for backyard chicken farmers.
