## SBA Announces Over \$5 Million in Awards to Support STEM, R&D-Focused Small Businesses

Growth Accelerator Fund Awards \$150,000 to 35 Partnerships Across National Priority Areas

Administrator Isabella Casillas Guzman, head of the U.S. Small Business Administration (SBA) and the voice in President Biden's Cabinet for America's 33 million small businesses, announced the SBA's 2023 Growth Accelerator Fund Competition Stage Two winners. Thirty-five award-winning accelerator partnerships will receive \$150,000 each to help advance equitable investment in innovative startups and high-growth small businesses across several priorities, including National Security & Global

Competitiveness, Domestic Manufacturing and Production, Climate and Renewable Energy, and Underserved Communities.

"Through the SBA's 2023 Growth Accelerator Fund Competition awards, the Biden-Harris Administration is delivering on its commitment to entrepreneurship, competition, and equity," said Administrator Guzman. "This network of accelerators will help ensure high-growth small businesses and innovative startups have access to resources and networks to scale in critical technologies across America."

In 2023, the SBA introduced a new two-stage format for the Growth Accelerator Fund Competition. In May, Stage One Catalyze winners received \$50,000 to build capacity and connections across the U.S. innovation ecosystem, focused on themes of National Security & Global Competitiveness, Domestic Manufacturing and Production, Climate and Renewable Energy, and Underserved Communities.

The SBA awarded 40 Stage One prizes to organizations from 30 states and territories, including D.C. and Puerto Rico, and invited them to apply for Stage Two of the Growth Accelerator Fund Competition. During Stage Two, the SBA will provide \$150,000 to ecosystem partnerships led by Stage One winners to promote equitable access to resources and accelerate support to high-growth STEM and R&D-focused small businesses.

"These new Growth Accelerator partnerships will strengthen collaboration among local and national entrepreneurial organizations committed to enhancing the chance of success for science and technology driven companies to turn their innovations into impact," said SBA Associate Administrator for Investment and Innovation, Bailey DeVries. "We're thrilled to bring

## **EPA Announces Five California 2023 Safer Choice Partner of the Year Award Winners**

The U.S. Environmental Protection Agency (EPA) announced five Safer Choice Partner of the Year award winners from California, recognizing their achievements in the design, manufacture, and the selection and use of cleaners, detergents and other products with safer chemicals.

The Safer Choice program helps consumers and facilities like schools and office buildings find cleaning and other products containing chemical

ingredients that are safer alternatives for human health and the environment. Applicants for this year's awards were encouraged to show how their work promotes environmental justice, bolsters resilience to the impacts of climate change, results in cleaner air or water, improves drinking water quality, or advances innovation in packaging.

"This week, we recognize outstanding Safer Choice partners and stakeholders who are working to make sure people have access to products with safer ingredients for people and the planet,"

said EPA Office of Chemical Safety and Pollution Prevention Deputy Assistant Administrator for Pollution Prevention Jennie Romer. "This year's Safer Choice Partner of the Year awardees have worked to contribute to the Biden-Harris Administration's goals of addressing per- and polyfluoroalkyl substances (PFAS), advancing environmental justice, and reducing plastic pollution."

The 2023 Safer Choice Partners of the Year in California are:

Apple (Cupertino) – Apple encouraged industry adoption of safer chemicals and used safer chemicals in its own manufacturing processes. In 2022, Apple approved 58 new cleaners for use in its supply chain, totaling 133 safer cleaner and degreaser alternatives, and identified 19,000 unique uses of process chemicals. Through launching ChemWorks and IPC-1402 (a standard for greener cleaners used in electronics manufacturing), Apple supported safer chemicals across the industry.

The Clorox Company (Oakland) – Clorox has been a Safer Choice partner since 2007. 84% of Clorox packaging is recyclable, reusable or compostable, an 8% increase since 2021. All Clorox Safer Choice-certified products display the Safer Choice label on the front of the packaging. Clorox promotes transparency and consumer understanding through the SmartLabel platform and standardized terms for over 800 ingredients.

"Developing products that have Safer Choice or Design for the Environment certifications is an important part of Clorox's integrated Environmental, Social and Governance goals that support healthy lives," said Lisa Pankiewicz, Vice President Global Stewardship at The Clorox Company. "Products that contain these certifications provide consumers with the trust and confidence to make choices on which products are right for them and their families."

**ECOS (Cypress)** – In 2022, ECOS submitted three new products for Safer Choice certification, reaching certification for 88% of their

## Major Surge in SBA Loans to Latino-Owned Businesses

According to data from the U.S. Small Business Administration (SBA), Latino-owned businesses have witnessed a rise in loan support. The increase, over 1.5 times, showcases the dedicated efforts to foster equitable growth among small business owners.

The SBA's recent findings, unveiled in Orlando by Administrator Isabella Casillas Guzman alongside Congressional Hispanic Caucus (CHC) Chairwoman Nanette Barragán and fellow CHC members, paints a promising picture for the future of Latino entrepreneurs.

Considering small businesses' crucial role in the nation's economy, this upward trend in support could have significant implications. Latino-owned enterprises contribute more than \$800 billion annually, reinforcing the nation's position on the global competitive stage.

"We are seeing a small business boom and the fastest creation rate of Latino-owned businesses in over a decade," Guzman remarked. She attributes the positive trajectory to the Biden-Harris Administration's steadfast dedication to bridging historic gaps in lending, primarily to this vital entrepreneurial segment.

Backing her sentiments, CHC Chairwoman Barragán emphasized the administration's purposeful efforts. While acknowledging the long road ahead to ensure full equality, she praised the SBA and Biden Administration for enabling more Latino businesses across the U.S. to access crucial funding.

In FY 2023 alone, over 7,300 SBA loans, through the 7(a) and 504 programs, have been secured by Latino-owned businesses. This significant increase from previous years — with loans amounting to \$2.8 billion and comprising 12.2% of SBA-approved loans — reveals the administration's proactive approach towards inclusivity.

Recent data suggests a renaissance period for small businesses in the U.S., especially among

women and people of color. Since President Biden's inauguration, over 13.6 million new business applications have been filed, which is 65% higher than the pre-pandemic rate. Notably, the Latino-owned business segment has grown over 20% faster than before the pandemic.

Several Congress members, including Darren Soto and Maxwell Frost, have lauded the administration's efforts. Emphasizing the crucial role of Latino businesses in Florida and beyond, they credited the SBA's initiatives for offering lifelines to entrepreneurs often sidelined by larger financial institutions.

Key strategies propelling the growth include the expansion of the Community Advantage Program, the \$100 million Community Navigator Pilot Program from Biden's American Rescue Plan, and the recent launch of the Latino Prosperity Tour. Additionally, the administration has tripled the number of Women's Business Centers at Hispanic-Serving Institutions and introduced reforms to address enduring capital access gaps.

The SBA's primary business loan initiative, the 7(a) Loan, along with the 504 Loan program, are pivotal for many small business owners. With guarantees up to \$5 million and \$5.5 million, respectively, these loans enable entrepreneurs to secure working capital, among other essentials. Furthermore, the SBA's guarantee encourages lenders to support businesses that might not usually qualify, offering them better repayment terms and conditions.

This signifies a promising era for small business owners, especially in the Latino community. As the U.S. seeks to emerge stronger from global economic challenges, the Biden-Harris Administration's commitment to supporting all entrepreneurial sectors may pave the way for a more inclusive and thriving future.

## State Route 309 safer one year later

One year after opening the State Route 309 roundabouts at Napoleon Road and Thayer Road, the Ohio Department of Transportation (ODOT) District 1 declares the project a safety success. Traffic crashes and injury rates have dramatically decreased at both intersections.

"As a traffic engineer, you understand why constructing a roundabout will improve safety, but seeing the numbers is definitely satisfying," said ODOT District 1 Deputy Director Chris Hughes. "These roundabouts are most certainly saving lives," he said.

Between January 2019 to May 2022, the State Route 309/Thayer Road intersection had 29 crashes, with one fatal crash and 16 injury crashes. Since opening in August 2022, four crashes occurred, resulting in one minor injury, and three with property damage only. Not only did the number of crashes per year drop but the injury rate went from 58.6% to 25%.

"We have certainly noticed a decrease in accidents," said Crossroads Church of God Pastor Brian Robertson whose church on the southeast corner holds two services each Sunday morning and operates The Learning Tree daycare throughout the week.

The roundabout at State Route 309 and Napoleon Road also saw a safety improvement. Prior to the roundabout, 11 crashes were reported between January 2019 and May 2022 resulting in eight injury crashes. In the one-year period since the roundabout opened, one minor injury crash occurred

"Things are going well," said Mel Rentschler, superintendent of Allen East Local Schools, located on the northeast corner of the intersection. "The traffic really slows down and the roundabout makes the intersection 100% safer for the students and everyone in the community," he said.

Both Robertson and Rentschler note that traffic moves more efficiently.
