

SBA Announces \$844,214 to Support Small Business Trade Growth in California

Administrator Maria Contreras-Sweet, head of the U.S. Small Business Administration (SBA), announced \$18.85 million to support export growth among American small businesses with \$844,214 awarded to California. The funding was awarded through SBA's competitive State Trade Expansion Program (STEP).

Contreras-Sweet heralded the news as a boon for America's small businesses: "Exporting provides tremendous opportunities for America's small businesses and entrepreneurs. Two-thirds of the world's purchasing power can be found outside of the United States, but only about one percent of America's 28 million small businesses are reaching customers beyond our borders. Exporting is an important growth opportunity for our small businesses that are ready to expand their reach into new and increasingly borderless global markets. These STEP awards, in addition to SBA's export loans and U.S. Export Assistance Centers, help small businesses across our nation have the tools, resources and relationships they need to take their businesses global."

STEP awards were created to advance key priorities identified in the President's National Export Initiative, namely to expand the base of small businesses that become exporters and to make the exporting process as easy as possible for small businesses.

These awards are granted to U.S. states and territories to support programs that help small businesses expand their export-related activities. This includes participation in foreign trade missions, foreign market sales trips, subscription services for access to international markets, as well as the design of international marketing campaigns, export trade show exhibits, export training workshops and more.

STEP funds allow small businesses the opportunity to meet foreign buyers face-to-face at trade shows or on trade missions, and complement SBA's export loan guaranty programs, which can finance

The Facts About Transportation Funding and Why We Need More Revenue

Efforts at converting California vehicles to sustainable fuel sources are successful in terms of reducing greenhouse gas emissions and increasing fuel efficiency. However, one consequence of reduced fuel consumption and an increase in the number of electric vehicles is lower long-term fuel excise tax revenues. A large portion of transportation funding in California is collected at the pump and it is the state's primary source of funding for the maintenance and repair of transportation infrastructure. The problem is exacerbated by the fact that the federal gas tax hasn't been raised since 1993.

As a result, many counties throughout the state do not have enough funding to keep up with "fix-

it-first" projects such as filling potholes or to invest in critical congestion relief projects. The California Transportation Commission reports that most counties have an average pavement rating of "at risk" or "poor" and in Sacramento Countythere are 11,285 miles that need to be repaved. According to the 2016 California Statewide Local Streets and Roads Needs Assessment, this will cost \$2.9 billion over ten years.

Earlier this year, a report from TRIP found that 42 percent of the major roads in the Sacramento region are in poor condition. Another TRIP report released in August found that "driving on deficient roads costs each Sacramento area driver \$2,270 per year in the form of extra vehicle operating costs as a result of driving on roads in need of repair, lost time and fuel due to congestion-related delays."

As our roads continue to deteriorate so does the level of funding. During the recession, state and federal transportation funding levels were significantly reduced. In fact, real transportation spending growth is 6 points below overall spending since the pre-recession peak and 19 points under overall spending post-recession. As a result, now there is a backlog of more than \$1 billion in Sacramento County alone for system maintenance and rehabilitation projects.

The economics of investing in infrastructure is simple: the Federal Highway Administration estimates that each dollar spent on road, highway and bridge improvements results in an average Image Credit: http://www.sfcta.org

benefits of \$5.20 in the form of reduced vehicle maintenance costs, reduced delays, reduced fuel consumption, improved safety, reduced road and bridge maintenance costs and reduced emissions as a result of improved traffic flow.

The need for additional transportation funding is not unique to Sacramento and that's why several counties throughout the state – including Sacramento – have placed transportation sales tax measures on the November ballot to secure a dedicated local funding source for transportation improvement projects. This local approach is especially important because a comprehensive transportation funding package failed to emerge successfully at the end of the state's legislative session.

Sacramento is one of many self-help counties throughout the state that already has a local transportation sales tax in place. But with federal and state funding historically being insufficient to meet all of California's mobility needs the existing local sales tax revenue is not enough to keep up with current and future demands in Sacramento County. Local sales tax dollars provide jurisdictions the opportunity to provide safe and efficient modes of transportation for all users. This is not a luxury, it is a necessity – for drivers, pedestrians, bicyclists and public transit riders – who all deserve to have reliable and safe travel options.

The Trillion-Dollar Reason Why Wall Street Should Take Gender Diversity More Seriously

There are plenty of reasons why companies and investors should take gender diversity seriously.

But if a quantitative reason based on stock-market returns is needed, Morgan Stanley has it.

Strategists at the bank recently updated their study on 1,600 public companies around the world and found that the shares of public companies that are more gender diverse experience less volatility and outperform those that aren't.


The study found that:

- Among stocks that rank high on Morgan Stanley's selection model, those with high gender diversity delivered much better risk adjusted returns.
- Since 2011, companies that were more diverse outperformed their counterparts by 1.5%.
- Year-to-date, the market has rewarded diverse companies "quite generously," although North America is an exception. That may be because of the rally in small-caps; larger companies tend to be more diverse.
- Stocks that rank low on diversity have the highest return volatility and the highest probability of experiencing sharp drawdowns.

These reasons move gender diversity to some-

EPA Announces Initiatives To Advance Tribal Sovereignty, Expand Environmental Observer Network


The U.S. Environmental Protection Agency (EPA) announced an interagency agreement on tribal treaty rights and other initiatives designed to advance tribal sovereignty and self-determination. EPA Administrator Gina McCarthy announced this and other initiatives to improve human health and the environment on Indian reservations in remarks at the White House Tribal Nations Conference in Washington.

"The Obama Administration has worked hard to foster an abiding culture of respect for tribal sovereignty and self-determination across the federal government," said Administrator McCarthy. "The initiatives we are announcing today will help institutionalize the great progress we've made in recent years." Under the Constitution, treaties are part of the supreme law of the land, with the same legal force and effect as federal statutes. That's why EPA announced a Memorandum of Understanding on interagency coordination and collaboration to advance protection of tribal treaty and similar rights related to natural resources affected by agency decisions. This MOU stems in part from EPA's recent "Guidance for Discussing Tribal Treaty Rights," an effort to encourage consideration of treaty rights in the agency's consultation policy. The memorandum will be available for signature by federal agencies on a rolling basis. The U.S. Department of Agriculture, the U.S. Department of Commerce, the U.S. Department of the Interior, the U.S. Department of Justice and the Advisory Council on Historic Preservation have so far signed the MOU, in addition to EPA.

EPA also announced the expansion of the Local Environmental Observers Network program, a concept tribal communities initiated and championed, beyond its current reach in Alaska and the Arctic region, and into the lower 48 states. This expansion will develop a lower-48 LEO network hub at Northwest Indian College in Bellingham WA; and create a model for the other 35 tribal colleges and universities in the lower 48 to replicate across the U.S.

The LEO network is a network of local observers and topic experts who share on-the-ground

How an SBA Loan Can Fuel Your Small Business

One requirement to qualify for a U.S. Small Business Administration (SBA) loan is for a small business to have a healthy annual revenue. Most small businesses that receive a SmartBiz SBA loan earn \$250,000 or more per year.

Once you've been in business for a few years and built up your credit rating, funds are much more affordable. If you meet the requirements, an SBA loan is an excellent option to help erase debt and increase cash flow.

2. Purchase Equipment

From copiers to computers to vehicles, small businesses need equipment to run successfully. An SBA loan can help finance those big-ticket items. For example, SmartBiz helped a meat distributor in Michigan purchase a new refrigerated truck, a chiropractor in Indiana buy diagnostic equipment, and a Washington, D.C., area caterer purchase a much-needed van. With 10-year terms and low rates, an SBA loan can be much more affordable compared to other options.



3. Stock Up on Inventory

SkateXS is a wildly successful skateboard business in Southern California that ships products worldwide. Last holiday season, demand was so high they were unable to fill orders. With an SBA loan, they are stocking up early to prepare for the December rush.

In addition to having inventory on hand when needed, small business owners can save a bundle by purchasing in bulk. SkateXS owner Bryan Tracey used to place orders for 1,000 skateboard stickers at a time. He now buys 5,000 stickers and it's much cheaper.

"Having cash on hand is a difference maker," Tracey says.

4. Hire Fresh Talent

Small business owners wear lots of hats. But they can find themselves wearing too many. If it's time to bring in fresh talent, a small business loan can help cover salary, benefits, and other costs associated with bringing on an employee. Without enough cash on hand, it might be impossible to bring on employees that can help you expand. Take a look at your business plan to discover if funds can help finance one or more new hires. Fit Small Business co-owner Marc Prosser needed to beef up his staff in order to meet his growth goals. He's using proceeds from a SmartBiz SBA loan for \$350,000 to add 20 staff members.

5. Purchase or Refinance Real Estate

With 25-year terms and low interest rates, an SBA loan is a great option for small businesses looking to refinance an existing commercial real estate mortgage or buy an owner-occupied commercial space. The SmartBiz team helped owners of an auto body shop take a maturing five-year loan and turn it into an affordable 25-year fully amortizing solution. helped cash flow, putting the small business in a much stronger financial position.

6. Obtain Working Capital

Working capital is the difference between current assets and current liabilities and can be a positive or negative amount. Working capital are funds available to pay a company's current debts. It's also the cushion you can give your short-term creditors. An SBA loan can be used for working capital that can then be used in a variety of ways like paying taxes and handling unexpected expenses.

5 Tips to Getting a Loan for Your Small Business

Breathe.

Yep, that's the first step. Take a deep breath, calm down, and prepare yourself for the task at hand.

Know why you want the money.

So, number two may sound as silly and obvious as the first tip, but honestly, this is a big one. You'd be surprised how many business owners want to expand, know they need funds to do so, but don't have a specific idea or plan around how to do it. They will just ask a lender for money for the always-vague "working capital". Don't be that guy.

Make a list of your goals, what you need to buy or do to get there, and how much those things will cost. This is also the time to figure out the payoff for each of those investments; how much will your business grow, and how much more will it make, by getting the financing needed to do each of the things on your wish list. This enables you to justify your request and gives the lender confidence in your growth potential.

Get your ducks in a row.

ducks-in-a-rowOk, so you're breathing properly, feeling relaxed, and have a handle on what you need the money for and what it will get you. Now, it's time to start preparing to reach out to a lender to discuss options. But before you click the submit button or dial the phone, you need to have your financial documents in order and at hand. Otherwise, your application will stall. Set yourself up for success from the start through organization.

For many small businesses, traditional bank loans or SBA-backed loans are not a viable option. Perhaps due to short time in business, low personal credit scores of the owners, or monthly revenue that is just too low for a bank to consider. Enter online lenders, also known as alternative lenders, which are often able to help small business owners find the financing they need. Typically, these lenders need less documentation than a bank would to underwrite loans, but they do have standards. In order to work with a reputable lender that offers fair APRs and affordable repayment terms, you will need to make available both personal and business documents.

Though lenders vary in their requirements, a complete loan application will typically include the following documents provided by the owner(s). This is the minimum and some lenders, or types of loans, may need additional documentation.

- Most recent three months of bank statements
- Last two years of business tax returns
- Most recent year's personal tax returns
- Profit & Loss statement
- Debt schedule

Figure out your DSCR.

The Debt Service Coverage Ratio (DSCR) is a formula that determines if a business is able to meet its debt obligations and if there is any cash left over for operating expenses. It sounds difficult but it really isn't. The business's total income, divided by total debt (including the prospective loan) equals the DSCR.

If the DSCR is above 1.0, then the business is operating in a positive cash flow state and is more likely to qualify for financing. Many online lenders use this formula as a key factor when deciding whether or not to approve a business's loan application. It also is a good snapshot for business owners to help them see where they stand when it comes to their debt load and cash flow.





AS OF 2012:

- * There are 1,469,991 Latina women-owned businesses¹ in the United States. That's an increase 682,077, of businesses, or 86.6%, from 2007. Of nonfarm and privately-held Latina businesses, 44.5% are women-owned, in 2007, 34.9% were womenowned. Latina women-owned businesses generated \$78.7 billion in receipts.
- In 2012, of these firms, 95.4% have no employees other than the owner. These firms have receipts of \$27.3 billion. * In 2007, 93.3% of women-owned firms were sole proprietorships with receipts of \$16.1 billion.



thing investors must seriously consider to reduce volatility in their portfolio, said Adam Parker, Morgan Stanley's chief US equity strategist.

"I don't think anybody is going to walk in the office and say we think diversity is a bad idea, we think buying companies with all white guys that are over 40 is a great idea," Parker told Business Insider.

This research takes that sentiment "from the ambiguous to the concrete," he said.

It's not just more women

Apart from a headcount of women at executive level and below, Morgan Stanley examined other measures like pay parity, diversity policies, and maternity leave benefits.

It further screened the companies by geography to avoid any apples-to-oranges comparisons

Morgan Stanley is gradually factoring the findings into its forecasts for equity returns, alongside other metrics like technicals, earnings revisions and valuations.

"Ultimately, we'll be able to observe whether this boosted-up ranking outperforms the ranking we would have had before we did the gender diversity work," Parker said.

"And assuming that continues to be the case as has been, then we may just throw out the existing ranking and only have the gender-diversity-boosted framework.

The five US stocks in the top quintile of both the existing, non-gender-diversity-using model and the gender diversity model were JP Morgan, Walmart, Verizon, Pfizer, and Merck. Royal Dutch Shell, Total, and GlaxoSmithKline topped the European list.

Why diverse companies do better

There's existing research which demonstrates that diverse workforces perform better financially. For one, there's less risk of groupthink that leads to poor decision-making when everyone in the boardroom looks and thinks similarly.

Where stock-market performance is concerned, it's trickier to prove causality.

Eva Zlotnicka, an equity strategist at Morgan Stanley, said there may be cost benefits for diverse companies.

She pointed to the tech sector, where there's competition for talent and companies with better maternity leave policies kept the best women around. YouTube CEO Susan Wojcicki said in 2014 that the company saw a 50% drop in turnover among new moms after it increased its leave time from 12 weeks to 18 weeks in 2007.

By retaining top talent, companies can spend less on recruiting and training, and avoid bleeding some of the institutional knowledge that gives them a competitive edge.

And so, not only can investors earn higher returns from investing in better-run companies, but the firms also stand to gain from greater gender diversity.

Even Capitol Hill can make some improve-ments. The US is among a small handful of countries including Papua New Guinea and Lesotho that don't guarantee paid maternity leave.

Looking at a list of maternity-leave benefits, "when you start to get to like country number 141 and you realize the US is still below that," it's weird, Zlotnicka said.

knowledge about unusual animal, environmental and weather events. The network uses valuable traditional and local knowledge to help observe and report changes in the local environment. Available Android and iPhone mobile apps give users a powerful reporting tool to use in the field.

Administrator McCarthy also reiterated EPA's commitment to help close the gap in water quality protections on Indian reservations. Last week, the administrator signed an advance notice of proposed rulemaking to invite comments on whether to extend water quality standards effective under the Clean Water Act to all tribes with reservations. Fewer than 50, out of more than 300 tribes with reservations, currently have such water quality standards. Last week, Administrator McCarthy also signed a rule that significantly streamlines requirements for tribes to receive treatment as a state (TAS) to administer Clean Water Act regulatory programs.

The administrator also recently signed a rule to establish procedures for eligible tribes to obtain the authority, under the Clean Water Act section 303(d) program, to identify impaired waters on their reservations; and to establish total maximum daily loads of contaminants that can be discharged into those waters. This will allow each tribe to meet their own water quality standards.

Some of the lenders out there are more than happy to lend money quickly and easily but with terms that could actually harm your business more than the cash they provide helps it. Daily debits from your business's account and interest rates in the triple digits can quickly sink a company; so get smart about the options before you set your mind on what you think you need.

Research the companies out there. Learn about them and the products they offer. Who are they? What are people (and the press) saying about them? What kind of lending do they do? Why are they different?

Lenders run the gamut from daily debit/Merchant Cash Advance companies (MCAs) to invoice factoring firms to those offering term loans and lines of credit that look much like what you would get from a traditional bank. There are scores of companies out there offering a wide variety of products, repayment terms, APRs, and fees, so take some time to familiarize yourself with the players in the market before you get started.

Though this list isn't exhaustive, it's a great starting point. When you are ready to reach out to a lender, or even a few, be prepared to discuss your needs, support your request, and show why you're a good investment on the lender's part. At the end of the day, you should feel comfortable that the representatives you work with understand your needs and are able to help you determine the financial product that is best for your business and that will help you achieve your goals.
