What Makes Sports Facility Construction So Challenging

There are nearly 10,000 sports complexes in the United States and together, they earned \$1 billion in 2019. Over 33,000 people are employed in the running and upkeep of these sports complexes.

The industry saw annual growth of 4.1% between 2014 and 2019, proving how popular and profitable it can be.

However, constructing a sports facility comes with its own set of challenges. Designing a state-of-the-art facility is a complex process and contractors should keep several factors in mind.

When the cost of building a local outdoor sports facility could be anywhere between \$12 million and \$20 million, it is not a simple undertaking. It makes sense to choose a contractor who has

experience with sports facilities.

Challenges Unique to Sports Facility Construction

Most large construction projects are challenging in one way or another but a sports facility entails a few unique challenges:

1. Strict Deadlines

Organized sports are played during particular seasons i.e. a time of the year when regulated games are in session.

For instance, Major League Baseball is played between March end to September end. Association football and basketball are played between August to May.

Thus, the construction of a sports facility should be done keeping these periods of the year in mind. Work should be completed within set deadlines because the start of a season cannot be delayed.

2. Environmental Challenges

When a multi-sport facility is being constructed, the design should keep in mind several considerations.

Lighting should be able to accommodate all the sports the facility intends to serve. Soccer, tennis, and basketball are often played at night because it's cooler.

Sufficient lighting should be factored in to prevent games from being prematurely stopped due to lack of light. Even if night games are not played, lighting is required for the security of the property.

Lights should also be turned on only when needed and allowed enough time to cool down before the next use. In addition, maintenance staff will require adequate lighting to do their tasks.

Games like hockey require that the stadium does not become too hot during the day so that night games can be comfortably played. HVAC systems should be flexible enough to handle the demands of various sports.

Usually, LED floodlights are used in sports facilities because they reduce electricity costs, don't generate as much heat as traditional light bulbs, and last longer than regular light bulbs.

Since commercial LED lighting does not heat up as much as regular lighting, players are protected from overheating and the facility does not have to invest heavily in cooling equipment.

3. Space Constraints

Not all sports facilities are built on large plots of land. Often, local teams have to contend with building on a smaller footprint of land—perhaps in the middle of a city or town—that is surrounded by restaurants and other commercial establishments. Thus, the design of the sports facility has to balance the needs of the sports team(s) and that of the space in which the facility is to be located.

Local building regulations also have to be kept in mind when drawing up the plan for the sports facility. The plan should have approval from the local municipality and its zoning department before construction begins to avoid any legal issues and delays later.

An indoor sports complex has considerations of lighting, plumbing, electricity, occupancy, ADA compliance, and other factors. It's typically more complex than outdoor facilities, hence more time should be invested in getting the building plan right.

4. Design Challenges

One of the major design challenges in a sports facility is that of visibility. Spectators should be able to see the full field, no matter where they

In this way, a clear cost estimation process can be carried out. We split the project between several departments. And costs are then estimated by each department. With the help of the bottom-up estimating technique, project managers get a clear picture. They tend to give a close eye look to each of

their project components. Hence, this technique has become a popular choice because of its accuracy

Three-Point Estimating

In this cost estimation technique, the project manager identifies three separate cost estimates. The first stage of this cost estimation technique requires preparing an optimistic estimate. Here project tasks get done in an efficient manner. And the project manager spends funds most efMoreover, the second point of this technique usually represents the "pessimistic" estimate. And here, project funds remain utilized in the least efficient style. Lastly, we have the third stage! It depicts the most likely situation and lies in between the two stages mentioned above.

One of the most polluted sites in WA is being targeted for development

The old sawmill site has an isolated, eerie vibe.

About a mile from iconic Snoqualmie Falls. Surrounded by forest. Inhabited by huge ghostly sawmill buildings. Modern rally racing cars occasionally zipping about on dusty dirt roads, giving the 261 acres a Mad Max ambiance. A mountain of old logs piled up in one corner. Pre-World War II Japanese American artifacts stashed here and there. And just across the Snoqualmie River from downtown Snoqualmie.

Beneath that ghost town of a sawmill: a halfunderstood mess of subterranean pollution. But this property also happens to be the biggest piece of undeveloped industrial and commercial land in King County.

The town and people of Snoqualmie will soon start wrestling big-time over whether to greenlight a 15-year makeover of the area, transforming it into a collection of restaurants, wine shops, apartments, offices and light industrial buildings.

On Aug 25, the state Department of Ecology added the sawmill site to its site hazard assessment list with a ranking of "1" — the most hazardous on a scale of 1 to 5.

Developer Tom Sroufe and owner Steve Rimmer see lots of potential for the site. Snoqualmie Mayor Matt Larson sees new tax revenue for a small city with financial pressures.

However, a citizens group — the Snoqualmie Community Action Network — sees the developer, mayor and city officials railroading through a project that will wreck the quaint nature of Snoqualmie, while stirring up massive amounts of underground pollution from the old Weyerhaeuser sawmill.

This dispute will soon kick into a much higher gear because a final environmental study report — commissioned by the developer — is due to be unveiled any day now. That will trigger a "quasi-judicial" governmental hearing, and then the Snoqualmie City Council will have to make a decision about whether to give the go-ahead to Sroufe's 15-year development plan.

"Quasi-judicial" means the city council is to be regarded as judge and jury on the matter. No one on either side can talk to council members before the public hearing. And city council members cannot do their own research on the project.

Those rules have sparked a fierce feud between project backer Larson, who is not a member of the council, and project opponent Councilwoman Peggy Shepard.

Loggers and hops growers drifted into the area 25 miles east of Seattle in the latter half of the 19th century. The 1870s brought about a dozen logging operations. An early incarnation of Weyerhaeuser built a huge sawmill complex that opened in 1917 next to the city. During construction, Weyerhaeuser chopped off a C-shaped bend in the Snoqualmie River, turning the separated section into O-shaped Borst Lake (named after the first white man who entered the area), essentially a stagnant scum-filled moat around an islandlike chunk of land.

This was a storage site for logs and an unintended catchment area for underground pollution. It is next to, but not part of, the site eyed for development

Roughly half of the sawmill workforce of 1,700 — about equal to the city of Snoqualmie's population — lived onsite in their own unincorporated minitown, with homes, barracks, stores, schools and a hospital. During World War II, many of the minitown's residents who were Japanese-Americans were shipped to internment

camps over Weyerhaeuser's protests in 1942. Limited in what they could carry, the Japanese Americans dumped many of their belongings in outhouse pits that have since been covered over.

"There's so much rich history there," said Anna Boranian, one of the leaders of the citizens group.

The complex was shut down in 1989, but Weyerhaeuser kept some offices there until the early 21st century.

Snoqualmie remained a small town of about 1,600 serving the sawmill complex and some Interstate 90 drivers until improvements to the I-90 ramps led to more restaurants, shopping and a light industrial area near the interstate. The town's population has since boomed to roughly 14,000.

"We were pumping out a house a day for a while." said Larson, the mayor.

City services are still trying to catch up with the population spurt, he said. That has led the government to hunt for new revenue. Annexing and developing the old sawmill site seemed like a good option. In 2012, the city annexed the sawmill's 261 acres. In 2010, Rimmer, the site's current owner and an aviation executive and rally racing enthusiast, bought the property to house the Dirtfish Rally School to train rally car drivers.

By studying the visitors to the upper Snoqualmie River area, Sroufe realized developing the sawmill site had great potential to attract more visitors. In 2017, Snoqualmie Mill Ventures —

Rimmer is one of the owners — submitted an application to the city of Snoqualmie for permission to develop an office-apartments-restaurant-light industrial complex.

The 15-year development plan is divided into three, roughly five-year phases. Phase 1 is the site's northwest corner with a pedestrian-oriented main street, including wine shops, restaurants, event spaces and apartments. Phase 2 is intended for light industrial use on the site's northeast corner. Phase 3 would be corporate buildings on the southern half, replacing the Dirtfish Rally School.

In April 2020, the venture submitted a draft environmental impact study report to the city, which predicted full development of the site would result in 228 to 304 people living in that area by 2032, with 1,570 to 3,410 people being employed there.

So far, the project has not nailed down any assured tenants, since a development schedule is still up in the air, Sroufe said. Also, a budget for developing Phase 1 is in flux, he added.

The environmental impact study says there are no known or suspected contamination in Phase 1, t there are problems in the other two parts. The report zeroed in on Phase 3, noting it holds PCB-containing transformers, a huge diesel tank and boiler ash being used as filler material in parts of the ground

What Makes Sports Facility Construction So Challenging

are seated. They should feel they're close to the action.

Premium seating arrangements also need to be accommodated strategically to be worthy of the ticket price. People should also have a clear view of all the facilities on offer at the sports complex so that they are more frequently used. In this age of television and streaming platforms, sports facilities should be attractive enough to keep visitors coming back.

Shade structures can be constructed for outdoor facilities to shelter athletes and spectators during hot summer months. Athletes can cool off in the shade between games and spectators can watch the games comfortably.

5. Turf selection

Many sports like football, baseball, and lacrosse use turf areas and it is crucial to choose the right turf.

There are two options—natural grass or artificial turf.

Natural Grass

Natural grass is often preferred because it is a softer, more yielding surface and more forgiving to an athlete's knees and joints. It does not heat up as quickly as artificial turf.

However, natural grass needs ongoing maintenance to make it suitable for games. A few con-

siderations for natural grass are planting dates, planting rates, use of fertilizers and herbicides, tillage, rolling, watering, and mowing.

In bad weather, fields with natural grass tend to get muddy and slippery increasing the likelihood of injuries. Irrigation and draining are a big concern in natural grass fields. If the water content in the grass falls below 60%, turf can become weak and die or become dormant.

When there's not enough rainfall, natural turf has to be supplemented with extra water to help it handle stress from games being played and harsh environmental conditions. Turf should get 1-2 inches of water per week during the growing season.

Factors like humidity, temperature, wind, sunlight, and rainfall determine how much irrigation is required. Historical weather data can help contractors determine irrigation needs and suitable irrigation systems.

Artificial Turf

Artificial turf is made of polyethylene blades and crumb rubber. It is preferred over other artificial turf options like nylon turf and polypropylene turf because it is softer and resembles natural grass the most.

There are no maintenance costs to worry about and it doesn't require much raking. Draining is ably handled by its irrigation systems so there is no fear of waterlogging. Thus, it's an environmentally friendly way to cover a sports field. However, it is more expensive than other types of turf and it heats up very quickly. The surface temperature can rise to 120 degrees Fahrenheit on a hot day, making it difficult to play on.

Certain types of bacteria can live on the plastic blades of the turf for over 90 days. Thus, if the turf is not cleaned regularly, it can lead to skin infections.

6. Weather Safety

Contractors must factor in the weather conditions of the location in which the sports facility is being built. Severe weather can damage complexes and even harm players and spectators!

Lightning is a common and dangerous occurrence. A thunderstorm and lightning detection system based on either acoustics, optical signs, or electric fields can provide early warnings and help sports managers plan games safely.

Lightning horns that track storms in real time, alert with an outdoor warning siren, and provide a countdown clock to resume operations work well.

7. Parking Spaces

Planning for parking may seem like an afterthought, but it is one of the most crucial aspects of building a sports facility. Spectators should find it convenient to come to the facility and watch their favorite teams play. If it is a hassle to find parking spots, visitors may not return. A sports facility should have around 50-100 parking spots. This will enable it to host community events and tournaments that bring in a larger volume of people.

If the available space allows it, parking spots should be closer to the field and facilities for spectators so that they don't have to walk long distances to access their seats. Some parking spaces should also be exclusive to differently-abled people. The perception of ease and convenience will pull in more visitors.

An important consideration in designing a parking lot is that vehicles should not get damaged by balls or other sports equipment. Thus, nets or other protective barriers have to be put up to prevent damage to parked cars.

Final Thoughts

A large-scale construction project like a sports facility demands a high level of coordination and logistics to carry it to completion.

It is necessary to have sound knowledge of sports facility architecture design to plan and build a structure that will be useful to both athletes and spectators. The facility should stand out to users and compel them to return to it every season.

After six years as manager of Silverlake Cheese Shop, Leah Park Fierro knew she wanted to start her own business. She wanted to express her passion for educating the community on the fine tastes of artisan cheese. Her startup, Milkfarm, is a neighborhood cheese shop that sells hundreds of international cheeses. They also sell artisanal wine, beer and charcuterie from small, independent local producers.

By September 2013, Leah had written a business plan. She found a location in the Eagle Rock area of Los Angeles. Knowing she needed help designing a business website, she attended a Pasadena City College small business event. There, she learned about the newly opened Small Business Development Center hosted by PCC.

The dream team

Leah was assisted by SBDC Directors Salvatrice Cummo and Mike Daniel as well as advisors Laura Lara and Se Reed. They helped her develop an integrated marketing strategy, create a business website, and use QuickBooks for her bookkeeping. The SBDC team also introduced her to a key partner, the Foothill Workforce Investment Board (FWIB). They supported Leah through a partial subsidy for her employee salaries.

Leah understood the importance of proper accounting systems, and knew she needed help in this area. "I had zero experience with QuickBooks," she explains. "I had worked in management and run a cheese store, but never actually had to do bookkeeping. To go from selling cheese to having to do accounting has been a massive learning curve, but [SBDC Business Advisor] Laura Lara has been tremendously helpful—I don't know what I would have done without her." Thanks to Lara's training, Leah was up and running with QuickBooks from

Good jobs and long-term thinking

Creating new jobs for local residents is important to Leah. So Cummo connected her with the FWIB, a program that matches employers with employees who are seeking to learn new job skills and overcome disadvantages. The fact that FWIB pays a portion of a new hire's wages during their initial four months was a bonus. "That has been a tremendous help." says Leah. "because when [a new employee has] to learn 300 cheeses and the meats and wines that pair with them, a lot of labor is lost to training." Leah has hired two full-time employees so far, one through FWIB, and plans to go back to the organization again when it's time to expand.

Social media marketing came easily to Leah. "I was already savvy, so that was easy to set up and execute." However, building a website and integrating it with her social media presence was more of a challenge.

Reclamation awards construction contract for first phase of Friant Kern Canal repairs

Construction to restore critical water supply infrastructure for San Joaquin Valley to begin by year's end

The Bureau of Reclamation and Friant Water Authority announces the selection of a construction contractor to begin work on the Friant-Kern Canal Middle Reach Capacity Correction Project.

Brosamer & Wall/Tutor Perini Joint Venture, based in Walnut Creek, was awarded a \$177 million contract to perform the construction aspects of the first phase of work to repair the Friant-Kern Canal along a portion of the 33-mile stretch. This portion of the canal has lost more than half of its capacity due to subsidence a sinking of the earth from groundwater extraction.

The total project is estimated to cost around \$500 million and will eventually restore water delivery to over one million acres of farmland and 250,000 residents in California's eastern San Joaquin Valley.

"Repairing this portion of the Friant-Kern Canal provides significant improvement for the canal's conveyance capacity and is a key priority for Reclamation and the Central Valley Project," said Reclamation Regional Director Ernest Conant. "We are looking forward to working with FWA and Brosamer & Wall/Tutor Perini Joint Venture to have shovels in the ground by the end of the year a significant step to providing reliable water supplies to farms and communities throughout the eastern San Joaquin Valley.

Brosamer & Wall/Tutor Perini Joint Venture was selected through a best-value competitive bid process overseen and managed by Reclamation throughout the summer. Reclamation anticipates a Notice To Proceed for the contractor in November with resulting construction activity beginning by year's end. Although the contract will be managed by Reclamation, FWA and Reclamation will work jointly with Brosamer & Wall/Tutor Perini Joint Venture to implement construction of the Friant-Kern Canal Middle Reach Capacity Correction Project. The work under this contract includes 10 miles of new canal with eight concrete inverted siphons below various structures and creeks along with various concrete turnout structures, and other miscella-

After more than four years of work to assess the canal's problems, develop designs to fix it, and assemble an initial funding and financing pack-

age, we are thrilled to take this enormous step toward restoring critical water deliveries that support the San Joaquin Valley's businesses, communities, and farms, said Friant Water Authority Chief Executive Officer, Jason Phillips. FWA looks forward to launching this phase of work with our partners at Reclamation and Brosamer & Wall/Tutor Perini Joint Venture.

Background:

The Friant-Kern Canal delivers water to more than one million acres of highly productive farmland and 250,000 residents. The canal, part of the Central Valley Project's Friant Division, is owned by the federal government but FWA and its predecessor agency have operated, maintained, and repaired it under contract with Reclamation since 1986. The canal's diminished capacity has resulted in up to 300,000 acre-feet of reduced water deliveries in certain water years with effects most prominent in the middle reach of the canal (milepost 88 to milepost 121). The Middle Reach Capacity Correction Project would restore capacity from the current estimated 1,600 cubic-feet-per-second to the original 4,000 cubic-feet-per-second in the most critical area near the Deer Creek check structure (milepost 103). Reclamation signed the Record of Decision for the project in November 2020.


Mayor Eric Garcetti joined elected officials at the L.A. River to announce over \$15 million in funding for a bridge and a multipurpose path along the L.A. River in Los Angeles and Glendale.

The Mayor stood alongside Assemblymember Laura Friedman, Councilmembers Nithya Raman and Mitch O'Farrell, Glendale Mayor Paula Devine, and Glendale Councilmember Ara Najarian to make the announcement.

"The L.A. River is an iconic destination for people across this region — and these investments demonstrate the strength of our coalition taking action to help it realize its full potential," said Mayor Eric Garcetti. "I want to thank Assemblymember Friedman for championing this piece of our historic waterway, which will provide Angelenos and visitors with better access to green spaces, as well as more places to walk and bike."

As part of the new funding, \$5 million will be used for the Colorado Freeway Extension undercrossing, which will establish a safe and continuous path along the North Atwater East Bank of the L.A. River. When complete, pedestrians, cyclists, and equestrians will be better connected to parks, equestrian facilities, neighborhoods, businesses, and recreation along the river. An additional \$10 million was also announced for the City of Glendale for the completion of the Glendale Narrows Riverwalk Bridge, a pedestrian and bicycle bridge that will make a long-needed connection between Glendale and Griffith Park's bike paths.

"It's hard to overstate the importance of investing in my district's active transportation infrastructure," said Assemblymember Laura Friedman. "The 43rd is home to incredible community amenities such as Griffith Park, the LA River Bike Path, the Chan-

ing this project come to life as soon as possible."

Since Mayor Garcetti took office, he has led the City's efforts to revitalize the Los Angeles River by transforming it from a concrete flood channel into a natural space — securing more than \$600 million for investments in L.A. River revitalization projects, and creating more parks, bike paths, and open space for recreational use.

The Mayor's efforts to transform the River are highlighted by the construction of three new bridge crossings to connect communities and bring more Angelenos to the river, including the North Atwater Multi-Modal Bridge, Taylor Yard Pedestrian and Bicycle Bridge, and the Red Car Bridge. Mayor Garcetti also spearheaded the development and implementation of the Los Angeles River Revitalization Master Plan; helped the U.S. Army Corps and Engineers to authorize a plan for \$1.5 billion in River restoration projects; and formed the 100-Acre Partnership at Taylor Yard, which will create a coordinated restoration across multiple adjacent L.A. River properties to restore habitat and create public natural space.
