## **Network to Bring High-Speed Internet Service** to All Californians

On the heels of Governor Gavin Newsom's \$6.5 billion investment to expand broadband infrastructure and enhance internet access for unserved and underserved communities, today construction began in rural San Diego County on the first leg of the 10,000-mile broadband network aimed at bringing high-speed internet services to all Californians, no matter where

"California is now one step closer to making the digital divide a thing of the past," said Governor Newsom. "We're starting construction today to get affordable high-speed internet in every California home because livelihoods depend on equitable access to a reliable and fast internet connection. This is about ensuring that all Californians, no matter the zip code they call home. can be part of the Golden State's thriving and diverse economy."

Construction began Thursday on State Route 67 near Poway in San Diego County, where Newsom Administration officials gathered as 500 feet of fiber optic cable was blown through conduit in the first segment of a massive, \$3.6 billion statewide project known as the "Middle Mile" broadband network.

### **Board of Supervisors Approve Renewal and Expansion of** San Francisco Tourism Improvement District

Mayor London N. Breed and Supervisor Aaron Peskin recently announced the approval of the San Francisco Tourism Improvement District (TID), a key component to the city's post pandemic economic recovery. The renewal of the TID expanded to include short-term rental accommodations and will generate revenue

through the assessment of hotel rooms and short-term rentals for the next 15 years, starting January 2024 to December 31 2038 The TID is designed to drive and increase tourism, attract conventions and promote San Francisco as a global destination. Supervisor Matt Dorsev who represents the South of Market neighborhood in District 6 also co-sponsored this legislation.

The revenue generated from this increase will create a buy-down fund to attract and retain convention business at Moscone Center. It will offset the rental of Moscone including costs such as security and transportation.

The district will provide specific benefits to businesses operating tourist hotels and short-term residential rentals by funding sales, marketing, and promotional activities; special industry events designed to attract leisure travelers, conventions, meetings and events; and create a buydown fund to help attract and provide support for qualifying events at the Moscone Convention Center. The renewal of the TID is part of San Francisco's Downtown Economic Recovery, which is being built on five key areas of focus: filling vacancies and diversifying industries; enhancing downtown vibrancy; maintaining a clean and safe city; increasing and improving access to downtown; and growing the City's labor force.

"San Francisco is a global destination for tourism and hospitality," said Mayor London Breed. "Visitors support our local small businesses, and their spending supports one of the largest job sectors in our City. Our focus right now is on making San Francisco a welcoming, safe, and attractive place so that people want to come and when they do come, they have an incredible experience. The renewal and expansion of the TID will help us support bringing more people to San Francisco, which is essential for our Economic

Tourism is vital to the city's economy. Travel and tourism is the top generator of outside revenue into San Francisco's economy, bringing in more than \$9 billion in annual economic revenue. The hotel industry is a significant employment sector in the City and it relies on robust travel and tourism.

# California to give \$2,500 training grant to workers who lost jobs during pandemic

Living through a pandemic sucks, but for Diana McLaughlin, early 2020 was especially bad: A divorce in February 2020, societal shut-down in March, and as part of the COVID-19 economic fallout, she lost her job in April of that year, returning to full-time work only 18 months later.

California lawmakers had economically distressed folks like McLaughlin in mind when last year they approved half a billion dollars on education grants worth \$2,500 to help workers displaced by the pandemic acquire new job-related skills.

McLaughlin is among the first 3,000 or so recipients of this grant, adult learners who were issued checks in a pilot program this spring and summer. Now the state is opening the grant to a wide range of adults with low incomes who lost their jobs or saw their hours severely cut during the pandemic. Half of the grant funds are reserved for displaced workers with children under 18.

Officials expect to reach 190,000 people with this money, called the Golden State Education and Training Grant Program.

Among the few stipulations to receive the grant, applicants must fill out a short application that takes about 10 minutes to complete and attest that they lost a job or hours after March 4 2020, when Gov. Gavin Newsom declared a state of emergency. Applicants also must affirm that they weren't enrolled in an educational or job-training program when they lost their jobs. There's an income threshold as well.

Part of what makes the application quick to complete is how little it asks. Unlike other grant applications for college, this one is self-reported and self-certified, wrote Judith Gutierrez, spokesperson for the state financial aid agency running the grant, in an email. "We are not requesting any documentation," she added.

McLaughlin wasted no time once she received her grant in June, 2022. After taking courses part-time at American River College, a community college in Sacramento, since October of 2020, she decided to go full-time to pursue her first ever-degree this fall and chose accounting as her major.

The \$2,500 is paying for her textbooks, software required for schoolwork and other supplies — anything remaining she's putting in a personal education account. Though she receives tuition waivers as part of a state financial aid program and additional dollars through the Cal Grant, the Golden State grant gives her extra confidence that she can afford an education while earning around \$38,000 a year.

"I spend my lunch break doing schoolwork," she said. After returning from the office, she takes her associate degree courses online. McLaughlin's younger son is a virtual charter school student, so the two complete their homework side by side.

"I feel that it's showing him how important an education is and to never give up because here I am, 47, and in college," she said.

### Expanding financial aid in California

At first blush the Golden State Education and Training grant, which will last through 2024 and is funded mostly through one-time federal stim-

ulus funds, is yet another example of the state's growing effort to lower the cost of college for adults and bring more Californians into college classrooms

In the past two years, public funding grew by nearly 50% for the California Student Aid Commission, which oversees most of the higher-education grant aid to students, to nearly \$3.6 billion. That growth includes more tuition and cash support for community college students, middle-class students at the University of California and California State University, students formerly in foster care, students raising children and the Golden State training grant, among others.

But the Golden State grant's eligibility rules start where other state and federal grants drop off, extending cash assistance to would-be students who otherwise wouldn't be eligible for traditional college financial aid.

The Golden State grant can cover education programs that are shorter than about four months — something the federal Pell and state Cal Grant do not. Students receiving the Golden State

grant may also use the money for extension and so-called noncredit programs, such as English-as-a-second-language courses, bicycle repair and various landscaping certificates. There's no minimum program length for this grant — and because state dollars cover some of the grant costs — undocumented students are also eligible for the \$2,500. Anyone getting the grant needs to already know which training program they plan to pursue.

#### Getting the word out

So that displaced workers with no ties to a college also apply, the Student Aid Commission is working with regional workforce boards, The California Workforce Development Board and other agencies to get the word out about the grant, said Jake Brymner, director of governmental relations for the Student Aid Commission.

Grant recipients can also use the funds if they enroll in certain workforce training and apprenticeship programs unaffiliated with colleges or universities. The Student Aid Commission is reviewing which workforce training programs are eligible and will soon add those to the approved list on the grant application. Students will only be able to use their grants at California public colleges, universities and these approved workforce training programs.

During the pilot when only public colleges and universities were eligible, 84% of the grant applicants sought educations at community colleges, data from the Student Aid Commission shows.

"This specific grant has great potential," said Daisy Gonzales, interim chancellor of the California Community Colleges. "What it does is it provides an entry point to our colleges for students that may not know about us." Students with no exposure to community colleges can gain access to food pantries and coordinators who are familiar with other state and local social services for which students could qualify.

She's also hopeful the grant may help to recover some of the colossal enrollment loss the system suffered in the past two years.

### State Begins Construction on 10,000-mile **Broadband Network**

The planned network which will be the nation's largest, will cover the entire state to help bring reliable, high-speed internet access to the millions of Californians who do not have it now. Roughly one in five Californians do not have access to reliable and affordable highspeed internet. Once complete, funding for "last mile" efforts will support internet connections from "middle mile" lines to homes and businesses, as well as efforts to ensure individuals can afford broadband service where it already exists

Last year, the Governor signed historic legislation allocating \$6 billion for achieving Broadband for All, including \$3.25 billion for the middle-mile network and this year's budget put an additional \$550 million toward the project as it moves into construction.

### The 2021 legislation included:

- \$3.25 billion to build, operate and maintain an open access, state-owned middle-mile network.
- \$2 billion to set up last-mile broadband connections that will connect homes and businesses with local networks. The legislation expedites project deployment and enables Tribes and local governments to access this funding
- \$750 million for a loan loss reserve fund to bolster the ability of local governments and nonprofits to secure financing for broadband infrastructure.
- Creation of a broadband czar position at the California Department of Technology, and a broadband advisory committee with representatives from across state government and members appointed by the Legislature.

### Grant can combine with other student aid

Even if grant recipients qualify for free tuition, especially at community colleges where nearly half of learners attend for free, they can use the money to cover gas, housing, food and other expenses. It's an added perk for learners who had no spare dollars to afford an internet connection or other expenses associated with attaining a degree.

Muideen Olawoyin was one class away from earning an associate degree in human services, a stepping stone toward social work. But a series of bad breaks and a long-term injury left him cash-dry.

"I (couldn't) even afford internet then, it was so hard," he said. When he picked up the Golden State check from his school, Cosumnes River College, he was able to get back online, enroll in that final course and earn his degree this summer.

The average income of the roughly 3,000 grant recipients was about \$22,000 when they first applied, according to California Student Aid Commission data provided to CalMatters.

### Some degrees don't boost wages

Not all training and education programs are made equal, however. Some research shows that shorter-term college certificates — like the kind in which students with this grant can enroll — have a mixed record of boosting the earning power of graduates.

Overall, these certificates lead to higher wages, but noncredit programs are less remunerative than traditional for-credit certificates. Still, associate degrees and bachelor's degrees lead to even higher wage gains for graduates, according to a 2020 Urban Institute study. Meanwhile, a fifth of certificate programs at public colleges and universities lead to lower wages than what workers with high school diplomas earn, a Hechinger Report analysis of national data showed.

California's foray into funding short-term credentials could inform the national conversation on whether to permit federal grant aid to pay for educations that are shorter than four months. For a few years now advocates have been trying to introduce "short-term" Pell grants, but the idea hasn't won over enough lawmakers yet.

None of the four Golden State training grant recipients CalMatters spoke with were pursuing short-term credentials — all wanted an associate degree. McLaughlin, who now works as an accountant for a fencing company, is dreaming bigger.

Her goal is to transfer to Sacramento State to earn a bachelor's — something her current employer encouraged her to pursue.

"I want people to know you're never too old for school," McLaughlin said. "And to never stop trying to reach your goals."

The U.S. Small Business Administration (SBA) announced a new funding opportunity for up to \$400,000 to be awarded to up to 12 entities including private organizations, colleges and universities, private sector firms, nonprofit organizations and state, local or tribal governmental agencies to provide critical training and counseling to aspiring and existing veteran small business owners as a Veterans Business Outreach Center (VBOC). The news comes ahead of Nations Veterans Small Business Week 2022, one of the Agency's flagship events, taking place October 31 – November 4, that will put the spotlight on one of the Biden-Harris Administration's priorities – supporting our servicemembers, veterans, and their families at every stage of the entrepreneurial journey.

"Under Administrator Guzman, the SBA remains committed to providing more local resources for veteran entrepreneurs, a critical but under-resourced group of entrepreneurs among the small business community," said

Larry Stubblefield, Associate Administrator for the SBA's Office of Veterans Business Development. "As the focus on serving underserved communities becomes increasingly important, OVBD expects the demand for VBOCs will continue to grow. This expansion will grow the VBOC program from 22 to 34 locations nationwide and assist in supporting veteran small business owners in all U.S. states and territories. The additional locations aim to enhance the experience for veteran small business owners by reducing appointment wait times, increasing local presence, providing additional local training opportunities, meeting the needs of Boots to Business participants, and ensuring that all VBOCs have the necessary resources to perform required counseling and training functions.'

With this SBA funding, grant awardees will be able to provide training to transitioning service members and military spouses through the Boots to Business entrepreneurship training program, which is part of the Department of Defense's Transition Assistance Program. ## 3 Reasons Communication Fails in Construction

Managing construction projects can sometimes feel like you're playing a broken game of telephone.

You start off by relaying a message to your team, but there's no guarantee folks will receive, understand, and interpret the message the way you intended. People can have conflicting data, misunderstand your message, or don't receive it at all.

Sometimes, this leads to some interesting mishaps. For example, here's a story of a person getting their car stuck in wet concrete because they missed the (several) construction signs displayed on-site.

Misunderstandings like this are not uncommon within construction, and you may have seen your fair share of them.

That being said, while certain misunderstandings can lead to funny situations, these mistakes also result in huge losses. That's why it's important to prevent them from happening in the first place.

To help you do that, we'll be going over the top reasons behind communication mishaps in construction.

### 1: Bad data

Working with flawed data inevitably leads to poor communication and decision-making. You can't expect to relay accurate information when the source of that intel is incomplete, incorrect, or outdated.

Research shows that bad data is one of the biggest culprits behind costly issues in construction projects. Our study with FMI found that one-third of poor decisions were made as a result of bad data, and those decisions can cost contractors up to \$165 million.

### How to fix the issue of bad data

Adopting a cloud-based construction management platform is the best way to avoid bad data.

It's easier to stay on the same page when stakeholders have access to a solution that houses all project information. Users can find the necessary data in one place, which leaves little room for errors and miscommunication. Plus, cloudbased platforms keep data updated in real-time so teams can view the latest information from anywhere.

### 2: Disconnected processes and workflows

Construction projects go through several phases, and each stage has its own sets of workflows and procedures. Communication issues often arise when these processes are disjointed and inefficient.

For instance, if your field and office teams aren't tightly connected, information is more likely to slip through the cracks. It's all too easy for collaborators to miss important messages or receive outdated info.

Problems with disconnected workflows also come up when using multiple applications that don't "talk" to each other. When your systems aren't integrated, folks resort to manual data entry, ultimately opening up room for mistakes.

Unfortunately, this practice is quite prevalent in the industry; research shows 53% of construction teams are manually transferring information between apps that don't integrate.

### How to fix disconnected processes and work-flows

You can address this issue with the use of unified platform solutions that keep workflows, apps, and stakeholders in sync. Doing so ensures information flows smoothly across various platforms and teams, which reduces mishaps and mistakes.

You can rest easy knowing that all stakeholders are kept in the loop. Plus, teams save time from having to manually re-enter or resend information to other team members.

### 3: Lack of transparency

In psychology, there's a logical fallacy called "signal amplification bias." This is a tendency of

some people to assume that something is obvious, and therefore doesn't have to be explained.

Folks who have signal amplification bias often under-communicate because they overestimate other people's knowledge about a certain matter.

For example, a team member may decide not to send a meeting reminder because they're assuming everyone remembers key dates. Or, a construction worker may choose to not verbally inform someone about the wet concrete because there are seemingly "obvious" signs already posted on-site.

### How to address the lack of transparency

The first step to addressing this issue is recognizing you may have signal amplification bias. Identify instances in which you assume that something is obvious, and make it a point to deliver clear explanations and instructions.

Beyond that, it also helps to adopt tools that promote better visibility of project information. Again, having a cloud-based and centralized solution is ideal, because it makes information more accessible to the right people.

Solutions that streamline tasks like sending reminders and taking meeting minutes can also help, because they make it easy to disseminate information to teams

# The Inflation Reduction Act: A Path Forward for Real Solutions

This summer's intense heat has wrought havoc across the country, exposing the perils of systemic environmental racism. For instance, neighborhoods with primarily Latinx residents experience temperatures that are four to five degrees warmer than the rest of the metro average.

Environmental inequalities resulting from racist water, housing, and urban planning policies aren't new. The ongoing water infrastructure crisis in Jackson, Mississippi that has rendered 150,000 mostly Black residents without access to safe water recalls the Flint, Michigan water crisis that first made headlines in 2014 and continues to impact the mostly Black residents living there today. As climate change reveals the historical failures of local, state, and federal governments to adequately invest in the resilience and safety of low income people of color, it's clear that our climate initiatives going forward must prioritize equity if we are to right these wrongs, and create a better future for our communities.

The Biden Administration's massive budget package, The Inflation Reduction Act, finally provides a path forward for substantial federal investment in equitable climate change mitigation. And it comes in the nick of time.

As communities everywhere, but especially low-income communities of color that disproportion-

ately bear the impacts of pollution and climate change, deal with worsening climate-related catastrophes, the IRA offers significant and urgently needed solutions including:

- \$369 billion in clean energy and climate investments
- Investments to spur the transition to a clean energy economy and generate more than 9 million jobs in the next ten years
- \$3 billion in environmental and climate justice block grants and \$1.3 billion in neighborhood access and equity grant programs to promote community resilience and access to safe, affordable transportation
- Roughly \$40B toward environmental justice with funds for air monitoring, pollution reduction at ports and schools, increasing access to affordable safe transportation, etc.
- \$27 billion to fund a Greenhouse Gas Reduction Fund with significant money for green banks
- Billions in direct incentives and tax credits for EVs and home electrification.

### How we got here

Federal action from the U.S.-the largest historical contributor to emissions in the world-is both overdue and essential. But because of the partisan politics around climate change, the IRA stops short of the bold climate measures and care infrastructure the Biden Administration initially proposed in the scuttled Build Back Better bill.

The trade-offs and compromises that led up to the passage of the IRA meant that measures that run contrary to our climate goals-namely, the expansion of harmful fossil fuel developments-ended up in the original deal to pass the IRA. However, thanks to pressure from outside advocates, Congress came together in a rare and helpful moment of alignment to oppose a separate side deal that would have included the worst of these measures. While this is good news for now, we will continue to need bipartisan leadership and support to ensure future federal action moves us closer to achieving our climate goals and environmental justice.

#### Where we go from here

There are three important things to remember moving forward.

- First, the IRA is the floor, not the ceiling, of what is needed to combat the impacts of climate change. It is up to state legislatures to build on these investments with state programs to create holistic strategies for tackling the climate crisis.
- Second, the IRA followed the Infrastructure Investment and Jobs Act and the American Recovery Act both of which included significant climate and equity aligned investments, meaning states have several sources of federal investments to implement.
- Finally, advocates must shift our focus to implementing investments equitably. Monitoring, evaluating, and shaping how

federal investments are being implemented is the only way to ensure we maximize the impact of programs that will benefit low income communities of color.

In our work at The Greenlining Institute, we bridge the gap between policymaker agendas and community priorities. From this, we've learned that there are critical "ingredients" for equity that must be baked into implementation to ensure benefits meaningfully reach those that need them most. Some of these ingredients include:

- Community-driven program design and implementation that establishes paths towards wealth building.
- Application of community investment standards to govern funds and programs intended to address inequity.
- Providing technical assistance to underresourced groups (including low income communities of color) to secure and implement funding provided by the IRA.
- Culturally tailored outreach, marketing, communication, and education on how to access the clean energy incentives included in the agreement.
- Streamlined application processes for programs that enable low income communities of color to access IRA benefits efficiently.

# Board of Supervisors Approve Renewal and Expansion of San Francisco Tourism Improvement District

"The expansion of the Tourism Improvement District is one part of the City's overall post-pandemic recovery effort, providing critical visibility and promotion of our ongoing efforts to increase public safety, street cleanliness and unique activation in the heart of San Francisco's tourism core," said District 3 Supervisor Aaron Peskin.

"Not only is District 6 one of the most densely populated areas in San Francisco, it's also home to dozens of hotels that support San Francisco's travel and tourism industries, which is driven largely by the world-class Moscone Convention Center," said District 6 Supervisor Matt Dorsey. "City policy makers should be doing everything we can to incentivize businesses to book conventions in San Francisco, and I'm proud to join Supervisor Aaron Peskin in the renewal and expansion of the Tourism Improvement District during a time where we need fight for a full post-pandemic economic recovery."

According to SF Travel, San Francisco is expected to receive 21.5 million visitors in 2022 compared to 2021's 17 million visitors, an increase

of 26.5%. Visitor spending is forecast to be up 89.3% in 2022 to \$6.7 billion, but down 30.2% compared to 2019, when the city had a record 26.2 million visitors and \$9.6 billion in visitor spending.

According to data provided by Tourism Economics, overnight domestic business travel has grown 134% compared to 2021, and spending is up 152%, but both are down more than 30% compared to 2019. San Francisco tourism is rebounding however a full recovery to pre-pandemic levels is not expected until 2025.

"The TID has proven to be a sustainable revenue model that enables San Francisco Travel to market the city as a top global destination. In renewing the TID, San Francisco hotel owners and operators and short-term rental hosts have demonstrated their support of our efforts and shown their commitment to investing in the future of San Francisco," said San Francisco Travel President and CEO Joe D'Alessandro.

"San Francisco is a world-class destination with a unique story that enlivens community and beauty that needs to be shared. We are thankful to our partners and stakeholders for getting this assessment through the finish line. The approval of the Tourism Improvement District is a testament to our welcoming hospitality and is vital to our full post-pandemic recovery." said Kate Sofis, Executive Director of the Office of Economic and Workforce Development. "Whether your visiting San Francisco for leisure or business, we are thrilled to be able to launch and host a series of events and activations for everyone to enjoy."

The TID will cover two zones with 227 hotels making up more than 33,500 rooms and 3,100 short-terms. The renewal will increase the assessment rate by .25% in Zone 1 (currently 1.00%) and will increase assessment in Zone 2 by 1.00% (currently 0.75%).

"Tourism is one of the city's primary industries that provide thousands of jobs to local residents. We are thrilled to support the TID which in turn will help shape the city's narrative to a global, national and regional audience, "said Rodney Fong, President & CEO of the San Francisco Chamber of Commerce. "Today's approval is a win for the city, our business community, and will help contribute to San Francisco's overall economic vitality."

In addition to the increase in assessment and the inclusion of short-term rentals in the renewal, the TID will also adopt industry best practice and add operational flexibility by authorizing a supermajority of the San Francisco Tourism Improvement District Management Corporation (SFTIDMC) Board of Directors to increase assessments by up to 1% to meet unforeseen or critical needs and costs of business attraction and retention. It also expands the SFTIDMC Board of Directors to include seats for a short-term residential rental host, the City Administrator, and the City Controller (representatives of San Francisco's hotel industry will continue to hold a majority of seats on the SFTIDMC Board).

The San Francisco Tourism Improvement District (TID) was formed in 2008 and became effective in January 2009. it was one of the first to be established in California, and this is the TID's first renewal since its formation.

### Google's New Technology Could Be the Next Big Thing for Remote Workers

As remote work becomes an increasingly permanent fixture in many corporate workers' lives, using technology in creative ways has become crucial in keeping up team rapport and communication.

Although that's mostly done through Zoom and other video chat functions, Google is taking it one step further by rolling out what could be the next big thing for remote workers and client-facing employees around the world hologram meetings.

Google has been working on the technology, dubbed "Project Starline," for several years, but made it public last spring.

Google explained that the new technology will appear "like a magic window, where users can talk, gesture and make eye contact with another person, life-size and in three dimensions. It is made possible through major research advances across machine learning, computer vision, spatial audio and light field display systems.

The company announced that it will expand the testing of Starline to other "enterprise partners" across a multitude of industries, such as technology, healthcare and sales. Google already has several prototypes set up in booths in its U.S. offices.

Among the companies to experience the new "early access" rollout are Salesforce, We-Work, T-Mobile and Hackensack Meridian Health. The companies will test the product using prototypes that Google installs in their offices.

If we don't prioritize racial equity as the foundation of distributing funding, we run the risk of perpetuating the harms of the status quo with most of the funding going to those who already have the capacity to apply for those grants, such as wealthier cities and well funded NGOs. We know that without an effective community outreach plan and accessible technical assistance, many people that could benefit from these resources can go unaware of their existence. Building lasting capacity within communities to apply for funding and implement projects is essential.

We have a huge opportunity to use this significant funding to meaningfully deliver the economic, environmental, and health benefits of the clean energy transition for communities that are most affected by pollution and poverty.

Galen Garretson knows knives and the value of a sharp knife first hand. He has worked in the culinary industry his entire career, first at San Francisco restaurants Beach Chalet, Town Hall and Mecca, then Magnolia and finally famed Pacific Avenue restaurant Ouince.

As his career progressed, Galen witnessed a common theme: chefs were unable to find a reliable, high-quality knife sharpener and therefore used dull knives. Galen saw beautiful sushi-grade fish lose their clean line, vegetables chopped in non-uniform sizes, and butchers turn red because of rough cuts. Finally fed up with this problem, he put down his chef's hat and replaced it with a whetstone.

As soon as he decided to open a knife sharpening business, Galen faced a big problem: as a start-up business, he couldn't find financing to pay for inventory, marketing, or sharpening equipment. In 2011 he came to Working Solutions, a nonprofit microlender, who worked closely with Galen on his business plan, lease agreement and loan uses. Then when he was ready, Working Solutions loaned Galen the \$25,000 he needed to open Town Cutler.

## Toni Ricci, Elite Dance and Performing Art Center

Toni Ricci grew up in Maine in a small town, in a poor family. Even though they didn't have a lot of money, she started dancing when she was five years old. She fell in love with it and yes, at the age of five, she knew that she wanted to own a dance studio.

Dancing saved Toni's life and kept her driven, despite a difficult childhood. She refused to let anything get in her way.

Toni became the student director of her high school's dance company; the high school, Thornton Academy, was known for its amazing performing arts program. She also took 9-10 classes a week at a local dance studio.

She was the first person in her family to go to college. She put herself through the University of New Hampshire and majored in dance.

While a junior in college, she saw an audition notice for Sesame Street Live and was hired onto the tour as Cassie in Dragon Tales Live. She left college and toured for two years. She made it to every state in the country, including a stop in California. When she visited Los Angeles, she knew that she wanted to go back. She packed up all her belongings into her car and drove to California with \$500 in her pocket.

Toni wanted to finish school and re-enrolled in California State Fullerton. She put herself

through school working everywhere – Target, Bath and Body Works, birthday parties, babysitting, and teaching at a few dance studios.

Eventually, she landed at a dance studio in Tarzana and within 2 years went from teaching 3 or 4 classes a week to 30 classes a week. She made the schedule and lots of the artistic decisions. In 2012, the owner decided to sell the business. Toni couldn't purchase it at that time because she was unable to qualify for the lease due to a low credit score and low cash flow. Toni had such deep relationships with her students that she thought "this is the time." She felt that she needed to open her own studio then because she couldn't lose 'her' kids.

### Starting off on her own

The first thing Toni did was to use her tax return money to incorporate the business. A few parents of students backed her with a loan, but it wasn't enough.

She had no money and a terrible credit score, but a lot of faith, hope, and persistence.

After looking for a big enough studio, she found a building on Independence Avenue in Woodland Hills that belonged to an Iranian TV station. She showed up every day for two weeks and convinced them to rent to her. "They believed in me and finally said yes." She signed a lease, co-signed by her cousin.

One student's father suggested the Jewish Loan Federation. She did the same thing, returning every day until she convinced them to give her a loan. Because of her bad credit, she had three friends co-sign the loan and three friends co-sign on the financing for the dance floor.
