U.S. Department of Transportation Advances America's Infrastructure with Expanded Regional Grants

The U.S. Department of Transportation announced another step forward in advancing critical transportation infrastructure projects across the United States by expanding the Regional Infrastructure Accelerators (RIA) program to 24 accelerators receiving \$24 million in new funding from the Bipartisan Infrastructure Law. Administered by the Build America Bureau, the RIA program accelerates project delivery and clears barriers for credit-worthy projects by funding and encouraging best practices in project planning, studies and analysis, preliminary engineering, and design.

"We are pleased to expand the Regional Infrastructure Accelerator program to 24 regions, helping communities build capacity and get much-needed transportation projects underway," said U.S. Transportation Secretary Pete Buttigieg. "DOT partners with these regions to help them secure financing and develop in-house expertise for innovative delivery of regionally significant projects."

"Building capacity at the regional level to use innovative delivery and financing options is critical to addressing America's infrastructure challenges," said Build America Bureau Executive Director Morteza Farajian, Ph.D. "The RIA program is a novel approach that enables the Bureau to help our partners deliver more good projects faster."

These awards result from the spring solicitation for projects for the RIA program. The Bureau received 21 applications requesting \$66 million in funding. The program, created by the Fixing America's Surface Transportation (FAST) Act, is designed to inform future work by measuring how different regional models can expedite the development and delivery of transportation projects. The RIA program is part of the federal Thriving Communities Network, an interagency effort to coordinate technical assistance, planning and implementation support to ensure infrastructure investments funded by the Bipartisan Infrastructure Law and Inflation Reduction Act create long-term benefits nationwide.

The RIA program previously awarded grants in 10 regions that are already accelerating transportation projects, including:

The Pacific Northwest Economic Region (PNWER) RIA supporting Washington, Alaska, Idaho, Montana, and Oregon communities utilized its previous \$1.235 million RIA grant and hands-on technical assistance to support project development for the Pine Road highway and rail grade

Biden-Harris Administration seeks input on innovation for clean and efficient commercial buildings

As part of President Biden's Investing in America agenda, and through the Green Proving Ground (GPG) program, the U.S. General Services Administration (GSA), in collaboration with the U.S. Department of Energy (DOE), announced a new request for information (RFI) about technologies that can enable energy efficiency, electrification, and decarbonization in commercial buildings and contribute to a more efficient electric infrastructure. With \$30 million in funding from the Inflation Reduction Act (IRA)–the largest climate investment in history– this RFI will result in more than triple the number of technologies in the program.

Earlier this year, GSA announced that it will invest \$30 million from the Inflation Reduction Act, in collaboration with DOE, to increase the sustainability of federal buildings by testing novel technologies through the GPG program. The funding allowed the program to increase

GSA's GPG program leverages GSA's real estate portfolio to evaluate innovative building technologies. Technologies selected to participate in this program will be piloted in one or more federal buildings and/or private sector facilities for evaluation by DOE national labs. The program enables GSA to make sound investment decisions in next-generation building technologies based on their real-world performance. Technology companies receive third-party evaluations facilitated by the federal government which can help scale their technology and grow their business, which strengthens U.S. competitiveness, the economy and creates jobs.

"The GPG program is one way we're creating the technical foundation for long-term, transformational changes," said GSA Administrator Robin Carnahan. "We're aiming for a triple win: more good American jobs, cost savings to taxpayers from reduced energy consumption, and a healthier future for all Americans."

This year's RFI is focused on emerging and sustainable technologies that support:

- Deep Energy Retrofits.
- All-Electric Buildings and Vehicle Fleets.
- Net-Zero Operations
- Healthy and Resilient Buildings.
- Building Commissioning and Control.

Submissions should be early-or underutilizedcommercial technologies ready for evaluation in occupied, operational buildings. Technologies will be considered for GSA's Green Proving Ground (GPG) program (for federally owned facilities), and/or DOE-facilitated voluntary partnership programs (for privately owned facilities).

The RFI will be open for submissions until Friday, December 8, 2023. Parties interested in submitting an application can review the

"The SBA's 8(a) Program has more than a 50year track record of making contracting with the U.S. government more accessible for thousands of small businesses who in turn provide critical products and services to advance agency missions. Leveling the playing field not only provides entrepreneurs from historically underserved communities the opportunity to grow their businesses, create jobs, and contribute to their local economies – it is also crucial to enhancing performance across our federal government.

As we await a final ruling, the SBA and Biden-Harris Administration remains committed to supporting the 8(a) Program and standing up for the small business owners who have helped drive America's historic economic growth. We will not let attacks from those who seek to take us backward chill our efforts to promote equity, expand access to the American Dream, and ultimately strengthen our country's industrial base." State Law That Will Create Transparency On Issues Impacting California's Communities of Color

The most pressing threats we face from climate change and the rise of AI decision-making in government disproportionately impact communities of color due to systemic racism, economic barriers, and past policies like redlining that led to widespread disinvestment from these communities. This year, The Greenlining Institute supported California legislation that establishes transparency into these threats to pave the way for accountability and the development of more equitable solutions. Greenlining's co-sponsored bills – Senate Bill 253, authored by Senator Scott Wiener and Assembly Bill 302, authored by Assemblymember Chris Ward – have been signed into California law by Governor Newsom.

"We are immensely grateful to everyone that made this achievement possible – to Governor Newsom, bill authors Senator Wiener and Assemblymember Ward, our co-sponsors and coalition partners, and all the legislators that supported these bills, playing a role in making equity real for California's communities of color," said Debra Gore-Mann, President & CEO at Greenlining. "For decades, communities of color endured the worst of systemic and institutional injustices because existing policies led to inequitable impacts and failed to prioritize their needs. To develop equitable and effective policy solutions to climate change and AI bias, we need to understand these problems better. Data and transparency are critical to gaining insight into the lived experiences of communities of color that are most impacted by the societal threats we face. These two bills are a step in the right direction," Gore-Mann continued.

"The signing of SB 253 and AB 302 reaffirms California's leadership role in developing and implementing cutting edge, and far reaching climate and tech solutions. Transparency into corporate emissions through SB 253, and the ways government use of AI impacts our lives through AB 302 is essential to hold lawmakers accountable to our communities," said Alvaro Sanchez, Vice President of Policy at Greenlining. "It is our duty as lawmakers, advocates, businesses, and residents of California to work towards a future where communities of color can thrive. These bills will help make that future more possible."

"California leads this nation by passing policies directed at supporting the diverse residents that make up this great state, and we build from the ground up. By shedding a sobering light on the drivers of climate change, like corporate emissions, and uncertainty around emerging technol-

Cavs-Clinic Riverfront building is big, evolving

Planning Commission input to shape Bedrock's plans

More illustrations were made publicly available this week, showing the large size of a new facility planned next to the Cuyahoga River in downtown Cleveland for the Cleveland Cavaliers' basketball practice facility and Cleveland Clinic's sports health-related medical services. Kansas City-based architectural firm Populous submitted the plans for what would be Bedrock Real Estate's first new building in its ambitious \$3.5 billion riverfront development to the City Planning Commission's Design Review Committee.

Although still in the early stages of design, the Cleveland Clinic Global Peak Performance Center is proposed to be a large, first-of-its-kind interdisciplinary training facility that would bridge over Eagle Road in what's called Flats South. Conceptual massings, which lack exterior textures and are provided to show scale and interior programming, demonstrate that size. They will be scrutinized by the design review committee starting tomorrow with give-and-take continuing for at least a month or two.

But what those massings do show is that the new facility will be large, measuring nearly 250,000 square feet. They are technically two buildings in one, connected by a bridge building over Eagle. The larger of the two sites is proposed to be about 186,000 square feet and the smaller roughly 61,500 square feet. The larger structure will contain the Cavaliers' practice facility wrapped by offices atop 105-110 parking spaces in an enclosed space.

The smaller site will contain a Cleveland Clinic sports health facility. The bridge structure will contain what is termed a Cleveland Clinic "performance space." There will be a rooftop space for staff overlooking the river on the Cavs building. Site preparation work is already underway to rebuild aging riverside bulkheads that would support the future riverwalk and building.

Mayor London Breed Announces New Proposed Activation of the Fillmore Heritage Center

Mayor London N. Breed announced that the City is beginning lease negotiations with a new operator for the Fillmore Heritage Center, located at the corner of Fillmore and Eddy Streets in the Western Addition neighborhood of San Francisco.

After a competitive bidding process coordinated by the Mayor's Office of Housing and Community Development, Human Rights Commission, and Office of Economic and Workforce Development, the City is beginning lease negotiations with Westside Community Services, in partnership with the San Francisco Housing Development Corporation (SFHDC) and Fleming Development, for the activation and operation of the commercial portions of the Fillmore Heritage Center.

The proposed uses for the various commercial portions of the Fillmore Heritage Center include a premier destination restaurant of the African diaspora, programming of a diverse range of musical acts, a food hall and commercial kitchen, a visual art gallery focused on the African diaspora, along with space for meetings, corporate events, film festivals, and neighborhood events.

"This is an important step in our work to ensure the Fillmore Heritage Center returns as a place for the community to gather and celebrate our culture," said Mayor London Breed. "Our goal is to deliver a space that is active, exciting, and reflective of the community that has long made the Fillmore the amazing neighborhood we all know it to be."

"The next phase in this process represents a commitment from the City to celebrate, recognize, and invest in the rich culture and history of the Harlem of the West," said Sheryl Davis, executive director of the Human Rights Commission. "Moving forward, we will work with community to incorporate the magic of the past as we build out the innovations of the future."

"Our collective team is honored to engage in leasing discussions for the Fillmore Heritage Center. We deeply recognize and respect the Center's rich history and its immense potential, and we understand its pivotal role as a catalyst for economic, entrepreneurial, and creative growth in the Fillmore community and surrounding areas," said Mary Ann Jones, CEO of Westside Community Services. "Successful Image credit by https://hoodline.com lease negotiations will enable us to work hand in hand with Fillmore community stakeholders. Our vision is to transform the Center into a premier destination for performing arts and culinary excellence. We envision it as a shining symbol of Black prosperity that will inspire and uplift many generations to come."

Built in 2007, the Fillmore Heritage Center was developed as a multi-use facility with the goal to both revitalize the commercial corridor and honor the cultural heritage of the neighborhood. Once considered the "Harlem of the West", the Fillmore neighborhood is known for its vibrant community of African American residents and a center for Black-owned businesses, many of them music and entertainment establishments.

Today, the Fillmore District remains a vibrant community that continues to build on its Black heritage, while embracing its proximity to nearby neighborhoods, such as Japantown. The Fillmore continues to be a destination for live music and entertainment and has become a central location for annual festivals and events attracting thousands of attendees to partake in the entertainment, food, and history of the neighborhood.

"This is a victory," said the Rev. Dr. Amos C. Brown, pastor of San Francisco's historic Third Baptist Church in the Fillmore District. "This is an opportunity to build a world-class watering hole that celebrates the culture and the history of this community. This is a historic moment focused on revitalizing the Harlem of the West."

Westside Community Services, San Francisco Housing Development Corporation (SFHDC), and Fleming Development were selected as the Fillmore Heritage Center's operators through an open and competitive Request for Proposals process issued in February 2023. The City aims to finalize the lease for the Fillmore Heritage Center by March 2024, after Board of Supervisors approval. The performance space and gallery space are anticipated to be activated in Fall 2024. The proposed food hall and new flagship restaurant are anticipated to open in early 2025. City representatives will facilitate a community meeting in the coming weeks as lease negotiations commence.
