

# California Rebuilding Fund helps maintain jobs, reduce stress for small business owners

Business owners who received loans from the California Rebuilding Fund say the program has improved their finances, their stress levels, and their employees' quality of life, according to a new report analyzing the program's impact. The Fund still has approximately \$15 million in capital available and will close on Nov. 15 or when funds are exhausted, whichever comes first.

Business owners who received loans from the California Rebuilding Fund say the program has helped them better manage their finances and maintain their employees, according to a new report released today from research firm 60\_decibels and fund supporters CRF USA, Calvert Impact and Kiva. The report, which surveyed 287 California Rebuilding Fund recipients to analyze the impact of the program on the state's small businesses, also found nearly 80% of recipients would recommend the program to others, 63% say they could not have easily found an alternative financing source, and one in five say they would have closed permanently without the loan.

The Fund still has approximately \$15 million in capital available and will close on Nov. 15 or when funds are exhausted, whichever comes first. Small businesses can visit [www.CALoanFund.org](http://www.CALoanFund.org) to learn more.

Key findings from the study of California Rebuilding Fund recipients include:

- 46% had never borrowed money for their business prior to applying for this loan
- 63% indicate they could not have easily found a good alternative to the California Rebuilding Fund loan
- 68% report they can better manage their finances now than before receiving the loan
- 67% say their ability to maintain jobs has increased because of the loan
- 77% say their stress levels related to finances has decreased as a result of the loan
- 21% believe they would have closed permanently if not for accessing the loan
- 78% would recommend the program to others, citing benefits like an easy process, affordable interest rates, and helpful staff

"After the pandemic nearly wiped out all of our revenue, a loan from the California Rebuilding Fund helped us get back on track," said Alicia Villanueva, owner of Alicia's Tamales Los Mayas in Hayward, who received a California Rebuilding Fund loan in 2021. "The loan gave me the freedom to keep my employees and gain back our lost business. Now, I'm optimistic for the future."

# SBA Awards Over \$5.4 Million in Grants to Strengthen Research Funding Opportunities Across the U.S.

Administrator Isabella Casillas Guzman, head of the U.S. Small Business Administration (SBA) and the voice for America's 33 million small businesses in President Biden's Cabinet, announced over \$5.4 million in funding to 44 awardees through the Federal and State Technology (FAST) Partnership Program. FAST

provides small businesses and startups, particularly those in underserved communities, with specialized training, mentoring, and technical assistance for research and development. Grant selectees qualify for award amounts of up to \$125,000 each.

"When we enable equitable access to federal research funding, we empower more of our nation's entrepreneurs and scientists to translate

their cutting-edge ideas into commercial enterprises," said Administrator Guzman. "This is why doubling our funding of FAST grants and expanding the network of awardees is so critical to building a stronger and more inclusive innovation economy that invests in all of our communities."

FAST's objective is to strengthen the competitiveness of small businesses and startups across the country, particularly those from underserved communities to help them benefit from the Small Business Innovation Research (SBIR) and Small Business Technology Transfer (STTR) Programs. Through FAST, the SBA continues to play a critical role in creating inclusive entrepreneurial ecosystems and helping American entrepreneurs grow their networks and revenue opportunities with new capital, a priority of Administrator Guzman.

This year's expansion of the FAST program created 12 additional awards and expands the program's footprint to 43 states and one U.S. territory. These organizations are led by state and local economic development entities, Small Business Technology Development Centers, Small Business Development Centers, Women's Business Centers, Procurement Technical Assistance Centers, incubators, accelerators, colleges, and universities. The expanded reach of the program builds on the success of previous FAST cohorts. With \$4 million in funding in fiscal year 2021, FAST helped small businesses to win over \$88 million in SBIR and STTR awards, a 22:1 return for every taxpayer dollar spent.

# Regulators Approve US Bank and Union Bank Merger

Regulatory milestone brings us one step closer to seeing \$100B Community Benefits Agreement come to fruition.

Earlier this year, the Greenlining Institute and members of the Greenlining Coalition supported a campaign led by the California Reinvestment Coalition and the National Community Reinvestment Coalition to hold US Bancorp and MUFG Union Bank accountable to communities following U.S. Bank's announcement of its intent to acquire Union Bank.

This campaign included public hearings where the Greenlining coalition, alongside community groups and organizations that would be impacted by the acquisition, voiced concerns in public comments and testimonies regarding the banks' ability to meet the credit needs of the communities they are required to serve.

Together with CRC and NCRC, Greenlining helped negotiate a \$100B Community Benefits Agreement, with a \$60 billion carve-out for California, in connection with the proposed acquisition—one of the largest CBAs ever secured in the banking industry to date. On Friday, October 14, it was announced the banks received regulatory approval to proceed with the \$8 billion acquisition, moving us one step closer to seeing this historic CBA come to fruition.

“This CBA is a huge win for communities—especially low-income communities and communities of color—that have historically been an afterthought while big banks pursue profits and power through consolidation. This is a testament to what we can accomplish when we work



together to hold financial institutions accountable in their business practices, and push them to prioritize the needs of the communities they operate in,” said Debra Gore-Mann, President & CEO at the Greenlining Institute.

The agreement includes commitments that will:

- Increase mortgage lending units by 30% to low-moderate income borrowers, low-moderate income communities, and communities of color over five years. We estimate this commitment to be at least \$35.8 billion.
- Increase U.S. Bank's community development loans and investments by 50% over the previous combined baseline of U.S. Bank and

MUFG Union's community development financing in California. We anticipate that a 50% increase would result in at least \$9.3 billion in community development lending and investment over the five-year plan period.

- Provide at least \$250 million in capital over five years nationally specifically aimed at increasing access to capital for minority-owned/led affordable housing focused developers to expand equitable access to development capital. U.S. Bank intends to launch a Special Purpose Credit Program (SPCP) to implement the \$125 million debt commitment, which was created to provide accessible lending capital to minority-led/owned developers in support of affordable housing projects.

- Open five new branches in low-moderate or middle-income Majority Minority (MMT) communities in California over five years.
- Increase U.S. Bank's spend with diverse suppliers by 20% in California over five years.

Greenlining also pushed to have climate resilience provisions included in the CBA to improve access to affordable energy and related green investments for low-moderate income communities.

“The risks climate change poses on communities, households, and businesses are increasing at a dramatic pace, and financial institutions need to step up to meet the moment. We will continue to push for even stronger climate investment targets in future CBAs,” Gore-Mann continued.

“We are pleased to see the regulatory culture around bank M&A shift to a focus on community impact thanks to years of campaigning for more scrutiny by our coalition and so many others. Now, our focus shifts to holding the banks accountable to all of the commitments they've made, and we look forward to continuing this work in coalition with our partners.”

# California Matches Record Low Unemployment Rate

In September, California matched the record low unemployment rate of 3.9% set in July 2022. The state also added jobs for the twelfth consecutive month and has now recovered 99.1% of the jobs lost to the pandemic-induced recession:

- California's unemployment rate fell .2% to 3.9% in September, matching the state's record-low rate and dropping 2.5% from September 2021.
- The state's job increase from August 2022 was revised upwards by 16,100 jobs to a 36,000-job increase – this was followed by a 6,500 job increase in September.
- September was the twelfth consecutive month the state added jobs – Education and Health Services showed the largest month-over gains.
- California has recovered 99.1% of the 2,758,900 jobs lost during the February 2020 – April 2020 pandemic-induced recession.

## How Seattle is planning for a quarter million more residents

City officials project Seattle's population will hit 1 million people by 2044. That's an additional 240,000 or so residents over the next 22 years.

Where will they live? What kind of homes will we build for them? How do we ensure new growth doesn't exacerbate existing racial and economic inequities?

These are all questions guiding the update of Seattle's comprehensive plan, which establishes parameters for how the city wants to grow over the next 20-plus years.

Seattle's Office of Planning and Community Development is in the early stages of the two-year update process, establishing the guide rails of what the plan might look like: Will we build tall apartment buildings with ground floor businesses in all corners of the city? Will we change nothing and hope for the best? Will it be something in between?

As part of this early scoping process, city officials want to know what you think Seattle should do to prepare for the next quarter-million residents heading our way.

### What the plan does (and doesn't do)

Michael Hubner, the city's comprehensive plan update project manager, likened the plan to drawing a road map that shows city officials and staff where we've decided to go on a 20-year road trip. The policymaking and budgeting that ultimately shape what the city looks like are the driving, sightseeing and snack buying along the way.

The comprehensive plan doesn't set the city budget, but it establishes priorities that city officials are supposed to follow when budgeting. It doesn't upzone neighborhoods to allow for apartment buildings or new businesses, but it shows city council members where they're supposed to approve upzones. It's not a transportation plan that says where new sidewalks and bike lanes will go, but the city's transportation plan must align with the comprehensive plan.

"From a planner's perspective this is a fascinating and daunting time to be doing a comp plan," said Hubner. "We've got everything from an unrelenting housing affordability crisis and homelessness crisis, to the climate crisis."

Hubner also said that while racial equity was an important part of the last comprehensive plan update in 2016, today the planning department is

"more cognizant of the history of systemic racism in public policy and private practices such as real estate."

The 1990 state Growth Management Act requires all cities in Washington with more than 50,000 residents to have comprehensive plans and to update them every decade.

Seattle's first comprehensive plan, adopted in 1994, established the city's urban villages strategy. It concentrated density and new growth to neighborhood hubs along transit corridors, leaving about 75% of the city's residential areas for single-family houses. The city has largely adhered to that plan with 83% of new homes being built within the boundaries of an urban village since it was adopted.

Hubner said that's been for better and worse. Seattle has gotten much-needed apartments, though most are studios or one-bedrooms not suited for families. The strategy also doesn't produce many new opportunities for homeownership, since in single family zones you mostly get a one-to-one replacement of old houses with new houses.

The urban village strategy, Hubner said, has not done enough to address "the legacy of exclusionary zoning in the city" which limited where Black residents and other residents of color could

live and shut them out of the wealth building opportunities of homeownership in many cases.

### What will the update look like?

The Office of Planning and Community Development has five broad concepts on the table ranging from staying the current course to opening up most of Seattle to denser housing. The city will draw on its own analysis, input from elected officials and feedback from the public to eventually coalesce around one concept for a finalized plan.

- **The Change Nothing Plan:** This would entail continuing with the urban villages strategy with no additional changes. Hubner was quick to point out that the city is required by state law to analyze what would happen if they made no changes. It is unlikely that the city would pursue this option.
- **The Focused Plan:** This would add pockets of increased density in the city in new and expanded urban villages. It would increase the number of apartments, but not add much new housing to buy.

## California Rebuilding Fund helps maintain jobs, reduce stress for small business owners

Continued from page 1

A public-private partnership launched in Dec. 2020 to reach small businesses that might be otherwise unable to access bank loans, the California Rebuilding Fund has distributed nearly \$80 million in low-interest loans and free business support to approximately 1,350 small businesses.

“We created the California Rebuilding Fund because we wanted to support the state’s community lenders through a vehicle that could quickly and responsibly deliver capital to small businesses in need,” said Beth Bafford, vice president of syndications and strategy at Calvert Impact, which arranged the California Rebuilding Fund as well as other small business funds around the country. “This new research shows the Fund did exactly what we set out to do – which is reach underbanked communities, put affordable capital in the hands of those who needed it the most, and build a more equitable, resilient small business recovery.”

The California Rebuilding Fund was made possible, in part, by an anchor investment by the California Infrastructure and Economic Development Bank (IBank), a state agency housed within the California Governor’s Office of Business and Economic Development. “The success of any program is measured by its impact, and we now know 20% of the businesses surveyed said they would have closed permanently were it not for the California Rebuilding Fund,” said IBank Executive Director Scott Wu. “Thirty-seven percent said they would have had to reduce staff hours for their employees, and 34% said they would have had to lay off staff, had they not received a loan from the Fund. The results speak for themselves and IBank is proud of its role in preserving California jobs and keeping small businesses open.”

While the California Rebuilding Fund was briefly closed because high demand had exhausted funds, the program announced a new \$15 million in September to allow for one final round of applications. The California Rebuilding Fund will close on Nov. 15 or when funds run out, whichever comes first.

Bechtel works to recruit, train and retain "top talent from all service branches, including Army, Navy, Marine Corps, Air Force, and Coast Guard and all components (former active duty, National Guard, and Reserve)" through a variety of recruitment programs, according to its website. Those include the Bechtel Military Veterans' Employee Resource Group, Helmets to Hardhats, Network of Champions and targeted job postings on military job boards.

#### 4. KBR

Very few construction jobs are about swinging a hammer and pounding nails. Many jobs in the industry require a high degree of technical training and expertise.

If you're a veteran, chances are that you already possess a high degree of technical training. KBR, headquartered in Houston, wants to help train and place you in a high-demand job within the government services and hydrocarbons sectors.

In addition to its robust military and veteran recruitment programs, KBR also partners with Fort Polk, Louisiana, and Central Louisiana Technical Community College for its Veteran Pipefitting Trade program. According to its website, the

# California aims to put dirty trucks in rear-view mirror

California's environmental regulators have been on a tear lately. Late last month, the California Air Resources Board introduced a new rule banning the sale of new gasoline-powered cars in California, starting in 2035.

This week, the board turned its regulatory gaze to the state's fleet of big-rigs.

As CalMatters' environment reporter Nadia Lopez writes, California aims to phase out the use of fossil-fuel burning medium- and heavy-duty trucks. The deadline: 2040.

Transportation is the state's largest source of planet-warming emissions and trucks make up about a quarter of those tailpipe emissions nationwide. In addition, they're also a prime source of smog and asthma-causing particulates that disproportionately choke the air of low-income neighborhoods in California.

California prides itself on being first to roll out aggressive climate policies and this is a worldwide first. That has truckers worried.

- California Trucking Association's Chris Shimoda: "We're flying blind into some pretty major questions about the practicality of actually implementing this rule."

Not that California is short on aggressive climate policies. Today, Newsom signed a package of bills that a press release referred to as "some of the nation's most aggressive climate measures in history."

The signing ceremony in Solano County was "clean energy-powered," no less.

Among the bills Newsom signed are four climate and energy bills that he pitched to the Legislature in the final weeks of the session this year.

- AB 1279 will put into state law the existing policy goal of reaching statewide "carbon neutrality" by 2045.
- SB 1020 will set benchmarks that the state electric grid has to hit before sourcing all of its power from renewable sources by 2045.
- SB 905 will require the Air Resources Board to come up with regulations for projects that capture, reuse and store carbon emissions.
- SB 1137 will ban the drilling of any new oil and gas wells within 3,200 feet of homes, schools, nursing homes and hospitals, effectively banning the activity from most developed areas in the state

# State Announces Funding to Support Sustainable and Resilient Regional Economies Across California

State leaders announced the first round of awards for the Community Economic Resilience Fund (CERF), a new state initiative supporting innovative plans and strategies to diversify local economies and develop sustainable industries that create good-paying, broadly-accessible jobs for all Californians. As part of CERF's initial planning phase, 13 economic development entities known as High Road Transition Collaboratives will receive \$5 million each to develop roadmaps, including a strategy and recommended series of investments, for their region. Following this planning phase, the program's implementation phase will begin in 2023 and provide \$500 million to fund projects identified by the High Road Transition Collaboratives.

High Road Transition Collaboratives represent California's 13 distinct regional economies and bring together diverse community, labor, industry, and business interests. Today's announcement includes 11 of the 13 awardees. Awardees were selected through a competitive bidding process based on their readiness and commitment to conduct inclusive planning processes that engage various community groups, including voices that have been traditionally left out of economic planning.

CERF was created by Senate Bill 162 and is administered by an interagency leadership team that includes the Governor's Office of Planning and Research, the Governor's Office of Business and Economic Development, and the Labor & Workforce Development Agency.

"We have an incredible opportunity to harness once-in-a-generation Federal and State investments to build a low carbon economy that creates good-paying jobs," said Samuel Assefa,

Director of the Office of Planning and Research. "We are thrilled to announce the CERF Planning Phase partnerships with organizations representing labor, community, business, and industry leaders to chart an inclusive and equitable economic future for all Californians."

"This announcement signifies a major step forward in economic development, as regional coalitions have come together across California ready to roll up their sleeves and build regional economic development strategies that will create more inclusive and vibrant economies built on a foundation of equity," said Dee Dee Myers, Senior Advisor to Governor Newsom and Director of the Governor's Office of Business & Economic Development. "As California and our federal partners work collaboratively to make significant investments to support local economies, these High Road Transition Collaboratives will play a major part in guiding these dollars to ensure the greatest impact for all Californians."

"This first-of-its-kind state investment recognizes that California is an ecosystem of diverse economies, each of which has its own challenges and opportunities," said Natalie Palugyai, Secretary of the California Labor & Workforce Development Agency. "By empowering regions to develop the blueprints for their own futures – and requiring that they do so in a manner that is inclusive and equitable – CERF is changing the way California views economic planning."
