"With our partners, we are working to empower the next greatest generation of veteran small business owners to build on the outstanding successes of the generations that came before them.

During NVSBW the SBA San Francisco District Office will host a Boots to Business: Reboot workshop on November 1st and 2nd at Travis Air Force Base. Uber Is Moving. Its New Neighbors Are a Little Worried



Uber won't move to Oakland for at least another 18 months, but already it has butted heads with local groups.

Nearly two dozen activist organizations have banded together to urge Uber to act as a responsible corporate citizen before moving its headquarters across the San Francisco Bay to Oakland, California.

The coalition is welcoming Uber into the city but hoping the tech firm will bring more good than bad into its new community. "Is Uber ready to get on that learning curve and think about the community it's coming into and the impact it's causing?" asks Richard Marcantonio, managing attorney at Public Advocates, a nonprofit law firm and California advocacy organization.

Uber is set to meet Friday with members of the coalition of 20 groups, which include the Greenlining Institute, the California Reinvestment Coalition, Public Advocates, and Policy-Link. Uber will send Adony Beniares, the company's lead on real estate and facilities efforts, as well as Jordan Medina, an Oakland resident whom Uber recently hired to be its community relations and outreach lead as it makes the tran-

This meeting is indicative of the growing pains Uber is going through as it matures from a hot startup into a full-on tech giant. As it phases out of its earlier years, where the sole purpose of any company is to survive, Uber increasingly is expected by community groups to be mindful of its civic responsibility.

Uber says it is still at least 18 months away from opening its downtown Oakland office, but in the meantime, the company has been meeting with many city leaders. The company tells Inc. it has also held several outreach events, such as community meet-and-greets and local vendor fairs, and plans on having more.

Seeking prosperity for all

For the coalition, securing a meeting was no small feat. The groups have been hoping to meet with Uber since the company announced its move to Oakland last year. In August, the organizations published a letter addressed to the company, calling on it to better the city.

The coalition asked for a number of things, including more transparency from Uber in terms of the number and type of jobs the company intends to bring to the city and what it will do to tap into the local talent pool. The organizations also want to know how Uber intends to support the city philanthropically, and how it will work with public transit, rather than destroy it.

UC partners with Boys & Girls Clubs to open college doors for California teens

High school junior Jose Palma arrives at the Boys & Girls Club of Pasadena early most days, long before the other kids. Whatever is going on at home or school, Palma knows he'll find a warm welcome amid the sagging, overstuffed couches and pool tables from the supportive staff in the teen room where he hangs out.

"It's not just a place. It is family," said the 18-yearold, who has been coming to the club since he was a tot. "The staff and friends are always there for you."

The club has helped Palma get through difficult periods in school and focus on academics, he said.

"I used to be that kid who would mess around in class. Now I'm that kid people look up to."

Palma, who has recently set his sights on college, will soon have extra guidance in getting there thanks to a historic new partnership between the University of California and the Boys & Girls Clubs of America.

UC is bringing its Early Academic Outreach Program (EAOP) to the Boys & Girls Clubs in Pasadena, Merced and San Francisco, where it will reach thousands of students with one-on-one academic support and college advising services.

The program, which already reaches about 42,000 California middle and high school students, has proven successful in helping participants aim for and pursue higher education.

EAOP participants are significantly more likely than their classmates to take the SAT and complete the courses they need to be eligible for a California public university. More than 60 percent of 12th-grade participants go directly on to higher education, compared to an estimated 41 percent of California public high school seniors statewide.

Now, UC is extending these valuable services beyond public schools to reach students through community organizations. The pilot project is part of UC's larger efforts to boost college-going rates across California.

California Senate President Pro Tempore Kevin de León and UC Board of Regents Chair Monica Lozano announced the program Sept. 28 at the Pasadena club, hailing it as a model for expanding access to UC among low-income and underrepresented minority youth.

"Higher education is a passport to opportunity," de León said. "It behooves all of us, both from a moral and an economic perspective, to ensure equitable access to higher education. This partnership with Boys & Girls Clubs of America is absolutely critical to building a more economically and culturally diverse system of higher education in California."

Connecting more Californians to UC

Through the partnership, three UC campuses — UCLA, Merced and San Francisco — will partner with their local Boys & Girls Clubs to offer personalized advising to teens to help them prepare for, apply and pay for college.

In its pilot phase, the program will serve an estimated 6,000 California students and their families at the Boys & Girls Clubs of Pasadena, Merced County and San Francisco. If successful, it could be expanded to include all 10 UC campuses and Boys & Girls Clubs across the state.

Through the program, UC will train Boys & Girls Club staff to coach students. Participants will also have access to SAT prep workshops, tutorials on writing strong college applications and opportunities to visit UC campuses.

They will also learn about UC's strong financial aid program, which covers the full cost of tuition for more than half of UC's California undergraduates. And they will find out about options for transferring to UC through a California community college.

"Even though they have the academic ability, many of our students don't see UC as within their reach," said Damon Williams, senior vice president of Boys & Girls Clubs of America, which serves significant numbers of low-income and minority students.

The partnership with UC, he said, is a potentially scalable model that will connect more economically vulnerable young people to a world-class university education.

"We want to strengthen college-going knowledge and get them on campuses to have those exploratory experiences that will really open the lens of possibility for them."

Coming full circle

Among those cheering the new partnership was UCLA's Brittany Lewis-Porchia, an EAOP college adviser, who made many of her fondest teenage memories at the Pasadena Boys & Girls Club, where the announcement was made.

"My brother and I learned to swim here — in this very pool," she said. "I learned leadership skills here. I learned to play chess here. I'm still friends today with the friends I made in this club."

For her, the partnership means coming full circle — helping a new generation of "Club Kids" make their way to cap and gown.

It also offers a unique opportunity to reach kids through an organization they know and trust, free of the stresses, time constraints and peer pressures of school.

"Our kids come from all kinds of backgrounds — but they know when they walk through that

How to Get a Small Business Loan: Tips for Female Entrepreneurs

For female entrepreneurs in male-dominated fields, staking a claim in the business world can be challenging. This is especially true when women apply for business loans, a notoriously difficult task for entrepreneurs of any gender.

A study by the California Reinvestment Coalition found that small business loans given to female-owned businesses in California have dropped 70 percent since 2007, and it's likely that other states have also seen a drop in small business lending to women. Even if a female business owner is financially secure, it's more than likely she'll be turned away if she hasn't been in business long enough.

Business News Daily spoke with financial professionals and female entrepreneurs, who provided the following tips for women-owned small businesses looking to secure loans.

Build relationships in your business community

Small business lenders want to know that the companies they're investing in are headed for success. That's why it's so important to establish yourself within your local business community before you try to apply for a loan.

"It is essential for female business owners to build relationships in their business communities," said Anne Hopkinson, owner of Haydenville Broomworks. "Part of being a trusted small business is building these relationships, and this can take time."

To get started, Hopkinson recommended looking for small business support groups in your area, such as university mentorship programs or small business development centers. Many advisers at these organizations work with lenders, and their professional relationships can benefit you in the loan-application process.

Have your financial information organized

Nothing will get your loan application denied faster than having your finances in disarray. Monica Guevara, manager of small business lending at nonprofit small business lender VEDC, reminded applicants that lenders need to verify all the information you give via documentation. So having the necessary statements and reports organized and ready for review will demonstrate that you've done your homework.

"Each lender will have different requirements, but you can stay ahead of the game by having your tax returns, P&L statements, and other financial documents organized and available," added Evan Singer, general manager of SBA loan provider SmartBig

David Goldin, CEO of alternative small business lender Capify, recommended getting a copy of your credit report before you apply, to make sure everything looks accurate.

"If you have any old vendors or delinquent accounts, clean them up," Goldin said. "Once you see your credit report, you can figure out what product you're eligible for."

Seek out women-specific lending programs

No matter where they apply for a loan, female entrepreneurs face a lot of competition. However, some lenders have implemented loan programs dedicated to women-owned businesses to make it a little easier for these business owners to receive funding.

"We've historically seen women underrepresented with coed funds, and the emergence of funds that are earmarked specifically for women is a new and exciting trend," said Marina Lee, founder of Women in Tech Network and Startups Edge.

door, they will have the support they need," said teen director Steve Austin, known to the kids as Mr. Steve.

Austin doesn't just have their backs. He's often looking over their shoulders, making sure they are going to class, helping with their homework and keeping their grades up. He goes to Back to School nights for the kids in the program to make sure he's on top of what's going on in their classrooms.

The result: Boys & Girls Club members have higher grades and graduation rates, on average,

and are more likely to avoid drugs and other risky behaviors than peers in their communities, according to data from the organization.

What they often lack is access to practical information on the nuts and bolts of getting from high school to a four-year university or community college.

Uber Is Moving. Its New Neighbors Are a Little Worried

"The goal should be inclusive prosperity in Oakland, and not just prosperity for Uber's fulltime workers," the coalition wrote.

The two parties were set to meet earlier in September but the meeting fell apart. Coalition leaders blame the complication on Uber, saying the company tried to limit the number of participants the coalition could bring. Uber also demanded a list of the individuals the coalition planned on sending but wouldn't reveal its own representatives, coalition members say.

"Basically, it fell apart because Uber was playing games," says Orson Aguilar, president of The Greenlining Institute, a racial justice policy and advocacy group.

Uber says the meeting was delayed so that Medina could take part in it. As part of his role, Medina will be tasked with meeting groups like the coalition over the next year and a half.

The coalition says it has purchased the Uber-Oakland.org domain and may use the website to hold the company responsible as a community member. The website could be used to report Uber's actions in Oakland, whether negative or positive, Aguilar says.

While there is concern, there are also other groups outside the coalition who say Uber's presence will largely benefit Oakland.

Uber's "going to have a very positive impact as long as we have good channels of communication between the corporation and the community," says Micah Weinberg, president of the Bay Area Council Economic Institute, an advocacy group that represents Bay Area businesses.

Uber is now valued at \$66 billion, and it employs more than 5,000 people, according to the company's LinkedIn profile. The company is seven years old, but it has not yet had to step up and participate in a community the way the Oakland coalition is requesting. In San Francisco, Uber is one of many fish in the tech sea, and the company typically maintains only a small field office in other markets because its drivers operate as independent contractors.

"The question is: Is Uber willing to drive people, and black people in particular, out of Oakland, or are they going to sit down at the table with the community and try to be part of the solution?" says Public Advocates' Marcantonio.

Uber is one of the few major tech companies that has never released a diversity report of its workforce. The company also has not hired a new head of diversity and inclusion since Damien Hooper-Campbell left the position earlier this year for a similar role at eBay.

The company's move east is highly significant to Oakland, which has not felt the impact of the recent tech boom to the degree other Bay Area cities have. Pandora currently is the best-known tech company headquartered there. Uber is expected to attract more startups when it arrives.

While fast-growing tech companies bring the promise of new jobs and an overall boost to the local economy, there is a fear surrounding the impact they could have on Oakland's large and vibrant minority communities. Whereas San Francisco's population is 15 percent Hispanic and 6 percent black, Oakland is 26 percent Hispanic and 26 percent black, according to the U.S. Census Bureau.

Those minority groups have been disproportionately excluded from the tech industry. The coalition wants to prevent that from happening as Uber moves into Oakland. "These are potentially high-paying tech jobs, and we want to make sure those jobs are accessible to the diverse residents of Oakland," says Paulina Gonzalez, executive director of the California Reinvestment Coalition, an advocacy group for low-income communities.

Additionally, there are fears about the impact Uber could have on Oakland's housing market, which has already been affected as more tech workers move into the East Bay. The median home value in Oakland has risen 108 percent to \$622,000 from \$299,000 in early 2012, according to Zillow, which forecasts prices will continue to increase.

"We have to be concerned about what's going to happen to the current population in Oakland, in particular the African-American and Latino populations," says Joe Brooks, senior fellow at PolicyLink, a research and action institute in Oakland. Uber says it is working with a number of local companies on the design and construction of its new offices, and that already many of its employees are Oakland residents.

None of the effects of Uber's arrival in Oakland will be felt until at least 2018, so the coalition hopes that Friday's meeting will get all involved started early moving in a positive di-

"If you look up the definition of 'uber' it means something that is magnificent, something that's really special," Aguilar says. "The community is saying, 'We want to see Uber do something that's uber for Oakland.' We want to see Uber live up to its name."
