How Construction Can Beat A Growing Labor Shortage

Is your construction firm planning to increase headcount in 2022? That could prove to be a difficult task. According to a recent survey by the Associated General Contractors of America, 88% of construction firms indicated they are experiencing project delays and worker shortages are the second leading cause (61%) cited behind longer lead times or shortages of materials (75%).

Despite uncertainty over the timeline for a full recovery from the pandemic, almost three-quarters of firms are planning to add new employees over the next 12 months. Unfortunately, 90% of firms who employ hourly craft workers had at least one unfilled position and 62% had unfilled positions for salaried employees.

For firms trying to fill craft worker jobs, 89% are having difficulty doing so and 86% that are hiring salaried professions are facing difficulties filling those positions. Some of the hardest positions to fill include pipelayers, bricklayers, concrete workers, project managers, supervisors, and estimators.

Just to put the struggles in perspective, during the Great Recession over 2.3 million jobs in construction were lost from January 2007 to January 2011. By February 2020, there were still 77,000 fewer jobs in construction than in January 2007. And then the COVID-19 pandemic struck. Between February 2020 and April 2020, the construction industry shed 1.1 million jobs. A good chunk of those were added back in 2020 but so far in 2021, the construction industry has only added 47,000 jobs as of September.

The median age of people working in construction in 2020 is 42.9, while the median age in 1985 was just 36. About 45% of all people employed in construction is age 45 or older. Compare that to the little more than 9% who are 24 or younger. Individual companies, and the industry as a whole, need to step up their efforts in order to attract more youth to jobs in construction.

Offer Candidates More

In order to attract top talent, you have to establish your company as an employer of choice, both within your industry and your local area. Offering competitive wages and benefits like health insurance and gym membership reimbursement to your employees is just the beginning. Remember, you're competing for employees just like you compete for work.

Set your firm above your competition by creating a strong company culture that values its employees and empowers them to have their voices heard and is backed by a strong leadership team. Engage your employees by offering opportunities that are both challenging and rewarding. Be the first place a candidate applies to when seeking a new job rather than being their last resort.

Invest in Your Employees

Construction firms need to increase their investment in training and development of the workforce. Make sure you are making opportunities such as training and continuing education courses available to both your new and existing employees. Offer to reimburse employees for classes once they've successfully completed them. Potential employees want to know that there are advancement opportunities and multiple career paths to move up within an organization.

Retaining good employees should be as important to your company as recruiting them. You want to keep the good workers once you've hired them. This means investing in them and their continued growth and success with your company.

People want to feel like they are contributing team members as opposed to just employees who show up to do a job. Show your employees they are appreciated and valued. Keep employees motivated by recognizing and rewarding them for their hard work and dedication to your company.

Seldom will a job candidate walk through your door with all the prerequisite skills, education,

CSUSB awarded \$3 million grant to create cyber apprenticeships

The National Security Agency has awarded Cal State San Bernardino's Cybersecurity Center a \$3 million grant to build up cyber talent in the state – specifically in the inland region – through a variety of approaches, including apprenticeships, and to bring more cyber employers to the area

The NSA grant, which is considered an economic development program, will help fund the center's efforts to increase the cyber workforce by encouraging students to consider careers in the cybersecurity field. The project is in partnership with the Riverside Community College District's LAUNCH Apprenticeship Network, San Bernardino County Schools, and the company Tomorrow's Talent.

"Our goal is to ensure that students in high school, community college and four-year institutions have a direct path into the cyber apprenticeship pipeline as well as internships and, ultimately, jobs," said Tony Coulson, executive director of the CSUSB Cybersecurity Center and a professor of information decision sciences in the university's Jack H. Brown College of Business and Public Administration.

With the increase of students in the cyber field, the project will also work to grow the number of employers in the Inland Empire to create and increase job opportunities by enticing companies to the region and matching them up with the cyber workforce, Coulson said.

The NSA apprenticeship grant is part of the center's ongoing work to enhance cyber studies and programs, where students can compete for scholarships, attend national conferences and do research on issues involving cybersecurity, Coulson said

The Cybersecurity Center has been designated as a Cybersecurity Center of Academic Excellence (CAE) by the Department of Homeland Security (DHS) and the NSA since 2008. Last year the center was named the Centers of Academic Excellence in Cybersecurity (CAE-C) Community National Center by the NSA, which selected the center for a \$10.5 million grant and directed the university to be a leader of the agency's core workforce development initiative, the Centers of Academic Excellence (CAE) in Cybersecurity Community.

The Cybersecurity Center has from 2010-2020 brought in more than \$32 million worth of grantsponsored programs from entities that include the National Initiative for Cybersecurity Education (NICE), the NSA, the Department of Defense, the National Cybersecurity Training and Education (NCyTE) Center, and the National Science Foundation.

Progressives And Conservatives Chose Partisanship Over Progress In Decision To Delay Passage Of Much-Needed Infrastructure Bill

Construction Official Says Yet Another Delay of the Bipartisan Infrastructure Bill Will Make It Harder to Improve Supply Chains and Undermine Efforts to Boost Employment and Economic Growth

The chief executive officer of the Associated General Contractors of America, Stephen E. Sandherr, issued the following statement in reaction to another delayed vote on the Bipartisan Infrastructure measure in the U.S. House of Representatives:

"It is extremely disappointing that some progressive Democrats and the Republican leadership would again delay passage of a much-needed infrastructure bill. This legislation will provide investments that will make our fragile supply

chains more efficient while providing a needed boost to economic growth and employment levels.

"The Republican leadership chose to urge its members to oppose a bill that President Trump would have proudly signed into law. This bill provided the kind of transportation funding the former president championed. As significant, it would have made permanent his One Federal Decision executive order that significantly accelerates federal permitting reviews.

"At the same time, many progressive Democrats opted to vote against the bill because of their on-

6 Best Small-Business Loans for Veterans of November 2021

Veterans can take advantage of counseling, training and discounted rates on small-business loans, to help start, sustain and expand their small business.

The Small Business Administration, for example, waives the upfront fees (typically 2% to 3% of the loan amount) on SBA Express loans for veterans and their spouses. And many community financial institutions focus on small-business loans for veterans, minorities and women.

Whether you turn to a traditional bank, an online lender or a community organization, look for loan terms that meet your needs — whether that's hiring new employees, purchasing equipment or covering other costs.

Here are the best business loans for veterans, plus more information on VA loans and other financing resources.

Can you get a VA business loan?

To qualify for a veteran business loan, your business must be majority owned (at least 51%) by someone in one of the following categories:

- Active-duty military service members participating in the Transition Assistance Program.
- Honorably discharged or service-disabled veterans.
- Reservists and active National Guard members.
- Current spouse of a veteran, active-duty service member, reservist or guard member.

 Widowed spouse of a service member who died in service or from a service-related disability.

You'll also need to meet general small-business loan qualifications, such as credit score, revenue and time in business. The exact requirements will vary by lender.

Veteran business loan options

Veteran business loans, often referred to as VA loans, are available through commercial lenders, nonprofit organizations and the Small Business Administration. (The Department of Veterans Affairs does not provide business loans.)

While some popular loan programs for veterans have been discontinued, including the SBA's Veterans Advantage and Patriot Express Loans, there are plenty of other options for veterans and their families

Veterans can borrow up to \$1 million (\$500,000 after Oct. 1, 2021) through the SBA's Express loan program. Upfront guarantee fees, typically 2% to 3% of the loan, are waived for veterans, reservists, national guard members and spouses who qualify.

SBA Express loans have a quicker turnaround time than other SBA loans — 36 hours compared with several weeks or months — but the underwriting criteria can be strict. You'll likely need a minimum FICO score of 650, strong annual revenue and at least two years in business to get an Express loan.

If you just launched your businesses or have bad credit, look into online lenders, which tend to have more flexible requirements (but higher rates).

Other SBA programs for veterans or service members include:

- Military Reservist Economic Injury Disaster Loan Program. The MREIDL can provide up to \$2 million if you have an essential employee who is a military reservist and gets called to active duty. This program is for covering regular business operating costs, not starting or expanding a business.
- SBA 8(a) program. The SBA offers this business development program to eligible businesses, which can include those owned by veterans. The SBA 8(a) program provides small businesses with a certification that can improve their chances of winning government contracts, as well as help navigating the bidding process

Are there startup business loans for veterans?

Lenders generally prefer to do business with established companies that have strong cash flow. This often disqualifies startups with less than a year of operating history and little revenue.



However, veterans and other new business owners aren't completely out of luck: If you have good personal credit, your options include business credit cards and personal business loans.

- Business credit cards. These typically provide up to \$50,000 in revolving credit, meaning you can borrow and repay from the credit card as needed, and pay interest only on withdrawn funds.
- Personal loans for business. These offer a lump sum of cash, with a fixed interest rate and repayment terms.

Both options are unsecured, meaning you won't have to put down collateral - an asset, such as real estate or inventory — to qualify.

Comparing small-business loans for veterans

When shopping for a loan, be sure to compare annual percentage rates, or APRs, which give you a holistic picture of a loan's cost. NerdWallet's small-business loans comparison tool can help. We've gauged lender trustworthiness, market scope and user experience, among other factors to help you choose the best loan.

If you're a veteran or related to a servicemember, look at lenders that cater to the military. Some may not offer funding; for example, US-AA's business loan program ended in 2018. But discounts may be available from other lenders. Bank of America reduces loan administration or origination fees 25% for veterans, for instance.

November is Native American Heritage Month, or as it is commonly refered to, American Indian and Alaska Native Heritage Month

The month is a time to celebrate rich and diverse cultures, traditions, and histories and to acknowledge the important contributions of Native people. Heritage Month is also an opportune time to educate the general public about tribes, to raise a general awareness about the unique challenges Native people have faced both historically and in the present, and the ways in which tribal citizens have worked to conquer these challenges.

NCAI participates in the DC Native Public Relations Roundtable, a group consisting of public relations professionals from national American Indian and Alaska Native organizations and agencies in the Washington, DC area. The group meets monthly to improve communication between groups and its primary function has been to create a more cohesive campaign for Native Heritage Month and to unify the month's schedule of events.

The first American Indian Day was celebrated in May 1916 in New York. The event culminated an effort by Red Fox James, a member of the Blackfeet Nation who rode across the nation on horseback seeking approval from 24 state governments to have a day to honor American Indians. In 1990, more than seven decades later, then-President George H.W. Bush signed a joint congressional resolution designating the month of November "National American Indian Heritage Month." Similar proclamations have been issued every year since 1994 to recognize what is now called "American Indian and Alaska Native

Heritage Month." This Facts for Features presents statistics for American Indians and Alaska Natives, one of the six major race categories defined by the U.S. Office of Management and Budget.


