### **Augmenting Your Construction Workforce for Success**

Construction companies remain as resilient as ever, but we'd be remiss if we didn't talk about the very real challenges our industry faces. The most pressing one, of course, is the labor shortage.

A survey by the Associated General Contractors of America (AGC) and Autodesk found that 85% of construction firms have open positions they're trying to fill, and 91% struggle to find qualified candidates for available roles.

These challenges are further exacerbated by supply chain issues—such as the 65% of firms reporting that supply chain challenges have delayed their projects.

It's no wonder then that construction companies are experiencing project delays, with 13% of firms saying they've had to postpone projects in 2023.

It's not all doom and gloom, however. While these challenges seem daunting, there are steps you can take to augment your workforce.

Construction technology has come a mighty long way in the past few years, and forward-thinking companies know how to leverage tech to support their teams.

Let's take a closer look at how you can do it, too.

### 1. Leverage artificial intelligence, machine learning, and deep learning

AI (and its subsets—machine learning and deep learning) can be a touchy subject for people because they're often seen as technologies that can replace humans. A survey by Pew Research found that over a third of workers in the US think AI will hurt the workforce, while just 13% think otherwise.

While AI concerns are valid, it's important to remember that artificial intelligence is a tool, not a replacement. When used in a thoughtful and ethical way, AI in construction empowers your team to work faster, reduce stress, and ultimately drive better decision-making.

This streamlines the process of ensuring safety compliance on-site, making it easier to identify potential risks and rectify them quickly.

Or consider Construction IQ, a built-in AI and machine learning feature in Autodesk Construction Cloud, which helps you predict, prevent, and manage risk. Construction IQ utilizes sophisticated algorithms and natural language processing to highlight higher-risk design, quality, or safety issues. Teams can take action sooner rather than later and prevent costly impacts downstream.

### 2. Consider augmented reality, virtual reality, and the metaverse

AR, VR, and the metaverse are distinct (but related) technologies that have the potential to redefine how construction teams collaborate.

AR can overlay digital elements—e.g., models or design data—onto the real world. Many teams use AR technology to visualize how a finished project will integrate with its surroundings. Another excellent use case is leveraging augmented reality to spot potential design clashes, thus avoiding costly work down the road.

VR, on the other hand, immerses users in a digital realm. Project stakeholders can operate VR headsets to experience a virtual construction site where they can conduct pre-emptive walkthroughs or safety training without physically being there.

Meanwhile, the metaverse gives teams an opportunity to "meet" and collaborate in a shared virtual space, facilitating real-time discussions on digital models and projects.

Together, these technologies bridge the gap between digital design and physical implementation. They empower teams to visualize, strategize, and execute projects more efficiently—which is a big win, especially for firms struggling with talent shortages.

### 3. Use robotics

Jobs that require people to be on the construction site are physically demanding. From carrying heavy loads to working from great heights, these jobs strain workers and lead to potential injuries. The labor-intensive nature of construction sites may also deter people from considering a career in construction

### **Governor Newsom Signs Assembly Bill 258 into Law**

### Democratizing State Resources to Empower Minority-Owned Businesses in California

The California Asian Pacific, African American and Hispanic Chambers of Commerce celebrated a significant legislative win for California's small business community – the Small Business Information Act, Assembly Bill (AB) 258, authored by Assembly Majority Leader Emeritus Eloise Reyes, was signed into law by Governor Gavin Newsom over the weekend.

process, and locating grants. Democratizing and illuminating state processes will provide small businesses more opportunities to grow and ensure public resources are reaching the hardest-hit communities

## UCLA Latino Policy and Politic Institute Launches The Economic Recovery and Entrepreneurship Project

The UCLA Latino Policy and Politics Institute (UCLA LPPI) has launched The Economic Recovery & Entrepreneurship Project (TEREP), a new research portfolio focusing on ethnic entrepreneurship in California, Texas, and Arizona. The first report published today – focusing on California – provides insights on ethnic small business owners' access to capital, use of digital technology and environmentally sustainable practices, and experiences with COVID-19 and climate change.

After conducting over 600 phone surveys with California small business owners and executives, this groundbreaking study has revealed several key findings:

 Black- and Latino-owned businesses face more barriers than white-owned businesses to accessing financial capital.

- Twice as many ethnic-owned businesses reported to have been largely negatively affected by the COVID-19 pandemic than white-owned businesses.
- Although engagement in online technology for sales is not high among ethnicowned businesses, they were more likely to report falling victim to cybersecurity attacks. Asian-owned businesses, especially, reported experiencing cybersecurity attacks at the highest rate.
- Black and Asian-owned businesses expect climate change to impact their business's finances and workers.
- White- and Latino-owned businesses reported a greater level of understanding of the impacts of environmental sustainability practices on their business than Black and Asian-owned businesses.

"As ethnic-owned businesses continue to grow, their equitable integration into economic development processes and environmental sustainability planning remains imperative, given their significant contributions to community well-being through job creation, revenue generation, and the promotion of social and cultural diversity," said Silvia R. Gonzalez, Director of Research at the UCLA Latino Policy and Politics Institute. "This research arrives at a crucial time as California policymakers, advocates, and business leaders seek to continue addressing the economic impacts of the pandemic and are hearing calls to foster a more inclusive economy that supports the growth of all communities," said Julia Silver, Research Analyst for the project.

The new research also includes interviews with six California business owners and executives. Interview findings speak to the difficulties that ethnic-owned businesses are currently facing.

Dora Herrera, executive manager at YUCA'S, a family-owned Mexican restaurant and one of the study's interviewees, shared a firsthand account of how the COVID-19 pandemic impacted the vitality of her business. "I told my sister, 'If the money doesn't come in Friday or Saturday, we're gonna have to close on Monday.' And the money, the grant, dropped on Saturday. We were that close to just closing." Herrera's experience is just one of the many accounts captured in the study.



Downtown's next 'whale' could net even more
A COMMENTARY

In local real estate parlance, a "whale" is a development project whose total floorspace measures 1 million square feet or more. Not only are they big, they're tough to get. But there are two Cleveland entities who were able to do what Capt. Ahab could not — catch the whale. Two whales are under construction right now — Sherwin-Williams' new headquarters tower downtown and Cleveland Clinic's new Neurological Institute in the Fairfax neighborhood, near University Circle. A third whale is in the early stages of the chase, a stage where things are most fluid and thus, very intriguing.

The whale is the Cuyahoga County's Consolidated Courthouse — a facility that would unite court facilities and related offices that are spread among multiple buildings downtown. It will be a massive project costing \$400 million to \$700 million to build or renovate. NEOtrans spoke with real estate insiders — developers, architects, engineers, construction managers, brokers, lawyers, financiers and county officials — to get their insights into this whale of a challenge that was posed by the county in two requests for proposals (RFP) issued last summer and whose deadlines passed last week, netting seven responses.

First, let's understand that this county initiative really has two basic parts. One is to provide a consolidated courthouse for the future. That could be accomplished by building a new structure somewhere else downtown, away from the current 7-acre Justice Center campus whose jail facilities and police headquarters are departing, respectively, for Garfield Heights and downtown's ArtCraft Building. Or it could involve renovating another, existing building somewhere else downtown. Or it could involve renovating the existing courthouse tower either as part of an

expanded courthouse complex or with new uses.

That might leave standing alone on the Justice Center campus the 1977-built, 420-foot-tall, 26-story courthouse tower at 1300 Ontario St. In the tower are many court offices and hearing rooms that are jammed into every conceivable space - hallways, closets and shared rooms that cause scheduling conflicts and security issues. It's why county officials want to replace or augment the 675,887-square-foot tower (not including its 124,230-square-foot atrium or 318,738-square-foot underground parking garage with 645 spaces) with a consolidated courthouse having 893,120 square feet of space. Again, that doesn't include atriums or parking decks. Those will certainly be provided and push the project well into the whale category

The second part of the county's initiative is to sell, lease or otherwise put into play the court-house tower, its surrounding pair of jail blocks, old police headquarters, and the land on which they set. This also includes offering the nearby, historic, county-owned Courthouse Square building, 310 W. Lakeside Ave. But just because county officials want to see what responses they get for both the Justice Center property and for the future courthouse, doesn't mean they are separate issues.

A proposal could involve an investor partner-ship acquiring the Justice Center site, renovating the poorly built courthouse tower and leasing it back to the county as a courthouse again while developing the rest of the site, plus Courthouse Square, with expanded courthouse offices and other uses like a hotel and/or residential uses. Or the county could pick two proposals — one that builds a new consolidated courthouse away from the Justice Center campus and the other that repurposes the Justice Center campus with new uses.

As noted earlier, there were seven responses to the Courthouse/Justice Center RFP. And the responses appear as varied as the county hoped they would be, giving them and their consultant,

CBRE Group Inc., a wide variety of choices to compare using its scoring matrix. NEOtrans was unable to secure a copy of the matrix as the county and CBRE cited non-disclosure agreements. There is no timeline for making a decision, a county spokesperson added.

However, several years ago when the county began looking for new sites for its jail and courthouse facilities, a steering committee measured those sites with criteria that anyone might expect in this case. The committee wanted a new courthouse downtown, built as close to the existing one as possible because supportive services are already nearby. That includes many law firms, parking areas, public transportation and restaurants for courthouse employees, jurors and visitors. Obviously cost-effectiveness is a key issue. Major, long-term assets and their cost of capital are measured over a 30-year timeline. Which project costs the least in that term is going to rate highly. And a courthouse plan that could be delivered with confidence more quickly and with fewer disruptions to courthouse operations would have won more points, too.

Plus, at least several acres of clean land that involved as few owners as possible was desired by the steering committee. It should be noted that the committee had preferred a cheaper mid-rise building over a more expensive high-rise building, thus requiring more land. And the committee

preferred to move the courthouse facilities only once. The poor condition of the existing courthouse tower required that it would have to be completely vacated in order to be properly gutted and renovated. Thus, the courthouse offices and staff would have to be moved twice if the current courthouse was renovated to remain as a courthouse. That's why the committee didn't support remaining at the courthouse for the future. But the current RFP included the courthouse anyway to see what ideas the private sector had for it and what those costs might involve.

Two of the RFP responses — by Lincoln Property Company Commercial LLC (dba Lincoln Property Company) of Chicago and by U.S. Realty Advisors of New York City — may involve acquiring the Justice Center campus and leasing some or all of it back to a large, single tenant. Those types of deals are often pursued by these two firms, according to sources who spoke on the condition of anonymity. The question is — if it is a large tenant, who is it? Is it Cuyahoga County? Unfortunately, these are the only two proposals into which NEOtrans has few insights. All parties are under non-disclosure agreements.

### Former US marine on how military veterans can build a construction career

Thousands of former military personnel are benefitting from a move to step up efforts to bring more veterans into the construction industry and to better transition battlefield skills to worksites. Lucy Barnard speaks to one of them.

Craig Knight spent the first years of his career as infantry sergeant in the US Marines, squinting through gun sites at the Middle East dust.

Stationed in some of the most dangerous war zones on the planet, as an MOS 0352, an antitank missileman, Knight was responsible for operating shoulder-fired and vehicle-mounted hi-tech weapons systems capable of destroying enemy targets at a range of more than 3,000

"Actually, being there in combat - you can't prepare yourself for it," Knight says slowly. "I've always been in shape so I felt like the physical aspect of it wasn't as difficult as I thought it might be but the mental and emotional aspect of it all, seeing death and destruction – and being away from family - that was difficult.'

"I originally thought I'd do it for 20 years - go in there full time and then retire. No problem," says Knight, now 34. "But in the military, the years, they're like dog years. They really wear on you."

After two tours of duty - first in Helmand Province, Afghanistan, taking on "disruption operations" against the Taliban and then in Al Anbar province in Iraq, taking part in operations against ISIS - Knight was ready for a less traumatising

Having originally signed an eight-year contract comprising four years active duty and four years of inactive service, by 2017, at the age of 28, Knight had had enough.

"My contract was coming to an end, and I had to make that decision – do I want to keep doing this for another four years or should I try a civilian job doing something else," Knight says.

But eight years in the Marine Corps left no obvious career path.

"I felt I didn't have a skill. I don't know how to lay brick or connect steel or something," says Knight. "For some, military jobs, say a lawyer or mechanic, come with those hard skills which you can transition fairly easily to civilian life," says Knight. "But being in the infantry, it's a little bit more difficult to transition those hard skills?

Despite having had no experience of the construction industry, Knight decided to use his GI Bill education allowance on leaving the army to enrol on a master's degree course in construction management at Wentworth Institute of Technology.

"Outside of digging in a defence - sandbag huts and some fighting positions and stuff like that, construction was never a part of my job in the

military," Knight admits. "But I always was intrigued about how things are built and I was good with my hands and building things so I figured I would transition into that."

The move paid off. While studying at Wentworth, Knight met a friend of a friend who worked for Suffolk Construction, the largest construction contractor in Massachusetts, and who was able to secure him an interview for his job at Suffolk.

Knight is just one of thousands of former military personnel benefitting from a move from recruiters to step up efforts to bring more veterans into the industry and to better transition battlefield skills to construction sites.
