What Cities Should Be Doing for Small Business

Small businesses are the backbone of urban economies: They play a critical role in creating jobs for local residents. Yet too often city leaders and economic developers are not prioritizing small businesses when allocating resources to drive growth, focusing their strategies instead on the attraction and retention of large businesses.

A new report by the Initiative for a Competitive Inner City may make public officials consider shifting these priorities. The report provides compelling evidence that small businesses rival, and often exceed, the impact of large businesses when it comes to job creation.

The research, conducted with the support of JPMorgan Chase, was released on the heels of the bank's announcement that it was committing an additional \$75 million to its Small Business Forward initiative, recognizing the contribution of small businesses to economic opportunity and reducing unemployment, especially for women, minorities and veterans.

ICIC's report measures the current state of small business jobs in five cities: Chicago, Dallas, Detroit, Los Angeles, and Washington, D.C., and identifies key findings regarding small businesses and urban job growth.

In all five cities, the distribution of small businesses and large businesses is similar, with small businesses -- those with 250 employees or fewer -- representing at least 99 percent of all businesses in the city. Despite this parallel, small-business job creation varies across the cities ICIC studied, ranging from 48 percent in Dallas to 74 percent in Los

- In four of the five cities, small businesses create most of the jobs: 58 percent in Chicago, 53 percent in Detroit, 74 percent in Los Angeles and 62 percent in D.C. In Dallas, small businesses provide slightly less than half of all jobs. Although "micro" businesses (those with one to five employees) make up the largest share of businesses in the cities ICIC studied, mediumsized businesses (those with five to 249 employees) are driving job creation.
- The importance of small business jobs is greater in the inner city. In four of the five cities, small businesses create a greater share of jobs in dis-

Women Veteran Owned Small Businesses represent a burgeoning economic powerhouse in the military small business community. As of 2012, women veterans owned 383,302 businesses, generating \$17.9 billion in sales. From 2007 2012, despite only representing 15.2 percent of the total number of all veteran-owned businesses, the number of women veteran owned small businesses increased by 294.7 percent.

The Business Case for Diversity

The good news is that there is broad agreement that diversity serves a social good. The vast majority of technology executives (72%), for instance, see diversity as very important, according to a recent survey by Lawless Research.

The bad news is that businesspeople fail to recognize that diversity also has benefits to the bottom line. Only 23% of respondents in that same study said they see a clear connection between diversity and financial performance. While similar data does not exist for banks and credit unions, my experience indicates there is a similar disconnect: Our industry believes that diversity is the right goal to pursue, but we don't necessarily see a financial incentive for taking action.

This bodes poorly for the future of the industry. There is no question that the demographics of our country are changing: 16% of the U.S. population is Hispanic and 13% is African-American. Furthermore, the Hispanic and African-American populations grew by 43% and 17%, respectively, between 2000 and 2010. And while the Asian population represents only 5.5% of the U.S. population, it grew by 46% in the first 10 years of this century. If businesses aren't figuring out a way to change, too, they risk being left behind.

The financial services industry should view these changes as a massive opportunity. For example, while 55% of white Americans are invested in the stock market, just one in three African-Americans and one in five Hispanics are investors, according to a 2013 Pew Research Center study.

Many of us are quick to think about closing this divide in terms of social justice. Since the Great Recession, the stock market's climb has created an extremely uneven recovery. The net worth of the wealthiest 7% of Americans increased by about 28%, while the net worth of the other 93% declined by 4%, according to the Pew Research Center. But shrewd business leaders will match their desire to create wealth for more American families with some simple math: add up all the potential new customers that will come from helping more Americans achieve financial stability that long-term investing can bring, and you will realize that striving for diversity is an excellent example of acting in one's enlightened self-interest.

Now comes the hard part: how can a financial services firm appeal to a more diverse clientele? During my tenure at the National Credit Union Administration, we thought a great deal about this. What we found, in consultation with credit unions in communities across the country, is that perhaps the single most important step is to hire a staff that reflects the community the business is striving to serve.

This is a tall order. To accomplish it, leadership at the top of the organization must make increasing employee diversity a priority goal by providing resources and processes to ensure success. The leadership must also make sure that managers and supervisors understand that a staff that reflects the population of the community makes it easier to build inroads with community leaders and non-profit organizations — essential elements to developing trust.

Hand-in-hand with hiring more diverse staff is participating in community events sponsored by local groups and offering classes in various aspects of financial education. Classes might include basics such as budgeting, understanding credit scores and borrowing prudently along with more sophisticated topics such as explaining the stock market and how to invest wisely. If done correctly, these initiatives will open the door to further dialogue and earn trust among the target constituencies. The institutons that are most successful in reaching various demographics are those that really became active members of their communities.

It is important to understand that this will be a long-term effort. Building trust and new relationships, particularly among communities that have historically felt disconnected from the financial services industry, won't come easily. But the result is worth the effort. Making diversity a business priority can lead to financial benefits and help a company realize its full potential.

There is a caveat. Diversity without inclusion will not produce the desired results. In other

words, merely hiring a diverse workforce without providing an accepting culture could derail any potential benefits from increased diversity. For instance, studies indicate that when women feel they are hired to fill quotas, it hurts relationships between co-workers. The same can be said for other racial and ethnic minority group members.

So, to be effective, business leaders must be proactive. First, they will need to assess the current diversity level to set benchmarks. Next, they will need to develop a hiring strategy that increases diversity without ignoring merit. Finally, they will also need to foster an inclusive and engaged culture by providing training and messaging as well as setting diversity goals and holding leaders accountable for diversity progress.

The business case for diversity is strong, but achieving it will be complicated. It requires an astute understanding not just of a given industry, but also of a company's workforce and the unique needs of the community. By thinking about diversity as a matter of the bottom line, we can and must evolve it from "nice to have" to "need to have"



Loan Volume Nears \$1 Billion in Northern California in FY 2016

The U.S. Small Business Administration (SBA) San Francisco District Office approached \$1 Billion of loans in Fiscal Year (FY) 2016 for over 2,000 loans including Microloans, 7(a) Guarantee and the 504 loan programs.

"The leveling off in our lending numbers from FY15's record setting amount speaks to California's strong economy and competitive lending environment." District Director Mark Quinn said. "These lending numbers show confidence in the economy and the impact small businesses make toward economic recovery."

120 lenders participated this fiscal year by approving 1,968 SBA guaranteed loans in Northern California for \$970,322,300. California, as a whole, topped \$5 Billion in SBA lending for the second year in a row with over 10,000 borrowers

and 233 lenders. California accounts for 19% of the total national SBA loan volume.

SBA's flagship loan program, referred to as 7(a), provides small businesses with comprehensive financial assistance covering the vast majority of small business needs including working capital, fixed and intangible asset financing, as well as refinance and export support through term and revolving loans. In the San Francisco District, 1,714 loans were approved in the 7(a) program for \$718 million.

504 loans provide small businesses with long-term fixed rate financing to acquire fixed assets for expansion or modernization. 504 loans are available through Certified Development Companies (CDCs), SBA's community-based partners. In the San Francisco District, 254 loans were approved

in the 504 program for \$251 million. Reauthorization of the 504 Debt Refinancing Program in May was instrumental in the success of the 504 Program in FY16.

Community Advantage Loans serve underserved markets, provide up to an 85 percent guarantee on loans up to \$250,000 and offer technical assistance to improve the rate of success among participants. California leads the nation with 25% of the country's Community Advantage lending.

For the third consecutive year, the San Francisco District's average loan size went down slightly for 7(a) loans to an average loan size of about \$419,000 for the fiscal year. The lower average loan size for 7(a) loans can be attributed in part to the fee relief SBA has offered for loans up to \$150,000, a program which has been extended for

another year. However, the average loan size in San Francisco continues to be higher than the national average, mostly as a reflection on the higher prices for commercial real estate in the Bay Area.

The San Francisco SBA District Office covers Alameda, Contra Costa, Del Norte, Humboldt, Lake, Marin, Mendocino, Napa, San Francisco, San Mateo, Santa Clara, Santa Cruz, Solano, and Sonoma Counties. Over 120 banks, credit unions and community lenders participated in various SBA loan programs. Annually, the San Francisco District Office cohosts over 1,000 training events for over 50,000 Bay Area small businesses or prospective businesses from SBA resource partners.

SBA and Milken Institute Launch Initiative to Improve Access to Capital for Underserved Communities in Los Angeles

The U.S. Small Business Administration (SBA) and the Milken Institute jointly launched the Los Angeles pilot program: Partnership for Lending in Underserved Markets (PLUM). This groundbreaking collaboration will develop and test initiatives designed to more effectively deliver capital to deserving minority-owned businesses throughout the United States. Los Angeles is only the second American city with a pilot PLUM program. Today's launch event included a workshop at the University of Southern California that brought together small business leaders from Los Angeles with the SBA and Milken Institute.

In making the announcement, Maria Contreras-Sweet, SBA Administrator and the voice of small business on the President's Cabinet, said: "PLUM will give entrepreneurs the tools and resources they need to change lives and rebuild communities. And while we have made great progress – SBA guaranteed loans have increased 21 percent to African-Americans and 18 percent to Hispanics in the past year – we still have work to do. As we did in Baltimore, I look forward to expanding this effort in Los Angeles and applying what we learn in communities across the country."

Kevin Klowden, executive director of the Milken Institute's California Center and co-chair of the Los Angeles Task Force, said: "In launching our pilot in Los Angeles in conjunction with the SBA, we specifically want to focus on the need to bring capital to African-American and Latino small businesses and provide them with new opportunities for real growth. In addition, we seek to stimulate job creation through directly addressing lending gaps in underserved communities. We look forward to working with the leaders of both Los Angeles and Baltimore to do so."

"Small business is a crucial ingredient for creating jobs and widening prosperity," said Eric Garcetti, Mayor of Los Angeles. "Widening access to capital for small businesses in tradition-

ally underserved communities, especially African-American and Latino, is a key goal of my administration, and so I am delighted that the SBA and the Milken Institute will be working in the city of Los Angeles to help realize that goal."

Following the Great Recession, small business owners, especially those setting up shop in underserved markets, have faced a recurring problem of limited access to capital. Conventional small business credit is still only at 85 percent of its pre-recession level. These gaps are especially evident in metropolitan areas with higher proportions of minority-owned businesses including Baltimore, Maryland and Los Angeles, California

The PLUM initiative responds to this persistent challenge by bringing together leaders and policy experts from SBA and the Milken Institute to develop policies, recommendations, and concrete steps toward increasing access to lending and other sources of business capital in minority and other underserved communities.

The long term goal of the initiative is to increase the capacity of lenders to better serve historically underdeveloped sectors of the small business community. Baltimore and Los Angeles were chosen because their economies also impact surrounding communities and can help drive growth in larger regional economies.

"My Administration is committed to creating greater access to capital and business opportunities for Baltimore City's small, minority, and womenowned businesses," said Stephanie Rawlings-Blake, Mayor of Baltimore. "Partnering with the SBA, Milken Institute and the city of Los Angeles on the PLUM initiative expands the opportunity to connect minority entrepreneurs and traditionally underrepresented business communities to programs that encourage their growth. Together we can create resources that address capital access disparities in order to bolster the health of local economies, which thrive when small and minority-owned businesses are successful."

Aron Betru, managing director of the Milken Institute's Center for Financial Markets and co-chair of the Baltimore Task Force, said: "After launching the Baltimore PLUM Pilot last month, I couldn't be more excited that we are now kicking off the Los Angeles PLUM Pilot, where the Milken Institute is headquartered. I know firsthand how the community of minority-owned small businesses in Los Angeles can benefit from this collaboration between the Milken Institute and the Small Business Administration to promote financial market understanding and increased access to capital."

For its part the Milken Institute will provide direction, research and engagement with stakeholders to address specific challenges faced by small business lending in underserved markets. SBA will provide expert leadership, data and information to support the initiative and will market transferrable solutions to other cities and communities beyond Los Angeles and Baltimore.

Partnerships for Lending in Underserved Markets (PLUM)

Minority owned small business play an important role in our nation's economic health, driving job creation, rising wages and better standards of living in communities throughout the U.S. Current and projected economic growth rates show minority-owned businesses are even outpacing their non-minority counterparts and have now overtaken pre-recession levels. However, other economic indicators show lagging investment in minority-owned companies. As these companies continue to perform, that gap has revealed a growing untapped market of high-return investments for business leaders and other investors with the vision to spot them.

Development of these promising minorityowned small businesses presents an exciting opportunity to catalyze latent market potential in previously under-developed areas. These are areas where targeted investment has shown transformative potential for local and regional economies with the tools and resources to build a profitable business and leverage opportunity. The PLUM initiative is in the process of developing collaborative organizational structures that will help minority entrepreneurs realize these opportunities and tap into an interested audience of investors.

The PLUM Initiative is a two-year pilot committed to developing straightforward, commonsense approaches to reducing barriers to capital, creating economic opportunities, and improving lending to minority small businesses initially in Baltimore and Los Angeles. Combining the Milken Institute's financial focused research and the Small Business Administration's commitment to all minority communities, this initiative will:

- Increase Access to Capital: The initiative will examine the potential for partnerships and the implementation of next-generation technology in addressing underserved markets, the development of flexible financial products and services tailored to African-American and Hispanic small businesses, and the potential for an active secondary market to ensure capital sustainability in the region.
- Tailor Technical Assistance: The initiative will
 examine the technical assistance and training
 available and provided to small business owners.
 The initiative will also examine the different sectors within the African American and Hispanic
 communities to ensure that any training is culturally competent and meets the differing needs
 and priorities of the communities.
- Strengthen Public-Private Partnerships: The initiative will focus on improving current programs and policies from a regulatory standpoint, as well as recommend new initiatives to encourage lending to underserved markets. Efforts will also focus on developing a report card to determine the overall success of the pilot initiative.

tressed inner-city neighborhoods than in the city overall: 70 percent in Chicago, 64 percent in Detroit, 77 percent in Los Angeles and 74 percent in D.C. Dallas is distinct in that large businesses employ more inner-city residents than small businesses, which only account for 38 percent of jobs.

• Inner-city unemployment is not insurmountable, and small businesses can play a key role in creating opportunities. In these five cities, a modest increase in small-business jobs could create enough employment opportunities for all unemployed inner-city residents. In four of the five cities, this growth translates to only about one additional employee per small business. Of course, this is not to suggest this growth will come easily for these small businesses, many of which have fewer than five employees. With relatively higher unemployment, Detroit would also require more aggressive small-business growth, just over three jobs per small businesss.

Despite the big impact small businesses can have on job creation, small-business support in most cities is an uncoordinated set of programs that focus only on the business owner's education rather than on the larger business environment. City leaders will need to leverage new tools

to maximize small-business job creation in their cities. ICIC offers five critical strategies:

- Create a comprehensive small business plan connected to regional and city economic assets.
- Expand contracting opportunities for small businesses so that they can compete on procurement contracts with government and anchor institutions.
- Design workforce programs for small businesses, since many do not have the resources or capacity to recruit and train new employees (especially those with barriers to employment).
- Coordinate resources and ease burdensome regulations by mapping and making more accessible the resources that already exist.
- Upgrade the inner-city business environment by improving infrastructure and neighborhood amenities to support small-business growth.

Big tax-revenue gains and economy of scale continue to shape how many economic-development professionals think about job creation. Yet ICIC's report makes a strong case for city leaders to support the growth of small businesses with the same resources and intentionality as they do with their efforts to attract and retain large businesses.

Closing the Gap: Secretary Pritzker Outlines 3 Priorities to Promote Equal Opportunity for Women

Speaking before 200 participants at the 13th Annual Lockheed Martin Women's Impact Network Leadership Forum, U.S. Secretary of Commerce Penny Pritzker made the case for the advancement of women in today's high-growth, high-tech industries.

During the Forum, Secretary Pritzker highlighted three ways that government and industry leaders can work together to make our workplaces more inclusive, and as a result, our companies more competitive on a global scale.

1. Implement policies that reflect the wealth of evidence suggesting that gender equality is a strong competitive advantage.

Secretary Pritzker highlighted efforts underway at the Department of Commerce to break down barriers for women in today's most innovative fields. As examples of these efforts, Secretary Pritzker pointed to the U.S. Patent and Trademark Office's "All in STEM" program, which aims to get more girls interested in science and technology; and the Minority Business Development Agency's "Inclusion Innovation Initiative," which connects women and minority entrepreneurs with opportunities to commercialize new technologies developed in our federal research labs.

2. Leverage the power of big data to identify inequities and create solutions.

In today's era of big data, tools are available to measure, examine, and address issues of in-

come inequality. For example, the Commerce Data Service worked with the Census Bureau to launch MIDAAS – or Making Income Data Available as a Service. Using the MIDAAS API, developers created tools that help individuals make data-driven decisions when it comes

to closing the pay gap. Data analysis, using Department of Commerce statistics, offers companies a new way to root out disparities among their employees, identify challenges that prevent women from climbing the corporate leadership ladder, and create solutions that promote inclusivity in the workplace.

3. Empower female entrepreneurs and innovators around the world.

Public and private sector leaders must work together to promote women's economic empowerment around the world. When women are able to succeed as entrepreneurs, economies grow, families benefit, and societies change for the better. At the Department of Commerce, Secretary Pritzker chairs the PAGE program, which connects top American entrepreneurs with young innovators from around the globe for mentorship sessions, workshops, and meetings with top investors.



American Indian and Alaska Native-Owned Businesses in the U.S.


(Sectors With at Least 500 Businesses)
