

# Creating an Inclusive Workforce for Native Americans

The Office of Federal Contract Compliance Programs (OFCCP) and its Indian and Native American Employment Rights Program (INAERP) support federal contractors' efforts to foster outreach and inclusion of Native Americans. Below is a list of best practices and strategies to help with efforts and make your diversity and inclusion programs successful.

**Indian Preference** – It is not a violation of the equal employment opportunity clause if a federal contractor maintains a publicly announced Indian employment preference if it is working on or near an Indian reservation. Implementing an

Indian preference policy is one of the best practices for increasing Native American representation in the workforce. Visit OFCCP's Indian and Native American Employment Rights Program webpage for answers to frequently asked questions and other guidance regarding when and how to implement Indian Preference.

**Utilize INAERP Recruitment Services** – INAERP can assist your company in its affirmative action efforts by researching Native American recruitment sources to match the unique employment needs of your organization. Contact INAERP at [OFCCP-INAERP@dol.gov](mailto:OFCCP-INAERP@dol.gov) to learn more about this service.

**Collaborate with Tribal Employment Rights Organizations** – Tribal Employment Rights Organizations (TEROs) use education and synergistic partnering principles to create mutually beneficial relationships with employers working on or near Indian reservations. TEROs are an invaluable resource for contractors seeking skilled job applicants and are subject matter experts on the laws and customs of their respective tribe. INAERP can assist with connecting you to a local TERO representative.

**Request a Subject Matter Expert to Conduct Sensitivity Training** - As your workforce becomes more diverse, invite a local tribal representative to conduct sensitivity training explaining the customs and traditions of their respective tribe. A TERO representative can assist you with your request.

**Network with Tribal Colleges and Universities** – With 37 accredited Tribal Colleges and Universities (TCUs) in the United States, federal contractors can tap into a pipeline to approximately 30,000 full-time and part-time students seeking post-secondary education in over 350 educational programs, including apprenticeships, certificates, associates, and bachelor's degrees.

**Establish Relationships with Urban Indian Centers to Use as a Recruitment Source** – With approximately 75% of the Native American population living off reservations, urban Indian centers serve as another key recruitment resource for contractors that are looking for job

applicants with varying backgrounds, education levels, and skill sets.

**Comprehensive and Welcoming Self-ID Programs** – It is critical that employers create an environment in which applicants and employees are comfortable self-identifying to effectively measure the success of affirmative action efforts. Including Native Americans in job advertisements and on company websites in a culturally respectful manner will increase the likelihood of participation in corporate self-identification programs.

**Sustain Long-term Relationships** – Tribes value trust and patience when fostering relationships. Set realistic goals when working with tribal organizations by acknowledging that it may take a long-term investment to see measurable results.

**Reconsider Employment Tests** – Companies frequently utilize standardized employment tests to screen applicants for qualifications. Native Americans are often sensitive to these types of tests for historically denying their elders access to education and employment. When possible, use other methods to screen candidates for necessary job qualifications.

**Create Native American Employee Resource Groups** – Employee Resource Groups (ERG) offer employees the opportunity to network, address shared issues and concerns, and receive support from fellow Native Americans.

# EPA Awards Nearly \$1.2M to Three California Small Businesses to Research Environmental Issues and Help Grow the Green Economy

This week, the U.S. Environmental Protection Agency (EPA) is announcing almost \$1.2 million in research funding to three California small businesses to further develop and commercialize their environmental technologies. The funding comes through the agency's Small Business Innovation Research (SBIR) grant program.

"California's small businesses are leaders in creating innovative and practical zero waste solutions that have far-reaching benefits for communities," said EPA Pacific Southwest Regional Administrator Martha Guzman. "These companies' efforts to bring their technologies to market will advance the circular economy while reducing waste that ends up in a landfill and cutting greenhouse gas emissions."

Each year, EPA issues an SBIR solicitation for technology proposals for targeted environmental topics. The SBIR program consists of two phases of funding. The companies announced today earlier received Phase I contracts of up to \$100,000 for six months during the "proof of concept" of their proposed technologies. Now, for this Phase II announcement, companies are awarded up to \$400,000 to further develop and commercialize their technologies.

**This year's SBIR Phase II award recipients in California are:**

**Hydrova Inc. (Santa Ana; \$400,000)** - A novel process to recover resources and produce hydrogen from secondary aluminum processing waste. The technology transforms traditionally land-filled wastes into valuable products that can be reused by the aluminum and cement industries.

"The EPA's Phase II grant will support the commercialization of Hydrova's DrossZero™ systems," said Julian Davis, CEO of Hydrova Inc.

"By closing the loop in the aluminum industry, Hydrova is furthering the United States' leadership in advanced recycling technologies."

**Kamilo, Inc. (San Francisco; \$399,989)** - Digital verification of the percentage of recycled content in individual products to advance plastic circularity. Kamilo's patented geospatial technology tracks waste plastic. This project will expand the ability to calculate the percentage of recycled content in products and convey this information with a Kamilo "TrustMark" verification label supporting regulatory compliance and substantiating marketing claims.

"We are thrilled to be recognized by EPA for our innovative technologies and for the opportunity to make a real impact on U.S. recycling and plastic circularity," said Anna-Marie Cook, CEO of Kamilo, Inc. "Thanks to the EPA SBIR program we are ready to commercialize our Kamilo % Recycled Content TrustMark."

# Hidden Value of ITBs

Expand Your Network, Grow Your Profit

Are the responses to your latest invitation to bid or ITB not generating the buzz you expected? It may be time to take a step back and work on actively expanding your network.

Take a good look at your ITBs. They are holding gifts you may have never considered before. The value of an ITB is based on action and being proactive in your outreach to contacts. An expanded network gives you more trusted, skilled options to deliver true customer value and expectations. Once you've nailed down your network, you can better evaluate profitability based on the needs of each project and your ability to deliver quality results.

So, where do you start? Turn on the inner extrovert and start relationship building.

### If you're a General Contractor:

Looking at ITBs as a networking tool begins with two buckets of contacts: your current network and people you do not know. When you're working with a bid management tool, you'll

have a built-in network of fresh and new connections. With access to new contacts that will see your projects, you can be proactive in your follow up with them.

Here are some next steps for a successful interaction:

- Make the follow-up call part of your process. A good best practice after sending your ITB is to follow up with a phone call. The conversation isn't over if you find out this contact can't make this specific bid. If they're already booked for that time, you can ask when they will be free. Or you can invite them to participate in another project at a different time.
- Take note of the conversation. Never treat the follow-up conversation as a one-off conversation. It is helpful to think of this person as a potential partner, so make sure you're making notes during the conversation. Maybe you can hear their dog barking in the background, or you just happened to call them on their birthday. These are talking points that will make future outreach much easier. Having a bid management tool, where you are able to take notes and

build actions from your conversations allows you to be more personal in future outreach.

If you're a Subcontractor:

When you receive an invitation to a party, do you respond or not? If you can't attend, at the very least, you should let the host know you appreciate the invite, and that you'll try to meet up soon. Just like a party invitation, the inviting general contractor is expecting a response. If you don't respond, you might miss your chance to work on the next best project this GC has available.

- Take the opportunity to connect about a future project. If you receive an ITB, you should evaluate it as usual to decide if it's a yes or a no. If it's a project that you know you're not going to bid on, there are still networking opportunities there. Give the GC a call and tell them why you cannot take this job and follow up with questions, "What else do you have in your pipeline that I could work on? Do you have jobs in your pipeline that we can collaborate on?"

If you're a Service Provider:

It's not just about the ITBs. Using a project lead service, there is an opportunity to go look

at projects and raise your hand to spark conversations and interest in what you can bring to the table.

- Line up your next opportunity on your current job site. While on-site, you can talk to the other trade contractors or the general contractor because they're not competing with you for work and ask what their next job is. This is particularly important if you're a service provider since often you are left out of the bidding process or thought of at the last minute.

### Final Thoughts

To get actual value out of ITBs, you must be willing to put yourself out there and make personal connections. Never think of networking as extra work, but as part of the process to bring in quality, profitable jobs for your business.

# More Jobs, Better Careers: California Distributes \$72.5 Million to Create Regional Education-to-Career Pipelines

**WHAT YOU NEED TO KNOW:** California is awarding \$72.5 million to four regions across California to provide students with more job and career opportunities in their local communities, improving access to higher education and workforce opportunities.

As part of California's effort to improve access to high-paying and fulfilling careers for students and workers, today Governor Gavin Newsom announced the state has awarded four final awards – totaling \$72.5 million – for the Regional K-16 Education Collaboratives Grant Program as part of a \$250 million investment in the 2021 Bud-

get Act. This program is a key component of a statewide strategy for strengthening regional economies, improving education-to-career pathways, and ensuring that education, vocational, and workforce programs work in partnership to provide broader access to education and employment opportunities. The funds were awarded by the Department of General Services (DGS), Office of Public School Construction, and the Foundation for California Community Colleges.

**WHAT GOVERNOR NEWSOM SAID:** "Every Californian should have the freedom to succeed by obtaining real-life skills and fulfilling careers — including those that don't require college degrees. With today's investment, Califor-

nia is yet again going further to prepare students and workers for high-paying, long-lasting, and fulfilling careers."

"The Department of General Services is proud to play a vital role in administering this much-needed program that ensures equitable pathways to meaningful careers and employment for all Californians," said **DGS Director Ana M. Lasso**. "As the program expands throughout all state regions, DGS is excited to see this valuable model for successfully bridging disparities in California communities."

As communities across the state work to transform California's public education system from cradle to career – scaling universal transitional

kindergarten, expanding after-school programs, improving college access and affordability, and more – the regional collaboratives being funded by the state are marshaling action and promoting implementation. Along with priorities such as California Jobs First, formerly known as the Community Economic Resilience Fund (CERF) and Cradle-to-Career Data System, California is building partnerships and structures for translating policies into on-the-ground improvements for students and workers.

Today's \$72.5 million in awards — four awards of approximately \$18.1 million each — will be going to the following collaboratives:

Encourage senior leadership to attend regular meetings and offer their time and resources as mentors.

**Coordinate with Tribal Vocational Rehabilitation Agencies** – Many tribes have their own vocational rehabilitation agencies that assist tribal members with disabilities in their efforts to find, secure and retain gainful employment. These organizations are an invaluable resource for successfully matching an individual's skills with jobs.

**Locate American Job Centers on the CareerOneStop** – Many American Job Centers are located on or near tribal communities. These centers offer numerous resources to assist your business in its affirmative action efforts to recruit, hire, train, and retain Native Veterans and Native Americans in general. They also provide job seekers free help for finding employment.

**Look Beyond Statistics** – Federal contractors routinely evaluate employment data for adverse impact against minority race groups. Frequently, they overlook Native Americans in statistical analyses because their representa-

tion is only 1% of the U.S. population. Take a broader look at your facility or organization to determine if Native American representation is indicative of those qualified to perform jobs in the relevant recruitment area.

**Consider Access to the Internet** – Access to high-speed internet is one of the biggest challenges facing Indian Country. Your company's usual methods of digital recruitment may not reach potential applicants on many reservations where access to the internet is non-existent or extremely limited. Consider placing advertisements in tribal newsletters and on tribal radio stations to reach potential job applicants.

**Engage Tribal Stakeholders for Recruitment** – Engage tribal leadership and other tribal stakeholders to be advocates for your company by helping them understand your corporate values and company recruitment and selection processes. Ask them to join you as ambassadors at TCU recruitment fairs, to sit in on corporate interview panels, and encourage their input when developing corporate cultural sensitivity training.
