# **3 Megatrends Transforming the Future of Construction**

It's normal to hear people saying they know what the next big thing in construction is going to be, but how often do those predictions really play out? Whether it's the lastest on-site robotics or cuttingedge hardware, it's hard to know what will really happen in the future and how those trends may transform the field as we know it today.

Trends come and go, but megatrends can make a huge ripple effect that lasts. Megatrends, or driving forces that define the world now and in the future, tell us what we can expect as time passes. They show us global patterns that influence the environment, mobility, and behavior.

Interestingly, there are some trends that could truly transform the industry for many decades to come. Here are the biggest megatrends to keep an eye on in the future.

### Sustainability:

A Shift Towards a Circular Economy

Sustainability is the first megatrend to discuss as the world looks for ways to help protect the environment and become more efficient and sustainable. To become sustainable, the culture of construction has to change into one of a circular economy.

What's a circular economy? It is one that tries to replace the take-make-waste systems with a circular system instead. That system helps keep products and materials in use, designs out waste and pollution, and focuses on regenerating the natural systems that may be impacted during construction or demolition.

With this concept, the construction industry can move forward in several ways. Some ideas for working towards a circular economy (and one of better sustainability) include:

- **Source reduction**, which helps reduce the amount of new materials needed for construction. For example, trying to preserve parts of an original building being renovated rather than demolishing it could help minimize the use of new materials.
- Salvage/Reuse, which would look at ways to reuse or repurpose materials during a build
- **Waste separation**, which takes care of waste that cannot be eliminated during construction but makes sure it is disposed of property or taken to recycling facilities for processing
- **Recycling**, which targets materials that may be reused again post-demolition or when there are extra parts or materials available after a build



# Mayor Breed Announces \$9.6 Million Federal Grant to Improve Critical Southern Waterfront Infrastructure

Mayor London N. Breed and Port of San Francisco Director Elaine Forbes today announced a \$9.6 million grant awarded to the City from the United States Department of Transportation (DOT). The grant, made possible by the Bipartisan Infrastructure Law and additional Congressional appropriations, will fund roadway improvements on Amador Street in the southern waterfront. Amador Street is the gateway to the Port's Maritime Eco-Industrial Complex, which provides sustainable, local jobs for working people in diverse industries.

"I want to thank President Biden, Speaker Pelosi, and Secretary Buttigieg for including the Port of San Francisco in their investment to modernize ports across the country and the jobs that support working people and neighborhoods," said Mayor Breed. "Strong partnerships with our federal partners ensure a safe, economically strong City. Funding like

"Thanks to President Biden and the Democratic Congress, this \$9.6 million investment will allow the Port of San Francisco to make urgently needed upgrades to Amador Street – providing greener, more resilient road access to our Southern Waterfront," Speaker Nancy Pelosi said. "With this new funding, the Port will be able to rehabilitate a key roadway while bolstering stormwater drainage, removing toxic railroad ties and improving the surrounding landscape. It was my privilege to fight for this federal investment alongside our Bay Area Delegation as Democrats continue to deliver vital infrastructure improvements in communities across the nation."

Amador Street is a 1,900-foot road heavily utilized by trucks that contribute to the nation's supply chain and located at Piers 94-96 in San Francisco's southern waterfront. In its current condition the roadway is unsafe, laden with potholes, causing slowed traffic to avoid damage to supply trucks. Replacing the roadway will reduce wear and tear on vehicles and allow faster travel, dramatically improving the flow and movement of goods within the Port jurisdiction, and for the national supply chain.

Additional improvements will include replacing outdated, insufficient pipes to increase the outflow of rain runoff and prevent flooding in the industrial area and nearby neighborhoods. The overdue sewer and piping system frequently floods from rain runoff and high tidal conditions, impacting Amador Street and movement of local and national goods. A new pumping system with remote monitoring capabilities will also be installed to better address flooding.

"The Port of San Francisco is an economic engine welcoming millions of people to its jurisdiction each year and has maritime operations that provide sustainable jobs for people in the

# **Five Ways to Combat Workforce Challenges** in the Post-Pandemic Construction World

From 2011 to 2019, the U.S. construction industry saw a 25% increase in employment, with 11.4 million U.S. construction workers in 2019. according to the Center for Construction Research and Training. After eight years of steady growth, the COVID-19 pandemic created numerous workforce challenges for the industry, from recruiting and hiring qualified workers to supporting changing workforce needs and fostering the development of existing employees. Like most industries, construction is working to weather these challenges, adapting and expanding fundamental business approaches to retain current construction workers and attract new ones. Here are five ways construction companies can do just that.

## 1. Take advantage of online tools for improved candidate targeting

One of the key benefits of using applicant tracking software is that they help more accurately match available jobs with qualified candidates. Deploy tools like talent management platforms specializing in the skilled labor workforce, which can automatically push job postings to specialty job boards that directly target industryspecific candidates. In turn, candidates can not only complete applications and upload their resumes but also designate their most relevant skills and competencies for more rapid interview and placement opportunities.

## 2. Create a hiring pipeline through education networking

Developing relationships with local schools and familiarizing students with the company's name and brand is critical in maintaining a steady pipeline of potential employees. During the pandemic, school visitation programs became seemingly nonexistent, preventing students from learning about construction career opportunities. In a post-pandemic world, companies must prioritize networking with and educating students early about construction careers, including job openings, pay and other work benefits.

As part of a company's professional development program, enlist employees to visit their former schools, share industry experiences and support efforts for recruiting future employees. Tap into high school career technology education programs to educate students on opportunities that require skilled trade certifications, including welders, ironworkers and heavy equipment operators.

At the college level, shift networking programs to focus on encouraging students to consider degrees in construction management or engineering, which allows them to enter a construction

management track following graduation more easily. Partner with local colleges and universities to provide internships to construction management program students. Doing this increases the company's exposure, fosters industry growth and connects the company with students whose future professional interests intersect with potential career opportunities.

### 3. Expand traditional training and professional development

Pairing new employees with more seasoned team members is a simple and effective way for companies to ensure team members have a smooth, seamless transition into the company.

How does this work in the real world? Consider this example of sustainability. Nancy Novak, Chief Innovation Officer at Compass Datacenters, says, "At Compass, we approach new builds and material selection with repurposing in mind...we favor those that may balance the site's environmental impact."

### Data Visibility + Literacy = Workforce 2.0

The next megatrend to look out for is the adoption of digital products and services. Digital adoption is still in the early stages with data strategy, but it could make a huge difference in how projects are handled.

Some of the world's leading construction firms are assessing how they can leverage data and make it into actionable information. To get to that point, though, there has to be transparency and a willingness to share the data that's collected

Alan Muse, Global Director of Built Environment, RICS, poses an interesting question. "We need integrated data and systems. To achieve that, we need common standards and a much greater propensity to share data. How can we encourage the sharing of data, including cost data, in the industry?"

One way is through building better trust in data itself.

Why don't companies trust their data? For one reason, data and analytics have typically been seen as cost centers rather than information that could provide a meaningful impact on the business's outcomes. Data is often seen more as a risk-mitigation tool instead of part of a larger strategy to boost profits.

On top of that, how data is collected can lead to bad data and incorrect numbers, leaving people wondering if they can trust their data at all.

To get data back where it needs to be, front and center, it's going to take firms getting assistance

with educating their teams and subcontractors, since the way they input and interact with data directly impacts enterprise knowledge sharing and operational efficiency.

Of course, data literacy also has to be addressed. Bad data is problematic and leads to poor decision-making and outcomes. In one study, it was found that 30% of respondents thought half or more of their project data was "bad" at least 50% of the time.

Building better data strategies and training teams on how to use data correctly could have a lasting positive impact through increased trust and transparency. Additionally, firms that can improve their data literacy are going to have the leading edge and a better ability to improve their predictability, performance, and ability to attract and retain digital natives looking for roles using data-driven processes.

According to Mallorie Brodie, CEO and Co-Founder at Bridgit, "Not all data is created equally. When it comes to innovation through

tech, the competitive advantage won't go to the GCs that capture and use more data, it'll go to the ones that are capturing the right data and sharing it with the right people.'

Collaboration Without Boundaries

In the best-case scenario, construction should be highly collaborative. Over the last several years, there have been real strides made to improve transparency and collaborative efforts, but there are still pain points and disconnects to deal with.

Another megatrend to look for is stronger collaboration by migrating to cloud-based platforms. Through these integrated work environments, anyone working on a project has better access to data and can see opportunities and challenges as they crop up.

# San Francisco Receives New State Funding to Advance Electric Vehicle Strategies

Mayor London N. Breed today announced San Francisco has been awarded \$2.4 million from the California Energy Commission (CEC) to help the City reduce air pollution and advance its Climate Action Plan. Last week, San Francisco officially accepted funding from the State that will add more Electric Vehicle (EV) charging plazas, fund a new e-bike food delivery pilot program, build on the City's efforts to make climate and EV programs equitable and accessible for all residents, and support the development of a robust EV mapping tool.

This CEC EV grant funds a piece of San Francisco's larger strategy to fight the climate crisis and reach net-zero emissions by 2040. Addressing climate change means tackling San Francisco's transportation and land use issues head on. At nearly 50% of total city emissions, the transportation system must be transformed to reduce overall reliance on cars and equitably and efficiently connect people to where they want to go by transit, walking, and biking. All remaining vehicles must transition to zero-emissions.

To support that transition, Mayor Breed's Climate Action Plan includes several detailed strategies to accelerate the adoption of electric vehicles and other electric mobility options. This year, Mayor Breed sponsored an ordinance to update the Planning Code to make the installation of EV charging sites easier, which will help expedite the public expansion of citywide EV charging stations, and builds upon EV charging legislation she sponsored in 2019.

"San Francisco is continuing to lead in the transition to electrifying our transportation sector and cleaning the air we breathe," said Mayor Breed. "We already have one of the greenest transit fleets in the country with Muni, and are adding more electric vehicle infrastructure on Cityowned lots. This funding will help us expand that work to more communities so all residents can benefit from electric vehicles, and pilot innovative programs in our delivery sector. These strategies are all part of our comprehensive Climate Action plan and goals to be emission-free by 2040."

"The California Energy Commission is committed to helping cities transition to a zero-emission transportation system," said CEC Commissioner Patty Monahan. "We look forward to working with San Francisco as they implement their plans to bring charging stations to underserved communities and shift delivery workers away from cars and onto bikes."

## **New EV Charging Plazas**

With this funding from the State, three additional charging plazas will be built, bringing more fastcharging options for San Francisco residents and visitors. Currently, the City has 104 publicly accessible fast chargers throughout San Francisco, enough to serve approximately 14,000 EV drivers. Prior CEC grants and new funding will support the City's progress to phase out gas-fueled vehicles and satisfy the needs of an all-electric transportation system by 2040 with a total of 680 publicly accessible fast chargers. An estimated 47% of San Francisco's greenhouse gas emissions come from transportation, with private vehicles making up a large majority of that number.

In the first half of 2022, 26% of new vehicle registrations in the City were zero-emission vehicles. While the number of EV registrations continue to grow, there are still communities without access to EV charging options. Currently, the Bayview neighborhood is one of the only neighborhoods in San Francisco without a fast-charging station. Without convenient access to a fast charger, nearby residents might be discouraged from purchasing EVs, which disincentivizes EV charging providers from installing stations.

Community education and engagement is an essential component of the Mayor's Climate Action Plan and is also a critical part of the grant initiative from the CEC.

# High-speed rail project construction could begin in '23

Brightline West is looking to begin construction next year on the long-talked-about Las Vegas to Southern California high-speed rail station.

The estimated \$8 billion project would connect Las Vegas to Los Angeles via a route alongside Interstate 15 that would incorporate multiple stops in the high desert and San Bernardino County.

There are planned stations in Las Vegas and in California in Victorville, Hesperia and Rancho Cucamonga, where a connection with the Metrolink would carry passengers to and from downtown Los Angeles.

The Federal Railroad Administration recently released an environmental assessment report for the Cajon Pass portion of the project, a 49mile extension of the track would run between the Victor Valley and Rancho Cucamonga. The assessment compared the potential environmental impacts of the proposed project to the impact of building nothing at all. The assessment report noted the FRA determined that the Brightline project wouldn't result in a significant impact to the environment or have a negative impact on low-income or minority populations. It also said that building the project was the FRA's preferred option.

"Brightline represents the greenest form of transportation in the United States, with the potential to remove millions of cars every year from the I-15, and tremendous economic benefits for Nevada and Southern California," Ben Porritt, Brightline spokesman said. "The environmental assessment underscores the positive environmental impact of utilizing the I-15 for high-speed rail and is a significant step in the process to receive the key approval to begin construction."

It is estimated that 40,000 temporary construction jobs would be created to build the highspeed rail line.

community," said Elaine Forbes, Executive Director of the Port of San Francisco. "This little place in southeast Washington changed history and started the Atomic Age. ... It did what it was supposed to do and did it against all odds," said Colleen French, the U.S. Department of Energy official who guided the B Reactor to become a national park.





# Highest Thanksgiving Gas Prices Ever, Nearly 20% More Americans Plan to Hit the Road

Projected average price of \$3.68 on Thanksgiving Day will break record set 10 years ago

As Americans prepare to hit the road for Thanksgiving, average gasoline prices will be at their highest seasonal level ever for the weekend according to GasBuddy, the leading fuel savings platform saving North American drivers the most money on gas. # California commission overhauls rooftop solar proposal

The California Public Utilities Commission today released a long-awaited overhaul of its proposal to regulate rooftop solar installations, removing an unpopular new fee but reducing how much utilities would pay homeowners for supplying power to the grid.

The revised proposal comes after the CPUC earlier this year abandoned a controversial plan that solar advocates warned would undermine the state's efforts to battle climate change.

The measures to overhaul management of California's residential solar program have languished for more than a year. The CPUC's challenge is to encourage more rooftop solar production while not disproportionately saddling low-income residents with higher energy bills.

Ramping up solar power to replace fossil fuels is considered critical to cutting greenhouse gases in California. State law has set a target of 90% zero-carbon energy by 2035 and 100% by 2045.

The revised proposal addresses some — but not all — of the concerns raised by solar supporters. Power companies say it's not difficult to discern the governor's fingerprints on the changes. Newsom, who appoints the CPUC's five members, twice weighed in, suggesting the original proposal needed to be revisited.

"The changes are stark," said Kathy Fairbanks, a spokesperson for Affordable Clean Energy For All, which represents 120 organizations, including Pacific Gas & Electric, Southern California Edison and San Diego Gas & Electric. "It's clear there was some influence." The CPUC will hear oral arguments at a public meeting next Wednesday and is scheduled to vote on the measure on Dec. 15. If adopted, the new rules would take effect next April.

## The revised rules would:

- Remove a proposed \$8 per kilowatt monthly fixed charge, a so-called solar tax, on new residential systems.
- Reduce utilities' payments to homeowners for excess power they sell by as much as 75% compared to current rates. The change would not apply to residents with existing solar systems.

Fund \$900 million in new incentive payments to help purchase rooftop solar systems, with \$630 million set aside for lowincome households.

- Encourage the installation of solar panels plus battery storage.
- Set lower rates in an attempt to shift consumers' use of power to the times of day that improve grid reliability.

The CPUC is required under state law to update its net metering rules, which triggered a prolonged, complex and politically thorny process.

Bernadette Del Chiaro, executive director of the California Solar & Storage Association, said the 75% reduction in credits to new solar customers means utilities will pay residents less for the power their rooftop systems provide to the grid.
